

Summary: Ballard reopens a mysterious John Doe case while pursuing justice for

a councilman's murdered sister. As she navigates reluctant witnesses, department politics, and her own demons, Ballard and her team uncover buried secrets that suggest corruption within the police force.



The episode starts with Ballard chasing after a suspect. The suspect opens fire, forcing her to shoot as well. ning the new cold case unit. It is a small unit with Ballard, Laffont, Colleen, Ted, and Martina. After closing their first case, Ballard is set on another case. According to Ted, the case is a lost cause. The culprit left no evidence behind, and no one is willing to talk to Ballard.

As Ballard briefs her team, Council Pearlman and Nelson arrive. Pearlman is unhappy about the recent attention Ballard's last case brought. Pearlman wants Ballard to focus on his sister's murder. This is why he supported and helped her set up the team. Ballard reminds him that they have few resources and she needs something tangible before approaching a man named Brian. Pearlman believes that Brian killed his sister. Nelson threatens to dismantle the team if Ballard doesn't solve the Sara Pearlman case.

We soon learn that Ted is friends with Pearlman and that he is there to keep an eye on Ballard. After the councilman leaves, Ballard focuses her attention on Sara's case. Ballard understands that Pearlman needs answers. In the meantime, she still has a John Doe case to solve. Unfortunately, the officer in that case quit and is dodging Ballard's calls.

Ballard visits the officer, Zamira, and tries to get her to talk about the John Doe case. Zamira is reluctant to cooperate but claims that someone in the LAPD was covering something up. Back

in the day, when she was working the case, a witness mentioned an altercation that happened before John Doe was killed and his baby went missing. According to Zamira, someone deleted any trace of the altercation. Ballard invites Zamira to her office to give her take on the evidence.

Later, Ballard confesses to Laffont that she plans to recruit Zamira. The next day, Zamira drops by to help with the John Doe case. After quick introductions, Zamira insists that she is only helping. She gives the team a better perspective on the case. Martina brings up documents from Sara's case, and Zamira's curiosity is piqued. Laffont notices that Ballard got the palm print that the killer left behind. However, they are not sure if it is usable.

Ballard is hoping to get some DNA from the print. She approaches the lab and begs Darcy to rush the results. Darcy agrees because she likes Ballard and thinks she was brave for calling out a rogue cop.

In the evening, Ballard heads home. She lives with her grandma, Tutu. Tutu notices that Ballard seems down and asks what's wrong. Ballard reveals that every time anyone mentions the past, it triggers her. Tutu suggests she tries to move on and start dating again.

The following morning, Zamira drops by the lodge where John Doe was last seen. She tries to talk to the manager, but he is uncooperative. One of the cleaners hears the conversation. A little while later, she calls the police and asks to speak to Zamira. Unfortunately, the call is forwarded to Zamira's old partner, Olivas. The lady quickly hangs up after hearing Zamira quit.

Back at the office, Ballard talks to Collen about her intuition. She worries that Colleen's intuition might undermine their case. The defence attorneys could use it to throw out the case. Zamira drops by and mentions her visit to the hotel. The visit left her feeling hopeless and reminded her of why she quit. The case was five years ago, and she figures bygones are bygones. Ballard asks her to at least give it a day before she decides.

Darcy calls Ballad to inform her that they got DNA from the palm print. Ballard drops by Brian's tattoo shop and gets a call from Nelson. Nelson reminds her that he would like to be updated throughout the case. At the tattoo shop, Ballard goes undercover and secretly collects Brian's DNA. Unfortunately, Brian notices and takes his gloves from her. The case has already ruined his life, and he wants nothing to do with the police.

Meanwhile, Olivas tracks down Ballard and her team. Zamira seems flustered to see her old partner, and Ballard seems angry to see him. Olivas informs them that a woman called for Zamira and offers his help. Ballard turns him down and sends him on his way. She insists that Olivas call next time. He mentions something about burying the hatchet, but she clarifies that she is not willing to do that.

Later, Ballard goes for a surf session to de-stress. She talks to the lifeguard, Aaron, and promises to call him later. She heads out to meet with Zamira and tries to convince the latter to join the team. Zamira wants to join the team but is hesitant. The past is still weighing on her. Ballard brings up her side of the story. She reveals that she was demoted for trying to bring down Olivas. Ballard also adds that she pulled up the cold case because Olivas worked it. She invites Zamira to join her and do some good. Zamira agrees and heads back to the lodge.

At the lodge, she finds a crowd and learns that Yulia, the lady who called for Zamira, is dead. She was killed while cleaning one of the rooms. Simultaneously, Darcy calls Ballard and informs her that Sara's killer is linked to another case. He might have killed another woman called Laura Wilson was killed back in 2008.

Ballard pulls Laura's case files and starts to investigate. She worries that they have a serial killer on their hands. Unfortunately, she is displeased to learn that Bosch was the officer in charge of the case.

Meanwhile, the hunt for the serial killer's latest victim reunites Ballard

with retired Detective Harry Bosch.



The episode starts with Ballard arriving at the lodge crime scene. She introduces herself to Detective Neylon, the man in charge. Neylon is unhappy that she is on his turf, but tries to be accommodating. He allows her to check the crime scene and promises to call her once he gets the ballistic report. Before leaving, Ballard talks to the manager and checks out the CCTV footage. Unfortunately, the murder was not caught on camera, but a suspicious man catches her attention. She quickly takes a picture before leav-

ing.

Outside, Zamira waits, and Ballard tells her that they will secretly work the case. She calls Laffont and sends him the victim's details. Laffont asks her to call Bosch, but she refuses. Neylon believes Yulia was killed in a robbery gone wrong, but Zamira and Ballard think otherwise. They follow one of Yulia's co-workers to a local salon. The woman refuses to talk since she is undocumented. Ballard allows her to leave and talks to the salon manager. The manager tells them more about Yulia, but nothing substantial enough to be a lead. Luckily, she recognises the unhoused man in the picture but doesn't know his name.

They head back to the office and debrief the team. Ted is frustrated to be sent on the hunting mission. Meanwhile, Ballard and Zamira start creating the case board and going through all the evidence. Ballard leaves to talk to Laura's mom but runs into Pearlman. He is mad that Ballard is looking into Yulia's and Laura's cases.

Ballard tells him about the connection between Sara and Laura. She also reminds him that all cases are important. As they talk about the cases, it dawns on Pearlman that Brian might not

have killed his sister. Brian was doing a military tour. Ballard promises to get Pearlman answers and calls Laffont to check out Brian's alibi during Laura's murder. Laffont suggests they bring Bosch in, but Ballard refuses.

The visit with Laura's mom doesn't go as smoothly as Ballard hoped. As she leaves Laura's mom's house, someone starts tailing her. Unfortunately, Ballard doesn't realise she is being followed. She heads to her therapy session where we learn that someone tried to rape her. Her therapist worries that Ballard is too hurt by the betrayal of her fellow officers. Ballard switches the topic back to the shooting. On her way out, she runs into Olivas and two other male officers. One of the officers makes a crude sexual joke, pissing Ballard off.

Back at the office, Colleen finds the last advert that Laura worked on. Martina finds a possible connection between Laura and Sara. Sara was in the drama club, and the killer might have met them through acting classes. Laffont gets an update on Brian's alibi, forcing them to drop him as a possible suspect. It also turns out that Leyton never submitted the bullet that killed Yulia to ballistics. Ballard sends Laffont to do it, and Colleen offers to join him.

On the other hand, Ballard visits Brian and apologises to him. Brian is relieved to hear he is cleared, but sends her away.

In the meantime, Zamira joins Ted in searching for the unhoused man. After a while, their search leads them to a guy named Frosty. Ballard joins Zamira and Ted to make an arrest, but Frosty tries to make a run for it. He ends up breaking his leg. Given that Frosty is hurt and too high, they call it a day and drop him at the hospital first.

After a long day, Ballard calls Aaron after getting hurt during the arrest. Aaron drops by her house and says she only calls him on the bad days. They end up sleeping together, and Aaron accidentally flashes Tutu the following morning.

On the other side of town, Ballard meets with the captain after Neylon reports her for working her case. The captain sides with Ballard and asks her to take over the case since she arrested Frosty. However, the captain asks her to close the case perfectly or lose the case. Before heading to the office, Ballard drops by Ballistics. She begs Freddie to run the ballistics on her John Doe case and prioritise the Yulia case.

She later meets with Zamira at the hospital to interrogate Frosty. Unfortunately for them, Frosty suffers from mental issues. Even when sober, he can barely make a coherent sentence. Zamira and Ballard believe that someone intentionally paid Frosty to kill Yulia because he was too lost already. When asked about the gun, Frosty claims he buried it, and it turned into roses. With no clear answers, Ballard and Zamira leave.

At the office, Colleen is still traumatised by her first visit to the morgue. Laffont comforts her, and they get back to the case. Ballard sends Zamira and Ted to try to find the gun Frosty disposed of. Bosch makes an impromptu visit and asks to talk to Ballard in private. He is unhappy she didn't reach out, but doesn't take it personally. He invites her for lunch and tries to encourage her to find the silver lining in her current situation. Bosch also mentions that he found the alibis of two witnesses problematic in the Laura case.

Back on the street, Zamira and Ted find Frosty's gun near a rose mural. Zamira calls Ballard, and they rush the gun to Freddie. Unfortunately, the gun can only be linked to Yulia's case. As for the John Doe case, Freddie says the bullet was never presented and thus never analysed. Zamira is sure she called in to request the bullet analysis. She couldn't follow up as she left the force, but now, she is certain someone in LAPD wants this case to go unsolved.

The scene then cuts to Ballard's stalker calling someone. He assures the other party that the case is closed and Frosty will be taking the fall. The other party gives him new instructions. The episode ends with the stalker arriving at work, and we learn that he is a police officer.

The episode starts with Ballard surfing. Later, Tutu gifts Ballard with a new surfing board, but the latter rejects the gift. Meanwhile, Zamira is at home, helping her mom look after her sick dad. Zamira is still hiding her return to the force from her family. Elsewhere, Ted secures a new client for his security company. Colleen visits the church while Martina studies. As for Laffont, he spends the morning with his husband and dog.

On the way to work, Ballad calls Laffont. Laffont informs her that he tracked

down one of the witnesses Bosch mentioned. One of them is dead, but they hope they can talk to the other guy. As they talk, the captain calls to summon Ballard. The captain asks Ballard to look into a new cold case that has gone viral after the victim's sister's protests gained public attention.

The case involves a young fraternity man who suspiciously fell to his death at the fraternity house. The class has an upcoming reunion, and the sister has been protesting outside the university, calling for justice. She believes the university covered up her brother's murder. Ballard talks to the lady and reopens the case. At first glance, Nick's death looks accidental, but Ballard notices an inconsistency in the autopsy report. It seems like Nick was hit before his death.

At the office, Colleen spots a mouse and thinks it is a good sign. She is currently looking for Yulia's family in Ukraine to share the sad news.

On the other hand, Zamira runs into a roadblock when following up on the John Doe bullet. She calls Ballard for help. The latter advises her to work on getting her badge back. Zamira needs her firearm qualifications before being fully reinstated. Unfortunately for them, they learn

that someone disposed of the bullet. Ballard insists on getting a copy of the dispo-order. This strengthens Zamira's concern that someone in LAPD is dirty. However, Ballard asks her to keep it on the low and focus on her reinstatement.

Back to Nick's case, Laffont and Ballard drop by the class reunion. On the way there, Laffont notices Ballard keeps ignoring calls from her former partner, Chastain. After talking to the fraternity brothers, Laffont and Ballard conclude that they are hiding something. After a team debrief, they agree to target the weak link in the group and get him to turn on his brothers. The plan works, and the man mentions a book that the fraternity boys hid before the police got on the scene. Ballard's team visits the fraternity house and confiscates the books.

It turns out the fraternity brothers kept a book detailing their sex-capades with the girls and grading the experience. The pages are filled with pictures of the girls, and it is well-detailed.

On the personal front, Ballard completes her mandatory therapy. Her therapist advises her to face her trauma, but Ballard refuses to open up. She also refuses to work on the surfing board Tuti got for her as it reminds her too much of her dad. In the meantime, Martina continues to struggle with balancing her studies and her internship job with the team.

The following day, Ballard gets a copy of the dispo-order and learns it was signed by a cop named Charlie Grant. He is currently retired and didn't work on the John Doe case. Ballard informs Zamira that she has to tell Laffont about their suspicions. Zamira is hesitant, but Ballard insists they can trust him. Ballard and Laffont visit Charlie, and he accuses them of lying. He denies signing the dispo-order and shows them his real signature.

At the end of the meeting, Charlie warns Laffont to be careful with Ballard. On the ride back, Laffont assures Ballard that he is on her side. He cautions her to tread carefully, as corrupt cops are as dangerous as they come.

If things don't work out, they can circle back to Adam. Adam also identifies the car he saw outside Laura's house as a Ford.

Meanwhile, Colleen meets with the salon owner to get more information on Yulia. She is hoping to contact Yulia's family and notify them of the tragedy.

After getting back to the office, Ballard asks the team to focus on tracking down the Ford car seen outside Laura's house on the day of her murder. Martina also updates the team on the John Doe bullet that she and her friend managed to reconstruct from the bullet wounds.

Ballard hopes Freddie can use the data to find out more. Freddie links the bullet to a case related to Javier, who is currently serving time in County Prison over firearm charges.

As for Zamira, she later apologises to Ballard for getting heated during their morning meeting. Colleen finds a lead on Reddit about a car and decides to follow up. She ends up getting another victim. However, to find out more, she needs Ted's help since he has a badge.

In the middle of the day, Laffont gets word that Chastain died in a car accident. Ballard tries to act indifferent, but her former partner's death affects her. In the evening, she spends time with Aaron and vents over Tutu making her build a new surfing board.

The following day, Zamira and Ballard visit Javier in prison, but he refuses to say much. Fortunately, he identifies John Doe as Luka Ibarra, a coyote for the Zacatecas Nuevas. Javier's alibi checks out, and they focus on finding more information on the vans and Ibarra.

Ballard uses work as an excuse to avoid her complicated feelings over Chastain's death.

On the other hand, Ted offers to connect Colleen with a guy from Ukraine to help her trace Yulia's family. Colleen later meets with Andrei and briefs him on the situation.

Their investigation into the vans brings up a new lead, Coleman. Unfortunately, the lead turns out to be another dead end. Later, Ted visits Jake's place to watch the game.
