Flashback to one day ago, Eileen is out for a run and almost runs into a moose that is blocking her path. Claire is eating at Rita's diner to celebrate her son's birthday as customers argue amongst each other.

Yuma is presented with her front-page story framed by her co-workers. Roz finds Eileen working on Gloria's timeline and explains that Toby can't be in Meade anymore.

Gabriel tells Bob that Rita is selling her diner and everyone at the newspaper starts freaking out. Roz and Eileen arrived at the Medical Examiner's office to help Sylvie, Gloria's mom, get Gloria's autopsy report. Helen, the medical examiner's secretary, refuses to give the report to Sylvie. Eileen informs her that the autopsy is public information.

Claire arrives at Rita's diner to ask her why she is selling. Rita refuses to talk, saying she doesn't have a choice. Claire is positive that Rita is being forced to sell and decides to investigate.

In the autopsy report, Gloria's injuries are multiple and severe, but the cause of death is still listed as undetermined. The police swabbed for DNA, but they do not have any test results in the report. Sylvie demands to look at the graphic crime scene photos and breaks down when she sees them.

Ellen and Roz confront Helen about the missing lab reports from the DNA test. Helen explains that the DNA test costs \$2,500 for each one, and Roz becomes livid that it's all about money and not getting answers. Helen informs them that there is no database to test the results against anyways. Eileen is confused, and Roz explains that the Attorney General promised the database 3 years ago but never provided one.

Claire digs into the sale of Rita's diner and finds out that Big Burger is buying it. Roz and Eileen go to Stanley with everything they have so far, and Roz wants to write the story. Eileen and Stanley disagree with her and say the story is not ready, and all they will be doing is making the police mad and give the murderer a heads up.

Stanley and Eileen are having lunch with Aaron Pritchard, whose family owns the newspaper. Aaron and Eileen have a disagreement about her fact-checking, and Stanley stands up for Eileen. Roz finds out that Toby has an uncle that he is close with.

Roz finds Toby's uncle, Ned Crenshaw, and she and Eileen head out to talk to him. Eileen receives another threatening phone call and pictures of herself going about her day. When she goes outside to confront her stalker, he peels away in a big black truck.

Roz and Eileen arrive at Ned's, who refuses to talk. Roz notices his freezer and Tanner Crab boxes and tells Eileen that Toby must be a commercial crabber. Claire and Miles arrive at a demonstration in support of Rita, and everyone wants to know why she is selling her restaurant to Big Burger.

Bob tells Roz and Eileen that there are only two places that fish for Tanner Crab. Eileen asks the whole team to help her search for the exact boat that Toby will be working on. Roz finds Toby's name on the Southern Ridge's crew list working in Kodiak.

Stanley explains that the paper cannot afford to fly them out to Kodiak and Eileen calls Jamie, the poetic pilot, for help. Jamie agrees to fly Roz and Eileen out to Kodiak in the morning.

Claire calls her husband, Jeff, because she is working over again, and Jeff is angry. He thinks Claire has been caring more about the Big Burger story than he and their kids. Claire is convinced that Rita does not want to sell her diner.

Frank Moses, who is running for Senate, is being interviewed by Austin, when he receives a text message and abruptly leaves the interview. Bob tells Austin that Frank has just been caught in a scandal and they need to stop Aaron Pritchard before he prints the newspaper's endorsement of Frank.

Austin tries to comfort Jieun about her article on Jordan Teller and asks her for help digging into Frank's financials. In Meade, Sylvia shows Roz and Eileen Gloria's room. She has kept it exactly the

same way that Gloria left it the day she was murdered.

Roz tells Eileen that they need to announce their presence and take a gift to the Council on Culture. Eileen blows Roz off. Sylvie has some community members take Roz and Eileen to the spot where Gloria's body was found.

Roz and Eileen are taken to Skeeter's house next. There isn't a house standing there anymore. The neighbors tell Roz and Eileen that Skeeter's real name is Clarence. One of the neighbors admits to Roz that he did see Gloria hanging around Skeeter's house. He explains that he didn't call the cops because he knows the cops are dirty and selling drugs from the evidence locker room.

Jieun and Austin discuss Frank using Austin's ex-wife, Anna's, law firm. Austin tells Jieun that she should look into counseling. Roz's estranged half-brother seeks her out to just say hello. When Frank picks his child up from Anna's house, he asks her for information on Frank Moses. She refuses to help.

When Chief Durkin's police report on Gloria's death is finally sent over to Roz and Eileen, they find everything has been redacted except for the negative parts about Gloria. Eileen tells Roz that they will begin investigating all of Chief Durkin's cases. When Eileen and Roz cannot get a hold of the monthly police report, Eileen sneaks behind Roz's back and asks Derek to get them for her.

Austin discovers Frank who is campaigning on saving the salmon, is secretly taking money from the mining industry! Austin tells Stanley what Frank is doing and Stanley tells Aaron. Aaron pressures Stanley to not run the story.

Roz and Eileen start digging into any other complaints or issues with Chief Durkin within the community. They find that there were 72 complaints of rape or sexual assault, yet nobody was charged in any of them. Chief Durkin doesn't investigate crimes against indigenous women!

Roz and Eileen confront Chief Durkin about his lack of investigation into crimes committed against Indigenous women. The chief explains that he doesn't want to waste his or the court's time on Alaskan women who just can't handle their alcohol.

Roz tells Eileen that she will not work with her on this story if Eileen goes behind her back again. They need to be equal partners. Jieun starts therapy because she is dealing with online hate after writing a story that may have caused Jordan Teller to commit suicide.

Austin's ex-wife, Anna, calls him and informs him that she has a new job offer. The job is in Chicago and she wants to take their son and go live there.

Stanley goes against Aaron's wishes and has Austin write up the story about Frank. Stanley starts making phone calls and begins the investigation into the Pritchard family including Aaron and his father, Conrad.

Roz questions Ezra by herself, and he claims that he barely knew Gloria. That she only stopped by Skeeter's to try to get some Oxys for the frostbite, she was suffering. As Ezra leaves, he lets Roz in on a little secret: Assistant District Attorney Barnett is sleeping with Taylor!

Eileen is at JBEN, disregarding both Bob and Stanley's warnings and decisions. Roz calls her and relays the news that ADA Barnett is sleeping with Taylor. Eileen tells Roz to start looking into all of Barnett's cases because he was probably sleeping with other victims involved in his cases. Austin is shocked to see Eileen at JBEN, and Yuna informs her about the Choi's missing son, Greg.

Greg is in the 486th Fighter Wing and has been missing for a week. Greg flies the F41fighter jet, which was made by the company Armeon. The Secretary of Defense was an Armeon executive when he made the contract to supply the United States Air Force with the F41s. Eileen uses all this information as ammo when cuts off another journalist to question the Secretary of Defense about where Greg is and the safety of the F41s.

The Secretary of Defense walks off-stage, saying no comment. He invited Eileen to follow him to his car And told her the only reason he was Secretary of Defense is because a lot of people in the government hate Eileen, just like he does. Roz starts calling all of Barnett's female clients, past and present, to see if Barnett was sleeping with any of them. Stanley yells at Eileen for going rogue and says if she ever pulls a stunt like that again, he will never support her again.

Bob is livid with Eileen and can't help but to speak his mind, calling her reckless. Liza Peters, another client of Burnett's, calls Roz to let her know that she slept with Adam Barnett when she was the victim in a case that Barnett was prosecuting. Bob finds the missing ferret, Hairy Potter, and Claire is so grateful.

Yuna heads to the Choi's house to find out what they know about Greg's death or the F41 he was flying. Yuna knows Greg was a good pilot, and now the Air Force is blaming him for his own death. Mr. Choi explains that Greg emailed his commanding officer, Colonel Norton, detailing all the issues and problems the F41 had. Greg was scared to fly it because it was so unsafe.

Roz asks Taylor if Barnett pressured her into having sex with him and promised her that he would get the full sentence for Ezra on the domestic violence charge if she did. Taylor confirms that is exactly what happened. Roz informs her she's found at least seven other women that ADA Barnett has pressured into having sex with him. Roz asks Taylor if Ezra was ever seen with Gloria. Taylor says that Ezra saw Gloria the night she went missing at a friend's house, but he was with his and Taylor's son all night, and their son confirmed it, giving Ezra an alibi.

Roz confronts Barnett about his affairs with the victims. Barnett says he never pressured the women, and he informed the DA's office anytime he started a relationship with someone involved in the case he was prosecuting. Roz finds a total so far of 9 women who claim Burnett pressured them into having relations with him for the promise of fully prosecuting their offenders. The DA's office informs Roz that Barnett never informed them of any relationships with any of the victims in his cases. With Ezra's son being his alibi, Roz and Eileen know they must start looking for Rega Horne.

Eileen's story about the F41 being faulty and the Air Force trying to claim that Airman Choi caused his own death goes national. Aaron Pritchard knocks on Eileen's hotel room door. He compliments her, asks for a drink, and then kisses her. Eileen kisses him back and then tells him that it can never happen again as she closes the door in his face.

Roz and Eileen are on a radio show called "The Concerned Citizen." Eileen and Roz discuss the firings of Chief Durkin and ADA Burnett after both men are exposed in The Daily Alaskan newspaper. Eileen takes a phone call from the same man that has been harassing her and sending her threatening gifts while on the air.

Governor Thacker's office announces that they will be holding a press confer-

ence to discuss Henley Scott, the white woman who fell off a cruise ship. Eileen, Roz, and Claire recognize the different amounts of press coverage and money being spent for the search and rescue of Henley Scott and Jade Jacobs, a missing Alaskan woman.

The Governor is going all out and says no expense will be spared to rescue Henley. They have boats, airplanes, and watercraft out searching for Henley. The press is all over the story, and Roz and Eileen get upset that no one is covering Jade's disappearance.

Roz, Claire, and Eileen are already sick of how much media coverage Henley is getting, especially compared to Jade, who has no media coverage. Stanley explains that they have to cover the search for Henley, as there are too many eyes across the world watching. He makes the women an offer to split the coverage between Henley and Jade if they follow the money and prove how much is being spent by the Alaskan government on each case to show the differences.

Eileen catches Commissioner Haynes and asks her how much money is being spent on the search and rescue mission for Henley. Commissioner Haynes explains that it's over \$1 Million so far. Stanley finds out that the Pritchard family is buying up protected land and going to try to build a road that would be worth millions.

Aaron is sitting in Stanley's office, upset about the declining numbers in the newspaper's subscriptions and sales. He warns Stanley that they need to get the numbers up, or he'll shut the newspaper down.

Roz is upset because she cannot get a photographer for her story on Jade. Jindahaa, Roz's boyfriend, offers to be her personal photographer and help get the pictures she wants for Jade's story. Bob starts asking questions about why the Man Overboard alert did not go off on the cruise ship. Craig admits to Bob that nobody installed the Man Overboard alert system on the cruise ship, even though it's required by law. A drone is used to get the name of the cruise ship and the flag it flies. The cruise ship is from Panama.

Roz shows up at Jade's search party. She starts asking how the police are handling the case, and Jade's mother informs Roz that the police have not been by yet and Jade has been missing for 50 hours. Eileen questions Commissioner Haynes again and brings up Jade. She asks why the Governor is spending millions looking for Henley and nothing looking for Jade. The Commissioner blames reporters, saying that they don't go crazy for answers when an Alaskan Woman goes missing in Alaska. They only demand answers when it's a pretty white girl.

Governor Thacker holds a second press conference about missing Henley, Bob, and Roz attend together to get some answers. Bob has found out that with the crews flying a Panama flag. They are not required to reimburse the Coast Guard the million dollars it has spent searching for Henley. They are also not required to operate with the Man Overboard alert, and the cruise ship is actually profiting off of Henley falling overboard.

Stanley gets a call from the Governor complaining about Roz's behavior during the press conference and asking her to tone down her questions. Eileen couldn't be prouder of Roz for asking the hard questions and not backing down. When Roz starts to leave, Stanley asks why she is still working on Jade's story. Roz explains that it is because Jade is still missing and could be alive. She believes Henley is already dead because she's been missing for so many hours in the Alaskan water.

Stanley shows up to volunteer at Jade's search party with Roz and Jindahaa. Eileen Calls them to inform them that she is going to the Governor's Gala, even though Claire is assigned to the Gala. Someone in the search party discovers Jade's bracelet in the woods.

At the Gala, Claire spots Eileen and wonders why she is there with Aaron Pritchard. Jindahaa offers to turn all the statistics from the missing Alaskan women into a visual data point, so the readers have something eye-catching that shows them how severe this crisis is. Eileen meets Aaron's dad and lets him know that the Governor is misappropriating the funds that are allocated to searching for missing Alaskan women.

Eileen bumps into Jaime at the Gala, who is reading some of his poetry that he has won an award for. When Eileen listens to Jamie read his poem, she realizes that he has written about their time together. Eileen asks the Governor why the majority of his task force's funding goes to a PR campaign, instead of actually helping find the missing women.

Henley's body is found, and people set up memorial shrines in remembrance of Henley. Eileen writes the article "The Price of a Life," showing the difference between Jade's and Henley's search efforts and media attention. Bob has a heart-to-heart moment with Roz and Eileen about how he never circled back to any of his old investigative stories to see if there is any resolution, closer, or unanswered questions.

Bob gives Roz and Eileen Alison Porter's contact information. He tells them when he first started investigating Gloria as a missing person, he found her friend Allison. Allison and Gloria went to church together. Alison told Bob that the police never came out to investigate or help search for Gloria. Instead, Allison said it was the community that pulled together to try to get answers and find Gloria. Roz and Eileen were never informed that Gloria went to church. Roz reaches out to Alison Porter and finds out that the pastor's name of her and Gloria's church is Reed Gallahorn. Irene swears she has heard that name before, and Roz makes the point that Rega Horn could be shorthand for REed GAllaHORN. Eileen calls Jamie and invites him out for drinks with her and her coworkers. He declines but asks for a rain check.

Eileen is all alone in the office when the man who's been harassing her by making threatening phone calls walks in the door. He calls himself a 'concerned citizen' and pulls out a gun! Eileen begs the man and prays to God.

The episode begins by giving viewers a little insight into the Concerned Citizen and his motives for targeting Eileen. He's sitting in his car outside of the Daily Alaskan, listening to a talk show where some man rambles on about how the media is quick to label someone "fascist, racist, or homophobic" if they disagree with them. Once he notes that everyone has left the building except Eileen, he grabs his gun and goes inside.

The Concerned Citizen locks the door and confronts Eileen. He points the gun

at the journalist, demands she gives him her phone, and walks her to the bullpen. While Eileen tries to pull information from the Concerned Citizen, Gabriel Tovar watches from the archives room.

Gabriel texts Stanley Cornik and fills his boss in on the situation. And Stanley informs everyone at the bar — Bob Young, Roz Friendly, Claire Muncy, Yuna Park, and Austin Teague. Although they're worried contacting the police might set the Concerned Citizen off, they call them anyway. After reaching (non-ally) Captain Freeman, the reporters stay in the bar and try to find more information about the gunman.

Back at the Daily Alaskan, the Concerned Citizen wants Eileen to write a confession about how she "spreads lies, suppresses the truth, and faithfully serves her corporate masters as they destroy the backbone of the country." From that line, Eileen realizes he reads the Eagle and Dennis Gibson. The Concerned Citizen then admits he disagrees with her "liberal crap," even though Eileen points out that she doesn't even vote.

In the bar, the group discovers a user named OilMan223 who comments on the Daily Alaskan's post and the Eagle's is likely the Concerned Citizen.

Gabriel starts to (understandably) get more nervous, so he calls Stanley. They brainstorm a way to send Eileen a message, and Gabriel realizes he can communicate with her via the analytics page on a nearby screen. He writes, "Colombian Staffer Locked in Morgue. Can you see him?" And she does.

Yuna links OilMan223's Twitter account to a website owned by Eric Berry. Stanley sends a picture of Eric to Gabriel, and he confirms that this is the Concerned Citizen. They inform the police, and Aaron Pritchard arrives at the bar to help. Meanwhile, the police surround the Daily Alaskan.

Eileen finishes her "confession," even though she doesn't believe a word of it. When Eric demands she publishes it online, Eileen starts making up excuses. And when the phone starts ringing, Eric's frustration reaches an all-time high, so he shoots the landline.

After the unnecessary overreaction, Eileen convinces Eric to let her go to the bathroom. While there, she clocks that Eric worked on oil rigs from his shoes, so she tries to relate to him by mentioning that her father was a steelworker. Eric seems to soften up a little, and back in the bullpen, Eileen says he can use her to tell his story. And they get to work.

While explaining his life story, Eric seemingly blames his problems on "environmental freaks" and their protests. He admits he hasn't worked for seven years as a result. And perhaps Eileen starts to feel sympathy for her hostage-taker.

Back at the bar, Claire discovers that the bank recently foreclosed Eric's house. Austin and a detective head over to find more information about the gunman.

The police inform the reporters that they can shoot and kill Eric, but Eileen has to move out of the way. So Gabriel sends her a message — "Former Vanguard employee in line of fire. Drop to the ground to terminate problem." However, Eileen refuses. She doesn't want to see Eric killed right in front of her, and we can't say we blame her.

The next morning, more than 10 hours after the hostage situation began, Roz confronts Dennis Gibson about OilMan223. She reads him one of the messages that Dennis sent Eric — "Take action, OilMan223. Reporters like Eileen Fitzgerald are a spreading cancer sore that requires excising." So, Dennis agrees to help.

Austin and the detective find a goodbye letter to Daisy, Eric's college-aged daughter, at his house. Her social media reveals that she's in rehab, so Bob and Yuna pay her a visit. They inform Daisy of the situation and try to convince her to call her dad.

Eric clocks Eileen staring at the analytics page, so he shoots it and demands that she tells him where the messages are coming from. Flustered, Gabriel knocks over some boxes, and Eric grabs him. The gunman barricades them in Eileen's office, out of sight of the snipers.

Dennis calls Eric, but Eric sees right through him and hangs up. Believing he has no other way out, Eric makes Eileen promise to tell his story, and once she does, he leaves the office, holds the gun up to Eileen, and a sniper shoots him in the head. As Eric's dead body lays on the floor, Eileen and Gabriel note that the gun wasn't loaded, and a call from Daisy comes on his phone. And just like that, it's all over.

Later, Eileen writes the story and sheds light on the attack on journalists. And afterward, she and Jamie, the pilot poet, take a much-needed flight over the beautiful Alaskan waters.

Following the hostage situation, Stanley Cornik forces Eileen to start attending therapy before returning to work. But, knowing Eileen, she just wants to get back into the newsroom. Unfortunately for her, the therapist believes she might have PTSD, so Eileen opens up about her panic attacks.

The journalist then comes clean about why she chose this profession — she cares about the truth because her parents lied to her. Unfortunately, Eileen doesn't elaborate.

Back at the Daily Alaskan, Yuna Park, Austin Teague, and Claire Muncy are recovering from their trauma. Eileen returns (much to Stanley's dismay), and they all welcome her back with open arms (figuratively and literally in Yuna's case). Meanwhile, Gabriel Tovar is taking time to process being held hostage by the Concerned Citizen.

Eileen wastes no time and jumps back into Gloria Nanmac's case with Roz Friendly. Roz has made a lot of progress and informs her partner that their most recent person of interest — pastor Reed Gallahorn —

runs a church called New Zion. The police arrested Gallahorn six years ago for a felony assault. But the charges were dropped, and they didn't take his DNA.

But that's not all. A reporter named Max Hansen investigated the death of Randy Martin, a teenager found behind Gallahorn's previous church in Nebraska. Max tells Eileen and Roz that the medical examiner ruled Randy's death accidental. However, Max believes Gallahorn is to blame since he had a motive — the reporter was investigating Reed for "extreme practices" (aka physical abuse), and Randy was his source.

Since Stanley doesn't want Eileen to go to Meade, she and Roz split up. Roz will travel to Meade, while Eileen will stay in Anchorage and report on Alaska's broken DNA system. They want to pressure the state to test Gloria's and Gallahorn's DNA.

Eileen goes to the medical examiner's office and learns that the state only tests DNA when a death is ruled a possible homicide. But only the Public Safety Commissioner's office can change the status of a case. So, Eileen visits Commissioner Haynes.

Eileen tries to convince Haynes to test Gloria's and Gallahorn's DNA, but the commissioner claims the case is too old. And Haynes then drops a bomb on the reporter — Conrad Pritchard is selling the Daily Alaskan, so Eileen's thinly veiled threat to write a story on the state not testing DNA doesn't scare her.

Meanwhile, at the Daily Alaskan, Aaron Pritchard and Stanley brainstorm budget cuts. Eileen calls Aaron and confronts him, but he has no knowledge of his father's recent business ventures.

Later, Stanley has Claire do some digging, and she discovers that Conrad's office requested financial reports and sent them to Horizon Capital in New York. Apparently, Horizon has been buying up newspapers around the country and gutting them. So Stanley calls Aaron and gives him helpful information to use against his father when fighting for the paper.

In Meade, Roz's half-brother Derek picks her up from the airport (they're working on their relationship). He drives her to Sylvie Nanmac's house, and Sylvie denies that Gloria attended Gallahorn's church. She raised her in the Presbyterian church, but Sylvie admits that Gloria started to pull away. So Roz goes to New Zion to ask Alice, Gloria's friend, herself.

She doesn't get much out of Alice, especially since when Gallahorn appears, he escorts Alice out of the room. Roz starts asking the pastor questions and learns he saw Gloria the night she disappeared. Gallahorn claims that Gloria fought with her mother and wanted to run away from home. So he tried to help her with "the spiritual tools to protect herself, but she couldn't escape the darkness." That's not ominous at all.

Roz returns to Sylvie, who admits she fought with Gloria about going out the night she went missing.

Elsewhere, Eileen meets with the executive director of the Justice Council for Alaskan Natives. She informs the reporter that the nonprofit lobbied for a \$2 million grant for DNA testing a year ago. But the state claims the budget is still in process, so Eileen gets her hands on the Department of Public Safety's budget. And she discovers that they used the \$2 million for something other than DNA testing.

Roz discovers that Gallahorn has a son, Chris. But he disappeared from the church's website six years ago (around the same time the police arrested the pastor for assault). So Roz sends Eileen Chris's address in Anchorage so that she can investigate further.

There, Eileen learns that Chris was the victim of the assault charges, but he signed an NDA. So Eileen compromises and says she'll pin whatever he tells her on a former member of New Zion.

Chris reveals that Gallahorn broke his jaw because he told his father he was an atheist. Chris also corroborates the physical violence rumors and claims that Gallahorn is a sadist. The pastor makes his congregation fast and quickly escalates to whipping and hitting them with paddles. Chris even shows Eileen his own scars.

Alice finds Roz and Sylvie in Meade and opens up about Gloria's experience with New Zion. Alice says that Gloria told Gallahorn she would expose his physical abuse on Facebook, and Alice has messages between her and Gloria to prove it. So Roz and Sylvie confront Gallahorn, and he shockingly agrees to submit his DNA.

Eileen laters writes an article titled "How Alaska's Broken DNA Collection System Betrayed Gloria Nanmac." As a result, Haynes reclassifies Gloria's death as a homicide and tests the DNA.

Conrad admits to selling the paper when Aaron presses him, so his son brings up Conrad's recent land purchases. As a result of direct threats to make these purchases public, Conrad sells the Daily Alaskan to Aaron. It looks like Aaron has a backbone, after all.

Unfortunately, Sylvie's health declines, and Eileen and Roz learn that the DNA testing matches Toby Crenshaw, not Gallahorn. The police are issuing an arrest warrant for Toby. And to end things on another sad note, Gabriel informs his colleagues that he's not returning to the Daily Alaskan.

Apparently, the system contained Toby's DNA because police arrested him for aggravated assault a few weeks after Eileen and Roz talked to him. At the arraignment, the judge reveals that the court is charging Toby with first-degree murder, sexual assault, and aggravated assault. Toby pleads not guilty, but the judge doesn't grant him bail since he earlier confessed to murdering Gloria. And during the arraignment, Eileen and Roz learn that the DNA found on Gloria's body that matched Toby was semen.

Later, Governor Thacker and Public Safety Commissioner Haynes hold a presser. They address their effort to combat the missing and murdered Indigenous women crisis and Gloria's murder. Thacker puts on quite a show, but Eileen and Roz press him about the untested DNA. The governor refuses to answer their questions and abruptly ends the press conference.

Afterward, Eileen and Roz write a story on the arrest and arraignment and get it to Stanley Cornik by their six o'clock deadline.

While Eileen and Roz continue to work on Gloria's case, Stanley focuses on Conrad Pritchard's recent (protected) land purchases. The managing editor assigns Claire Muncy and Austin Teague to the developing story.

Claire and Austin ride a helicopter over the land and discover semi trucks labeled "Katona Resources." After returning to Anchorage, Claire discovers that Katona specializes in "enhancing value through the mining of rare Earth materials," which basically means that they don't care about the environment. The team resorts to talking to Frank Moses, the senatorial candidate from Alaska Daily Episode 3, to get more dirt on Conrad.

As fans recall, Austin wrote an article exposing Moses' ties to a shady mining company, retroactively destroying his campaign. But Conrad, who endorsed Moses, abandoned him after the story. So Austin appeals to Moses' hatred of Conrad (and his love for Alaska), and Moses reveals the new senator (who Conrad is paying off) is sponsoring legislation to ease mining restrictions on federally protected land.

Stanley takes this information to Aaron, who is frustrated because he used the shady land purchases as leverage to get his father to sell him the paper. But regardless of the sticky situation, the Daily Alaskan publishes the story.

Environmental groups protest Conrad's mining plans the next day, and the senator backs off the legislation. Conrad confronts Aaron at his hotel, but Aaron stands his ground, and his father literally declares war on the paper.

Elsewhere, Gabriel struggles to work in the same place where he saw his abductor get shot and killed. Yuna Park helps Gabriel process his anger since she can relate to him through her experience with Jordan Teller. She takes him to an abandoned building, and they throw cement blocks off the roof.

After publishing their story, Eileen and Roz feel remorseful for portraying Toby as a guilty man before his trial. So they visit him in jail, where he claims that the sexual encounter between him and Gloria was consensual. Toby says that they were in a romantic relationship and loved each other. And, of course, the reporters are then confused as to why he confessed to murdering Gloria.

Toby reveals that two detectives coerced his confession — they wouldn't let him sleep until he signed it.

Back at the Daily Alaskan, Roz gets her hands on the affidavits for Toby's arrest. Dawn Howard is listed as the arresting trooper, but Commissioner Haynes is the one who signed it. Eileen and Roz confront Howard, who admits she disagrees with how Anchorage police interrogated Toby. So she didn't want her name on the affidavit.

Eileen and Roz then go to Toby's lawyer, who reveals that the police didn't video-record the confession. It's Alaska state law to get confessions on video, but Miller says there was "equipment failure." So the lawyer has no choice but to bargain with the prosecutor for a deal. He brings the charges down to second-degree murder. And in a hearing in two weeks, Toby will change his plea to guilty.

Eileen and Roz later publish a story on the coerced confession, but no one reads it. However, these two reporters are relentless and will stop at nothing to get the truth.

Eileen and Roz return to jail and ask Toby about the night Gloria went missing. He reveals that Gloria's frostbite was bothering her, so she went to Skeeter's for oxycodone. Toby didn't join her cause he thought Skeeter was "sketchy." The couple fought, and when Gloria called him later, Toby didn't answer. She left a voicemail, though, so Eileen and Roz go to Toby's Uncle Ned's house to retrieve his phone.

Gloria apologizes in the voicemail and says she's scared at Skeeter's place. She heartbreakingly pleads for Toby to pick her up, but the message ends before they learn why Gloria is so afraid. However, Eileen notes that the phone number from the voicemail isn't Gloria's. So Roz calls it, but it's out of service.

Eileen is in therapy and claims she hasn't experienced a panic attack recently. But for some reason or another, we don't believe her.

Afterward, Eileen joins Roz in visiting Toby in jail. They ask him about the strange number Gloria used to call him and leave a voicemail the night she disappeared. Toby reveals that it was from Gloria's second phone — the one she bought without her mother Sylvie's knowledge. Apparently, Sylvie didn't like Gloria talking to Toby, so she went behind her back

to have a relationship with him.

Eileen and Roz take Gloria's voicemail to Al's Dank Buds so that Al, an audiophile, can decipher the background voices. He uncovers a child saying, "Daddy, I want to go," and Roz believes it could be Ezra Fisher's kid, Jackson. Ezra, listed as a person of interest in Gloria's original case file, previously told the two women that he left Skeeter's party to pick up his son and never returned.

Roz goes to Ezra's ex-girlfriend Taylor's house and asks if she can question Jackson. But Taylor is still peeved about Roz exposing Adam Barnett, the prosecutor in her domestic violence case against Ezra, for exploiting his female clients. So she wants nothing to do with the reporter. However, Taylor does tell Roz where to find Ezra. Eileen recruits Austin Teague to track Ezra's recent jobs and Bob to obtain Gloria's phone records. Unfortunately, Bob cannot get them from his source at the phone company without a court order, but Eileen encourages him to keep pushing.

Bob takes a page from Eileen's book and ventures to his source's home to confront the man. He threatens to publish a story regarding customers' dissatisfaction with the phone company. It's harsh, but it gets the job done, and Bob gets Gloria's phone records.

In addition to doing a favor for Eileen, Austin deals with his own problems. Earlier that day, Austin had a custody mediation meeting with his ex-wife, Anna. As fans remember, Anna wants to move to Chicago, where her family lives, and take their son, Zack, with her. And if Austin and Anna cannot reach an agreement, a custody battle will ensue.

Anna tries to convince Austin to move with her and Zack to Chicago, but he wants to stay in Alaska. So it looks like they'll have to take their conflict to court.

But it isn't all bad news for Austin in "Truth Is a Slow Bullet." Yuna Park corners him in the archives room and supports him in the mess with his ex-wife. To be honest, we kind of forgot that Alaska Daily was trying to pull off a "will they/won't they" situation with Austin and Yuna. But we were quickly reminded when Austin called her support "hot," and Yuna pulled him in for a kiss.

Now, it's time to get back to reality. Roz seeks out Ezra at his job and questions him about the voicemail, but Ezra refuses to talk to her. So Roz returns to the Daily Alaskan, where she and Eileen call the village police officers of the towns where Ezra has worked. One named Sadie Quinn remembers Ezra because he assaulted his girlfriend, Julie, at the time, and the troopers charged him.

Eileen enlists Jamie, her poet pilot, to take her and Roz via plane to the small town where the assault occurred. But before taking off, Andy Ward of the New York Times reaches out to Eileen and offers her a job. She claims she is determined to finish what she started in Alaska, but Andy is persistent and gives her time to think the offer over.

Eileen and Roz meet with Julie, who explains that Ezra is a mean drunk. She says that Ezra beat her badly one night, and she "played dead to survive." When he eventually passed out, Julie sought out Sadie, who restrained Ezra and called the troopers. However, the District Attorney dropped the charges, and Julie never heard from Ezra again.

Eileen and Roz go to the courthouse where they handled Ezra's case. The worker there explains that the government passed a law a few years ago — Rule 40 — that prohibits courts from publishing domestic violence charges that were dropped in Alaska's database.

Austin calls around and uncovers two more dropped domestic violence charges against Ezra.

Roz returns to Taylor's house and fills her in on the recent discoveries, so Taylor agrees to let Roz talk to her son. Jackson reveals that Ezra took him to Skeeter's party but made him promise not to tell anyone. The 10-year-old also tells Roz that he remembers Gloria because his father had to drive her home after she got hurt and was "sleeping." Ezra left his son at the party, though, so he wasn't in the car with them.

Eileen and Roz take the new evidence to the District Attorney, but he dismisses them, confident that Toby is guilty. So the two reporters publish a story about how Rule 40 protects domestic abusers. And they discuss their new job opportunities (The Washington Post offered Roz a position). But the jury is still out on whether Eileen and Roz decide to stay at the Daily Alaskan.

Over the course of the episode, Gabriel Tovar and Roz's boyfriend, Jindaháa Twitchell, enlist a group to complete a missing and murdered Indigenous women database. The results are haunting and a very real depiction of what is happening to Native women in the real world.

And at the end of the hour, Bob hands over Gloria's phone records to Eileen and Roz. They reveal that Gloria called 911 two days after she disappeared.

After learning Gloria called 911, Eileen and Roz go to the dispatch center to listen to the recording.

In the call, Gloria begs for help and says she doesn't want to die. The recording cuts in and out, but she clearly says Ezra Fisher's name in the message. Unfortunately, the dispatchers couldn't locate where the call was coming from. And the lack of funds from the government meant that cops in Meade never heard it. But assumingly, Ezra left her to die in the frigid Alaskan climate. They've got their

man.

Although they don't have enough evidence to implicate Ezra, Eileen and Roz use what they know and write an article about the 911 call.

Back at the Daily Alaskan, Claire Muncy "kvells" over Austin Teague and Yuna Park's new relationship, and Bob Young is having a bad day. Austin later meets with a reporter from the Gazette, who recently got laid off. Apparently, the paper was sold, and then they axed half of their newsroom.

After finishing their article, Gabriel Tovar informs Eileen and Roz that he found a number for Clarence Redding, aka Skeeter, from Gloria's phone. They call it, and Skeeter's niece answers. She gives Roz his new contact information, including his current address.

Eileen and Roz go to Skeeter's house, and he confirms that Ezra and his son Jackson were at his party the night of Gloria's disappearance. When Eileen and Roz push him further, he runs back into his house. But Skeeter's girlfriend Nancy invites them inside when she finds out they wrote the article about the 911 recordings.

Nancy pushes Skeeter to tell Eileen and Roz the truth. And the reporters inform him that he can go to the District Attorney and ask for immunity in exchange for his testimony. So Skeeter reveals that Ezra left with Gloria, corroborating Jackson's story. Ezra didn't return for hours, and once he did, he had on a new change of clothes and asked Skeeter to burn his old ones.

Ezra said he would kill Skeeter if he told anyone. But Skeeter didn't burn Gloria's crutches (which were with Ezra's clothes). Police recover the crutches, and Eileen and Roz write another story on the new findings.

Eileen and Roz then meet with Toby Crenshaw and tell him that Ezra killed Gloria. Toby, who has been having a rough time in jail, is frustrated that this new evidence doesn't mean he can immediately go free. The District Attorney needs to take action and believe that the case against Ezra is winnable before dropping the charges against Toby. However, since Toby confessed, it's (unfortunately) easier for the DA to build a case against him.

Elsewhere, the manufacturer who prints the Daily Alaskan pushes their time slot from 9 p.m. to 7 p.m. An elusive new newspaper (with lots of cash) is taking up their slot. They are likely related to whoever bought the Gazette.

Bob contacts Frank Lester, the editor of the Gazette, and discovers that the new owners are rebranding and expanding the newspaper. Frank was a part of the layoffs, and Dennis Gibson from the Anchorage Eagle is replacing him. So Austin and Yuna venture to Dennis' house, but just as they arrive, he leaves. They follow him and watch Conrad Pritchard emerge from a flock of SUVs to greet Dennis.

Eileen and Roz's story lights a fire under Alaskans, and a protest appears outside the DA's office. So the DA holds a press conference and announces he is dropping the charges against Toby, and Ezra has been arrested. Governor Thacker adds that the Department of Public Safety will be investigated to ensure the system "works." As Eileen put it, Thacker's scapegoat is Commissioner Haynes.

On the drive back to the Daily Alaskan, Roz reveals she's turning down The Washington Post's offer. And before Eileen can reveal if she's accepting The New York Times's offer, she receives a message. Someone named Disillusioned writes, "You've shined a light in dark places, but you're not done yet. LRS192. Happy hunting."

LRS stands for Legislative Research Services. So Roz heads to the Legislative Building, but report 192 is missing. She and Eileen then meet with Commissioner Haynes, but as usual, she's closed off.

Thankfully, Haynes' assistant catches Eileen and Roz before they leave and reveals herself as Disillusioned. She believed that Haynes would do the right thing, but when she doesn't, Disillusioned discloses that report 192 contains solutions to solve the missing and murdered Indigenous women crisis. But the government ignored them. The assistant later quits, compelling Haynes to hand the report to Eileen outside the Daily Alaskan.

The solutions inside the report include healthcare access for Alaskan Natives, increased trained policing for rural communities, investments in a DNA database to track repeat offenders, and a functioning 911 system. Eileen and Roz write a story on report 192, exposing the truth of the government's response to the MMIW crisis.

Later, Sylvie visits the Daily Alaskan to express her gratitude, and the journalists celebrate at the bar across the street. The pilot poet is also there and openly flirts with Eileen, so they're officially a thing. And Eileen tells Roz that she's deciding to stay in Alaska.

Austin reads aloud a press release from Conrad stating that the Anchorage Eagle is coming in three months. But Aaron arrives and gives them all a (rather inspiring) pep talk. The episode ends where the show truly began — with a heart-to-heart between Eileen and Stanley. But this time, it's under the Northern Lights instead of the New York City fog.
