Summary: The MPU investigates the abduction of a young child, whose abduction

The episode starts with Jason in Kandahar, Istanbul. He and his partner are trying to help a girl sitting on a bomb. Jason assures her that she will be okay and refuses to leave her behind.

He tells the girl about his son Keith as he tries to keep her calm. He manages to get the girl off the bomb but something slips and the bomb starts ticking. Luckily, they are able to make it out before it explodes.

Later, the team of soldiers celebrate their successful mission and Jason's de-

parture from the team. While at the party, he receives a call from his wife, Nikki informing him that their son is missing. She tells him that the Missing Persons Unit (MPU)has verified that their son was abducted. Jason promises to get home and find their son himself.

We flash forward to six years later, in Philadelphia. Jason and Nikki are getting a divorce after being separated for three years. They are both in different relationships, Nikki is dating Mike, and Jason is dating a woman named June and they run a private security company together. Jason dropped by Nikki's house to drop off the divorce papers.

Nikki gets an alert about a missing child and says she has to go. Jason tells her that he doesn't understand how she can work for MPU when they never found their son. He points out that their son Keith would have been turning 17 in the coming week. He signs the divorce papers and apologizes that their marriage didn't survive losing a child.

At work, Mike updates Nikki about Chloe's abduction. The girl was kidnapped 32 minutes ago and every second counts. Kemi turns to her prayers to help and asks for guidance to work through the case. Mike is skeptical but Nikki is open to any help heavenly and earthly to find Chloe.

Nikki talks to Chloe's parents and they demand to see the video of Chloe's abduction. Nikki assures them they will do their best to get Chloe back. They get a call about a sighting of a girl

fitting Chloe's description at a hotel. They head to the hotel and find the kidnappers trying to flee with Chloe. Nikki does her best and stops them before they manage to escape. She saves Chloe.

Meanwhile, Jason visits a fertility clinic to find out why he and his girlfriend are having trouble getting pregnant. He gets a call from Sidney (his daughter with Nikki) and she informs him she is going to a friend's place. He receives a message and quickly leaves the clinic.

Back in the office, Mike proposes to Nikki and she says yes. Their lovey-dovey celebration is cut short by Jason who insists on showing Nikki new information about their missing son, Keith. He received a picture of Keith holding the day's newspaper. He believes their son is alive but Nikki is not sure the boy in the picture is their son. She is terrified it is another dead end.

She takes him to see C Hemmingway who specializes in doing facial recognition from human remains. She asks him to show them the age progression photos of Keith and Jason is certain that the boy is Keith. C thinks the photos are not a great match and it is inconclusive. Jason asks Kemi to find out where the recent photo of Keith was taken.

Nikki leaves to take Chloe home and leaves Jason at the office. Mike asks Jason to help with Chloe's case as the kidnapper is not talking. Jason notices that the kidnapper is wearing a ring with a terrorist sign. He interrupts the interrogation and the kidnapper tells him that although he failed his mission the kidnapping will succeed.

They realize Nikki is in danger and send her a message. Nikki sees the message while she is in the elevator with two other kidnappers. She manages to kill one but the other one kidnaps Chloe again.

They bring in Chloe's parents for interrogation and the mom accuses the husband of putting their daughter in harm's way because of his job. It turns out that the husband is a CIA and can't tell them classified information.

Jason follows up with the case and Nikki tells him that at the moment there is nothing they can do until the dad gives them a lead. They start talking about who was at fault when Keith went missing and agree it was no one's fault. Nikki brings up the fact that June and Jason are trying for a baby. Jason drops a bombshell that he has been faking his orgasms and he doesn't want to have another baby. Nikki asks him to tell June the truth.

She brings up Mike's idea to hire Jason to be part of the MPU. Kemi interrupts their conversation and tells them the photo of Keith was taken in a room in The Blue Paradise hotel in Vegas. They head to the hotel with SWAT but the room is clear. They only find a burner phone that rings and Jason picks it up. The caller demands one million for the release of Keith. Nikki thinks they are being played but Jason insists that they need to invest further into the case.

Finally, Chloe's dad discloses the case he worked on that might have led to his daughter's kidnapping. He gives them 50 names of people in a case that involved targeting terrorists in Libya and killing them using drone strikes. The team uses the list to find the next of kin who might want revenge. Nikki recognizes one of the terrorists from the photos Jason managed to get from his connections in his past job.

Jason comes up with a genius way to make the terrorist they arrested talk. He tells them that the plan was for Chloe to wear a bomb at the Måneskin concert. They immediately issue an evacuation order at the concert venue. They find Chloe backstage under the stage wearing a bomb.

Nikki and Jason remain with Chloe and Mike tries to find the terrorist leader, Saad. Jason calls an old pal to help him defuse the bomb. He assures Chloe she will be okay.

Mike finds Saad and he refuses to surrender, he shoots him before he detonates the bomb and Nikki luckily defuses it in time.

As they celebrate getting Chloe back, Jason gets a call from Keith. They drive off in a hurry and find him being treated by paramedics outside a convenience store. They are happy to be reunited again but his kidnapers are nowhere in sight. Keith wants to go home and they take him back. Sidney welcomes her brother home and they celebrate the miraculous return of their long-lost son.

Nikki calls Mike and is elated and thankful. She lets him know that Jason accepted the job offer. Mike was driving to her place and after seeing her dancing with Jason, he feels slightly jealous. Nikki asks him to visit another night, she didn't realize he was already outside, observing them through the window.

Summary: The team investigates when a woman runs down a man and forces

him to get in her car at gunpoint; more information about Keith's kid-

napper comes to light.



The episode starts with a woman waking up and getting ready for the day. She heads to a fast food joint, Burgerpotamus and waits for someone in her car. A young man comes out of the store and sits at the bus stop. The woman gets out of her car carrying a bat and proceeds to attack the young man.

Elsewhere, Jason and June visit Renwick who has a tip for them. He caught something while working, he found a backdoor in smart TVs. He hacked a smart TV and found a live feed of a young

man tied to a chair and being tortured by a woman. Sadly, Renwick doesn't know who the man is or the woman holding him captive.

Jason calls Nikki and sends her the video of the man being tortured. Nikki doesn't want to leave Keith alone but Jason insists it is a life and death matter. Nikki heads to the office and Kemi updates her that no one has reported the guy in the video missing.

The team watches the live feed and learns the woman is avenging her dead son. She believes the man she currently has captive sold fentanyl to her son who overdosed and died. She put five Adderall pills laced with fentanyl in a burger and forcefully feeds the young man. Jason calculates the dosage and gives the man 68 minutes before he suffocates from a fentanyl overdose.

C points out that the man in the feed has so much blood on his face, it is hard to identify him. Luckily, he developed an app during Covid-19 to identify people while wearing masks and believes he can use it to identify the guy.

As usual, Kemi lights a sandalwood incense as part of her prayer ritual for the people missing. C and Jason are not fans of the prayer session but Kemi is undeterred.

Mike walks in with news about Keith's alleged kidnapper. Nikki and Jason follow him to his office. He shows them the video from the convenience store that Keith ran to after escaping his kidnappers. Jason asks why they are not canvassing the area and we were wondering the same thing!

According to Keith, he was being chased by someone down the street. Mike asks for authorization and permission to speak to Keith. Nikki thinks asking him about his kidnappers is dragging him back from normal life. Is she serious right now?

Jason agrees that Keith needs a normal life but they need to find his kidnappers. Nikki agrees to let Mike talk to Keith. They bring Keith in and Mike tries talking to him about his kidnappers. Keith distracts from the questions asked and brings up his parent's divorce and his sister's hostility towards him. He refuses to answer Mike's question and Nikki barges in to comfort him.

She calls Sidney to pick up Keith and Sidney notices Keith is using his right hand to write. Keith was left-handed before he was kidnapped. She takes a photo and later shows it to her mom. Nikki worries that Sidney is not reacting well to Keith's return and wonders if they are missing something. Jason argues that Sidney is a teenage girl and she is self-obsessed, it will pass.

They get back to the case of the young man and Kemi found a lead from the woman's glasses. The woman is named Molly and they immediately head over to her registered address but she is not there and neither is the young man. They are back to square one and time is running out.

Meanwhile, Molly insists that the man is a drug peddler and demands the name of the drug supplier but the man knows nothing. She refuses to give him an antidote until he confesses and gives her a name.

On the other hand, C has a dilemma after his dad's caretaker drops his sick dad at the office and claims she has an emergency. He is not the only one having family issues, June confronts Jason about cancelling his fertility clinic appointment. Jason confesses that he fakes his orgasm and is not ready to have a kid. He apologizes but June is angry and hurt. I don't blame her, that was a whole level of wrong!

The team visits C in his office and he tells them that he identified the man being held captive by Molly. His name is Hugo Mendez. C is having a hard time with his dad's sickness and is frustrated when Kemi lights sandalwood in his office. Fortunately, the smell makes his dad conscious and C is happy his dad was alert even for a brief moment. He later thanks Kemi and apologizes for being curt with her earlier.

The team issues an alert for Hugo and brings in his brother to interview him about the connection between Molly and Hugo. The brother insists that Hugo doesn't do or sell drugs. He does honest work and, he is an upright citizen.

Nikki and Jason visit Hugo's works place, the burger joint and ask to take a look around. One of the workers acts suspiciously and tries to leave the premises. Nikki arrests him and takes him downtown. They realize Hugo is innocent and further investigation leads them to the house Hugo is being held captive.

With time running out, they rush to save Hugo and Jason tells Nikki that he understands why the woman wants vengeance. He wants to kill Keith's kidnappers too, Nikki cautions him that it will only make matters worse. Jason feels even angrier after seeing Keith's test results from the hospital. It seems Keith suffered a lot of injuries while in captivity.

They get to Molly and she has a gun pointed at Hugo and refuses to believe he is innocent. Jason reasons with her and insists that Hugo is innocent and gets through to her. Jason gives Hugo the antidote and they rush him to the hospital.

Mike calls them after they rescued Hugo and tells them he has a lead on Keith's kidnappers. He shows them a video taken at the convenience store. A vehicle pulled up one minute after Keith entered the store. Mike realizes that the car idled in the parking lot and took off as soon as the police showed up. Jason calls June to ask for a favour to be able to quickly trace the owner of the car.

Even though June is angry, she agrees to help but she packs her things from their house and leaves him. Jason and Nikki track the car's movement and find its last known location. They drive to the location and Nikki asks Jason to stay in the car. She doesn't want him to lose control and take justice into his hands.

Of course, Jason doesn't remain in the car. He goes around breaking into the rooms at the inn but the kidnapper is long gone. Nikki asks Jason to be patient and assures him justice for Keith will come. She also asks Mike to be patient with her situation with Jason, especially now that Keith is back.

We later see a woman reading an article in the newspaper about Keith's miraculous return.

At home, Sidney insists that Keith is not who he says he is. Nikki tells her that Keith went through a lot of abuse that forced him to change. Keith apologizes for not being able to talk about

what he went through and Nikki says it is okay.

The episode ends with Sidney texting someone about her frustrations that Keith back. In the text, she says, "It can't be him because we know what happened to him!"

The team immediately starts looking for the motive behind the kidnapping. They decide to find out this; they need to find out more about each passenger on the bus, but it will take too long to get authorisation from the Transit Authority. In turn, Mike asks Jason to use a different method to get the list of passengers.

Jason threatens an officer from the Transit Authority to get his log ins. Unfortunately, the man in question used cash instead of transit key cards. The team realises they can't track the bus or the passengers since their phones are off, and Nikki issues an amber alert.

A deeper look into all passengers gives them nothing, and they wonder when the ransom demand will come through.

Nikki interviews Andrew and gets a vague description of the perpetrator. Andrew regrets getting kicked out of the bus and is scared of losing Kayla. He just lost his wife to cancer and can't afford to lose his daughter, too.

As they continue to work on the case, the bus is reportedly sighted, and the team rushes to the scene. In the meantime, Hollis and Nikki try to reach the families of the people on the bus. Nikki sets up a room to keep them around. She then talks to a student who skipped the school trip to find out more about the victims. The kid tells her about the fake Instagram handles most kids use to fool their parents.

Kemi finds Kayla's fake Instagram account and finds one of the selfies Kayla took that morning. However, the perpetrator is not captured in the photos. She argues they need to find a live feed from the camera when the images were taken to see if they can find a new clue. This is when Nikki asks Jason to contact one of his guys.

Jason pays Wayne, an old friend from Afghanistan, to help. Wayne turns out to be a woman, and she is angry at Jason for not being there when she needed him. He was supposed to testify in a hacking case on her behalf, but he never showed up.

Now, Wayne is under house arrest and can't access the internet. She is losing her mind and jumps at the offer when Jason explains she can help with the case. Nikki is surprised when Wayne arrives at the office, and she is a woman. She questions why Jason left out this information, and he explains that Wayne helped him a lot when he first learned their son was missing.

Meanwhile, Hollis informs the team that City Hall has received a ransom demand. The perpetrators want the police to release John Maritz. Maritz is a fixer for the rich, and he pissed some influential people off. He is currently serving his 16-year sentence for wire-tapping and racketeering. The perpetrators want him released in the next four hours, or they start killing passengers.

Nikki and Hollis update the families and assure them they are doing everything possible. The families are scared after hearing about the ransom. To calm the families down, Nikki explains her situation with Keith.

In the meantime, Nikki keeps hitting bureaucratic walls from all sides as she tries to solve the case. Finally, C comes through and identifies the kidnapper, Baz Marsh. He was convicted of murder before, but it is unlikely he planned this elaborate scheme.

Jason and Mike visit Marsh's last known address and discover he leased a commercial property. The evidence in Marsh's house suggests he was paid to target the bus during the school field trip. They also find a phone recording them. The scene cuts to someone ordering someone to visit their friend and then destroying the burner phone he used.

The episode starts with our person of interest, Benjamin Franklin, who works for the Walking History Colonial Tour Company, giving a market tour and leading the tourists to a dessert shop. Someone among the tourists claims that he knows Benjamin from Kansas City, which spooks him.

He distracts the man's grandson with a key and takes the chance when the grandfather is not looking to escape. Meanwhile, the MPU unit detectives are getting to work, and Kemi offers to help

Nikki run a background check on Wayne, which she turns down.

A new member, Helen, a forensic scientist, has been added to their team, and Nikki thinks her superior might send her to spy on them. Elsewhere, Jay and Mike bicker about working together as partners when Kemi asks them to get to work first since they have a strange situation.

Two tour personnel, colleagues of Benjamin, are in Nikki's office reporting Benjamin's disappearance. They are convinced that something might have happened to Benjamin since he is a professional who never breaks character, so he could not have left during his shift. Mike and Jay arrive and run into the performers on their way out when Helen gives them their presents.

Kemi updates them on the new case, and after getting his information from the tour company, they realise that he is using another pseudonym, which makes it hard to find him.

As Jay wonders how much trouble an old man can get into, Benjamin drives into an isolated house and removes the makeup on his face and the clothes, becoming a different person. He pulls out a gun and a photo from a box, sets the house on fire, and leaves.

Meanwhile, Kemi realises that Helen's personality clashes with many of her colleagues and superiors, so she has been transferred a lot. Regardless, she starts to prove beneficial to the missing persons unit when she finds them a lead to Benjamin's residence, which he burnt down.

Jay and Mike head to the location and find photos of a woman in a box. They also take back samples from the body suits half burnt on the floor, and Helen cracks the case by finding out the missing Benjamin's name is Owen Malloy. He is an old enforcer for the Irish mob accused of killing his former boss before running into hiding.

Meanwhile, Owen confronts the man who had recognised him at the market at gunpoint, wanting to find out who he told about him. However, the MPU issues a nationwide missing person alert, and Owen has to escape before anyone recognises him.

The MPU started to receive updates on his sightings around where he confronted the man. Nikki sends Jay and Mike to investigate, and even though they do not find him in the mentioned car, they notice a mob bar within the vicinity and decide to ask around.

The bartender is not forthcoming with information, and Jay jumps on the table, getting everyone's attention, and asks if anyone knows about the mugging reported outside. Although no one speaks out, he checks out the person involved, and they ask him about Malloy and learn that he is believed to have killed their former boss.

When Mike and Jay return to the office, Charlie, the Irish mob boss, is in Nikki's office. Apparently, the two have a history. They worked together in the past, as Charlie helped Nikki close many of her mob cases, eventually leading to her promotion. Therefore, Charlie wants her to return the favour and look the other way as the mob deals with Malloy, but Nikki does not intend to do that, even after Charlie threatens her.

Through intuition, Jay makes a breakthrough in the case as he wonders why Malloy chose to stick around instead of leaving the country to escape the mob. He figures that there must be someone more important to him around that he needs to keep an eye on and keep her safe. Therefore, he puts two and two together and finds Malloy's daughter, Ava. Nikki orders them to see Ava since they have to get him off the streets before Charlie and his men find and use her to get to Malloy.

Nikki talks to Ava, but she neither believes that her father is alive nor agrees to stay in the station to keep her safe. She heads to the market to open the stall, and Malloy approaches her. She immediately recognises him as Benji, and after he shows her a photo of him, her mother, and her as a baby, she believes he is her father.

However, their conversation is cut short when Ava notices men approaching, and she screams to her father to run. Malloy manages to run a couple of blocks before he is cut off and shoved into a van.

Ava heads back to the Missing Persons Unit and helps the team locate the direction in which the mob took her father by tracking the only number saved on the phone he gave her. However, they lose the phone's signal, and the area is too large to search everywhere, which will be too late. Nikki holds that the team has one hour to bring back Malloy since the men who have him will not kill him before they get the order from Charlie.

The MPU team gets busy, and they find out that Malloy was taken into a cabin in the Poconos area after Jay and Mike mention the cabin they saw in the bar. However, it is difficult to narrow down the search area until Helen, who had previously gotten onto Kemi's bad side when she sent him materials implying that she is crazy, helps them narrow down the location, and the team races against time to find Malloy.

Meanwhile, Malloy gets beat up by Charlie's men, but he holds that he did not kill their former boss. The men get impatient since they have not received Charlie's kill order, and as they prepare to act, the MPU shows up just in time.

The Irish mob and the MPU exchange fire, but they finally arrest Malloy and kill all of Charlie's men. Charlie calls after he is released from holding, but it is too late, so Jay answers it. Jay and Mike take Malloy to the station and give him a moment with his daughter.

Kemi and Helen make up when Kemi brings her a gift, and they talk about her mother's bipolar, which makes her get into science to try and understand her mother's condition. However, the person abducting her takes her away before they can help.

The team gets a lead on the biological father, Marvin, but he has an alibi. Nikki thinks they might be back to square one, but Kemi believes they might have a workaround for figuring out who Gemma texted when Jason walks in with Wayne.

Although she is wary of Wayne assisting because Braun is on her because Jason is asking for the homicide file, Wayne promises not to do anything overboard, and she agrees. Wayne easily gets into Gemma's phone and finds out that Gemma received money from the adoptive father, David.

Mike and Jason return to the boxing ring and flush out the real baby daddy, Dante. After Jason instigates him, he ends up accidentally punching Mike, which is a federal offence, and they use that to get him to talk. However, he insists that he did not know that Gemma was pregnant, but he figured it out after he saw the alert. Dante insists that he did not take Gemma and that the detectives did not find anything incriminating after they searched his house.

Summary: The MPU searches for a homeless female teen that disappeared after

running away from home and living in Philly's Gayborhood. Kemi is hit especially hard as the team races to find and rescue the missing teen. Jason and Nikki spar over his continued investigation into the

car bombing.



The episode starts at a bar, and the crowd cheers for a performer. Outside, two girls head towards the bar's back door, talking about getting food from Canary, saying she always has food for them. The performer opens the door and hands the two girls some food, and they bid each other goodbye. One of the girls, Maya, is abducted soon after she and her friend go their separate ways.

Two days later, Mike and Nikki volunteer at a local school where Mike teaches the kids basketball, and Maya's friend ap-

proaches them. She tells them about her disappearance, and the team starts looking into it by sending Jason and Mike to find Canary, who gives them Maya's backpack, which he found on the road on his way home on the night of her disappearance. Nikki and Kemi find photos of some girls inside the bag who might help them learn more about Maya.

Meanwhile, Jason tells Nikki about the car bombing, saying he looked into it despite her warnings and that the file was whitelisted. Jason suspects that Braun is connected to the case, and as they argue about the basis of the accusations, Mike walks into the room and reports that Braun wants to have lunch with him.

Consequently, Kemi identifies the girls in the photo and discovers that Maya is registered in the camp database under a different name, Hannah Marie Sutter, from New Jersey. Nikki orders Kemi to issue the missing person's alert. Elsewhere, Maya wakes up in a locked room in an unknown place, chained to a bed and with a CCTV camera pointed at her. She is scared and starts hyperventilating, yelling for someone to get her out of the room.

Maya's parents show up at the missing persons unit, and Kemi gets into an altercation with Kemi during questioning. Maya ran away from home, but the parents did not report it, saying that

she had run away two times earlier and they just let her be waiting for her to come back home whenever she was done acting out. Kemi gets angry at their indifference and lack of concern about Maya's welfare, while the parents defend themselves by saying that Maya is a problematic child. It seems that Kemi went through a similar situation with her parents, so she gets angry at their indifference and lousy parenting.

The team gets feedback from a social worker working in a shelter for teenage homeless people who says that Maya had come to the shelter, but they did not have a bed for her. Mike is concerned that some teenagers spend nights on the streets when the shelters run out of beds, and the social worker shares the same concern.

Jason notices a boy with drugs in the shelter and approaches him. He talks about the person who sells them drugs, and they realise that the pickup point is a few blocks away from where Maya disappeared. Meanwhile, Maya discovers that more people have stayed in the same room, meaning that her kidnapper has abducted other people before.

On the way to meet up with Skit, Jason suggests that Mike change his clothes so he does not appear obvious, but regardless, Skit knows that they are police officers. Skit attempts to run away when they ask about Maya, but a citizen trips her, helping Mike and Jason make the arrest.

At first, Skit is not forthcoming during questioning, but threatening to charge her with possession gets her talking. She says that Maya came to her occasionally, and the last time she saw her, she did not have money. Skit refused to sell her without cash but insisted that she had something coming up that would get her some good money. She promised to get back to Skit when the deal came through but never showed up.

Kemi tracks Maya's girlfriend Caitlyn, and she says that she met Maya for the first time at a soccer camp, and being with her felt right. However, she was not ready to be someone different from her family, so she did not come out to her parents like Maya. However, a couple of days ago, Maya arrived at her house asking to stay with her, but Caitlyn told her to leave. Then, a few days later, she found a note in her locker saying Maya would remain within the city and she would not go without Caitlyn.

The note Maya slips into Caitlyn's locker leads the detectives to her workplace, which is a gay bar. The owner knows Maya and says he gave her odd tasks in the bar, like taking out the trash and doing the dishes so she can make some money. He remembers seeing her a few days ago, and she seemed motivated. The bar owner also mentions that many street kids vanish in that area and is glad someone is finally looking into their disappearances. Meanwhile, Maya tries to free herself by using her earrings to unscrew the bed.

Following the hunch from the bar owner, Kemi looks into the cases of missing kids, many of whom are all over the state. She narrows the search by finding out the ones reported missing outside the state, and Jason brings in Canary to help identify the ones that disappeared close to home. Canary is quite helpful since she is good with names and faces and gives them a background of where these kids used to work before their disappearances.

Someone gives Maya a makeup set at the mysterious location, asking her to make herself pretty for the camera. Maya tries to plead for the person to let her go, and she will not talk to the police, but he only orders her to clean up and get some rest since bidding will start in a few hours.

Kemi finds out something interesting about the bar owner. All the businesses that Canary mentioned that offered the homeless children some work belonged to the same bar owner, and a few years ago, he was arrested for a sexual offense involving a minor. Mike and Jason head back to the bar, but after questioning David, they find out that he is not at fault, and the sexual offender charge was made by his boyfriend's parents, who were homophobic when he was 18 and the boyfriend was 17.

Jason figures out that something is fishy about a bartender they had talked to earlier at the bar. He mentioned that he had never missed a day of work, but David told them he had called in sick. Kemi looks into the bartender, and he looks clean, but looking into his utility bill, Kemi notices that he has several optical fibre connections going into his house, meaning he needs data for uploads and downloads. Wayne gives Kemi a toolkit to help her search through the dark web for the bartender's IP address, and she finds out that he is online trying to sell Maya to the highest bidder.

Richard, the bartender, notices the police IP address, but before he can investigate, everything

shuts down. Therefore, he heads down to the basement, planning to get rid of Maya and protect his business, but she has unscrewed the bed. She uses the bed frame to attack Richard, takes the key, and sets herself free. However, Richard is on his feed before she can make it out the door, and they fight. Fortunately, Mike, Jason, and the SWAT team arrive at the house and hear Maya's screams. Mike and Jason breach the door and shoot Richard to stop him from hurting Maya.

The detectives take Maya back to the MPU, and Nikki asks Kemi to stay with her while they wait for her parents to pick her up. Maya opens up about her living situation with her parents, saying that whenever she leaves home and has to stay on the streets, regardless of the hardships, she never feels as alone as she does with her parents. Kemi shares her story and says that when she was taken from home, it was not her parents who came to her rescue but the police. She tells Maya that she does not have to feel alone and asks that she call her anytime she wants to talk. Maya is overwhelmed since no one has ever looked out for her before, and no one has ever missed her. Kemi gives Caitlyn's message and asks her to start working on herself, take her medications, see a therapist, and become a better person, and then she will be ready to face the world in a few years and find her place.

At the end of the episode, Mike talks to Nikki about Jason, asking if he is up to something that would make Braun concerned, but Nikki lies, saying she is unaware. Later that night, she and Jason sneakily meet up, and she hands him the homicide police report indicating that someone confessed to the car bombing and the case is closed. However, it seems like Jason is not willing to let it go.

Nikki finds out that Ms. Patty had filed multiple complaints about another neighbour who owned an auto repair shop and sends Mike and Jason to check it out. They run into Harold

paying the owner, Julian Meeks, and they are initially suspicious but find out that Harold is trying to play the hero by casing the joint.

After convincing Harold to leave, Jason breaks the car's side mirror, and they take it to Meek's shop for a repair. While Jason talks to Meek, Mike snoops around the place, which spooks him and his partner since they are running an illegal export of auto parts. They attack Jason and Mike and try to escape but are soon apprehended.

Jason notices that Mike and Nikki are not on good terms, but Nikki refuses to tell him what is happening between them. Jason tells Nikki that he is convinced that Braun is playing her and that he is hiding something. He convinces Nikki to allow him to look into the incident, and she agrees at the end of the episode, warning Jason to ensure she does not regret trusting him.



Their motivation dips even further when their coach's boat suddenly stops due to a failed motor. They are told to row forward and meet at the dock, but they never arrive. In the middle of the river, their boat hits something,

following which one of the girls falls into the water, and all five of them disappear.

When the girls don't arrive at the dock, the coach immediately reports it to the cops, and the case comes directly to the MPU. Jason and Mike are immediately on the scene. They are told that perhaps the boat hit a stone, but Jason calls it an unlikely possibility in thirty feet of water. He notes that something was placed under the water by someone to upturn the boat, which means that this was no accident and someone kidnapped the girls. Sure enough, we later see a shot of the girls being herded through a forest into a secluded cabin. When one of them tries to run, she is shot, and her bloodied shirt is later found in the water.

The first people to be suspected of this foul play is the rival team, but it soon becomes clear that they wouldn't do anything criminal to win the race. So, the team starts looking into the girls and their history. For the rowers, things seem pretty straightforward. But the cox, Bella, is the odd one out. A quick investigation into her reveals that she had a regular visitor who would show up at her dorm room every Sunday. Other girls believe that she sees a much older man who is also paying for her tuition and other stuff. After going through the CCTV footage from the college, it turns out that the said sugar daddy is someone that Nikki knows.

The CCTV footage shows Charlie McGannon, the Irish mob boss, who visits Bella every Sunday. Nikki decides to talk with him directly, and he reveals that he is being blackmailed. The

kidnappers have already reached out to him for ransom and have asked that the money be transferred through Bitcoin in a way that will make it untraceable. Having worked with Charlie for about two decades, she had hoped that he would value her loyalty and take care of her like she took care of him. But right when she needed him the most, he refused to help her. So, she decides to hit him where it hurts and has Bella, along with the rest of the team, kidnapped. This fact is also supported by Wayne, who finds a way to track the Bitcoin, which Charlie has already transferred to her.

While the MPU knows that Caz and Renee are behind the kidnapping, they need to figure out where the girls are being held because Charlie has already paid the ransom. This leaves no reason for the kidnappers to keep the girls alive, which means the MPU doesn't have much time to solve the case. Fortunately, the girls come to the rescue. When their boat was sabotaged, and they were kidnapped, Bella threw the tracker into the water. Later, it is found by the cops, and through the timing recorded in the tracker, they are able to narrow down the range within which the girls might be held currently.

Because Renee works for Charlie, it makes sense that she would be aware of his hideouts and might use one of them. This turns out to be true as Charlie recognizes a location within the range. Flashbacks reveal that Charlie had her killed and buried in a deep grave. At the same time, he also had Caz and his accomplices killed in prison while they were awaiting trial for the kidnapping. He has had his revenge by killing each and every kidnapper, and both Jason and Mike are aware of this but can't prove it. So, they leave him with the warning to stay away from Nikki, as people close to him seem to get hurt pretty often. He agrees to it, but there's a good chance we have seen the last of him.

Her target turns out to be Nikki Batista. Raina tracks down Nikki, hides in her car, sedates her, burns her car at the edge of the town, and then drives away in an-

other car with Nikki in the trunk. A few hours later, Chief Inspector Houston shows up at the officer and asks about Nikki.

The sudden mention of her being in danger sets off all alarms, especially as everyone notices that Nikki is unusually late.

Looking into the suspect's history, it is revealed that Raina had a girlfriend who is also out on parole. They believe that the women might have planned this together, so the team tracks down the girlfriend's address. Sure enough, Raina is found there, but Nikki is nowhere to be seen. Before this, Raina was almost caught with Nikki in her trunk when she was stopped by a cop who noticed her broken taillight. It turned out that Nikki was the one who broke it to catch someone's attention and get help. While Raina shot the cop (though not fatally) and ran away, Nikki managed to drop a clue that would throw more light on her situation.

With Raina in custody, Jason and Mike interrogate her to find out where she kept Nikki. They know that she probably didn't kill her because if she wanted to, she would have done it in the car

itself and not taken the trouble to kidnap her and ride around the town with the risk of getting caught. While Mike finds himself spiraling as he worries about his wife's safety, Jason comes up with a plan to make Raina spill all the beans. When she refuses to budge from her position, Jason tells her all the parole violations that her girlfriend has committed and how she will be sent to the darkest prison cells if Raina doesn't tell them about Nikki.

Scared for the safety of the woman she loves, Raina confesses that she did kidnap Nikki, but it wasn't for herself. Some time ago, a lawyer reached out to her and told her that he would get her out on parole and also give her half a million dollars and a clean passport for her and her girlfriend so they could permanently leave the country. In return, she had to do a job for his employer. She had to kidnap Nikki, and she did it gladly to get her revenge on the cop. While she claims she didn't know who hired her, she does give Jason a clue. When she met with the man who was supposed to give Nikki to her, and he paid her, she noticed a tattoo on his wrist, which looked like a Celtic knot. Jason immediately recognizes it as Charles McGannon.

In the last episode, after Nikki and her team found McGannon's daughter, Jason and Mike warned him to stay away from her. However, a federal agency that had been looking into McGannon approached Nikki and wanted her help putting him away for good. Having been in contact with the mobster for so long, she had been stashing evidence that would work as insurance in case something went wrong. The episode focuses on the disappearance of a young man named Lei, who enjoys a reputation as one of the best emerging artists in the city. One morning, his mother comes to the MPU to report him missing. On any other day, she wouldn't have fretted so much, but on this day, her son had to be there. Lei was supposed to show up at the hospital to donate bone marrow for his brother, who urgently requires a transplant to save his life. He wouldn't have missed this day for anything, which is why when he doesn't

show up at the hospital, his mother becomes convinced that something has happened to him. As the team starts looking into the case, they are also made aware of the fact that Lei's disappearance doesn't just impact his chances of survival but also his brother, who will die if he does not receive surgery as soon as possible.

Soon enough, several suspects come to light. After talking with Lei's brother, Kemi discovers that they had resorted to an alternative form of medicine in the hopes that he would be cured. They went to a doctor called Dennis McComb, who runs a clinic called Happy Healthy Homeopathy. Lei's family gave him eight thousand dollars in return for the assurance that his medicine could cure the patient for good and save his life. However, his methods did not work, and Lei's brother had to go back to conventional medicine. Because he is too weak to receive chemo or radiotherapy, the surgery is the only option to save him. He would have received it earlier, but with eight thousand dollars already spent, the family didn't have enough money left to pay for his surgery.

On the day that he disappeared, Lei was on a quest to get the money for his brother's surgery to save him. Jason and Mike discover that Lei showed up at McComb's clinic that day, and they had a fight. But he stormed out of the place, and it is caught on CCTV, which proves that he was still alive when McComb saw him last. Still, this is not enough to clear the suspicion of the doctor. Meanwhile, a new suspect emerges in the form of another artist who calls himself Spider.

It turns out that Lei had been arrested on the day he was last seen by anyone, and Spider is the one who posted his bail. He also pays Lei the money he needs, but in return, he wants the young man to paint a mural.

Despite being a rival, Spider liked Lei's work, which is why he offered to pay him a decent amount. In return, he turned the guy towards a location with specific instructions about the mural. When Jason and Mike reach the place, they discover that the mural is actually the defacing of a poster featuring McComb. This gives the doctor a strong motive to want to harm Lei. Jason's quick thinking also presents the opportunity. It turns out that the mural is visible from McComb's place, which means he could have easily come to the rooftop where the poster is and attacked Lei. When confronted with these details, he confesses that he did, in fact, find Lei defacing his poster and threatening him. But before he could do anything, Lei ran away, and that was the last he saw of him.

The doctor's confession puts a lot of things in perspective. From here, the MPU turns its focus on finding the place where Lei may have gotten trapped. According to McComb's account, he jumped from one rooftop to another. This leads the investigators to believe that he may have fallen somewhere. In the beginning, they focus on the open areas, but then Kemi discovers an abandoned building right in Lei's path. She theorizes that the unsound nature of the building may have led the roof to collapse when Lei jumped on it. She is proven right when Jason and Mike reach the location and find Lei trapped under the rubble of the collapsed roof. They try to get him out of the debris but have to halt their effort when Jason reveals that removing the whole thing in one go might trigger crush syndrome, leading Lei to die as soon as he is taken out of the rubble.

Meanwhile, the condition of Lei's brother worsens, and the doctors become desperate to take him into surgery, but they cannot do it until Lei is there to donate the bone marrow. The problem is that the donor himself is on his deathbed. Eventually, Mike makes the call to start removing the rubble, slowly to keep him alive but also enough to keep him from dying. Their efforts work, and a few precious minutes later, the paramedics show up. They patch up Lei and take him to the hospital, where his family is waiting. With his return, his brother's survival is also almost guaranteed. He recuperates from his wounds while the doctors prepare to take his brother into surgery that will save his life. This way, the MPU manages to save both brothers and can rest easy.

Nikki Batista's death hits everyone pretty hard, but it is particularly earth-shattering for her husband, with whom she got married only a few months ago. Their marital bliss was still in its early days when she fell victim to Charles McGannon's evil plans. Jason takes some time off from work to spend it with his and Nikki's daughter, Sidney. He later reveals that she has decided to take a semester break to process her feelings while also figuring out what she truly wants. Jason encourages her to take all the time she needs, and he extends the same advice to Mike, especially after he sees how much the man is struggling.

While Mike refuses to accept it, everyone can see that he is coming apart at the seams. It is clear that he is not sleeping properly, and his headaches make it clear that his unprocessed grief is starting to take a physical toll on him. The fact that he returned to work a mere three days after his wife's death shows that he is trying to bury his feelings rather than facing his head first, which is the only way forward. By suppressing his grief, he is priming himself for further physical and mental issues. His friends and colleagues can see that he is suffering, but they don't know how to help him. The only way he can seem to keep himself together is by focusing on the cases and saving lives, and for now, that will have to do.

The episode opens with an army officer, Sophie Kirby, driving her friend and fellow officer, Nina Lane. In the middle of their joinery, they are rear-ended by a truck, and as soon as Nina comes to, she calls 911, and the paramedics swift in appearance, almost too swift. Two paramedics jump out of the ambulance, carry the still unconscious Sophie to the vehicle, and drive away, leaving an injured Nina to her own devices. She is shocked to be left behind like this, but moments later, another ambulance ar-

rives, which is when Nina realizes that the first one was a fake and her friend has been kidnapped.

When the case is brought to the MPU, Chief Inspector Houston himself takes the lead. It turns out that Houston's concerns about the case are personal, as he personally knows Sophie Kirby and her husband, Adam. He puts Mike as the lead on the case. With Sophie being an army personnel, the military is also involved, but Houston makes it clear that the MPU is in charge as they have a much bigger chance of getting the job done swiftly and efficiently. Adam is brought to the office, where Houston tells him about the kidnapping face-to-face. The man, who is also an army officer, reveals that he left active duty when he lost his leg during a mission.

Since then, he has been desk-bound and works in the arms and munitions department. When he discovers what happened to his wife, he decides to find her himself but is restrained by Houston, who assures him that the case is in good hands. He also tells the Inspector that the kidnapping could be the work of a Major West, against whom Sophie had filed sexual harassment charges. When Mike and Jason find Major West and talk to him, he confirms himself to be the insufferable man Adam described him to be. While the Major refuses to be amicable, he does tell the MPU officers that Adam and Sophie have been having marriage troubles and that the neighbors had heard the couple fighting for several days before her kidnapping. He suggests they start looking closer to home.

Meanwhile, the fake ambulance carrying Sophie is abandoned. The two perpetrators burn it and carry her away in a black van. They talk about the Major, who needs to be notified of the

situation, especially the fact that the cops are already onto them. Later, we see Adam sending texts to a person called the Major, in which he tells them that he has gotten rid of the cops. Around the time that Mike and Jason find out about Adam and Sophie's marriage troubles, Helen tests the burned ambulance in which Sophie was kidnapped. She discovers a shell case, which turns out to be from the armory of the munitions center where Adam works.

This casts a stronger suspicion on him, and the team immediately starts questioning him. Adam reveals that since his injury, he has been struggling mentally and physically. This extended to become a financial burden when he found out how expensive his prosthetic leg was going to be. To get the money, he made a deal with a biker gang. They would take care of his financial problems, and he would get them guns from the munitions center. This would be an illegal trade, and Adam knew the consequences it could bring him, but he had no other choice. So, he decided to go through with it. After some time, he got tired of working for the gang, which is when they threatened Sophie, and now they have kidnapped him.

He also reveals that he pointed toward Major West so that the MPU would be occupied with him, and in the meantime, he could find a way to settle things on his own. What he doesn't know is that behind his back, the gang has decided to kill him and Sophie, who tries to make a run for it but fails. Meanwhile, Houston offers Mike a promotion. This means that he would be leading his team and getting a bigger office, among other perks. A while back, Mike would have jumped at this opportunity, but now, he politely declines the offer because getting a bigger office means getting drowned in paperwork, leaving it on the team to handle the dangers on the ground.

Now that it's clear who the kidnappers are and what they want, the MPU comes up with an elaborate plan to save Sophie. The question of raiding the gang's compound guns blazing is out of the question because they have enough munitions to sustain an army. Moreover, a quick look into its leader, Thomas Skinner, and other members reveals that almost all of them are ex-military, which means that they will be prepared. To avoid this gunfight, Jason offers a plan to make a fake sale. With his experience in the private military, he can assist Adam under the guise of giving the guns to the gang. Once Sophie is safely in their custody, they will go forward with the operation and attack the gang to arrest their leader and neutralize them for good. But certain things need to be taken care of.

To begin with, they cannot take fake guns. The ammunitions have to be real; otherwise, they will be caught too early and put Sophie and their own lives in danger. To get real guns, they have to have a senior officer approve it, so they ask Major West to do the job for them. He is unempathetic to their cause in the beginning, but then Inspector Houston offers to talk to West's superior on his behalf and get the sexual harassment charges done away with. Meanwhile, Adam and Jason try to get the guns out but are stopped at the checkpoint because the officer is suspicious of them. She refuses to let them go but has to agree when West makes the call just in time. Once his part in the plan is done, West expects Houston to hold up his end. Instead, the Inspector sends him to a prison cell and promises to talk to his superior and give his honest thoughts about how despicable West is.

Jason and Adam arrive at the gang's compound with guns, where Skinner becomes suspicious of Jason and questions him to make sure that he is actually a private military contractor and not an undercover cop. Once he has the guns and has made sure they are real, he points them at Jason and Adam, threatening to kill them, including Sophie. enough to discuss anything between them, which is why he became concerned about her keeping secrets from him. Meanwhile, Mike gives her the space she needs and focuses on tracking down Violet. Soon after her escape from the psychiatric facility, Violet robs a convenience store by setting a fire in it and running away with the cash after pulling a gun on the owner. The news and the security footage make their way to the MPU. Jason and Mike quickly follow up with this incident, while Sidney looks at the footage and wonders if it was her letter that ticked off Violet and made her violent.

She blames herself for the whole thing, but Kemi and Helen convince her that she is not responsible for Violet's actions in any way. Meanwhile, Jason and Mike discover that after the robbery, Violet met up with an old acquaintance of hers whom she gave her beloved rosary to keep safe. At the time, the woman didn't understand why Violet did it, but after Jason and Mike talk to her and update her about the situation, she gives them the rosary, which also gives them a major hint about where Violet may have gone next. The rosary proves that she is a heavily religious person, which means that in times of crisis, she would go to church. Now the question is, which church? It would be impossible to narrow down the choice, but then, one place stands out amongst the rest. After Violet is spotted there, it also comes to light that this is the same church where Henry died and Sidney was born.

When Violet's location is found, Jason and Mike take Sidney with them as they believe it would help the mother see her daughter in flesh after so many years. Their decision proves to be right because Violet has been so mentally broken that she is hallucinating Henry and has convinced herself that she needs to die to keep her and Henry's problems from going to Sidney. When the gun does not work, she decides to throw herself off the building, which is when Sidney shows up. Seeing her surprises Violet, but that's not the only thing Sidney wants to talk about. Apart from expressing her desire to meet her birth mother and find out where she comes from, she reveals that the main reason behind these questions is that she is about to become a mother herself. The realisation that she is going to be a grandmother and will have the chance to watch her grandchild grow up gives her pause.

Sidney's words instill hope in Violet, and she decides not to kill herself. She comes off the ledge, and after her tearful reunion with her long-lost daughter, she is taken back to the psychiatric facility so that she can receive the care she requires and get healthy so that she can be there for Sidney and her child. When Sidney tells Violet she is pregnant, Jason and Mike are shocked. At first, they think that their daughter used this as an excuse to calm down the suicidal Violet and help her. But then, when they are back home, Sidney confesses that her pregnancy was not an excuse. It is very real, and as she mentioned before, this is also the reason why she reached out to Violet.

Jason is concerned about why Sidney thought she couldn't come to him with such news, but Mike understands that Sidney needs her space, and whenever she is ready to talk about it, they are there for her. Only then will she let Jason and Mike meet him. Given the circumstances, her decision is completely logical, and Jason and Mike respect that. Now, they also have something to look forward to, and, most importantly, they have to be there for Sidney together.

The episode begins with a play being rehearsed in the Bainbridge Street Theatre, which is poised for reopening with the said play. It is helmed by acclaimed playwright Lillian Waverley, who is nervous about its success because it marks the theatre's reopening and her return to the stage after a very long time. During a dinner break, Lillian goes missing, and soon, a video surfaces, where the kidnapper threatens to kill her if the play is not shut down and the theatre is not closed. The threat seems to be directed at Celia

Fisher, whose husband bought the theatre, and she took it as a personal project. To understand the current case, the MPU looks into the place's history and discovers that it suffered a terrible fire where more than 80 people were killed.

Evidence suggests that the kidnapper is someone directly affected by the fire. What gives them away is the fact that their hands were burned in the fire, which has given their fingerprints a unique marker. This fact leads the team to investigate everyone around the fire back then, but the culprit is nowhere to be seen. Furthermore, the kidnapper gets more and more aggressive as, in the following video, Lillian is doused with gasoline. She is threatened to be put to the fire if the theatre is not closed. While Celia is ready to meet these demands, her husband refuses to bow to the kidnapper.

Part of Mr. Fisher's refusal stems from the fact that he believes that his wife is having an affair. To prove his theory, he gave her a necklace that has a tracker. He discovered she had been having covert meetings with someone in a hotel through it. He is angry with her about it, which causes him to give her grief over the theatre. At first, his obstinacy is not minded, but when it seems Lillian might be killed because of it, Celia pleads with him to change his mind. Meanwhile, Jason and Mike also discover that someone had rigged the electric system of the place, due to which one of the crew members is injured, though not fatally. This convinces them that the kidnapper is someone working on the play, behind the scenes.

During her visit to the theatre, Celia comes across a crew member whose hands are completely burned. She realises this man, named Robert Krasnow, is the kidnapper, but before she can call

the cops, he hits her and takes her to the same place where he has been keeping Lillian. This is where he reveals that his wife and daughter died in the fire, which is why he doesn't want the theatre to open again. He calls out Celia and her husband for not caring about the victims, and this act is his revenge for the death of his family. Around the same time, the MPU also figures out Robert's identity and his backstory, confirming the existence of a strong motive. The question now is how to find him.

The fact that Celia has been kidnapped leads the MPU to ask her husband to use the tracker he had put in the necklace she is still wearing. Using it, Jason and Mike find a storage unit, and they locate Robert's when they find gasoline pouring out of it. They try to convince Robert to give up his plans. They speak of their loss and grief to empathize with him, and somewhere, a chord strikes with Robert. He agrees to let Celia and Lillian go. However, he is too broken to go on without his family, so he burns himself alive.

While Lillian is brought home safe, the tragedy leaves a mark on Celia, who decides to leave her husband and confirms the fact that she was having an affair, and her lover is Lillian. A while later, the theatre opens on the day it was initially decided. The whole thing goes without a hitch, and the play receives an overwhelming response. At the end of the play, Celia and Lillian confirm their relationship publicly. Celia also reveals that she has decided to donate a portion of the proceeds from the theatre to help the families of the victims who died or whose lives were impacted by the fire. This way, she can carry the theatre's legacy forward, while also respecting the memory of the people who lost their lives or loved ones at the place.

While the MPU is busy finding and saving Lillian Waverley, Jason decides to focus on another important thing. Since Sidney's bombshell revelation about her pregnancy, he has been wondering about the identity of the child's father. Because Sidney has refused to tell him and Mike, he thinks that it would be best for him to look for the guy himself. He tells Wayne to dig into it, and sure enough, she comes up with a name. Jason doesn't waste any time before meeting with the guy, especially after he discovers that he is moving to Oxford to pursue a great opportunity. While Jason is happy to see that the boy is academically gifted, he doesn't like the fact that he is running away from America after making his daughter pregnant.

When he confronts the boy about it, he reveals that he had asked Sidney to move to Oxford with her, but she refused to do it because he is worried about her father. A new case for the MPU comes in the form of a man named Jeffery walking into the MPU office with a box. He reveals that his fiancée, April, has gone missing, and he believes that his father, Walter, may have something to do with it. He reveals that his father has fallen into a coma, and when he was going through some stuff in the basement, he found a box with the photos of him and April. It seems that Walter has been keeping an eye on them. But what truly concerned him was the discovery of another box of weapons and

stuff used to harm people. Jeffery worries that his father may have done something to April.

The problem is that Walter is in the hospital, and until he wakes up, he cannot be interviewed or interrogated. The team gets lucky when the man regains consciousness. Jason thinks about wasting no time and arresting the man, but before he can do that, a familiar face shows up to tell him that he cannot always have things his way. It is Lt. Gabrielle Bennett, Jason's ex-colleague from Philadelphia PD. She used to train under Jason, but when she got tired of him working his way around the rules, she came clean about it, and Jason was forced to move on.

Despite the friction between them, the importance is given to the case. Gabrielle is intent on arresting Walter because evidence reveals that he is a serial killer known as the Ringbearer. He was called that because he would abduct women, kill them with hypothermia, and then return their bodies, minus their ring fingers and their rings. The women would be either divorced or those who got a restraining order against their exes. The murders started a couple of years back, but the killer was so precise with the killings that he did not leave any clues behind. Now, when there is a possibility that Walter could be it, Gabrielle is not ready to leave anything to chance, even if it means working with Jason again.

When Jeffery walks into the station with the evidence pointing a finger at his father, he seems to be entirely aware of what he is doing. In the box, Kemi and Mike find another box that turns out to have the rings of the women killed by the Ringbearer. In a way, this confirms that Walter is the said killer and must have abducted April as well. However, when the old man is interrogated, he reveals that the box belongs to Jeffrey. He claims that when he confronted his son, they got in a fight, and Jeffrey threw him down the stairs, hence the injury.

With the father and the son blaming each other, the MPU is conflicted about whom to believe. Moreover, they are yet to find April, and the clock is ticking on her life, which means they must figure out who is telling the truth. Jason asks for Wayne's help, who looks into the previous deaths and discovers that all the women had been to the same court to have their divorce or other documents handled, and Jeffrey processed all of them. This creates a clear connection between him and the Ringbearer's victims, hinting that he could be it. When Kemi tries to get Jeffery into the interrogation room to talk, he holds her at gunpoint and locks himself and her in a room. His only demand is that his father be questioned and April be found as soon as possible.

Wayne discovers Jeffery couldn't have abducted April because he was at work then. Now that he has an alibi, it is clear that Walter has abducted her. Meanwhile, Kemi gets Jeffery to confess to the fact that he and his father killed the women together, which means that there had always been Ringbearer serial killers. They did it out of hatred for Jeffrey's mother, who walked out on him when he was a kid. This led the father and son to hate the women who would drop out on their families by getting divorces. It seemed logical to kill these women for a while, but then Jeffrey met April and fell in love with her. His father couldn't digest that his son had fallen for a divorcee, so he decided to rectify the situation when his son wouldn't listen to him.

When it becomes clear that Walter abducted April, Jason and Mike try to scare him into telling them where she is being held. However, he tricks them, making it even more difficult to find the victim. This is when Wayne works her magic. She discovers that Walter used to work at a meat processing plant, which is close to the location where he took the MPU team. She tells Jason and Mike to keep looking around and find a walk-in fridge. Luckily, they find it in time, and April is saved. She is immediately taken to the hospital. The news of her rescue defuses the situation with Jeffery, who releases Kemi and surrenders himself.

Gabrielle is impressed with Wayne, considering the initiative she showed in the investigation and how, without her, April couldn't have been saved. It seems that Jason needs to acknowledge this as well, but he messes things up with her. At the beginning of the episode, Wayne tells Jason about a job offer that requires her to move to a different town. Because she is not too keen to leave Philadelphia, she wonders if Jason can get her a job at MPU. While he doesn't doubt the fact that she is immensely talented, he is not sure about having her around all the time. So, he lies and tells her that Mike refused to hire her on the grounds of her criminal background.

Wayne expresses this disappointment in front of the team, where she is told that Mike is not the authority on hiring people. This exposes Jason's lies, so by the end of the case, she takes the job that requires her to leave. Jason apologises to her, but his actions have shown her that perhaps, he doesn't want her around, so she is ready to move away. She doesn't know how long the job will require her to stay out of Philly, but it will be long enough for her and Jason to figure out what they really want from each other, and most importantly, if they still want each other at all.

Lt. Gabrielle Bennett was introduced to the MPU in the previous episode, where the team collaborates with Philadelphia PD to find a woman in danger of becoming the next victim of a prolific serial killer. She liked working with the team so much that when she discovered that there was a vacancy, she decided to get the job. With her exceptional track record, it is not difficult for her to get the position. However, she also knows that she will have to work hard to get the team to trust her and accept them as their

leader, while they will have to figure out what kind of a leader she is and whether she will accept their ways or try to change them. While the rest of the team is more open to the idea of accepting her, Jason is yet to get over the ghosts of the past.

All these doubts and questions take a backseat when a missing person's case comes before the MPU. A woman shows up to report that her friend, Carmen, has gone missing. She was supposed to show up for a meeting, but she never did, which is entirely unlike her. Carmen works as a customs broker. She is well-liked, highly diligent, and not the kind of person who disappears without a trace. At first, Gabrielle decides to give it twenty-four hours, as is protocol before filing a missing persons report. But Kemi offers to look into the case a little bit, just to see what is happening. This is how the MPU works, and Gabrielle decides to trust their process.

When Kemi looks into Carmen, she discovers that the woman has a social media page where all the photos she has posted so far are photoshopped. This seems a bit odd to her, on top of the fact that her job as a customs officer put her in a position where she could be bribed into clearing stuff for customs. She had already been using it to move some fake stuff around, which creates the motive for someone to harm her. An alert is issued for her, and this brings an FBI officer to the MPU. It turns out that Carmen is an undercover FBI agent. Her handler had been worried about her because she had been out of touch for a while, which made him wonder if she had gone rogue. But with her disappearance, he worries if something happened to her, and more importantly, if, due to the MPU alert, her cover is blown.

With the FBI in the mix, it falls on Gabrielle to convince them to work with the MPU. She gets them to release Gabrielle's files to better understand her case, and at the same time, her partner is updated about the situation. He reveals that the reason Carmen, whose real name is Maria, may have been acting off is because she is pregnant. Meanwhile, Kemi scours through the CCTV feed and discovers that Carmen was last seen in the car with a man whom Gabrielle immediately identifies as the criminal Philly PD has been looking for a while. Kemi figures out what neighbourhood the kidnapper might be staying in, and where they might have ordered food from, which leads her to find the exact location where they'd been staying.

By now, it has become clear that Carmen was abducted due to her position as a customs officer, which means that the kidnapper wants her to move a package. When Jason and Mike show up at the location, the kidnappers are gone, but there is enough evidence to suggest that the package they wanted to move is a little girl. A quick DNA scan reveals that the girl is named Maria, who went missing from her home about 72 hours ago. It turns out that her father is a criminal on the run. He is currently believed to be in Ecuador, which means that the kidnappers are planning to get her there.

When the criminal in Ecuador comes into focus, the FBI gives preference to him. They ask the MPU to stop their investigation, while also revealing that they want Carmen to go through with getting the girl to her father so that they can figure out where he has been hiding. This means that they won't be helping their own undercover agent, and she doesn't even know about it because they have stopped communicating with her. When Carmen's partner shows the team her secret email, Kemi figures out how Carmen and her handler had been communicating. They find the last message from her, which gives Jason an idea. From her files, which were promptly taken by the FBI but were already printed by Jason, it turns out that her message refers to a time and place.

It is clear that she is trying to get a pilot to fly the girl out to Ecuador. Because the kidnappers don't know the pilot, Jason decides to impersonate him after he is taken in by Jason and Mike on trivial charges. When Jason shows up at the meeting, Carmen realises that help has been sent her way. She updates him about the flight plans, and the next day, the MPU waits for the kidnappers to show up with Carmen and the girl. After a showdown where bullets fly around, the MPU succeeds in containing the situation. Carmen is given the opportunity to close the case by arresting her own kidnapper, and she and the girl are brought back home. The girl is ecstatic to be reunited with her mother, who is immensely grateful to Carmen, who has decided to drop her undercover work and stick with a desk job to focus on building her family and have a safe pregnancy.

Later, Gabrielle approaches Jason, where she gives him a recording in which she is heard authorising a mission that she was explicitly told to abandon by the FBI. She believes that this is the dirt on her that Jason can have, considering that he still does not trust her. She confesses that she took the job because she thought it would look good on paper and bolster her career opportunities. She also admits that it feels much better to save lives than to solve murders and she intends to keep working with the team to learn their ways while also exploring her own space in the MPU. The recording is her gesture to convince Jason that she means well, and he decides to believe her. Her attempt at gaining his trust surprises him, but it has the intended effect as he deletes the recording and shakes hands with her, showing that he is ready to move forward with their new dynamic.

The episode opens with the foreman, named Burt, at the brewery, where an accident with another worker leads him to confront his boss about safety issues at the workplace. Following the heated argument, Burt goes back in, but he never comes out. An unseen person attacks him and is nowhere to be found, leading his daughter to come knocking at the doors of MPU, to the only place and people that can help her and her father.

When the investigation begins into Burt's disappearance, the first thing that

the MPU discovers is that he is a well-liked person. It was because of him that a fatal accident was averted the day before, saving his colleague's life. This shows how much he cared for the people around him, but that's not where his good nature stopped. Burt had been hounding his boss and the brewery's owner, Lembeck, about the safety issues for a while. The accident with his colleague could have been averted had Lembeck followed the protocol and taken the safety measures, but he did not think this was worth his time and money.

Believing that his boss would not do anything, Burt printed out all their email correspondence regarding the safety issues for future purposes. He might have intended to use those emails to report his boss, but they come in handy for the MPU when his daughter presents the printout to them, showing that Lembeck had the motive to harm Burt. Interestingly, he is also reported to be the last person to have seen him alive, putting him at the top of the suspect list. When the finger is pointed at him, Lembeck reveals that his rival brewery owner may have wanted to harm Burt.

According to Lembeck, Burt was indispensable to his brewery because he was the only one who knew the formula for their new brew, which would be a breakthrough for them. This would have wiped out his competitor, Demetri, who already seems to have quite a criminal record. When Mike and Kemi pay him a visit, he tries to run and immediately calls for a lawyer when Burt is mentioned. Things get more interesting when Burt's helmet, which is marked with his blood, presents traces of a substance traced to Demetri's brewery. This establishes a connection between him and the victim, but a completely different story comes to light.

Demetri reveals that he couldn't have hurt Burt because they were working together. It turns out that the formula for Lembeck's new brewery was stolen from Demetri. When he told Burt about it, the guy looked into the matter and found that his boss was a cheat. So, he decided to get to the bottom of this and report him. Meanwhile, at the brewery, it is revealed that Burt had been part of the lottery group, and the last lottery ticket had earned him and the team a win of 50 million dollars. This is another motive for someone to hurt him, but before Mike and Jason ponder the possibilities of the discovery, the brewery's receptionist, Bianca, makes a run for it. This is when we discover that Bianca and her boyfriend, Wyatt, are the ones behind Burt's kidnapping. They found out about the win and believed that Burt was planning to keep all the money for himself.

However, he reveals that he was going to give it to Jerry's widow. Jerry was their coworker who passed away the year before. Since then, Burt has been visiting his widow to try to help her out for Jerry's sake. At the same time, he also bought lottery tickets with the same number that Jerry used to. Burt was doing this in his friend's honor and never expected to win. So, when he did win, he credited Jerry for it and believed that his widow should get the money. This did not sit well with Wyatt and Bianca, who wanted all the money for themselves. Soon, it becomes clear that Bianca is the saner of the duo, and her boyfriend is more unhinged than expected. He is ready to torture Burt for the ticket, but when it becomes clear that he is not going to tell them where he has hidden the ticket, they decide to kidnap his daughter to blackmail the truth out of him.

Before Burt's case is brought to the MPU, the team is a little out of sorts. Poor Helen broke up with her stripper boyfriend, Jackson, because she was scared of how serious things were getting between them. Jason brings Wayne's dog, Ursula, to the office because he is babysitting the dog and has nowhere to put her while he is at work. As if this weren't chaotic enough, another problem arrives for Gabrielle in the form of her ex-husband, Damon. It turns out that he is Demetri's lawyer and is not happy with the way MPU handled him. He warns Gabrielle about keeping her team in check, which makes her angrier, but even more determined to solve the case. When Wyatt and Bianca try to get the lottery ticket, they make a video of Burt and send it to his daughter.

Through this, it becomes clear that Wyatt has kidnapped Burt. What remains to be ascertained is the location where he is holding the victim hostage. Through her contact, Gabrielle gets a satellite image of the brewery and its surrounding location and discovers that Burt is being held on the roof of the abandoned section of the brewery. This coincides with Bianca trying to trap Burt's daughter in the hopes of kidnapping her and forcing Burt to hand over the ticket, but her plans are disrupted by Kemi. Once the location is confirmed, Jason and Mike make their way to the roof, and after a brief gunfight, Wyatt is subdued and Burt is freed. He is reunited with his daughter, and it turns out that he hid the ticket in a book he gave to Jerry's widow.

When he hands her the 50 million dollar worth of ticket, she reveals that she has feelings for him, which he reciprocates. This encourages Helen to call Jackson to try to fix things with him. At the same time, Lembeck's corrupt practices, especially the part about stealing the recipe from Demetri, come to light, and charges are filed against him. Still, Demetri being dragged to the police station does not sit well with Damon, and he uses this excuse to intimidate Gabrielle, telling her that he can and will destroy her. However, Gabrielle refuses to be scared of his tactics, which shows that the conflict with Damon is going to cause problems for her in the future.

The episode begins with Jason on his way to Wayne, who has returned from her job, which she went for after Jason purposely kept her from being hired at the MPU despite her talent for being an indispensable asset for the team. While he contemplates how to make up to her, a girl walks in front of his car. She is covered in blood and tells him that someone took her friends. She is in too bad a state to reveal more, but with the missing people in question, Jason immediately calls upon his team.

While the injured girl is sent to the hospital, Jason and Mike look for the car that she clearly was in. They find one crashed in an alley. It is a limo whose driver has been shot dead, and it clearly belongs to the kids who were on their way to the prom. Investigation into the vehicle reveals that the car was paid for with the credit card of a senator, which means that one of the missing kids, called Chase, is an extremely high-profile case. With his mother being a politician, there could be any number of people who want to hurt him, so that is where the MPU begins.

At first, they find a protester who broke into the senator's office building a while back. He is also known to be a vocal opponent of her policies. However, his socials reveal that he was at a protest when the kidnapping took place. To figure out who else was in the car, Kemi looks into Chase's social media feed and discovers that he made a public prom proposal to a girl named Jane. Another thing that is found out about Chase is that he has had trouble in school. He was previously enrolled in a private school, but was expelled after selling drugs on school premises. Now he is in a public school, and while there have been complaints about him as such, it seems that the kidnapping might be because of the drugs. When his mother is confronted with this fact, she defends her son and says that he has not been involved in anything bad. This fact is backed by Jane as well, which brings the case back to square one.

Despite the claims that he is not into selling drugs now, Mike and Jason follow up on a lead where they find a man who seems to have been Chase's drug supplier. On a closer look, the man turns out to be a lawyer. He reveals that Chase and Jane had come to him with evidence against a local chemical plant owner, revealing that the chemicals were so widespread that they were poisoning the water supply of the school and affecting the health and safety of the children. The evidence was so damning that the plant's owner sent his men to deal with the situation. This is why the lawyer was also on edge.

This revelation makes it clear that Chase was kidnapped because of the chemical plant issue. But that still leaves the question of locating him, which becomes more difficult as his mother refuses to let them send out an alert for him. So, Gabrielle calls in Wayne to help locate Chase through his phone. She agrees to help if they start paying her for her job. While Jason is on the fence about it, Gabrielle agrees to her demands. Sure enough, Wayne finds Chase's phone, but because his location is off, it is impossible to track him. However, she gains enough access to see what texts or calls he is making or receiving. Meanwhile, the kidnappers ask Chase to call Jane.

It seems that she was their main target, but they didn't realise that Chase's date was changed, and they kidnapped the wrong girl. They want the evidence that Jane has against them and ask Chase to text her for a meet-up where they'd be waiting for her. Wayne and the MPU see the text exchange and immediately go to the school because Jane doesn't know she is walking into a trap. By the time Mike and Jason arrive at the school and send all the kids back home to prevent anyone from getting hurt, Jane is already on the run from the kidnappers who are holding Chase and his prom date at gunpoint. Eventually, however, the MPU officers succeed in bringing down the kidnappers, and everyone is saved.

With the kidnappers neutralised and the kids back home safe and sound, the MPU officers can finally call it a day and get some rest. Meanwhile, Mike tells Jason to make things up with Wayne, and eventually Jason decides to make use of the prom decorations and calls Wayne there to celebrate with her. During their dance date, she gets a text from her employer, for whom she was working when she was out of the city for a few days. Interestingly, the person on the other end asks her whether she made it into the MPU, and she replies in the affirmative, while also mentioning that no one suspects a thing.

This is a little suspicious of her, and makes us wonder why she really wanted to be in the MPU. She had been pushing for it for a while, and Jason's refusal to let her be an official part of the team almost ended their relationship. At first, it seems that she simply needs a job, and because Jason and her friends work there and they have already called upon her help several times, it seems logical that she would want to work with them. In this episode, when Jason asks her why she is so intent on joining the MPU, despite the shitty pay and long hours, she counters that she likes what the unit does to help people and she wants to do some good. However, the contents of her texts reveal that there is an ulterior motive behind her actions.

Does this mean Wayne has secretly been a villain all along? Not necessarily. We are yet to find out who she was texting, but one must also consider the circumstances under which she would have agreed to join the MPU and fool Jason and the people who have become dear friends of hers. There are already a few people who might want an inside man in the unit and find ways to harm them. At the beginning of the season, when Wayne helps find Charlie McGannon's daughter, he is so impressed with her that he wants to be with her. While now he is rotting in prison, could it be that someone from his gang reached out to Wayne and is blackmailing her into working for them?

Similarly, suspicion also falls on Gabrielle's ex, Damon, who has already threatened her and the unit. His issues with his ex-wife have led him to declare war against the unit, though on legal terms. The situation is so dire that we see Gabrielle worrying about his threats even in this episode, where she shares her concerns with her boss, Bill Houston, who also happens to be Damon's stepfather. With all this in mind, it wouldn't be far-fetched to expect that he has something to do with Wayne and the text. He might want someone on the inside to feed him information on the team, and Wayne could do that pretty easily. It remains to be seen who she is really working for, but clearly, the answer will only set up more questions which only Season 4 can answer.
