The episode starts in Chicago 1996. After a brief introduction to the Butterfly Effect (how seemingly unrelated incidents can be connected) Jimmy Keene's life is about to be changed forever thanks to a girl on a bike and a business deal.

Meeting his contact, Rog, everything goes sour. Jimmy's friend from first grade, and fellow drug dealer, has sold them out. He's stolen drugs and Rog grabs a shotgun, looking to make him

pay. Although Jimmy manages to talk him down and save Dany's life, it's the beginning of the

In the morning, Jimmy's house is stormed by FBI agents who handcuff and arrest him. Jimmy has stacks of cash, illegal firearms and drugs across the table. Even worse, his prosecutor for this case wants to make an example of him.

However, if Jimmy takes the plea offering, he'll get 2 years but because of the guns he'll have to do the midrange — which means he'll have to serve 5 years and be out after 4 on good behaviour. This appears to be the only solution.

Before court, Jimmy pleads guilty but unfortunately he gets 10 years, not the 5 he was hoping for. Seven months later, Jimmy is still in prison but called in to a meeting. There, he meets

Special Agent Lauren McCauley accompanied by Mr Beaumont, the guy who convinced him to plead guilty in the first place.

Anyway, Lauren admires the fact Jimmy is thriving in prison. He gets along with everyone and has even set up a side-gig hustle, giving out 30 minute blocks for renting out porno mags.

With Jimmy's charisma and skills, the officers want to put him to work. Specifically, they want Jimmy to be riend another inmate and get him to reveal the location of a dead body.

You see, the man in question has actually killed 14 women but they only know the location for 1. In order to conduct this mission, Jimmy will need to move across to a maximum security prison specializing in the criminally insane, all the way out in Missouri. If he can get the inmate to open up and reveal the location for the bodies, Jimmy is going to be granted his freedom.

We then cut back 4 years earlier. A woman named Jessica Roach is found deceased in Indiana having earlier gone missing on July 20th. This girl happens to be the one from the bike we heard about earlier in the episode. This is how she's connected to Jimmy's case.

The van in the middle of this whole mess happens to be owned by a guy called Lawrence D. Hall. Police are all over this, fronted by Chris Drydale and Sherriff Brian Miller who begin sniffing around and asking questions.

Now, we already know that Lawrence has been arrested but there could be doubts around whether he's really the killer. Larry is apparently a serial confessor and apparently harmless, at least according to Chris Drydale. Brian is not so sure.

Brian heads up and meets Larry. Now, the guy is known to be involved with military reenactments and given there was a Revolutionary Re-enactment a day before Jessica Roach's disappearance, it's clear that Brian is trying to connect the dots.

Larry also owns an 82' Dodge van which he was driving around. He also had words with a couple of girls then whom he claims were "pretty rude" to him. Compounding these worries further, Larry admits that he's been having dreams about killing women lately.

Back with Jimmy, he discusses his options with his father. Jimmy's dad believes moving to Springfield for this operation is a death sentence, and there's no guarantee that he'll even be able to get the information from Larry.

Jimmy's mum shows up in prison some time later though and informs Jimmy that his father is sick. In his current state, he doesn't have 10 years so Jimmy is likely to take the deal.

Jimmy lets Lauren know as much, but apparently it's not a done deal. There are other applicants they're looking at too. Jimmy isn't exactly happy but Lauren encourages him to "do his homework" and continue looking into the case file. And he does just that, reading through the details of the file that night.

The episode starts with us in the past, following Tricia Reitler as she heads home. However, she's stalked by a guy in a van. This is on March 29th 1993 and it would appear Larry is the snatcher.

We also cut back to the timeline involving Brian questioning Larry. He claims that his dreams about women is more of an out of body experience than him actually doing these deeds.

When Brian shows Larry a picture of Jessica though, he gets riled up and wants to go home. Brian's questioning is a dud, so as a result he's encouraged to head home and build a case so he can

bring that against Larry. Brian does no such thing.

Brian sticks around as Larry is questioned by police. The latter refuses to take a polygraph test too, believing he wouldn't pass it. When he's shown a picture of Jessica, Larry asks to touch it. He claims she's a nice girl but she got sad when she was in his van.

Larry continues on, claiming there is someone else "taking the credit" for what he's done. He also brings up a very specific act in this case — folding the clothes. Now, none of this is public knowledge and the clothes were all folded at the crime scene — it would appear they've got their man.

The confessional statement takes what Larry has said in the interview room and twists it into a big scenario involving rape and throwing the girl in his van. When Larry is presented this

confession to sign, surrounded by officers, he's shocked and claims he didn't do this. The officers are adamant he did. Larry scoffs incredulously, "No wonder I couldn't sleep at night." He signs.

Brian heads out to Larry's abode with the other FBI agents and pores over the details. Lauren takes Brian outside where they check out the vans. One is full of gear while the other is completely bare. According to the ERT guy, it smells like three things: Chemical cleanser, Armor All and denatured alcohol. The one thing that the usually messy Larry Hall (given the state of his van and house) keeps clean.

In the present, Jimmy is questioned by Lauren over girls and, in particular, what he likes about them. In the middle of this, Jimmy perks up and believes Lauren is playing him. He's convinced there's no one else they've chosen for this task. Only... that's false.

Lauren spins her laptop screen around to reveal another candidate, a guy who used to be a Ranger for the Desert Storm whom they've had their eyes on. Beaumont wants to pick him.

Remember what we said earlier about the van being kept clean? When Lauren speaks to Jimmy again, she brings up how Hall was a competent cleaner. According to the three office buildings he worked on as a janitor, the bosses of those places claim they've never met anyone who cleans half as well as Larry.

Not only that, but Larry also has a twin called Gary, who has all the looks and charm. Larry has always been desperate for attention and is impressionable, which could explain why he's admitting to this crime, even if he hasn't necessarily done it.

When Larry is transferred, in the back of Brian's car no less, he talks about how the confession was coerced. He's got himself a lawyer, courtesy of Gary. Brian doesn't seem too bothered though.

Anyway, Lauren wants Jimmy to be like Gary, letting Larry confide in him like a brother when he's transferred into the prison. Given he adopts many of the same attributes, including being cocky and athletically fit, it makes sense that he's chosen for this job. And he passes the test too.

Jimmy is immediately transferred out and across to Springfield. He's nervous, concerned about what's to come as Jimmy approaches the foreboding building.

Now, time is of the essence with this case. It turns out the judge has looked over the details of the Larry Hall case and has concerns. The block letter signature and the fact Brian was "intimidating" are both enough for a second appeal to be put on the docket. That means Jimmy needs to speed up his case.

Jimmy heads into Springfield and prepares to get accustomed to this new prison. It's far more brutal than the previous one he was in. That night, Jimmy realizes he's in a cell adjacent to Larry's.

The episode starts with Jimmy biding his time and attempting to speak to Larry. It's been a disorientating first week for our protagonist, who feeds back his progress to the psychologist on campus. He's being prescribed an antidepressant to blend in with the other inmates, given everyone on the cell block are taking some form of medication. This is the best way for him to blend in.

Most prisons have an element of predictability and you settle into the rhythm. Of course, Jimmy's previous prison was

exactly like this but now, in Springfield, unpredictability and random occurrences are, well, a common occurrence. This puts Jimmy in a difficult position, but the Doctor gives him his home number just in case things get hairy and he needs the guards.

Jimmy continues to try and talk to Larry, but the guy blanks him. Even worse, Jimmy's dad shows up, flashing his badge and blowing Jimmy's cover. Thankfully the guards don't think too much of it, given a fair few inmates also have cops as fathers.

On the way back to the yard, Jimmy is encouraged to meet with Vincent "The Chin" Gigante, who's a big-time player in the prison. He wants Jimmy to work for him, promising he'll do pleasant time if he plays along. If not, then he's going to find hell behind bars.

Jimmy does manage to actually talk to Larry in the end, courtesy of sticking up for the guys in the TV room. He beats down a man attempting to change the TV channel and that gets him access to Larry. They talk about vehicles... until Carter, the guard from earlier, arrives.

Carter speaks to Jimmy in confidence and blackmails him into submission. Given Jimmy's father is a cop, that's not going to go down well with Gigante. He knows Jimmy is a snitch but doesn't know for who, so he asks for a loan of 10k in order to stay quiet and not tell the inmates.

Unfortunately, Jimmy doesn't have the money and despite using his father to try and find different hotspots it could be located, it really doesn't look good.

Lauren and Brian discuss Larry's mental disposition and how he never mentioned a word about the killings while they were driving together. Still, that doesn't stop them from going through the list of deaths, this time focusing on a girl called Rayna Rison.

This is another of Larry's victims, someone who was linked courtesy of the van, a ski mask and a bottle of birth control pills. Digging deeper into this, the label was apparently dubious, with no known prescription.

The officer working on this case tells the pair that "Larry Hall planted fake evidence on himself for a crime no one was looking at him for." But then we know that Larry has a twin brother don't we? Was it really Gary responsible for this? Lauren is starting to have doubts that Larry may actually be responsible.

Lauren shows up at Springfield and projects as much to Jimmy. However, Jimmy is in trouble given he needs 10k in order to stave off the guards. Not only that, but Jimmy learns Larry could actually walk free, especially if the judge decides that this was a coerced confession.

It's a precarious pressure cooker situation, as Lauren pleads with Jimmy to accelerate his timeline to find out what Larry knows.

with time to learn more about each other.



The episode starts in 1973 with a funeral. As dirt is dropped on the coffin, a young Larry is encouraged to join his father in the middle of the night. Fast forward a year and Larry's childhood is juxtaposed by Jimmy Keene's ties with his own dad, as they play football together.

Fast forward to the present and Jimmy begins rooting around Larry's cell. Opening up a Penthouse magazine on the floor, stuffed under a pile of Hotrods and a loo roll, he finds numerous menacing pictures Larry has drawn; graphic, vio-

lent imagery.

Summary:

When Jimmy heads back to his own cell, Carter is there waiting. Jimmy claims he doesn't have his money, putting the guard in a tough spot given he's in debt to powerful individuals. For now, Carter doesn't pounce but it's clear this is a precarious situation and a ticking timebomb.

There's an eerie silence hanging over Springfield, "riot quiet" as Larry calls it. He's convinced that something is going to go down and we soon see exactly what at dinner. The inmates go absolutely mental, helping themselves to food, hitting back against the guards and grabbing anything that moves.

Blood is spattered over the tables and walls, the entire prison is a complete mess, and as sirens scream out, all the inmates are forced into lockdown. Larry was right. He's also on clean-up duty too, and organizes the other inmates to get the place sorted.

Jimmy jumps on the opportunity to ask Larry questions about his cleaning. Here, he learns that Larry used to work as a cleaner (which we already knew of course) but he did move to a place that specialized in medical supplies. He also grew up in cemeteries, claiming it was a "pretty nice way to grow up." Back then he was digging graves and taking valuables from the deceased. The way Larry sees it, it's a selfish act for the deceased to be buried with their own belongings when they could be using those to do good.

Larry's father even encourages his son to slice off the deceased's fingers to take their jewellery, showing absolutely no remorse or emotion toward his son.

Interestingly, Jimmy's relationship with his father is certainly not the pretty picture we were led to believe at the start of the episode. Between fights involving his mum and dad and being left on his own, Jimmy and Larry's childhood is a fascinating juxtaposition of fortunes.

When Jimmy's father left home, his mother ended up with a new man; an abusive guy called Glen who used to beat her and the kids. Jimmy decided to hit back, getting himself bulked up and taking karate classes. Larry points out that the real pain here is that Jimmy's mother seemed to love Glen more than Jimmy.

Larry also shares some of his truths too, including how he soaks a rag in starter fluid and has that stuffed away in a Mason jar in his van. If you use this on an individual, it knocks them out in seconds. Apparently Larry does this so "they" stop hitting him. And by they, he means girls. It's almost a confession but it doesn't seem like enough to really nail Larry.

During visitation, Larry is visited by Gary where he asks about the girl they picked up in California. Apparently she left the next day, and the girl's name is Sharon. Gary changes the subject to the police sniffing around. He warns that Larry is in their sights and they won't stop until he's put down. Larry though seems to be pretty confident that he's going to get out.

Summary: Jimmy's mounting fear and paranoia compel him to provoke Larry.

McCauley and Miller have a breakthrough. Larry's therapist grows

concerned.



The episode starts with Jimmy walking purposefully through the prison. All the inmates stare a hole through him, but in reality it's just his own paranoia. Jimmy is brought in for his regular meeting with Dr. Aaron Zicherman. Only, he's not actually there, he's on vacation. Instead, he's confronted by Larry's doctor.

Jimmy is guarded and questions the new doctor, asking exactly why she's filling in and knowing that Jimmy would be there. She shrugs it off, claiming she's just interested in helping those with men-

tal health issues.

The doctor urges Jimmy to show some compassion. "Are you a threat to the mental health of any of my patients?" She asks. This is, of course, in reference to Larry — and Jimmy is quick to ask as much. She doesn't need to say anything but Jimmy can sense this is where the conversation is going.

Jimmy intensifies his questioning with Larry after this, asking about Gary. Well, Larry is not happy with his brother's wife, calling her a "stinky bitch" after she called their re-enactments dress-up.

Larry has pretty strong opinions about the education system, and Jimmy plays right into this, asking about the "brides" he's had and asking how young these girls were he's slept with. Larry bites right back, and it's a really tense conversation, especially as Jimmy is forced to lie in a bid to get his new friend to open up.

Meanwhile, Brian and Lauren continue to trace Larry's moves and move up through Illinois to do so. There are a number of different roads and it would appear that the pair stopped somewhere

that intersects. The gas station up on the road opened in the Spring of 94. The manager believes they broke ground around the summer of 93 though.

Continuing on, at the autoshop, JT (the tender) recognizes a picture of Larry and points out that he's memorable and "creepy as old fuck." Apparently he used to constantly hang out and chat up the young girls. JT eventually ran him off though, given he made too many of the girls uncomfortable — including his own daughter, Audrey.

Brian and Laure decide to question her next. According to Audrey, Larry used to encourage her to go to his van and check out his cleaning products. He used to give her things too, including a locket and earrings. They were all her size, which made his earlier comments about her ankles and earlobes all the more unnerving. Audrey admits that most of the items she threw away — but one thing she kept. This happens to be a mountain bike. Jessica Roach's mountain bike to be precise.

Meanwhile, Jimmy is approached by Vincent Gigante who warns him off bringing drugs into the prison, telling him this is a bad idea. Jimmy claims he thought about it but changed his mind. The thing is, Gigante is suspicious of Jimmy, especially as nine of his contacts have actually seen Jimmy in person but it's all hearsay, and as such it puts Jimmy in a precarious situation.

Speaking of precarious, an agitated Larry heads into therapy and lashes out at his therapist. He brings up how he's in a great mood, and how there are "positive signs" in the prison. Larry's cockiness is a projection of Jimmy's behaviour and she sees straight into this.

Jimmy's projected cockiness hides a much more vulnerable core though, specifically his own paranoia. Between the situation involving Gigante and Carter, Jimmy is caught off-guard by Larry's chat in private.

Larry points out that he's never raped anyone... but he has slept with different girls. He brings up Jessica Roach and how she was "nice at first". She had a mountain bike and ended up getting a flat tyre. Larry gave her a lift and he's convinced the girl was happy to chat and take a ride.

As Jimmy listens, Larry likens her to a rabid squirrel. He reveals everything in excruciating detail, including knocking her out with the liquid, "ragging her" in the back of the van and how Jessica scratched him deeply. He doesn't remember having sex with her but when he woke up his clothes and hers were both off.

Jimmy keeps a straight face through all of this, even when he points out Jessica was crying after. It's an admission of guilt and he could go down for this. However, it's not enough right now to get Larry off the hook. Larry's hearing is coming up soon and despite Jessica Roach's bike being found with Audrey, there's not enough evidence to keep him behind bars. One thing's for sure though, Larry is 100% guilty here.

Summary: Jimmy reaches his breaking point. Larry becomes suspicious. Mc-

Cauley and Miller talk to an important person in Larry's life.



The episode starts with Jimmy having a bad dream. He's imagining himself in Larry's place; he's choking out girls; disagreeing with his father; he's also playing football. When Jimmy eventually wakes up, Larry is watching him from the edge of the cell. Larry mentions his stories, as Jimmy challenges him and wants details. Eventually, Larry grits his teeth and squares up to Jimmy. "I'm not lying James," He says.

Jimmy isn't convinced, pointing out that he has "wannabee" eyes. When Larry

leaves though, he tells his friend to meet in the woodshop later so he can show what sort of eyes he has.

While Jimmy prepares for what could be to come, Carter approaches our protagonist and proposes a business deal. Carter wants in on his transaction with the marshals but Jimmy is clever. He throws a curveball — call off his dogs for a week and he'll tell Carter who he's working for. Of course, in that week's time Jimmy could well be walking free — if he can nail a confession from Larry of course.

That night, Gigante waits for Jimmy outside his cell with his boys. He throws an ominous threat his way, before walking off. With this rattling around in Jimmy's mind, our protagonist shows up at the woodshop as promised. He's carved 21 birds. Apparently he's the carver while Gary is the one who paints. The birds watch over the dead, guiding their spirits and making sure they're okay. Now, that means if there are 21 birds then there could well be 21 dead bodies too.

Larry tells Jimmy he's part of something bigger. Folding the clothes are apparently an act of kindness for a deity. And the person's clothes? Trisha Reitler's. Larry also admits to killing her,

and goes on to nonchalantly declare he's dug so many graves — including Tricia's. According to Larry, Tricia's grave is the best he's ever dug and no one will find it. He also knows exactly where that is — including "everyone else's" too.

Jimmy lets Larry finish his story before gently suggesting he hand over the map so he can give the victims peace. Jimmy suggests sending the map anonymously so the families have closure. Larry though, doesn't see this lack of closure as a bad thing and begins chuckling. He refuses to do this and instead, is self-aware enough to know he'll win his appeal and walk away a free man. But not if Jimmy has anything to do with it.

Jimmy snaps. He shouts at Larry, telling him he's never going to leave this place and lashing out at the killer. The guards step in though and break the pair of them up.

In the morning, Jimmy is picked up by four guards who throw him into solitary confinement. He pleads with them for a penful, so he can at least sketch out a map of where the bodies are, but it's no good. Instead, he remembers Larry's words and decides to use his own blood to make up the map on the wall. The guards don't believe that Jimmy has been sent by the FBI, and leave him to rot.

Meanwhile, Brian and Lauren visit Gary again. He's convinced that Larry won't be able to have a normal life but is pretty confident that his brother hasn't killed anyone. It seems he's trying to convince himself more than the officers though, especially if Brian's probing is anything to go by.

Gary hands over a photo album to show the officers their past together. He also mentions the hitchhiker they picked up years back. Here, he confesses that Larry slept with a girl and watched him choke, spit on her and hit the girl several times. Gary was in shock, seeing his brother with a wild, wolf-like look in his eyes. Gary is convinced that this is the incident that tipped Larry over the edge. Lauren warns that if Larry gets out, he'll get right back to his old tricks again.

Dr. Zicherman and Lauren eventually pick up Jimmy from the prison, who's fixated on the map and determined to draw what he's seen for them. Like a man possessed, he draws it out on the table, marking where the bodies are. Jimmy is clearly not in a great mental state, pointing out the details for the case, including the two belts, the folded clothes and the other details.

That map Larry sent back home? Well, Larry's father takes that and the bird, throwing them in a fire and destroying them. While they burn, Jimmy Keene is freed from prison and released. However, the ordeal has very clearly changed him.

Jimmy feels guilty that he wasn't able to do more, as Lauren introduces him to Brian. Although the trio have effectively stopped any more crimes from being committed, it's still not the closure Jimmy wanted.

As for Larry, after losing his appeal he attempted suicide but was unsuccessful. Gary heads in to visit, telling his brother that he needs to tell the truth about the girls. Larry refuses though, believing he's been "corrupted" and is to blame for him diving off the deep end.

Jimmy's father is on the mend from his early stroke though and recovers at home, where Jimmy shows up a free man. However, on November 28th 2004, we learn that Jim Keene actually died of a heart attack. This is 5 years after Jimmy was released from prison.

As for Jimmy Keene, he's still haunted by everything that's transpired. Larry Hall recants all 15 confessions his brother convinced him to admit to, while none of the graves are actually unearthed for Larry's victims.

Jimmy embarks on a successful business career following everything he's done, dedicating his life to helping out the police in profiling serial killers.
