Summary: Retired Det. Harry Bosch, now a Private Investigator, is hired by aging billionaire Whitney Vance to handle a personal matter with major implications. When the man who ordered her murder a year and a half ago walks free, a devastated Honey "Money" Chandler teams Bosch to fix injustice. Maddie Bosch, still finding her footing as a rookie patrol cop, is assigned to a hard-charging Training Officer.



Maddie Bosch (Madison Lintz) is a rookie in hot pursuit of a suspect across L.A. The chase starts off in a patrol car, with Maddie on comms whilst her training officer takes the wheel, and ends on foot, with Maddie tackling her suspect to the ground, only to get written up by her partner for breaking rank. Meanwhile, Harry Bosch himself (Titus Welliver) is in the midst of one of his private investigations, entering a property via questionable means in order to retrieve some assets from a domestic residence. Else-

where, a doctor heading home after his shift is stabbed multiple times on a street corner and left bleeding to death by his assailant.

Once the opening titles have rolled, *Bosch: Legacy* cuts to Bosch, Maddie and Honey Chandler (Mimi Rogers) waiting to enter a courtroom to hear the outcome of the trial following Chandler's shooting and the attempted hit on Maddie that dominated Bosch's seventh season. The verdict is a mistrial, and it is later revealed that there will be no retrial for the man who orchestrated the crimes in question.

As Maddie is set to begin phase two of her police training, it becomes apparent that her father's lack of talent in the diplomacy department may have left her with her cards marked. Her error in judgment when she was chasing down her suspect from the other night is not something that anyone seems willing to let slide, with her newly assigned training officer making it absolutely clear that if she does the same on her watch she will be out.

Back at Chandler's home office, it looks like she's dragging her heels when it comes to getting back in the saddle after her shooting. The ordeal is something that has definitely left her shaken — as it would anybody — but in typical Chandler fashion, she isn't willing to lay down without a fight. It would be my guess that this is something that may be explored in more depth throughout the season, but we shall see. In the meantime, Chandler's new colleague is fighting to get her back on her feet and being the fierce lioness that she was prior, immediately signing her up to take on the case of the man who apparently confessed to the killing of the doctor we witnessed at the start. As this thread unwinds, it emerges that Chandler's client is a dissociative schizophrenic whose confession may have been coerced by the officers interrogating him, as opposed to it being a genuine admission of guilt. This leads to Chandler calling on Bosch as a professional witness, and although he is reluctant, the two join forces once again for the greater good.

At the same time, Bosch is also taking on a new private client — a gold-turned-steel-turned-aviation billionaire on the hunt for an heir to his estate. Years ago, he fell in love with a girl his family didn't approve of, and when she fell pregnant he turned his back, bringing the romance to a close. Now, with no one else to pass his legacy to, and his time on earth drawing to a close, he wants to see if they can be found so that he might be able to make up for the burden he left them with. Of course, with billions of dollars at stake, and the man having more than a whiff of death about him, the vultures close to him are also starting to circle, and so it appears that Bosch may be up against the clock with this case. To add to his struggles, L.A. experiences a small earthquake, which rattles the foundations of Bosch's famous apartment, and the building is condemned by the local government. On top of this, it turns out that he may have let his earthquake insurance lapse so the swanky pad that his Clint Eastwood movie money bought may sadly be no more.

As the episode nears its end, an evening news bulletin airs and it is confirmed that there will be no retrial for Carl Rogers. Upon hearing this news, Chandler heads straight for Bosch's place, where he and Maddie have also made the same discovery. Unable to let it slide, Chandler calls on Bosch for his help once again, and it looks like long-time fans of the character are going to get to see him color outside of the lines once more as he vows to go after Rogers outside of the confines of the traditional justice system.

With so much set up in this first episode, it looks like this is set to be a cracking opener to a spin-off that I hope will be just as well-revered as the original show that laid the foundations for it. With the dust far from settled following Bosch's final season, it seems like we may get to witness how each of our three main characters transition into this next chapter of their lives, experiencing all of the challenges with them as they do.

Summary: Honey Chandler's return to the courtroom continues as she fights to defend a homeless man wrongly accused of murder. Bosch zeroes in on Carl Rogers and locates an important character connected to Vance's haunted past. Maddie and her Training Officer, Reina Vasquez, have their first caper as partners.



With Bosch personally taking care of all matters concerning Carl Rogers after the official justice system failed to give the man his comeuppance, his first port of call is to run some reconnaissance on the man; his home life, transportation habits, when and where placing trackers on the man's assets may be possible. Meanwhile, Chandler visits her therapist, and it becomes even clearer that her traumatic ordeal is still very much with her and the aftermath probably hasn't yet reached its peak. It is also not long after

this that it is revealed she has given up her big-city law firm in favor of a more homely practice — a change of pace that perhaps provides a level of comfort she's more in need of these days.

With Bosch's heir-hunting case ticking along nicely, senior members of Vance's company develop concerns that should a legitimate heir surface, they will have some standing in the company and therefore a say in how things are done. As such, the board put provisions in place for Bosch and his case to be watched closely, to make sure they remain abreast of the situation as it unfolds. Of course, with details relating to the persons being searched for being as vague as they are progress is slow, so they're mainly just tailing Bosch for now.

Back with the Rogers case, it emerges that the man may have some Russian connections, but nothing that can be conclusively proved... yet. Bosch heads to L.A.'s fashion district to see if he can uncover any stronger links between the two, but with Russians also landing on US soil with the sole aim of tracking down Rogers, it may be a link that uncovers itself first.

With Bosch doing his thing, Chandler works to convince Bella, daughter of Judge Donna Sobel, who was another victim of Rogers in that she was killed by the hitman he hired, to come on board for the civil case she hopes to bring against him for her wrongful death.

At the same time, she's still plugging away on the Jeffrey Herstadt case. She learns that he had a seizure and was treated by first responders on the same night he supposedly stabbed and killed the doctor. Chandler takes a look over all of her case notes and discovers that the same first responder who treated Herstadt also was first on the scene at the stabbing. In light of the emergence of DNA evidence after Herstadt's confession was found to be coerced and therefore inadmissible in court, Chandler is determined to track down this first responder to see if she can establish a link that would explain how Herstadt's DNA ended up at the murder scene despite not having been there himself. When she finds him, she gives him his orders to be in court the next morning, where she proves that Herstadt's DNA was transferred to the crime scene when the same pulse oximeter was used without having been cleaned first. As a result, the case is thrown out due to lack of evidence, and Herstadt walks free.

Back out on the streets again, Maddie has another shift with her TO Vasquez, who seems to thaw out a little more with each day they work together. She begins to question Vasquez's motives a bit when she seems too eager to invent probable cause for pulling over whoever she feels like just because she recognises them, but when Vasquez pulls rank, Maddie has no choice but to follow suit. They roll up on two guys walking down the street, and when they start to get a bit chatty, they begin to get searched. Maddie cuffs her suspect, but as she's dealing with him, Vasquez bolts. Still smarting from her last reprimand for not sticking with her partner, Maddie leaves her perp on the curb, follows Vasquez, but they're unsuccessful in apprehending their man. When they return, the other one is also gone, but with Maddie's handcuffs still attached to him, they need to track him down to avoid any further embarrassment. When they eventually track him down, Vasquez retrieves the cuffs and lets him go. Whether she's a cop supporting a rookie cop, or if she's bent remains to be seen, but Maddie lets it slide as she's spared her second citation in the space of a week.

As the episode closes out, a new development in Bosch's official case sees him take a trip to a local maternity home in the hopes he may track down a woman called Abigail. She apparently had a lot to do with the girl Vance fell in love with all those years ago, and may hold some more answers that could move things along a bit for Bosch. When he arrives at the home, he learns that she retired a while back, but after spinning the woman on the front desk a bit of a sob story, he manages to get an address so that he can pay her a visit.

It turns out that Vance's girlfriend had a son, but he was very frail when he was born and so he couldn't be given away to his foster family straightaway — something that Abigail suspects may have contributed to the girl's decision to take her own life as she had the chance to form a bond with the baby, only for him to be ripped away from her. However, the baby went to a good home, and with his foster family vowing to keep the name he was born with, Bosch now has some more details to work with that may give Vance some of the answers he's after.

Summary: Bosch and Chandler's pursuit of Carl Rogers unexpectedly intersects with Russian organized crime. A chilling crime scene in Thai Town forces Maddie to face the limits of her job.



The episode begins with another hint at Chandler's state of mind following her shooting. When one of her gardeners spooks her as she's making breakfast, she's transported back to that morning when she was shot, but this time gets a round off first, taking out her hitman this time around.

Later that day, Chandler heads off to the prison where her would-be killer for hire has the pleasure of doing his time, and with the Bosch in tow, the two aim to get some answers as to who the person

was that Rogers got to that saw his whole case fall apart. She strong-arms him into revealing the person who contacted him — he doesn't provide a name but does reveal that it was a female lawyer who was working with the Russians. When she returns to her office and Marty hears about her methods deployed in order to obtain this information, he's not exactly thrilled but accepts it is what it is, and that is that it's something he has no control over whether he likes it or not.

After his visiting hours at the prison, Bosch hops back on the Vance case with right-hand man Mo, who manages to find a driver's license for a Dominick Santanello — the long-lost son they've been searching for all this time. However, when it's discovered that it was never renewed, Bosch has a horrible feeling that, like his biological mother, Dominick is no longer with us. His gut is right — when searching through The Wall of Faces, he discovers that Dominick was killed in action in Vietnam shortly before his 20th birthday. Not all is lost, however, as reading through the message board on his page reveals a possible close contact with a woman called Olivia who, when Bosch asks her to contact him, turns out to be Dominick's adopted sister and another avenue for him to investigate.

Meanwhile, Maddie and Vasquez are bonding over coffee, donuts, and Robert Rodriguez movies, and exchanging the stories behind why they decided to become cops. Before they can

get too heavy on details, a call comes through the radio for a reported rape. They attend, with Maddie assigned the job of working out how the suspect entered the property in order to commit his crime. When she goes slightly overboard in tagging the crime scene, however, she strays from her lane and becomes a slight irritant to the detective working the case. Over the coming days, the rape case is one that Maddie can't seem to shift, but to her own detriment as she reveals to Vasquez that she gave her details to the victim which could potentially jeopardize the whole case.

Bosch seeks to inform Vance of how his investigations are progressing. They meet away from Vance's house in the hope they might avoid listening ears. Disappointed that he's going to die without leaving the legacy he'd hoped for, Vance tasks Bosch with finding out whatever he can about Dominick as a person. As he leaves the meet, Bosch notices he's being tailed again but manages to lose the company men and head on to his next stop relatively undisturbed.

His next port of call is to follow Rogers into a meeting he has set up with the Russians. It emerges that Rogers owes them money that he doesn't have, and with the Russians understandably unhappy with the situation it looks like Rogers might be a new entry on the endangered species list very soon. They give him his orders and dismiss him from the meeting, and as he leaves, Bosch goes to follow. However, the heightened Russian security picks him up on their CCTV, which leads to a rooftop cat and mouse chase. Bosch escapes, but with his image plastered all over the recordings, the Russians now know his face and recognize him as a target.

Luckily Bosch has reason to leave town for a couple of nights after he arranges to meet with Dominick's sister Olivia. Fully aware that he is being watched from every angle, he decides to hire a car so that he's slightly less conspicuous. Unfortunately, the people following Bosch are a step ahead of him, and whilst he's been keeping an eye on the situation at ground level, he's neglected to consider the possibility that he may also be being followed by the eye in the sky, and so he doesn't leave town as stealthily as he thought.

Summary: As Bosch digs deeper into Whitney Vance's past, other powerful forces at play monitor his every move. Chandler defends a man in a case of wrongful arrest. Carl Rogers finds himself is forced to hatch a new scheme. Maddie wrestles with the emotional toll of her job.



The episode starts with Maddie on a run, but with a head clouded with flashbacks to when she took the statement from the previous episode's rape victim. It's something she simply cannot shift, no matter how hard she tries — it just doesn't sit right with her.

Chandler is well and truly out for blood as far as Carl Rogers is concerned. She's found a way she and Bosch might be able to apply pressure in the form of some dirt she's found on the son of Roger's right-hand man. She's also tak-

ing on another new case for the firm — one concerning a wrongful arrest that destroyed the life of the man at the center of everything.

Elsewhere, Bosch's meeting with Dominick's sister Olivia sheds some more light on who he was as a person. She shares some old photos with him and points him in the direction of some of his possessions that she's kept hold of over the years. Amongst everything, Bosch finds a camera and a roll of film that was never developed which could hold some more of Dominick's secrets. He takes it with him to see if anything can be done with the negatives as it looks like some of

the photos might be of a woman and child that Dominick had some connection to. Shortly after he leaves Olivia, she is visited by some representatives from the VA. Sensing something is off, she informs Bosch, who suspects these reps might be something to do with the crowd who have been following him around all this time.

Chandler heads to the Korean supermarket where her client stands accused of robbing at gunpoint. After speaking with the store owner and the two connecting over their similar shared experiences, she discovers that the store has CCTV which records everything that goes on at the tills and this was how the police identified her client as the guilty party in the robbery. Their facial recognition software matched him from their records to the CCTV footage, but completely ignored the fact that the man in the robbery video had very visible tattoos all up his arm — something that Chandler's client was severely lacking. This revelation leaves the investigating officer very red-faced, and the local police department with the knowledge that they have one hell of a mess to clean up. They offer an out-of-court settlement of \$1.2million in a bid to make the whole sorry mess go away, which Chandler's client is more than happy to accept because he can't afford to wait any longer for another result.

Still on a fierce winning streak, Chandler takes Bosch with her to serve papers to Rogers now that she has her civil case well underway, and with the Russians also aware of this development, tensions between them and Rogers ramp up. He is under even more pressure now to pay back the money he owes them, so his next move — whatever it is — has to be massive. He meets with some associates who he has tasked with helping him make up the funds to pay back the Russians, and the whole rendezvous is overseen by a couple of familiar faces — Crate and Barrel, who are happy to do a little bit of freelancing in their twilight years. After the meet, they follow Rogers to another location. They observe for a little while and note the comings and goings of a number of oil tankers, but what exactly they're up to isn't quite clear as much of the activity goes on behind closed doors.

It's clear that Bosch needs to get behind the scenes of whatever is going on with the tankers, so he, Chandler, and Crate and Barrel hatch a plan to do exactly that. Bosch stows away in the cab of one of the tankers, and once the coast is clear, he sneaks out. After creeping about in the shadows for a bit, Bosch lays eyes on a trapped door in one of the offices and is forced to go down into it when he has to find somewhere to hide quickly. Once below ground, he discovers he's been dropped down into a tunnel with a lot of pipework, which upon closer inspection reveals that Rogers' plan to repay his debts to the Russians is to steal fuel. He records his findings and forwards them to Chandler before making his way above ground to make his getaway. However, on his way out of the plant, he gets confronted by one of the security guards, and with nowhere to go, it looks like Bosch has once again found himself in a tighter spot than he'd like.

Summary:	The Whitney Vance story takes a surprise turn, complicating Bosch's investigation. Bosch and Chandler plot to turn the tables on Rogers. Maddie struggles with taking her job home with her.



Picking up where the previous episode's cliffhanger ending left off, we see Bosch somehow managing to talk his way out of getting caught by the security guard roped into Rogers' scheme to steal fuel. He masquerades as a security consultant, threatening to have the guard's job if he can't give him a good reason not to fire him whilst escorting him from the premises. Bosch makes it back to his getaway — reliably provided by Crate and Barrel — and heads back to base in time to fill Chandler in on his findings in more detail.

The next morning, Maddie and Vasquez pick up a pregnant homeless woman. Whilst Vasquez gets some food for her,

Maddie rings around local shelters in the hope that she may find one to take the woman in. Later on, when they are dropping the woman off at one of the shelters, she declines their help right outside the door. Once again, Maddie struggles with the notion that not everyone is going to accept the offer of help when they get it, feeling more like it is her mission to give help no matter what — something that by now looks to be a trait that's been passed on to her from her dad.

With the clock ticking on the Vance/Santanello case, Bosch is still chasing leads. He manages to track down one of Dominick's old Navy buddies, a man called Lewis. Bosch shows him the picture of a woman and child that was developed from the film he found in Dominick's old camera.

Lewis doesn't know all of the specifics about her but reveals that she was a photojournalist who interviewed Dominick for a story one time and it was love at first sight for him. As well as this, Bosch is hatching a plan with Mo to destroy the tunnel being used for siphoning the fuel. Mo is tasked with hacking into the frequency used to detonate the kill-switch explosives that have already been laid by Rogers' men so that when the time comes, all Bosch has to do is be in range and he can light the tunnel up.

With the boys working on their portion of the plan, Chandler is making headway in her area too. She has a meeting at the D.A.'s office where the two work to concoct a deal for Rogers — something that he will have no option but to accept when his stolen fuel-funded plan to pay back the Russians fails and he needs a safe space.

Back on the streets, Maddie gets a call from the rape victim she previously worked with. In typical fashion, she completely ignores Vasquez's advice to disengage, instead heading over to the victim's address and giving her opinion on some security measures she could take to help her feel safer in her own home again. Later, when catching up with her dad over lunch, Maddie runs her involvement in the case by her dad, saying that she cannot let it go no matter how hard she tries. He responds, saying it's up to her to decide what kind of cop she wants to be. However, before the two of them can get into it much further, a news bulletin reveals Whitney Vance — Bosch's client — has died.

Meanwhile, Chandler heads off to meet with Simon Wakefield, Rogers' right-hand man who was used as a pawn in order to obtain the info surrounding the fuel scam. After confirming that he would help in exchange for his son to escape an investigation of his own, he arranged a sit-down with Chandler to discuss the finer details of the heist being planned. However, before Chandler can have that conversation with him, Wakefield's chattiness is something that also has become common knowledge between Rogers and his Russian associates. When Chandler arrives at Wakefield's place, all she finds is a body floating face-down in the pool out back. However, she also finds his phone too, fishing it out and handing it to Mo to work his magic and hopefully provide the information that Wakefield himself would have done had he lived long enough to have the chance.

As it turns out, the fuel heist is due to go down that night. Bosch and Mo get in position to carry out their plan to bring the operation crashing down, but with Mo's signal interception not going quite according to plan, Bosch is forced to resort to Plan B.

Elsewhere, Chandler heads into a meeting with Rogers and his lawyer. Whilst she's going over what would be required from Rogers in regards to the civil suit she's actioned against him, his phone starts to buzz. He ignores it, and the two proceed once more, with Rogers not having a bar of what Chandler is proposing. However, when his phone rings again, Rogers answers it. It's his guys from the site of the fuel heist who explain how the place has just been blown to hell by Bosch and Mo. Rogers tries to play down the severity of the call in Chandler's presence, but she reveals her hand, telling Rogers that she knows exactly what that phone call was about and that it means he now has a choice to make; settle with her right now, and open himself up to the acceptance of the prosecution deal she set up in the event of this exact situation playing out, or leave the deal on the table and chance his luck with the Russians. Knowing that he is essentially a dead man walking in the eyes of the Russians at this point, Rogers takes the deal and is immediately whisked off to a safe house, but whether that will be enough to protect him from his enemies and himself remains to be seen.

Summary: Will Carl Rogers outmaneuver Bosch and Chandler and escape justice once again? Maddie Bosch faces every cop's biggest fear.



Following the deal they struck with Chandler at the end of the previous episode, Rogers' lawyer's first move as episode 6 opens is a late-night call with her to express his concerns that the prosecution deal she secured might fall through. Chandler assures him that it is all kosher, but that doesn't put his mind at ease. Immediately after the call finishes, he heads back inside the safe house where Rogers is now holed up and hands him a vial of white powder. It's later revealed that the powder is the main ingredient in facilitating Rogers' escape from the safe house, knocking his custodians out cold after he slips it into their coffee.

The reason for Rogers' escape is he has a shipping container already lined up and waiting for him to make his own way to Vietnam — a country with no extradition to the US and well away from the Russians who are even more eager to catch up with him than local law enforcement. They pay his girlfriend a visit, but she knows nothing, however, how much the Russians care about that is up for debate.

Meanwhile, Maddie and Chandler chat about what Rogers taking the deal means to them. Maddie makes it clear that she isn't thrilled that he got what she sees as an easier route as opposed to the full force of the law coming down upon him after his initial trial, but Chandler is keen to point out that for them, it could have been a whole lot worse. They revisit the day when

Chandler was shot, as they sit in the spot where Maddie was interviewed upon finding Chandler's body that fateful morning.

Back at his office, Bosch has some time on his hands again after the Vance/Santanello case came to something of a dead end. After reading about a supposed beef he has with a former colleague of his who was tasked with investigating the murder of the doctor stabbed to death at the start of episode 1, Bosch decides to do something proactive and try to figure out who really killed the doc if Jeffrey Herstadt didn't. However, this is put on hold after word gets to Chandler that Rogers left the safe house and is now on the run. She calls on Bosch and the two go to track down Rogers in either of the two possible locations they suspect he could be headed for, owing to the fact that the shipping container he has earmarked for his escape is being stored at one of them. Bosch rules out his location after finding out the container has already moved on from there, but when he informs Chandler she decides to wander for a while longer before heading back.

Whilst nosing about in one of the warehouses at her location, Chandler stumbles upon a container that fits the description of the one that she found blueprints for that led to her's and Bosch's knowledge of Rogers' escape plan in the first place. She takes a look around but heads for cover when the Russians arrive, having also learned of Rogers' exit plan. They sit and wait for Rogers' inevitable arrival, and when he does eventually turn up, they take him out once and for all, with Chandler bearing witness to everything. Later on, she and Bosch drink to the outcome but vow that this is knowledge that must forever remain between the two of them.

A new day dawns, and a new lead arises in Bosch's presumed-dead Vance/Santanello case. Tucked away in amongst all of this junk mail one morning, Bosch opens an envelope containing Vance's gold pen, plus a holographic will that makes Bosch executor of Vance's estate. He takes his findings to Chandler, who confirms that his next steps need to be confirming the validity of the will, plus safeguarding the document. With billions of dollars at stake, she makes clear that there isn't much that people who think they have a claim won't do in order to secure it, so urges Bosch to have as many insurance policies in place as possible.

Whilst Bosch is having a promising day of sorts, Maddie is having her hardest on the job yet. Paulina — one of her friends from the academy — is shot during a traffic stop. When the news comes through at the police station, Maddie gets ready to head to the scene but is instead given the job of informing Paulina's family following the shooting. She finds this out just as the news breaks city-wide that a rookie female officer has been shot, news that reaches her dad immediately. As soon as he hears the report, he gets straight on the phone with Maddie and is relieved when she picks up. She fills him in on what she knows and then reveals where she's headed next, saying she doesn't know how to break the news. He tells her that somehow she'll find the words, and the two leave it there, with Bosch taken back to the day when he had to tell Maddie that her mum, Eleanor, had been killed.

That night, Maddie heads over to her dad's office, and the two talk it through, with Maddie pressing him for information about what it's like to get shot given his own experience. Bosch reluctantly tells his story, and it's a sobering one for Maddie to hear, but she takes some comfort in hearing that the person who saved him was her mum and that that was how the two of them met.

Later that night, Bosch heads out to take care of something. He's waiting beside one of the main roads into the city when a car pulls up and none other than J. Edgar steps out. The pair catch up briefly, before Bosch hands Jerry the envelope containing Vance's will to put in evidence for safekeeping. The pair part company again, leaving Bosch to contemplate the events of the day by himself.

Summary:	Bosch takes up a murder case once thought solved by the LAPD. Maddie's pulled into the department's pursuit of a cop shooter. Chandler wrestles with the fallout of Carl Rogers.



After Paulina's shooting in the previous episode, we kick off with a briefing room get-together for all of the officers assigned to the case to catch the suspect, James Sharp. It's an incident that the entire department is still reeling from, Maddie especially given her friendship with Paulina and, of course, her own history with gun crime.

Meanwhile, in Chandler attends another therapy session, and it becomes clear that she's struggling to come to terms with her attack even more now that

Carl Rogers is dead. He was something for her to channel her feelings about it all towards, and now, with him no longer in the picture, it's like they have nowhere to go. She's worried that without that focus, she's reached the end of the road as far as her own recovery is concerned and that she'll never again be the same person that she was prior to the shooting.

Of course, the Carl Rogers case isn't entirely closed. There are still a few loose ends in the shape of his hired gun Datz and the Russians, who are still lingering on the outskirts of a bigger picture that Rogers was a small part of. They know that Datz has been talking to Chandler and Bosch, and as such, the hitman is a leak that they need to fix. Datz dies on the receiving end of a prison shiv, and given the heavy-handed methods Chandler used in order to obtain information from him about Rogers' fuel pipeline plans, she immediately comes under suspicion for the hit.

As the news of Datz's demise gets back to Chandler, Bosch is back on the ground trying to get to the bottom of who stabbed Dr. Basu in order to bury the beef Gustafason has with him about Jeffrey Herstadt walking free. He speaks with one of his former mentees in order to try and gain an insight into the kind of man Basu was in a bid to work out who might have had a motive to kill him. As he leaves, Bosch bumps into the detective with an axe to grind, who threatens to arrest Bosch if he doesn't stop digging into the Basu case, which is like showing a red rag to a bull, and naturally Bosch continues his pursuit for the real killer.

Elsewhere, Maddie and Vasquez are on the beat, grabbing coffee and donuts when a call about an attempted rape in Thai town comes over the radio. Vasquez doesn't take the call, but agrees with Maddie that they should compare notes with the attending officers later on, which reveals details that suggest this report is related to the rape case they attended a few weeks ago.

Like a dog with a bone, Bosch continues to follow up with everyone known to be connected in some way or another to the Basu case. He speaks with a witness who was questioned the night of the murder, and learns that some of what he told the investigating officer — Gustafason — was left out of the official report.

Also being questioned by this point is Chandler, who is treated to a visit by the FBI who know about her links to Datz and the potential connection to his murder. The particularly pointed questions get Chandler's back up, as they relate to information that was supposed to be privileged. She gives Bosch the heads up that he could be next on their interview list, and she's not wrong. They catch up with him pretty quickly, and being his usual diplomatic self, Bosch earns himself a trip in their car for a more formal conversation.

Meanwhile, it emerges that James Sharp is on the run with his girlfriend and they are in desperate need of money. This provides the police with an opportunity to set up a trap in order to catch Sharp and ensure he's punished for shooting Paulina. Around the same time that this scheme is being put together, Maddie is contacted by the original rape victim who is after some updates on how her case is coming along as she's heard nothing from the investigative team. Maddie slips up when she says something that suggests Paulina's shooting has been prioritised over all crimes against civilians — something which could come back on her later.

With the FBI circling, Chandler is desperate to find a lead that points the finger of suspicion away from her in the Datz murder. After speaking with the client she is suspected of contacting about ordering the hit, it is revealed that the rumour circulating on the inside is it was the Russians who took out Datz because they knew that he was in conversation with Chandler — a development that is certainly cause for mild concern for her at the very least.

After being released by the FBI, Bosch gets a call from Dominick Santanello's Navy buddy who has managed to remember the name of the newspaper that Nick's girlfriend worked for, giving Bosch something new to work on in relation to identifying her. He heads to the main office to trawl through their archives in the hope that he might find a name, which he does — Gabriela Lida. However, before making this move, Bosch is also paid a visit by police who seem to be on payroll at Vance Engineering owing to how obstructive they're hoping to be. Luckily, Bosch smells a rat and spins them a line that forces them to shift their eyeballs elsewhere for now.

Now with a name to work with, Bosch tracks down Nick's girlfriend, who tells him the story behind that beach photo that he pulled from the camera he found at his sister's house. He learns that Gabriela never got in touch with the Santanello family as she feared they would try to take her daughter from her. When he asks where her daughter is now, Gabriela reveals that she — Vibiana — lives in the nearby arts district with her son. She agrees to take Bosch to them another time so that they can talk about his reasons for reaching out — something which he has not yet revealed. He leaves Gabriela to it for now, not knowing that the whole liaison was being watched very carefully by Vance's head of security, Sloan.

Finally, the day has come for the trap to take down Sharp to be put into action. Maddie and Vasquez are put into position in the event that a car chase ensues, and it does when the drop doesn't go down quite as everyone had hoped. The chase comes to an abrupt end when Sharp crashes, and when Sharp appears to pull a gun, a shootout of sorts follows, resulting in both Sharp and his girlfriend getting killed — another outcome that Maddie finds hard to stomach.

Summary: As the Vance case enters a new phase, Bosch faces an escalating threat. A controversial police shooting ensnares both Maddie and Chandler.



The episode kicks off with a flashback to the time when Bosch himself was on a mission to track down his own father. The Vance/Santanello case has always struck a chord with him due to his past, and being so close to solving the mystery of who Vance's estate should pass to now is bringing it all home again for him.

Meanwhile, reverberations are still being felt following the Sharp shootout towards the end of episode 7. Everyone who was at the scene is being individually briefed by LAPD lawyers, Maddie in-

cluded. When her turn comes around, Maddie gets a whirlwind guide on how to answer any questions she may get asked as part of the investigation, with the overall gist being to say only what she could see and not allow any room for speculation. The whole exchange has a very odd feel to it, but is accepted as just the way things are for the time being.

On the other side of the shooting, lawyers are queuing up for represent Nicole Davis' family in a wrongful death suit against the LAPD. When Chandler hears about the possibility of a civil suit, she's determined to win the Davis family as her next client. When she and Marty head over to the household to put their case to the family, they quickly learn that a Detective Morrison was quite heavily involved with them, to the point his conduct could be questioned. Although reluctant to make any moves, Chandler puts forward a compelling argument and before they leave, she and Marty manage to secure the Davis' family as a client.

Away from the fallout following the shooting, Bosch is on his way to meet Gabriela so that she can introduce him to her daughter and grandson. He arrives in less conventional fashion than you'd expect, owing to his attempts to be covert and sneak past all of the eyeballs that have hardly moved off of him since Vance passed away. Gabriela's daughter Vibiana isn't too receptive to the idea that her biological grandfather was so desperate to seek her out at first, but her belligerence turns to shock when she learns that if a DNA link can be made she would be owed an inheritance worth billions. Of course, this is all dependent on Bosch moving quicker than the contractors working on behalf of the board of Vance Engineering, who are keen to remove all possible heirs from the picture so as to protect their position within the company.

Also keeping Bosch busy is his exploration of the Basu murder. After paying his surviving wife and daughter a visit, he learns that Basu was in conversation with the medical board about over-prescribing medication — another detail conveniently left out of the investigation record. Quite what it means in the grand scheme of things, Bosch doesn't jump to any conclusions just yet, but he doesn't just let it slide either.

Back at the station, Maddie makes plans with fellow rookie Perez to go and visit Paulina after their shift that evening. Whilst the two of them are there, a press conference that Chandler gave earlier that day airs on the news, revealing to Maddie that she is representing the Davis family in their civil suit against the LAPD. Knowing that she could basically be going head to head with her former mentor and someone who she has come to hugely admire causes Maddie some internal conflict, evident in how quickly she turns the news bulletin off.

Later that night, Perez drops Maddie home, where she invites him in and the two spend the night together. She and Vasquez catch up the next day and Maddie lets slip about the night before, but before the two of them can get into the details, Maddie spots something shady. They pull over to go and investigate, and catch a peeping tom in the act — someone the department believes to be connected in some way to the events that have been unfolding in Thai town recently. It's a big win for the department, and for Maddie too, who receives a lot of credit for the take down.

Meanwhile, back with the Davis civil suit, Chandler is building her case and uncovering a lot of potential dirt that could result in a big pay day for the family. She has Mo doing some technical reconnaissance which, if the back alley meetings that Detective Morrison is having with SAS officers is anything to go by, will definitely bring something to the surface that will be beneficial to the civil suit.

Before episode 8 draws to a close, the story moves to a tactical training facility somewhere. There, a woman who is clearly very adept with firearms, is going through the motions, shooting at targets and not missing a single one. From the shadows, the man in charge of Vance Engineering's efforts to shut down any claims to the Vance estate emerges, and gives the woman her next assignment — Bosch.

Summary:	The truth behind Whitney Vance's death finally comes to light. Maddie helps with a major break in the Screen Cutter case. Chandler builds her best case against the LAPD.



The episode opens with Vance Engineering's hired gun creeping around Bosch's office whilst he's out walking the dog. She's gathering intel, trying to find out a way to access Vibiana and her son so as to eliminate them from the claim for the Vance estate. Bosch returns before she is done, and the pair briefly cross paths but he doesn't realise due to her cleaner's disguise. As soon as he steps into his office, however, he can smell perfume that tells him someone has been in, and as he looks around he sees the woman hastily

leaving.

Whilst Chandler personally delivers their heirs' DNA samples to a lab, Bosch continues on with confirming the authenticity of the holographic will that was delivered to him on Vance's instruction before he passed. He heads to his secretary Aida's house in order to persuade her to testify to the fact that she put the will in the mail to Bosch. She is hesitant at first, but when Bosch reveals that she is down to receive \$10million if the document he has can be confirmed as Vance's last will in testament, she soon comes around to the idea.

Meanwhile, Chandler is working on the Davis wrongful death case. Gathering evidence is going well for her so far, with Mo digging up all of the video footage that could provide a 360-degree view of the shooting as it went down. Also lined up is a meeting with a lawyer from a previous

case against SIS, although that doesn't prove to be as helpful as Chandler had perhaps hoped it would be owing the fact that the defendants have a habit of coordinating their testimonies in these cases.

Following on from the break in the Thai town case last week, Maddie and Vasquez — along with the rest of the local beat cops — are being briefed on the developments and appropriate follow-ups. Vasquez is handed the lead on the case as everyone prepares to hit the streets in order to find more evidence that might lead them to identifying the screen-door cutter who was the perpetrator in the first rape case. It leads to Maddie and Vasquez rifling through trash cans in the hope that they might find something, which they do — the luchadore mask used in the crimes no less. As the one who finds it, the discovery earns Maddie some more brownie points, and also gives her something that she can update the first rape victim with.

Back with Bosch, Mo uncovers all of the prescription records relating to the Basu murder. He easily identifies the doctor guilty of dishing out the most opioid prescriptions, as highlighted by Basu himself, but when Bosch pays some of his patients a visit, it becomes clear that the drugs prescribed aren't actually reaching them.

Meanwhile, the local detectives sniffing around the Vance case parallel to Bosch return after finished the will goose chase he sent them on the last time they spoke. However, they are slightly less hostile on this occasion, owing to the fact that they now think that Whitney Vance may actually have been murdered as opposed to dying of natural causes. After sharing their evidence files with Bosch, he spots a few things that cause him to question the legitimacy of the holographic will he was sent. After piecing together a theory, he heads back to Aida's house with Chandler, with the affidavit for her to sign, however once it is signed, Bosch can do a direct comparison between that document and the will and his theory that Aida was the one who wrote that will is confirmed. When Bosch and Chandler probe her on the matter, Aida confesses to taking it upon herself to add \$10million for herself, and also smothering Vance when he didn't die as she had expected he would. Having done the work for the local detectives, Bosch allows them to swoop in and arrest Aida, who goes quietly, not that she had much choice.

With the Davis case ticking along, it looks like the net might be closing in on Detective Morrison, whose own morality is also starting to catch up with him. He pays a visit to Nicole's mother, who points out to him that he made promises that he didn't keep and that is why her daughter is now dead. This leads to him making the decision later on to cooperate with the investigation into the shooting as opposed to helping to cover it up.

After a successful day on the ground gathering evidence and making that phenomenal discovery concerning the mask, Maddie is getting ready to head home after her shift when she receives a call. Whilst they were out in the neighbourhood, she found a building inspection notice with a contact number on, and it is that person returning her call. However, as it is revealed who is on the other end of the phone, it seems like that inspection notice might have been bait, as the man she is speaking to is actively searching for Maddie online.

Despite their best attempts (including burning down the first lab that the DNA evidence was submitted to), the board over at Vance Engineering didn't manage to stop the confirmation of heirs to Vance's estate. However, this only fuels their determination to track down Vibiana and remove her and her son from the picture. Late one night, Bosch gets a call from Vibiana to say that she feels like there is something off about a message she received from Sloan; that he wanted to come up and do a security check despite having already done one that evening. Bosch agrees that something about it doesn't seem right, and tells Vibiana she must leave immediately. He races over, but can he get to her before Vance Engineering's people do?

Summary: Bosch reaches a dangerous end game in the Vance case. Chandler courts an unlikely ally in her wrongful death suit. Maddie pays the cost of getting too involved with her work.



Picking up in exactly the same place the previous episode 9 left off, we start with Bosch racing to Vibiana's location after getting a call that makes him extremely worried for her safety. When he gets to her apartment building, he gets to work on setting up a few distractions that will hopefully enable him to get her and her boy out of the building and away to safety without bringing them face to face with the woman sent to kill them both. It's an objective he just about manages to achieve, with the three of them driving off

and leaving the assassin looking on from the top of the building.

With the Davis case now starting to build, Chandler has a meeting with the judge who has been assigned the case, where she is arguing for access to the bodycam footage of all the officers at the scene of the shooting. Her request is granted, and alongside the footage that she has Mo gathering her, Chandler has an angle of almost every second of the shooting as it played out.

Back on the streets, Maddie and Vasquez are grabbing lunch. Whilst they are doing that, Maddie's mystery caller from the previous episode miraculously turns up, but before the encounter has much chance to develop, reports of a shooting come over the radio and the two of them respond to the call. When they get to the scene and check out what's going on there, they find a man who has been shot and is dying from his wounds. It's a hard scene for Maddie to take in, and is another milestone in her early career.

Meanwhile, Bosch is catching up with Mo when he finds out that he is also helping Chandler with the Davis case which, given Maddie's involvement, is not something he is very happy about, and something that he later locks horns with Chandler on. However, he also gets his tech whizz

to review the footage from Vibiana's apartment the night before, and manages to get a glimpse of the assassin sent there to kill her. He also sees David Sloan being executed by her in the moments before he received the call from Vibiana to say she suspected something was up. This tips Bosch over the edge, and he heads off to pay Vance Engineering's heavies a visit so that he can tie up this saga once and for all. After deploying some interrogation techniques he learnt during his time in Afghanistan, Bosch learns who the woman is and that there is no way she will pull out of the contract at this point. In order to stop her, he must go after her himself.

Armed with all of the body cam footage, Chandler heads out to confront Detective Morrison in the hopes of recruiting him as part of her side in the Davis case. She reveals to him that she knows the gun that was the reason for the cops opening fire was planted after the bullets had let rip, which presents him with another dilemma — does he want to be with Chandler, or against her? Given the fact he's already supporting the police investigation into the shooting, plus his own guilt about what went down, Morrison agrees to do the right thing and support Chandler's case.

Elsewhere, Bosch is fighting his own good fight and gearing up to go after the assassin sent to kill Vibiana and her son. After drawing her out to a bakehouse where she believes her targets to be hiding, a cat and mouse chase utilising all of the resources he has to hand ensues. The killer is eventually lured into one of the bedrooms where Bosch catches up with her. There is a brief shootout, but it is Bosch who comes out on top. With the coast clear and Vibiana and her son now safe again for the first time in weeks, Bosch takes them home, with his parting wisdom being to do something good with their newfound riches.

Bosch is later joined by Maddie for one of their usual catch-ups. She shares the fear she feels when she tries to contact him but gets no answer — something that was a very real theme whilst he went dark in his attempts to take down the would-be assassin. Maddie confides that she's struggling with some of the heavier stuff she sees on an almost daily basis in her job despite her best efforts to block it out, after which she heads home. There is the distinct feeling that she is being watched, and as she gets ready to take a shower, it is revealed that someone wearing a luchadore mask identical to the one Maddie dug out of the rubbish a few days before is hiding in the closet, clearly getting ready to make a move.

Meanwhile, Bosch heads off to the homecoming party/art exhibition hosted by Vibiana. He had arranged to meet Maddie there, but after waiting around for her, and also getting no response to his call, he heads over to her house. With no answer at the front door either, he kicks it in to find the house empty, with one particularly disturbing detail to note — her screen-door has been slashed.

Summary:	Maddie's gone missing, and it's all hands on deck to find her. Bosch allies with Chandler, Mo, and an old friend in a race against the clock to save his daughter's life.



The episode kicks off with Maddie Bosch returning home to be surprised by the "screen cutter rapist". Although out-matched and surprised in her bedroom, she doesn't go easy. With Maddie chloroformed, Kurt Dockweiler uses the opportunity to remove the mask and marvel at her. Seconds later he's shown loading a body-sized suitcase in the back of his truck.

Harry Bosch reels in Maddie's living room as the investigators bag evidence, photo the scene, and collect fingerprints.

Regaining his composure, he realizes he's being questioned by Detective Bennett. He can't provide much, claiming that Maddie kept her personal life very personal. Detective Jerry Edgar returns from questioning the neighbor but doesn't have much to offer. Pulling Harry to the side, Edgar assures him they are utilizing every resource available while also confirming that RHD Captain Rick Seals has agreed to keep him in the loop.

Meeting with Seals in the mobile unit stationed outside Maddie's complex, Harry becomes hostile when Seals is reluctant to let him get involved in the case for fear that it could lead to a missed conviction. Harry is urged to go home and wait by the phone in the event of a ransom call.

He does leave in his Jeep but calls Maurice "Mo" Bassi to see if he can get into Maddie's bank account and track her debit card. When Mo asks for her account information and tells Harry it might take a while, Harry also asks him to scour her social media and phone activity as well. After they hang up, a distracted Harry runs a red light and barely avoids getting T-boned.

While searching Maddie's locker for clues, Edgar and Sergeant John Mankiewicz "Mank" come across her patrol book. Using the book, Edgar learns that Maddie and Reina Vasquez had been putting in a lot of extra leg work on the screen cutter case. He calls Vasquez in to rehash some of the interviews.

Elsewhere, Harry uses his own little black book to reach out to contacts. The only luck he seems to have is with Sergeant Mank, who promises to relay updates. Just as he's wrapping up, Harry receives a call from Coroner Ernie Munger, informing him they just received a body with blunt force trauma matching Maddie's description. When Harry learns that the body was found on an exit ramp on the 5 in East LA, he makes Ernie promise to give him the first look. Ernie assures him he hasn't even notified RHD yet.

At detective headquarters, Edgar checks on Detectives Brad Conniff and Julie Espinosa's progress with the complex's surveillance footage. Julie explains that most of the tenants had Ring door cams, but they only targeted the porches, not the street. When asked to expand their canvassing to a 3-block radius, Brad expresses his frustration over not having a proper description of the attacker or vehicle. Edgar encourages them to note anything suspicious before leaving.

Harry is an emotional wreck before and after visiting the morgue, although the body isn't Maddie. Using the opportunity to check on Mo's progress, Harry learns of several calls from a burner and Honey Chandler, all within the last week. Visiting Chandler, he uncovers that she didn't just call Maddie, she visited her. During that visit, she did take note of a suspicious man smoking in the courtyard, although she wrote him off as a tenant at the time. Harry relays the information to Edgar and suggests setting up a visit with a sketch artist.

Along a deserted stretch of desert highway, Kurt the screen cutter is shown pulling off and giving Maddie a syringe full of sedative.

Elsewhere, Vasquez walks Harry through the alley where Maddie found Kurt's mask in season 1. There are cameras all around, but none of them work. Vasquez also tells Harry that she all but begged Maddie to drop the case. Harry says Maddie just couldn't let it go that easy while assuring Vasquez she isn't responsible. Continuing to canvass, Harry discovers a city inspector's citation zip-tied to a chain-linked fence. Vasquez says Maddie noticed it as well.

Chandler meets with the artist while Edgar digs into footage from Maddie's shifts. Most appear to be random traffic stops and routine foot patrols.

From a desert carwash, Kurt reaches out to his cop buddy, Pete Fusco to learn that no witnesses have come forward. After ending the call, Kurt is shown using his debit/credit card to wash out the back of his truck which is now empty of the suitcase Maddie was being held in.

Edgar pays another visit to Espinosa and Conniff who have found three suspicious vehicles that popped multiple times within the last week near the area where the mask was found. They've already managed to track down the registration information that revealed two were residents and one was a visitor. Espinosa also mentions a truck registered to the city, but the footage didn't provide enough details to ID the employee. Edgar and Bennett end up linking the truck to Kurt and visit his house. Although he's not home, Edgar procures a cigarette butt from the ashtray on the front porch. When asked, he tells Bennett that the victims all reported smelling smoke on the attacker. At Maddie's apartment, Harry studies the left behind evidence from the struggle while possibly seeking comfort or answers in some of her photos and belongings. Kurt is shown seemingly preparing for some event as he irons a suit and takes a shower. Bennett delivers the newly finished sketch to Edgar. He immediately recognizes the man from Maddie's body cam footage. Seconds later at Chandler's home, she confirms Kurt's identity as the man in Maddie's courtyard. Although Edgar wants to wait for a search warrant that should only take an hour, Harry pries Kurt's address out of him.

Harry arrives at Kurt's just as he's putting the finishing touches on his ensemble. Kurt goes for a gun stored in a bedside safe but uses a boot in a dryer to make a clean escape. Harry's search of Kurt's personal belongings doesn't appear to reveal anything useful. There is one photo of Kurt as a toddler, however, that does draw his interest. He later also finds a thorn or debris embedded in the bathroom mat before being warned away from the scene by Edgar. Kurt pays a visit to the Hollywood section of the Los Angeles Police Department and confesses to knowing where Maddie is. He won't reveal anything further until speaking with his attorney who is supposed to be on his way.

Having learned about Kurt's confession from Edgar, Harry arrives at the station looking for answers but is headed off by Mank in the parking lot. Edgar soon joins and updates them about Kurt's claims.

As she regains consciousness, Maddie is revealed to be handcuffed and buried somewhere in the desert. The episode wraps with her banging and pleading for help.

Summary:	The Screen Cutter attempts to bargain with Bosch and Chandler, who go to extremes to locate Maddie before it's too late.



The episode opens with revealing Maddie Bosch to still be buried alive in the desert. Kurt Dockweiler meets with his attorney, James Rafferty, who leaves less than enthused over his unwillingness to share details. What little Kurt shared is revealed when James is all but accosted by District Attorney Emmett Archer in the corridor. After going back and back between plea deals and sentences, James urges Archer to not waste time because Kurt claims Maddie's is limited.

Outside the Hollywood Station, Detective Jerry Edgar does his best to calm a frantic Harry Bosch who wants to question Kurt. Edgar's reminders of following protocol and that Maddie is extremely resourceful do little to soothe Harry, although he does stand down for the moment. Their conversation is wrapped up with Harry reminding Edgar of the foxtail and dirt he found in Kurt's bathroom mat. Once alone, Harry phones someone and tells them to drop everything he needs them.

Back with Kurt, James shares what he learned from the DA. Kurt claims to not have a problem with providing proof. He, however, wants the deal in writing before he does so. Throughout the discussion, Kurt continually reminds James that he's in control and struck first for a reason. Kurt also makes it known that the cops will not find Maddie without his help.

Calmly assessing her situation, Maddie finds a bottle of water and what appears to be a camera mounted on the underside of the coffin lid.

Harry's earlier call is revealed to have been to Barrel and Crate, as they tail him from the precinct's parking lot.

At a face-to-face meeting with, Maurice "Mo" Bassi Harry learns that Kurt was smart enough to wipe his hard drive and Cloud account. Mo does manage to learn that Kurt was searching for mild sedatives that would put someone out for 4 to 6 hours. This only troubles Harry and he even accuses Kurt of leaving the information behind as a tease. All of a sudden, Mo's computer begins frantically pinging and he appears troubled by what he sees on the screen. Joining him behind the monitors, Mo explains how breaching Kurt's Cloud account triggered an action to send a live



video link (labeled Madeline Bosch) to LAPD and local media outlets. Mo quickly learns that the signal is being routed through an untraceable dark web server.

Sergeant John "Mank" Mankiewicz and Rico Perez along with other officers gather to watch the latest updates about the released video. Seeing the news, Honey Chandler reaches out to Harry and leaves a voicemail offering her condolences and help. Joining Edgar in his office, he and RHD Captain Rick Seals debate who and where the video came from. Seals appears to doubt the video came from Kurt, while Edgar believes it to be an attempt to apply pressure. Once alone, Edgar phones Harry to update him on the lab report from Kurt's bathroom but has to leave a voicemail. This is because Harry is right outside putting together an elaborate ruse to get some alone time with Kurt. He does so by phoning front desk Officer Onaki under the guise of Detective Baston and ordering him to return Kurt to the interview room for another DNA swabbing. Before Harry is shown sneaking into the interview room, Maddie manages to use part of her shirt or coat to pick the lock on the handcuffs. Although he gets physical with Kurt, all Harry learns is that he's familiar with his career and police procedure. Edgar soon arrives and talks Harry down while also sharing the lab reports. High levels of salt along with calcite, gypsum, and borax lead Harry to suspect Kurt was in the desert. Harry calls and requests a meeting with Mo.

Feeling helpless as they watch Maddie's video feed, Reina Vasquez and Perez debate about what they can do. Unfortunately, Perez is still on to clock but Vasquez isn't and seems to have a plan in mind. Maddie is now free of her cuffs but starts to panic as her pleas for help go unanswered. Recalling new details from the memory of the attack and ensuing trip into the desert seems to reinvigorate her. As the scene fades, she's shown using the cuffs to carve something into the wooden surface of the coffin.

Mo is already at Harry's office and monitoring Maddie's video feed when Vasquez shows up eager to help. After getting acquainted and being invited in, Vasquez figures out that Maddie has averted her hands and face from the camera so that she can hide her movements. Mo had assumed she was crying. On the phone with Chandler, she and Harry debate why Kurt would hire an out-of-town lawyer who specializes in child welfare cases. Ending the call, he suggests she get in touch with Crate and Barrel who are still tailing James. She reminds him that Maddie is a survivor before hanging up.

When Maddie tires herself out and flips back over to rest, a scorpion is shown making its way into the coffin through the exposed ventilation pipe. Arriving at his office and finding Vasquez, Harry assumes the worst and asks what's happened. Instead, they have good news and reveal that Maddie has managed to carve the letters, "EDW" into the coffin. Harry assumes that it means Edwards Air Force Base and suggests that Maddie might have seen a jet. If they can get the flight log, they might be able to narrow down her location. Harry also asks how Mo is doing with his other problem and he gives him a small envelope which Harry takes and leaves.

Maddie soon realizes she has a deadly visitor in the form of a scorpion but manages to remain completely still as it climbs up her body. Biding her time, she eventually uses the sharp hook end of the handcuffs to kill it. While doing so she dislodges the ventilation pipe and sand starts sifting into the coffin.

Crate and Barrel watch from the second floor of a hotel bar as Chandler introduces herself to James. She immediately lets him know that she will hold him responsible if anything should happen to Maddie. When he claims he wants her back as much as anyone else, she sarcastically says she can see how hard he's working to get her back. Harry is shown getting on the elevator as Chandler attempts to pry more information about Kurt and James' relationship. James claims him to be a client. Harry uses Mo's package (keycard) to access James' room. As Harry goes through what appears to be adoption papers, James claims to have been acquainted with Kurt since he was a minor. Harry uncovers an article about an old cult (The Order of Tranquility) and a map before he receives word from Chandler that James is on his way back to the room. Harry is still in the room when James arrives and has to hide behind the bed. James' trip to the bathroom provides Harry with the opportunity he needs to escape, undetected.

As Chandler and Harry make their escape, he phones Mo to update them both about Kurt's court records. He says that Kurt used to be Adam White and was raised as part of a religious cult in the desert. It was allegations of physical and sexual abuse that got him into the system and ultimately turned him into a rapist. Harry suspects that Maddie is being held somewhere near the cult's old compound (Zzyzk in the Mojave Desert). Mo uses the map Harry forwarded to him and cross-references it with the training log from Edward's Airforce Base to narrow down



potential locations, while Chandler promises to get them a flight. Seconds later, they are being airlifted into the desert near what little is left of the compound.

While Harry and Chandler split up to search, Edgar has a sit down with Kurt. Noticing the refreshments, Kurt sarcastically asks if he's trying to play good cop. Edgar says he hopes they lock him away but understands it's just a matter of time before the DA gives Kurt whatever he wants. Kurt claims to not be afraid of going to prison. He just doesn't want to go as a labeled sex offender. Chandler finds and points out newer solar panels on the roof of one of the buildings. They soon learn a laptop inside is hosting the signal to Maddie's video. After a bit of back and forth in the interrogation, Kurt drops enough hints to lead Edgar to suspect that Maddie has been buried alive. He feigns a call and goes outside to relay his discovery to Harry, who uses the information to find high ground and look for clues. He not only discovers the ventilation pipe, but he sees that it's moving. As he rushes to get a shovel, Chandler phones the pilot with the news. Not being very deep, it doesn't take Harry long to dig Maddie out.

Sometime later, Maddie is shown recovering in the hospital as Harry keeps a close watch. Edgar arrives shortly and they share a few words outside her room where Harry thanks him for everything he did. While leaving the hospital together, Harry surprises Maddie with news about an Airbnb he's booked for her. Just as she claims to be happy with a long shower and a good night's rest, Sam delivers another surprise in the form of Coltrane. Sam tells Maddie it's good to have her home as the episode wraps.

Summary:	Chandler enlists Bosch to defend a man accused of a brutal crime. Back on the job, Maddie struggles to find her footing. The FBI sets its sights on Bosch and Chandler.



The episode opens with Vince Harrick and Lexi Parks unloading groceries in their kitchen. Vince appears to be in a rush as he mentions his night shift at the Sheriff's station. When she jokes about them being two passing ships in the night, he says he'll be home by 7 to start the omelets if she'll make the coffee. When he returns the next morning, he discovers Lexi brutally bludgeoned with a pillow over her face in their bedroom.

4 months later, Maddie Bosch is shown swimming laps at what appears to

be a community pool. After tiring herself out, she uses a weighted belt to hold and time herself to the floor of the pool. She's nearing a minute and a half when he resurfaces.

Against the advice of his Contractor, Harry Bosch decides he'll finish the last of the restoration on his home. Although Maximo wishes him luck, he warns that the city has become critical about enforcing residential housing codes. Maddie arrives to learn about Harry's plans and quickly voices her concern about the repairs never getting finished. When the discussion leads to dinner, Maddie says she might already have plans.

Elsewhere, two detectives arrest a man named David Foster for the murder of Lexi Park. He proclaims his innocence as he's dragged away, and tells his wife, Louise Foster to call Honey

Chandler. Arriving at work later that day, Chandler learns about David's arrest from associate, Marty Rose.

At the police station, Maddie discusses her problems sleeping with her former training officer, Reina Vasquez. Vasquez suggests getting her own place will do the trick and points out how affordable Boyle Heights is. Maddie claims the commute would be too much before asking about Vasquez's new position with Hollywood's Crime Reduction Unit. Vasquez loves it and encourages Maddie to keep her head up because it's just a matter of time before she gets back on the streets. After they part company, Maddie encounters Rico Perez who jokingly warns her of the dangers of paper cuts before confirming they are still on for a later meeting.

Matthew Ramirez informs Chandler about the arrival of FBI agents, Sylvia James and Lucas Jones. They want to discuss what she and Bosh were doing near the Long Island port on the day that Carl Rogers' and Glen Keating's bodies were shipped to Ho Chi Minh City. Chandler doesn't reveal any information and they issue her a legal order to not destroy any documentation, files, or communications linked to the case. Harry claims to not be concerned when she shares the news with him at dinner. He does point out the crucial mistake she made by running to him. She realizes the slip and apologizes. He adds that he'll warn Crate and Barrel before encouraging her not to feel guilty because he doesn't.

Harry visits Maurice "Mo" Bassi and asks him to monitor Ramirez and Marty's correspondences for fear that they might be cooperating with the FBI. Harry also reminds him that his freedom is on the line as well.

While working at the front desk, Maddie helps a pushy Tina Cooper file a stolen property report for a \$35,000 bracelet. She claims to have carelessly left it in her purse on the passenger seat while making a return that should have only taken a few minutes. Tina adds that her insurance company is the only reason she's filing the report. Maddie later asks desk sergeant, John Enochty if she can personally deliver the report. He agrees, but the pawnshop detective informs her that it usually takes at least a month before they start receiving reports of stolen items. Maddie later visits the store where Tina made the return and confirms Tina's story. She also notes a Tesla parked in front of Tina's vehicle and the getaway Jeep that pulls up in the street. Harry meets with and warns Crate and Barrel that they might be subpoenaed for their role in the Carl Rogers incident. They assure him there is no need to worry because they are now retired and don't need to worry about protecting their reputations. If it comes to it, they claim they'll plead the fifth.

At a meeting with David, Chandler tells him the cops claim to have evidence linking him to the crime. He says that's impossible because he didn't even know Lexi. After some awkward hesitation, he claims to have been with his wife on the night of the murder.

Harry returns to Mo and learns of an e-mail on the law firm's server so heavily encrypted, he couldn't access it. He could access the attachment, which is revealed to be the schematics for a shipping container. He couldn't confirm who sent it.

Maddie meets with the owner of the Tesla and gets authorization to view the vehicle's built-in camera footage. At the courthouse, without objections from the DDA Brad Landreth, Chandler gets Judge Newland to postpone the arraignment until after discovery. Meeting with Landreth privately, he assures Chandler that discovery will be completed by the end of the day. He also warns her that they have undisputable DNA evidence linking David to the scene.

Chandler shares the news with Rose as he's leaving their offices. He agrees it isn't good news but claims David's use of his wife as an alibi might be worse. Chandler jokingly says at least it's not his mother. Mo is shown following him home, while Harry tails Ramirez to a local restaurant where he meets with the FBI. When Mo checks in, Harry orders him to the restaurant to take up surveillance.

Maddie has drinks with Paulina Calderon, who still hasn't returned to the job after being shot. Maddie shares information about the robbery case and how good it feels to be doing something.

Harry enjoys a drink of his own while reviewing Mo's surveillance photos of Matthews meeting with the FBI. He attempts to reach Maddie who doesn't answer because she's in bed with Rico. The next day Harry shares Matthews' betrayal with Chandler. She first considers firing him but then decides to feed him bad information to mislead the feds. She also unveils her plan to bring Harry on as an investigator on the Lexi Park case to make their meetings legitimate.

When Maddie turns her evidence over to Vasquez, it's revealed that she used the Tesla's built-in camera to get the license plate of the getaway vehicle. Vasquez commends her work while also

chiding her for doing more than she was supposed to.

After Harry reviews the Park files, he decides to visit the property. He meets a nosey neighbor who claims to not have heard a thing that night because the alarm wasn't set. When he asks about the dog, she says they didn't have a dog, they only used the sign as a deterrent.

A man named James Allen is shown at a bar picking up a male patron whom he returns to his hotel with. James claims to need to freshen up, but his attention is quickly drawn outside by approaching lights and a revving motor. James goes out to greet the visitor and leaves the man alone.

At a meeting with Louise, Chandler that David not only lied about his alibi but that he is also an ex-addict. She later gets the full story and his real alibi when she visits David in lockup.

Detectives call Tina back down to the station where she meets with Maddie. She gets upset and claims to not want to press charges when she learns she can't get her bracelet back until after the trial. She leaves in a fit after ordering Maddie to force the detectives to drop the charges.

Chandler implements her strategy to mislead Matthews and the feds by confiding in him that she hired Harry to work on Foster's defense. She also orders him to retrieve all the files on Carl Rogers' case. Meanwhile, Harry returns home to be ambushed with a subpoena by FBI agents Sylvia and Jones. They insult him by referring to him as a "has-been" and let him know they are well aware of his involvement in the Rogers' case. He orders them to leave their subpoena and go.

Chandler attends a meditation class for the first time and shares a nice conversation with a man. A quick scene shows a random man sleeping with what is assumed to be a prostitute. When they finish, two men show up at the door and blackmail him. They mention his wife and daughter's names to add emphasis to their threat.

During a phone call with Chandler, Harry says he can't find any evidence of a link between David Foster and Lexi Park. He claims that only makes Foster look more suspicious. She shares Foster's real alibi, but hasn't been able to reach him.

Agents Sylvia and Jones update their boss, William Baron on their investigation and request a phone warrant. Baron claims a warrant to tap Harry's phone won't be a problem, but tapping Chandler's is tricky, probably not even impossible. He suggests letting it go to court while they dig deeper into their evidence.

At home, Harry goes back over the Lexi Parks' crime scene photos. He attempts to hide them when Maddie shows up, but after some convincing he shares them. She admits the photos are disturbing and asks if Lexi was raped. When Harry confirms she was, Maddie admits to feeling lucky that Kurt Dockweiler didn't sexually assault her. Harry encourages her to not minimize what she went through. When he reminds her that the trial is coming up soon, she gets flustered and rushes off to bed. The episode ends with Maddie checking to make sure her windows are locked and putting a pistol under her pillow.

Summary:	Bosch digs into the Lexi Parks murder. Chandler's new case attracts all the wrong attention. Maddie accepts an exciting assignment that partners her once again with Reina Vasquez.



The episode opens with Maddie Bosch taking a huge step towards her recovery by moving out of Harry Bosch's house. Harry returns from his walk with Coltrane just in time to see her off. They both admit they'd prefer an extended stay, but deem the move the next step towards recovery.

Harry continues with the Lexi Parks case by reviewing some of her previous work as city manager. He also speaks with a co-worker who describes her as more than a pretty face. The co-worker

admits Lexi had her enemies, but nothing that warranted murder. A call from Honey Chandler and an older booking number from Maurice "Mo" Bassi send Harry on the trail of James Allen. Before ending the conversation, he asks about the face-to-face with David Foster he was promised. She assures him that she's working on it.

At the Hollywood Station, Maddie is pulled aside by Reina Vasquez to speak with Sergeant Julius Edgewood. He commends her work on the burglary case before offering her a position in the Crime Reduction Unit. After learning that she'll be partnered with Vasquez, she immediately accepts.

Chandler visits her therapist and reveals how she represented David Foster for possession when he was 19 and got him into a drug rehab. She says his current troubles along with being hit on at meditation classes have made her restless.

Harry's search for James leads him to Jordynne Allen's house where he learns that James is dead. Jordynne claims that two detectives visited her last night and said his body was found in

an alley in Hollywood. They suspect an overdose, which she adds isn't surprising. Harry asks if the two visiting detectives left a card. When she goes inside to get it, he phones Chandler but has to leave a voicemail.

FBI Agents Sylvia James and Lucas Jones visit Raul Arraya in Terminal Island lockup. While asking about Raul's involvement with Chandler, they share a recorded conversation between Chandler and Willy Datz. She claims that Raul owes her a favor and warns Datz that Raul and "his boys" may one day visit him. Raul admits that although Chandler saved his life, he didn't need to go after Datz. Datz had previously ratted out the Russians and that's what got him killed.

Elsewhere, Mo and Chandler gain access to Matthew Ramirez's phone by sending him a mock birthday invitation for Marty Rose. Harry meets with Sergeant John "Mank" Mankiewicz at a diner to secretly inquire about Maddie's progress. Mank claims she couldn't be doing better and mentions the bracelet case along with her invitation into CRU. Harry appears hurt that she hadn't shared the information.

Rico Perez returns to his apartment after a run to find Maddie at the kitchen table working on her victim impact statement for the Kurt Dockweiler trial. After she admits to having problems finding the words, she questions why she is even offering the statement. He says that it's supposed to be good for her, like lancing a boil. Maddie claims to not see it that way but is glad Kurt's locked up. He reminds her that the statement is entirely her choice.

Harry uses the card left to James's sister to secure a meeting with Detectives Rondell Pierce and Christina Vega. After explaining why he's interested in James, Christina admits they may have misled Jordynne about the cause of death. It appears James was strangled with a wire. Rondell adds that James was an alleged sex worker and the case might be tied to several others with the same MO. Harry makes sure to point out the damage their ruse could do before leaving them.

While Maddie celebrates her promotion with Paulina Calderon, Perez, and Vasquez, Harry shares James's death with Chandler. She admits that it will be easy for the prosecution to paint James as a liar, but questions if there is a way to cast doubt on the DNA evidence. Kevin Long eavesdrops on their meeting before rejoining and sharing his discoveries with Don Ellis. When Harry exits the restaurant, Don decides to get a closer look. He and Long end up splitting up, with Don following Chandler and Long tailing Harry. When Long suspects Harry is in for the night, he returns to the restaurant to collect Don. Together they follow Chandler and make a fake 911 call about being a possible drunk driver. When the call comes in over the police radio, they hit the sirens. Sensing something amiss, Chandler phones Marty at home before pulling over and alerts him that she might have a situation. When she finally pulls over, she does so quickly and removes several items from her purse and locks them in her glove compartment. She also locks her car upon exiting. She accuses them of an "unwarranted stop" and ends up being hauled downtown for refusing the breathalyzer. When two uniformed patrol officers show up to escort Chandler down to the station, Long and Don don't waste a second getting into her car and popping the trunk. It becomes clear that they are after her files on David Foster.

Tending to his routine duties at the Hollywood Station, Mank notices Chandler stewing in the "drunk tank" and learns that she has been held all night for refusing the breathalyzer. He appears mystified that she just didn't take the test, but she claims she refused it on principle. She goes as far as accusing Don and Long of harassment while Mank tries to figure out how to handle the situation.

Marty and Bosch visit David in lockup. Harry pulls out one of the more brutal crime scene photos and asks David if he can identify the victim. David does. Harry shares news of Allen's death along with the fact that Lexi was raped postmortem. After some reluctance and Harry's threats to abandon the case, David admits he and Allen were "involved" for six months.

When Perez drops Maddie off, he mentions how their living together increases the odds of someone at the station finding out about their relationship. Maddie reminds him that it's only a temporary arrangement until she finds a place. She also hints that Vasquez likely knows, although she's never discussed it with her.

While escorting Chandler to retrieve her vehicle from the police compound, she and Harry rehash her arrest. He assures her he will find out more about the two arresting officers and reveals what he learned from his earlier meeting with David. Harry admits that he believes him. At the police compound, Chandler becomes stunned and angry when the attendant reveals that the car was unlocked on arrival. She turns down his offer to file a complaint. Arriving at the car,



she immediately makes sure the Foster file is where she left it. Although it is there, she claims it is out of order. Harry accuses her of drinking too much.

Later and alone at the FBI field office Sylvia and Lucas finally get their hands on the enhanced security footage from Simon Wakefield's home. The footage shows Chandler visiting him well after the coroner's suspected time of death. Lucas reminds his partner that they did recover Chandler's prints on the pool's security system before adding that Wakefield's phone was never recovered. Further reviewing of the tape reveals that Lev Ivanovich was also at the house well before Chandler arrived.

The episode starts with Maddie waking up early to go for a run, making sure she brings her gun with her, and Ellis and Long place a tracker on Harry Bosch's car.

Maddie arrives early at the police station with a spring in her step, ready to start her new assignment. Harry is looking over the crime scene photos of Lexi Parks again, and notices a tan line on her wrist, likely from a watch, despite the report not mentioning a watch being found at the scene.

He doesn't suspect it was stolen, as her ring wasn't taken. Harry follows this up by posing as a prospective buyer for the Park's house, so he can get a closer look. He finds the watch case with no watch in it, but a receipt instead.

Harry runs into Deputy Vince Herrick outside the house, and Herrick threatens to arrest him, but in typical Harry Bosch style, he doesn't back down and calls his bluff, then tells him he's sorry for the loss of his wife. But not before asking him what happened to Lexi's watch. Herrick claims the watch is in a repair shop.

Vasquez and Maddie are on a case near The Chinese Theatre, looking into crimes against tourists. Maddie spots a suspicious man in a hoodie, but the man gets away when a fight breaks out.

Harry and Chandler meet up, and he tells her he thinks he made a mistake going to the Park's house. They are at the motel James Allen used to bring dates to, to confirm Foster's alibi, but the manager says Foster and James were properly involved and he wasn't any old client.

Chandler bribes the manager to give them access to Allen's room. He asks for \$200 for an hour. Harry takes pictures, but nothing seems out of place in the room, apart from a spot where a picture was clearly hung on the wall.

They have to pay out again soon after, to bribe a security guard at a cemetery for footage of the entrance to the motel. Chandler says it's not wise as they may need him as a witness, but they need the footage so she pays up.

Mo attends a cyber security seminar, and spots a woman who interests him. Her name is Jade Quinn, and the pair meet at the after party and play poker. He reveals he's the hacker known as Rico Spider. He asks for her number, but tells him to figure it out if he's such a good hacker.

Ellis and Long stop trailing Harry and Chandler for the day, and go to the house of two sex workers who they are in business with. Long looks over footage from the day and spots a man with a nice watch that would be a good target for them.

Harry and Maddie have dinner and discuss her new assignment, and he questions why she didn't tell him beforehand, but reveals he already knew. She says "act first, apologise after." Harry tells her he's proud of her but tells her to look after herself.

Harry gets a visit from the detectives investigating the Lexi Parks case, and is warned off it. Then he, Chandler and Mo look over security footage of the cemetery. They spot a van like Foster's arriving at the motel, and leaving a few hours later, backing up his alibi. Chandler says they'll need something better than this for the court case.

Maddie catches the man in the hoodie, but is a bit heavy-handed when arresting him, and Vasquez warns her to be careful not to lose control.

Harry and Chandler are called before the grand jury in relation to the Carl Rogers case. Journalist Scott Anderson spots him after court and asks him some questions. Anderson tells Harry the FBI took over the Simon Wakefield case, which is a worry to him.

Chandler shreds all the documents on the Rogers case, and hands them to Matthew to get rid of. He takes them to the FBI agents on the case, and also gives them a copy of the digital files. It's all part of a plan to entrap the FBI. It's revealed that the FBI have something on Matthew which is forcing him to co-operate with them.

At the end of the episode, the FBI meet with the owner of the pipeline and he ID's Harry Bosch from pictures, as being the man who blew up the pipeline!

Matthew tells them they caught him in a lie about the schematics for the shipping container, forcing him to work with them.

Chandler tells him to keep them informed on anything the FBI tell him as the case progresses, and seems hurt that he betrayed her, and tells him to go, leaving his job up in the air.

Chandler receives word that the DA's office will be scheduling a hearing to discuss whether to remove Bosch from the Parks investigation after he visited the victim's house.

Elsewhere, Mo goes on a date with Jade, and she explains she was cagey with him because of an ex boyfriend who had been harassing her, and blackmailing her by hacking into her family's medical records.

At the hearing to decide on Bosch's involvement in the Parks case, Chandler manages to argue that since Bosch used his real name, and gained access to the house legally, he shouldn't be removed from the case.

With the judge in agreement, he then calls Chandler into his chambers along with the prosecutor and DA. He thinks the Foster case is an open and shut one, and urges them to work on a plea deal. The DA offers second degree murder with 15 years to life, and a possibility of parole. Chandler insists Foster deserves his day in court, but says she'll inform him of the deal. To which, he declines.

Maddie arrives at work and is met by the assistant DA who wants an update on her victim impact statement. Maddie insists she's not the victim, and they should focus on Dockweiler's rape victims.

Mo goes on another date with Jade, and learns more about her hacking issue, and she tells him the server is only accessible on site at a pharmaceutical company. This leads the jazz loving hacker to dress up as an inspector and gain access to the building, and he copies the security guards key card, and connects to the company's system in the server room. He tells Jade all he needs now is to fake or obtain an employee's credentials to gain access to her files.

Harry meets with Detectives Pierce and Vega who are assigned to the Allen case, and they tell him Allen had previously been arrested for sex work and drug dealing, but it all stopped 3 years ago. They don't believe he stopped doing it, but that someone on the inside was looking out for him.

Harry asks them to find the last cops to arrest Allen, and he also takes a look at some of the pictures from Allen's murder scene.

Harry goes to the crime scene and knocks on doors in the building overlooking the alley. Tenants in the buildings insist there were two murderers, and they heard doors slamming and a car engine.

Harry tells Chandler about the two murderers theory and comes to the conclusion that Allen must've been unconscious when he was strangled as there was no struggle. This still leaves them needing to figure out how Foster's DNA got on Parks body.

Maddie seeks advice from Chandler about her victim impact statement, and she tells her she doesn't owe anything to anyone. She also speaks about her own experience with Rogers, and her need to not let the perpetrator have control over her.

The day of Dockweiler's sentencing arrives, and Maddie attends to give her statement. She insists Dockweiler is not just a kidnapper, he's a rapist, and she considers herself lucky compared to his rape victims. She then tells Dockweiler to look at her, and tells him he deserves everything coming to him.

Harry tells Maddie he's proud of her, and tells her the pain may never go away, but today is a big step forward, and Maddie agrees with him.

Mo tells Harry that he noticed a few things on Lexi Parks phone logs, including a call to a repair shop, which Harry then decides to check out for himself. The man in the repair shop confirms Parks called about a watch repair, but doesn't reveal anything else.

Ellis and Long have been tailing Bosch, and follow him to the repair shop and after he leaves, they storm in and tell the shop owner to tell them what they told Bosch. He says it was just concerning the repair call made by Parks, but Ellis shoots him dead anyway, along with his brother who is also present at the scene. They make it look like a robbery and spark a getaway.

Summary:	Bosch starts to unravel the Lexi Parks murder, with potentially dangerous consequences. Chandler tries to outmaneuver the Feds as the case against her hangs in the balance. Ellis and Long get a little too close for comfort.



The episode starts with Ellis and Long getting increasingly concerned that Harry is getting closer to finding out the truth. Ellis has a plan and it involves some old fashioned police work as they stake out an illegal brothel. Outside the courthouse, Chandler drops an envelope into a mailbox, with the contents of it unknown to the audience. But it's clearly part of her bigger plan.

Harry visits an Omega watch shop to follow up on Lexi Parks' missing watch, and the store owner invites him into his

office, explaining that the watch belonged to someone else—a doctor named Schubert, who pawned it off to the Nguyen brothers to pay off gambling debts. Elsewhere, Mo has access to the pharmacy files as he continues to help Jade get hold of some information. He is given the option to look at the files, but he decides against it. When they meet up for a date at a jazz club, Mo gives Jade the USB drive with the files on, freeing her from her psycho ex-boyfriend.

Ellis searches Harry's apartment for stuff he can use against him and finds a photo of him and Maddie. He thinks they can get to him through her as he recognises her as the cop who was

kidnapped. Ellis and Long present the brothel evidence to their superior, and he gives them the go-ahead to conduct a raid, and they ask for backup from Hollywood CRU, which is Maddie's unit. Ellis manages to get teamed up with Maddie for the raid.

As it turns out, Chandler's package she sent off near the courthouse was a subpoena for the grand jury, which she sent to the journalist, Scott Anderson. It was sent anonymously, but Anderson uses the connection to Harry to single out Chandler as a possible source for it. Anderson meets with Chandler, but she declines to comment. He tells her he knows the grand jury is dealing with Russian organised crime and domestic terrorism, and he plans to publish the story the following day.

After publication, the press wants to speak to Chandler to follow up on it. Chandler says someone is trying to ruin her reputation. Jurors are dropping out of the case due to the content of the article, and this causes an issue for the FBI, as they will be back to square one with the investigation.

Maddie is preparing for the raid with Ellis, and he asks her about her father, and she lets slip what she knows about the masked men who killed the Nguyen brothers. The raid takes place, and the cops arrest the pimps and sex workers, and Ellis is very heavy-handed with one of the suspects, kicking him multiple times. Ellis speaks to Maddie afterwards and asks her to keep it between them. Maddie simply responds that the raid was "educational."

Meanwhile, Harry continues investigating the Lexi Parks case and obtains a USB drive from a coworker of hers, which has a recording on it of Lexi calling the Nguyen brothers. On the recording, she tells them she knows the watch was stolen and threatens an investigation if they don't share the records with her. Harry also tries to contact Dr. Schubert, but has no luck with this.

Harry receives a text from the detectives working the Allen murder case, revealing that Ellis and Long were the cops protecting Allen. He finds out from Mo that they are experts in surveillance, which makes him think they are probably tracking his car. Mo finds the tracker, but Harry insists on leaving it there so they think they have eyes on him.

Chandler identifies Ellis and Long as the cops that pulled her over in her DUI arrest, and Harry thinks the watch is the key to everything. Harry and Mo break into the Nguyen brothers shop, and Mo is able to crack the safe, and they discover a DVD, which could hold the key to everything.

Ellis and Long guess that Harry found their tracker, but they follow him and Mo as they drive back to his place. Ellis speeds up his car, turns off his light and rams Harry and Mo off the road. The episode ends with Harry and Mo unconscious in a ditch off the roadside.

The episode begins moments after the horrific crash that ran Harry and Mo off the road. Ellis and Long flee the scene of the crime. Harry has minor cuts and scratches, but Mo is in the hospital dealing with concussion. They talk about the crash, and Mo thinks he saw a silver car but can't remember too much. They both attest to hearing the sounds of a 'muscle car.'

Harry goes home, removes the tracker from his car and destroys it. Harry and Chandler look at the DVD he got from the

watch shop, and it shows Ellis and Long discussing the watch with the Nguyen brothers. They recall the last man James Allen had a date with remembers hearing a 'muscle car,' which further implicates Ellis and Long.

They decide to check it out and go to a place where Harry knows cops take their cars for repairs. He tracks down a silver car and proves it belongs to Ellis. He takes pictures and finds a receipt, which he makes a note of.

Chandler goes back to the graveyard to get more security footage from the water tower, hoping to prove Ellis' car was at the motel the night James Allen was killed. Elsewhere, Ellis and Long find out Harry survived, which unnerves them greatly, as he knows too much.

Agent Baron tells FBI agents Jones and James they are getting search warrants in the Carl Rogers case, but it's taking longer than expected. However, he has another plan to pursue in the meantime. Jones and James approach Maddie and interrogate her at the police station, asking her where she was when Rogers was released and how Chandler felt when he was released. She reveals they were all upset, but says no more. The agents tell her they think Harry was involved in domestic terrorism, but Maddie refuses to answer anymore questions.

Maddie meets with Harry and asks him if any of this is true, but he tells her he can't tell her in order to protect her.

Mo confirms Ellis and Long visited Allen the night he was killed, using the footage Chandler obtained. They think Schubert got Ellis and Long to steal the watch to pay off the gambling debts, and sold it to the Nguyen brothers as part of the arrangement. Harrick then buys the watch for Lexi, but she finds out it's stolen and threatens the Nguyen brothers, exposing Ellis and Long in the process. Ellis and Long kill Lexi and frame Foster for the murder. Case solved, right? Not quite, as they can't figure out how Foster's DNA was found at the scene.

Harry tells Chandler the FBI talked to Maddie, and Chandler reassures him Maddie's career won't suffer for all of this. Elsewhere, Ellis tells Long they need to do something drastic because Harry is getting close.

Harry visits Dr. Schubert at his home to talk about Lexi Parks and warn him he could be in danger. Ellis and Long turn up at Schubert's home and storm the house. Schubert hides upstairs, while Harry joins him and calls 911. Schubert tries to convince Ellis and Long that he didn't tell Harry anything, but Long shoots him anyway. A gun battle ensues, and Harry manages to shoot Long, but Ellis gets away. Long is on the brink of dying, but Harry doesn't care—all he wants to know is where Ellis is going. Long refuses to say.

The police arrive on the scene, and they tell Harry to put his hands up. He talks to the detectives on the case and tells them all he knows about Ellis and Long's involvement in the Lexi Parks murder. Harry thinks Ellis will go after the sex workers he had been using, so Chandler agrees to let them use her safe house.

Harry and Maddie talk about everything, and he says he doesn't regret how everything went down. Maddie then asks Harry if he would ever lie to her, and he says he wouldn't.

Elsewhere, Foster is in the hospital after being attacked in prison, and Chandler meets with the prosecutor and the judge to discuss putting him in protective custody until the trial takes place, and they agree to do this.

The FBI finally gets their search warrants and subsequently raids Harry's apartment and Chandler's office at the same time. Martin Rose is very disappointed that this reflects badly on his firm and says he might have to consider Chandler's position.

The episode ends with the FBI not finding much of interest, apart from a recording of Chandler threatening Carl Rogers, which makes them think she knew about the explosion before it happened. They turn up at Chandler's house and arrest her.

The episode starts with Ellis hiding out on a boat after paying someone to help him escape town, provide him with new clothes, passport and a new driver's licence. However, obtaining a car is proving more difficult. He is told he must pay more money to get a car, and he reluctantly agrees to this.

Martin bails Chandler out after she was arrested at the end of the last episode. She promises him she'll fix things after putting the firm's name into disrepute. She gives a statement to the

press where she claims the FBI are attempting to destroy her reputation, and calls their investigation baseless.

Agents Jones and James think she is just playing up to the cameras, but Baron is concerned she's up to something.

Chandler and Harry are trying to get the Foster case thrown out, explaining why they think Ellis and Long killed Lexi Parks. The DA denies their attempts and refuses to drop the case. Chandler suggests he's motivated by re-election and not what's right for the case.

The next day, Chandler is at a hearing to dismiss the case against her, with Harry alongside her. When the FBI comes in with a bag of shredded documents relating to the Rogers case, Chandler reveals it was all a set up, and she gave the real files to her lawyer, which are very much still intact, meaning the FBI have a bag of scrap paper. This means the search warrant based on their suspicions that Chandler destroyed evidence is baseless, and the evidence they

found is inadmissible. Genius! The judge dismisses the case, but Baron tells Chandler it isn't over yet. Harry tells him to back off.

Harry drives away from the courthouse, but has spotted a tail on him, so he runs a red light and tries to shake the tail, but a cop car pulls him over. Turns out, it's Maddie keeping an eye on her father, figuring that something might be up and that he's a target for Ellis.

Mo is in a safe house, keeping an eye on the twins who worked for Ellis, while Harry and Chandler are on their way to get their testimony. Harry slips the lookouts Maddie has posted near his office and is picked up by Chandler.

The twins mention to Mo that Ellis and Long got possession of a boat as part of a scam, and Harry thinks this is where Ellis might be hiding out. He takes Chandler's car to check it out.

Maddie talks with Vasquez about following in her father's footsteps with good and bad consequences. She says knowing her father so well comes in handy. When the police say a blonde woman turned up, she believes this is Sam, the dog walker, confirming Maddie's theory. She gets a tracking location on Harry's phone and sees he is heading to the marina. She believes he's going after Ellis on his own, so she and Vasquez go along to check it out. They split up at the scene, with Vasquez telling Maddie to stay in sight.

Harry finds the boat and the boat owner tied up inside, whom Ellis caught snooping earlier on. Ellis sneaks up on Harry and holds him at gunpoint. Harry tells him the police are on their way, telling him to check the scanners to confirm this. Ellis second guesses himself, giving Harry the chance to knock him out and a fight ensues between the two men. Ellis tries to pull out another gun, but Harry wrestles him, and a shot is fired into the ground before the gun itself hits the ground. Maddie and Vasquez hear the gunshot and follow where it's coming from.

Harry and Ellis take their fight onto the deck of the boat, with Ellis getting the upper hand on Harry, and he chokes him. Harry grabs a sharp object and stabs Ellis in the chest with it, causing him to let go of the chokehold. But Ellis grabs the gun again and points it at Harry. Maddie arrives in the nick of time and shouts at Ellis, telling him to freeze and drop the gun. However, he raises the gun at Harry, and Maddie shoots Ellis, knocking him off the boat, and into the water, killing him. Vasquez arrives on the scene after it all goes down.

Harry thanks Maddie for saving his life, but Maddie has to be questioned about the shooting, so the police don't want them discussing the incident too much. Harry tells her she did the right thing.

At the end of the episode, Baron reveals his plan to get Harry and Chandler. Jade, who had been going on dates with Mo, is actually an undercover agent, who is working Mo to get the information they need to bring Harry and Chandler down. Betrayal!



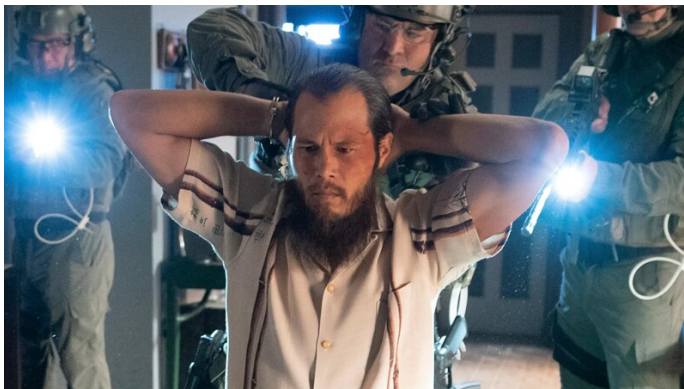

Summary:	Bosch ensures the Lexi Parks case reaches its just conclusion. Chandler considers a big career change with the help of an old acquaintance. Maddie wrestles with the fallout of her first officer-involved shooting. Mo faces a serious ultimatum with the FBI.



Maddie gives her testimony about the Ellis shooting. She says she saw Ellis with a gun and decided to make the call to shoot him to save her father's life. The police tell her they have not found the gun yet, which causes Maddie concern.

Maddie's lawyer says it'll all be fine, and when she asks Vasquez if she saw the gun, she says she only heard the shots, as she arrived after it had all gone down.

Maddie and Harry talk about the incident, and she justifies the shooting of Ellis by using Harry's old saying "Taking

a life to save a life." However, she is mad with Harry for slipping his protection and nearly getting himself killed. She also reflects on her mum's death, how she is angry about that, and how she can't afford to lose another parent.

Elsewhere, Matthew tries to mend bridges with Chandler after he sold her out to the FBI. But Chandler tells him she needs people she can trust and wishes him all the best for the future, but he won't be working with her. She visits her therapist and tells him she doesn't feel like the person she used to be, but insists she can live with that as she did what she had to do to survive.

The FBI want Jade (aka Janice) to push Mo on what he knows about Harry and Chandler, but she risks exposing herself to the rest of the hacker community. Baron says they have a plan to keep her undercover, and give Mo an easier sentence if he agrees to co-operate in bringing down Harry and Chandler.

Jade Mo eat dinner together at his apartment, but he's getting irritated at her unwillingness to take the relationship to the next level.

Soon after, the FBI raid Mo's apartment and arrest him. They make out Jade is someone who uses hackers to steal corporate secrets, and they will prosecute her unless Mo gives them information on Harry and Chandler. Mo tells Baron he needs an official deal and a few days to make a decision.

Chandler is in court and makes her move against the DA in the Foster case. She presents evidence that suggests a third party was involved, believing Ellis and Long murdered Lexi Parks and used a condom from James Allen to plant Foster's DNA on the scene. The judge decides the evidence is solid enough to present in court. Chandler then reiterates her desire for the DA to drop the case, but once again, he refuses.

Chandler tells Harry one of the FBI's witnesses has recanted his testimony that ID'd Harry at the scene of the pipeline, putting him in the clear. They focus their attentions on the Foster case, with Harry saying they need a confession from Long, who is recuperating from his injuries in hospital after Harry shot him. Harry comes up with a plan, figuring he won't know Ellis is dead.

Harry impersonates a doctor and sneaks into Long's hospital room and reads a fake confession from Ellis to him. The fake confession claims Long murdered Lexi Parks, but Long maintains it was Ellis who lost it and killed her.

Harry records what Long says, and he and Chandler present this to the DA. He insists it's inadmissible in court as he didn't get Long's consent to record it. Chandler says that doesn't matter as she plans to release the recording to the press, and he'll have to explain why he didn't drop the case despite the evidence.

Maddie tells Perez she's moving out despite him being supportive to her. She says it doesn't mean they are breaking up. (It absolutely means they are breaking up.)

Chandler awaits the DA's decision on Foster, meets Irvin Irwing, and asks if he'll endorse her to be the next DA. He's retired now but considers her request. The DA finally agrees to drop the charges on Foster, and his name is cleared.

Maddie gets a call from a correctional officer telling her Dockweiler died in prison from a suspected overdose. She tells Harry, and he says he was likely killed by inmates because he was a known sexual predator, saying he got what he deserved. Maddie insists he got off easy, and decides she needs closure on what happened to her mum all those years ago.

She visits the FBI headquarters and views the Memorial Wall. Looking through her mum's obituary, and she finds a picture of her mum with Maddie as a baby, and she gets emotional. She then talks to Chandler about it and says it's nice to know a bit more about her mum, but she worries she will lose her empathy for others. Chandler reassures her this won't happen, as her thinking about it is evidence that she won't.

There's more good news on the way as Sgt. Mankiewicz calls her to tell her they found Ellis' gun in the water, and she is cleared for shooting him. He tells her to keep it to herself until it's official.

Mo is still in trouble, as Jade comes over to get more information out of him, but Mo turns the tables on her and reveals he knows she's working undercover. She says she has the USB drive proving he hacked the pharma company, but Mo says the drive had an auto delete function on it, so everything is gone. She tells him she did have feelings for him, and in another life, things might've been different.

Chandler announces her intention to run for DA, after criticising the current DA for his handling of the Foster case. Harry and Maddie are in the crowd watching on. Maddie thinks it's going to be so cool if she gets in. Harry tells journalist Scott Anderson when he approaches him that Chandler gets his vote. Scott Anderson also wants to know why the grand jury investigation went away and suggests Chandler sent him the subpoena. Bosch refuses to comment.

Back at Harry's apartment, Maddie asks Harry if he'd work for Chandler if she became DA. Harry says DA investigators mostly deliver subpoenas and drive witnesses to court, which isn't of interest to him. Maddie says it's better than working for the dark side.

Maddie stays behind while Harry goes out to walk the dog. Harry's phone rings and Maddie sees that it's from an inmate in Wasco St Prison. She picks up, and it's Preston Borders, a rapist and murderer arrested by Harry Bosch years ago, and he reveals he took care of Dockweiler on Harry's request. Harry walks back in, and Maddie reveals who she was talking to, saying, "Dad, what did you do?" You'll have to wait to find out as the final episode ends.

The episode begins 8 months after the previous episode with Honey Chandler giving a campaign speech on the courthouse steps.

Elsewhere Detective Jimmy Robertson meets with Captain Rivera, District Attorney Emmett Archer, and Chief Hughes. They tell him to investigate Harry Bosch and see if he really had Preston Borders kill Kurt Dockweiler. After the meeting, Robertson privately meets with Rivera to discuss things even further.

Harry privately meets with his prison contact to discuss what the word is in Wasco. He tells Harry that they haven't tied Dockweiler to anyone. He offers to buy Harry a beer but he turns him down and tells him to keep in touch.

Jon and his wife leave a restaurant or a function and are robbed as soon as they pull into their driveway at home. Janet Vasquez and Maddie Bosch respond to the call. Vasquez interviews Jon while Maddie questions the wife.

Frank Sheehan goes to Honey's campaign headquarters and asks to volunteer. When he finally gets to speak with her alone, he asks if she can get his old job back with a possible pardon. When



she doesn't give him an answer, he brings up Michael Harris and the settlement she got him. She tells him that Michael was innocent and he tortured him to get a confession. She eventually tells him that she can't help him because she isn't taking on any new cases. He says that he had to try and leaves.

Robertson and Perry Lopez interrupt Bosch's lunch with Maddie to say hello. At the end of the affair, Maddie tries to approach Bosh about the Dockweiler situation. He tells her that he didn't but would have if he could have. As soon as Bosch says goodbye to Maddie, he receives a call from Honey.

Minutes later Honey is telling Bosch about his visit from Frank. The conversation doesn't get any further because Bosch receives a call from Maurice 'Mo' Bassi. When he learns Harry is with Honey he tells him to put him on speaker. Mo tells them that Frank has been at several of her events over the last two months.

Maddie's boss gives her and the other officer a description of the vehicle used in the robbery the previous night. At the same time, Bosch visits Mrs. Sheehan to talk about Frank. She asks how many times he visited Frank when he was locked up. He tells her none. She says that she didn't visit him either. She also tells him that Frank stopped by the house to look through some of his old things.

Frank is briefly shown visiting a park of sorts while Robertson and Perry meet with someone from the prison to discuss the Border phone call.

Honey and her team are watching campaign commercials when Michelle Carter comes to tell her that her car alarm is going off. When she goes to shut it off, she finds a brick through her window with the message — Just the beginning.

Seconds later, Honey is discussing the brick with Bosch and her team. Bosch tells her that since she wants to be DA, she needs to report it and start working with law enforcement.

Vasquez and Maddie get lucky at a gas station and find a full plate for the suspected robbery vehicle.

Bosch tails Frank to a hardware store. He goes inside to watch him shop but gets spotted. They briefly talk about Honey running his name through the mud. Bosh eventually tells him that he needs to stay away from Honey but he says that he doesn't know what he is talking about.

Honey meets with a group of women to talk about restoring support for victims and their families.

Rivera meets with two of his officers to talk about Honey's campaign people requesting police presence at their next fundraiser. Rivera tells them to send the request to Hollenbeck since it is in their division.

Robertson meets with Archer to get a warrant for Border's prison burner phone. He tells him to go see Judge Simon Newland.

Bosch and Mo break into Frank's apartment while he is gone. They search the place but don't find much of interest other than a rescue response manual. At the same time, Frank goes to a storage locker and begins work on something.

The phone tech tells Robertson and Perry that Borders has been making calls to someone in the Hollywood Hills. They relay this information to Archer.

Harry works with one of the local PD to stage security for Honey's event.

While Honey gives her speech, Bosch calls Barrel to acquire about Frank's whereabouts. When he learns that Frank is still at home, he tells Barrel to go knock on his door. Just as Honey welcomes the Mayor to the stage, Barrel calls Harry to tell him that Frank isn't home. Harry tells Vasquez and Mo to pull back to get eyes on the whole courtyard. When Honey begins working the crowd again gunshots ring out and everyone scatters. Bosch realizes that it is a diversion and makes plans to box in Frank. It works and seconds later they are pointing guns at each other.

Just as it looks like Bosch is about to talk Frank down, he turns his weapon on himself and commits suicide. This is where the episode ends.

The episode begins with Harry Bosch attending the funeral of someone he served with. Maddie Bosch also shows up. While she is talking to Bosch, Ken Gurbiz interrupts and invites them to the reception. Seconds later they are at a bar and Ken and Bosch are sharing old war stories about their time serving together. While Bosch is gone to get another round, Maddie tells Ken that Bosch never talks about his time in the war. This leads to Ken telling her about the time they hit an IED and ended up tracking the guy who

made it. Bosch was the one to get a confession out of him then killed him.

Bosch arrives at his office to find Siobhan Murphy waiting on him. She tells him how her whole family is missing and there was a sighting around Mexico. He doesn't agree to take the case but promises to reach out to the missing person's detective overseeing the case and get back in touch with her.

Jimmy Robertson and Perry Lopez speak to James Rafferty about the time Kurt Dockweiler was attacked at the station by Bosch.

Honey Chandler and Jen Kowski attend a function, trying to get money for the campaign.

Maddie Bosch is walking up the steps to Honey's house when Bosch calls. She ignores the calls. Later, she tells Honey a little about the story she heard about his time in Afghanistan. Honey tells her not to judge him too harshly because it was war.

A woman at a restaurant is eyeing the other patron's jewelry. She asks for the check when she sees two cops pull up. When she gets in the car, her male partners want to stay and follow one of the patrons home. The woman wants to leave because of the cops.

Robertson and Perry go to Bosch's old station to speak with the Watch Commander about the time Bosch attacked Dockweiler at the station. The watch commander denies that it ever happened.

Bosch is watching videos of the missing Gallagher family video when Honey calls. She wants him to prove that she was treated differently because the LAPD didn't take her concerns about Frank Sheehan seriously. He tells her that he will look into it when he has time.

Robertson and Perry watch the Bosch and Dockweiler interrogation tape.

Bosch checks out the Gallagher's vehicle at police impound. He doesn't find much interesting but the fact that the keys were left in the glove compartment. He also learns that Stephen Gallagher was overextended and he was possibly stealing money from his own company. Bosch gets the detective's blessing to look into the case.

Back at campaign headquarters, Jen Kowski tells Honey that she will be having lunch with Lisa Broad tomorrow.

Elsewhere, Maddie asks Janet Vasquez if she ever dated an attorney. She tells her she hasn't. The conversation doesn't get much further because a car matching the description of the robbery car rolls a stop sign. When they pull the car over, the driver claims that the vehicle belongs to her friend, Nestor Gomez. Maddie runs the plates and writes up the ticket while Vasquez talks to the driver. When asked about Nestor, the driver clams up. Maddie and Vasquez decide to look more into the car and the owner back at the station.

Robertson tells Perry at the bar that you have to investigate Bosch the way he investigates people. He then asks him how far he is willing to go. Seconds later, they are breaking into Bosch's office. While there Robertson finds a thank you letter from the Dignan family. He apparently wrote their son, Curtis Dignan, a recommendation letter at Wasco Prison.

Bosch updates Siobhan on the case thus far and tells her that a family of four just doesn't disappear. She then takes him to the Gallagher house where they meet Maurice 'Mo' Bassi. Bosch searches the house while Mo canvasses the neighborhood for neighbors willing to let him look at their security footage. Minutes later they are watching surveillance footage of the Gallagher family leaving for their vacation.

Maddie and Vasquez bring Jon and his wife back in to identify the vehicle, driver, and passengers. They are unable to provide anything useful. Elsewhere, the robbery gang talks about the ticket and their options moving forward.

Honey meets Lisa for lunch. Lisa tells her that she still very much believes in what Emmett Archer stands for. This doesn't go so well and leads to the two briefly insulting each other's beliefs. Things change when Michelle Carter shows up. After lunch, Honey briefly argues with Michelle showing up and using herself as a political pawn.

Bosch meets with the Watch Commander to talk about Honey not getting extra security for the event. The Commander tells Bosch that some people at the station thought Chandler was trying to play them. The Commander also tells him that Hollenbeck was supposed to provide the backup but he doesn't mention a thing about Robertson and Perry.

Robertson and Perry show up to question Rita Tedesco just as her husband calls from the prison. They ask her if Preston Borders even mentioned Bosch. She doesn't answer and tells them next time they want something, speak to her attorney.

Bosch goes to Lieutenant Don Thorne and jumps onto him for not providing Honey backup. Thorne tells him that maybe he did try to coordinate with Hollenbeck and they chose not to provide backup.

Robertson and Perry tell Captain Rivera about Curtis and what they've learned from looking into the case. Rivera tells them to look into it.

Honey meets with Chief Hughes to discuss the lack of backup at her fundraising rally. Honey threatens to go public unless Hughes backs her in the campaign. Hughes tells her that she should go public because she has nothing to hide.

Robertson and Perry show up to question Maddie about the phone call from Borders. Maddie says that Bosch told her Borders was just calling to yank his chain. She says that she believes him and doesn't have an answer for why she didn't report the call herself.

Bosch and Siobhan meet Sheriff Beto Orestes at the Gallagher vacation house. Inside the house, Bosch finds the blanket that Siobhan made Kerry Gallagher. This blanket was also seen in the footage of the family packing for the vacation. This is where the episode ends.

Janet Vasquez notices Maddie acting strange and asks her what's going on. Maddie is hesitant but eventually tells her about the investigation. Vasquez tells her that she doesn't want to know because she doesn't want to have to lie for her.

Bosch questions Sheila Walsh and Finbar McShane separately. As it turns out, they knew that Stephen was embezzling money from his own company. Bosch doesn't learn much more but does manage to get Sheila to put together a packet of employee rosters and banking records.

Honey Chandler gets ready for a radio debate with Emmett Archer while Siobhan hangs up missing posters of her family.

When Robertson and Perry question Borders he has them turn off the recorder and tells them that one day he came back from breakfast and found the found in his cell. It happened to have one missed call. He refuses to say more unless they sit him down with the District Attorney.

Bosch calls Siobhan and tells her that putting up flyers is going to muddy the waters. She says that she can't sit around and do nothing. He tells her to come back to LA and offers to get her but she says that she can make her own way back.

Robertson and Perry tell Archer that Borders is willing to play ball if they'll get him moved closer to his wife. Archer tells them to get him in front of a Grand Jury and have him swear on a Bible.

Maurice 'Mo' Bassi tells Bosch that he went through the employment records and found an employee who was on the payroll but wasn't on the list. This would be Justin Boatman, Sheila's son. He also happens to have a record.

Minutes later, Bosch is questioning Justin about Stephen. He tries making a move on Bosch, but he counters and low blows him. Justin then tells him that he took some petty cash from Stephen and that's why he fired him. He also tells Bosch that there are a lot of shady things going on at that company.

The robbery gang hawks some of their wares at a recording studio while Bosch goes back to questions Sheila about leaving her son's name off the list. This doesn't go so well but while he is there, he plants a bug. Nestor Gomez and the robbery gang argue about the spilt and other aspects of the operation.

Honey and Archer argue on the radio about who is being endorsed by local law enforcement. When Honey wins the argument, Archer asks her who she turned to when the local police wouldn't back her at the fundraiser. When she says Bosch, Archer brings up the fact that Bosch is under investigation for conspiracy to commit murder. Bosch also hears this and calls Maddie to give her a heads-up. He reaches her voicemail. As soon as he leaves the office, he receives a summons to appear before a grand jury.

Bosch stops by Maddie's apartment. He tells her that the whole thing will eventually go away. She tells him that Robertson and Perry stopped by to speak with her. When he swears that he had nothing to do with Kurt Dockweiler's death, she asks him about Afghanistan. She makes him leave after he refuses to comment.

Bosch has to sneak over to Honey's house to discuss what happened on the radio show because the media is camped out on the front lawn. Elsewhere, Rita briefly speaks to Borders. After speaking with him she goes into a garage and speaks with two of Border's associates.

Bosch receives a call from Mo, who e-mails him an audio file of Finbar and Sheila. They talk about a deal going down the following night and it being less than the others.

Robertson and Perry tell Rivera that Archer screwed them by going public about the Bosch investigation.

Bosch visits Curtis Dignan at work to ask him if he caught the news. Curtis swears that he never said a word. Bosch tells him to make himself scarce after speaking with his PO. Perry and Robertson watch the meet go down.

Nestor and Albert are posted outside a restaurant when they receive a text from their female accomplice telling them that there are no suitable targets. They choose not to listen to her and go after a man in a red hat and a woman. The man puts up a fight and causes quite a disturbance. The two of them barely get away. Sometime later, Maddie is interviewing the neighbor who heard the gunshot and robber's conversation.

Michelle Carter shows up at campaign headquarters to learn that Honey is down in the polls.

Honey briefly meets with her DA contact to talk about Bosch while Bosch and Mo follow Finbar from the Gallagher business. They follow him to what appears to be a parking lot full of heavy machinery. They see him dealing with several men.



The episode ends by showing the Gallagher family in the back of a van. They are taken to a remote area and unloaded by a single individual.

Honey Chandler learns that the Times are meeting to discuss their endorsement. Her team wants her to distance herself from Bosch but she isn't so sure.

Robertson and Perry talk to Curtis about Preston Borders and Kurt Dock-

weiler. He initially denies even knowing them. He also refuses to help them out. After Curtis's interrogation, they discuss things with Captain Rivera. This is where they plan to lock Curtis up beside Borders and wire both cells.

Honey tries to stop the Times from pulling their endorsement by speaking with Mr. Porter. Mo setups outside Crider Equipment and crashes their Internet. He then goes in and plays the hero. In the process, he apparently connects one of the computers and clones the hard drive.

While Robertson and Perry relocate Borders to his new cell in Los Angeles, they trick him into thinking Curtis is a rat. Despite this, he refuses to say anything. Crider receives a message from Finbar McShane saying that he wants to meet.

Honey meets with a contact to discuss the Times pulling their endorsement. She tells him that she can make sure that a cop in LA gets prosecuted for a wrongful death shooting. He tells her that he will convey her concerns to the board but they will want to make sure Archer has equal time. She tells him that's fine.

Janet Vasquez and Maddie speak with a contact at a tattoo shop. Lucy tells them that she heard about this new slick crew selling quality merchandise at recording studios.

Borders learns that they are going to make him tell his story to the grand jury before he speaks with the DA.

Bosch shows up at Crider Equipment and questions Crider at gunpoint. Crider tells him that McShane is selling him equipment at half price from Gallagher Equipment. He never said why he was selling it and he never asked. Seconds later Bosch is discussing what he learned with Mo. They decide that their best play is to check Crider's alibi for when the Gallaghers went missing and to speak with McShane's partner.

Maddie and Vasquez use what they learned back at the station to track down a car with stolen plates. The same vehicle also happened to visit a local recording studio named, Find Your Grind.

Bosch shows up to question Sheila Walsh. She admits to selling the equipment but says that the Gallagher went on vacation.

Rita Tedesco waits on the sidewalk for Borders to pass on his way to the grand jury. At the hearing, Bosch testifies working with Curtis in the past. He also admits to speaking with Curtis at the paint store. He evokes his 5th Amendment rights when the lawyer asks him what the nature of his and Curtis's last conversation was.

Finbar briefly talks to Siobhan Murphy about her hiring Bosch. She tells him about Bosch finding the blanket at the cabin.

A public defender named Kris Downey asks Maddie out on a date. She turns him down. After this, she turns in her day worksheet to Sergeant John 'Mank' Mankiewicz. During this time he tells her that IA is going to come and talk to her.

Borders is now being questioned by the grand jury about the phone. He says that he may have used to speak with someone on the outside. He takes the 5th Amendment when he is asked if he talked to Bosch.

Honey goes before the Times board and tells them that Archer is trying to destroy her credibility. Harry briefly comes up during the discussion and she defends him.

Harry is leaving the grand jury session when he sees Rita at the courthouse. He then goes and tries to tell Robertson and Perry that something isn't Kosher but they don't listen to him.

Shelia calls SoCal National Bank and gets Finbar's password reset.

While staking out Find Your Grind, Maddie tells Vasquez that IA wants to talk to her. She also tells Vasquez why IA wants to talk to her. Vasquez tells her that she can't let what Bosch did ruin her career.

Sheila takes a photo of Finbar's bank statement after logging into his account. She also calls Bosch and leaves him a message, asking him to call her back. Finbar possibly hears this because he is right outside the door.

Bosch sees Robertson and Perry get followed after leaving the courthouse. He follows. Before long, Robertson and Perry's vehicle is overtaken. When Bosch swoops in a shootout ensues. Borders makes a run for it and Bosch goes after him. Back at the shootout, all the bad guys are killed and Robertson pursues Bosch and Borders. Borders eventually uses the blood from his cut arm to lure Bosch into a trap. By the time, Robertson catches up, Borders has Bosch held at gunpoint. Robertson has no option but to shoot Borders when he intimates that he might see Bosch.

Honey goes on the air attacking Archer when Bosch receives the calls from Sheila. Bosch arrives at the Gallagher offices after hours to find the doors unlocked. He enters and goes looking for Sheila.

The episode ends with Bosch finding Sheila dead.

Rita Tedesco learns that Preston Borders died and the police are now after her.

The episode begins with the police wrapping up the Sheila Walsh crime scene. Harry Bosch tells one of the investigators that RHD should be working the case because the guy who did this already disappeared an entire family. The investigator says that he heard the family fled to Mexico. Bosch tells him that is what Finbar McShane wants people to think. Bosch offers his assistance but the investigator doesn't seem too interested. Elsewhere, Finbar is shown getting in a cubbyhole in the back of a commercial truck.

After finding a burner phone attached to the underside of his patio, Bosch calls and reports it to Jimmy Robertson. Jimmy tells him that he'll have someone come by and collect it.

While campaigning at a local diner, Honey Chandler learns about Dennis Williams and how his son was murdered. She orders Michelle Carter to look into it.

Maddie Bosch reads a statement for IA. She admits to receiving the call from Borders and not reporting it. She also says that she is prepared to take whatever punishment they deem necessary with protest. After the meeting, Maddie runs into Bosch. He tells her that when Kurt Dockweiler went to prison he did reach out to an old CI of his and asked him to make Dockweiler's time hell. He also tells her that Borders got word of this and killed Dockweiler to frame Bosch. Maddie doesn't really know how to respond.

Robertson meets with Emmett Archer. He tells him that he wants him to continue the investigation into Bosch after his vacation. Robertson relays the news to Perry Lopez.

Bosch and Maurice 'Mo' Bassi discuss the Gallagher investigation. Bosch suspects that Finbar buried the family somewhere near the cabin. One of the family videos shows an old piece of heavy equipment, something like a backhoe. Bosch suspects he buried them with that.

While Maddie was at her IA investigation, Reina Vasquez made some headway into Find Your Grind Studio. When they meet back up, they head over to the studio to question Reed Lewis about a handbag he purchased for his wife. He admits to buying the handbag but says that he didn't know it was stolen. He also tells them about the girl who comes into the studio looking to sell high-end items. He claims her name is Fortune.

Bosch goes back to question Bing about the backhoe in the Gallagher family video. Bing admits to having the backhoe but it has since been washed. He offers Bosch a chance to look at the tracker.

Robertson and Perry check out the PO Box Office where Bosch rents the box for his PI business. After leveraging the clerk into letting them look in the box they find a utility bill that's being billed to an address in Shadow Hills. They decide to check out the address.

Honey learns that Lisa Broad wants to have lunch with her. She also learns that Dennis's son actually overdosed and wasn't murdered. Honey orders Michelle to keep looking.

Bosch and Mo learn that the backhoe was moved at 2 in the morning on the weekend that the Gallagher family went missing. It was moved to just a few miles from the cabin.

Robertson and Perry find Rita at the service address location, but she pulls a gun on them. It takes a minute but she finally drops the gun and lets them arrest her. They then report this to Captain Rivera. He agrees to finesse Archer but isn't too happy that they disobeyed orders. Seconds later Robertson and Perry are questioning Rita about Bosch. She admits that he had nothing to do with Kurt's murder.

Fortune delivers new plates to her robbery crew. After that, she calls Reed and tells him that she is going to stop by the studio. Reed calls and reports this to Vasquez.

Honey meets with her campaign team to deliver a final speech before the election. She skips out on lunch with Lisa and tells Michelle to go in her place.

Mo and Bosch track down the GSP location from the backhoe.

Honey meets with Dennis from the restaurant to discuss his son's, Shawn's, overdose. Dennis maintains his assertion that Shawn was killed. He tells her the story about how Shawn's friend visited him after his death and told him about his older boyfriend and how he liked to inject his younger boyfriend with designer drugs. Dennis did his own research and found out that Shawn was dating City Councilman, Patrick Currey.

Bosch and Mo search the GPS location with a drone while Robertson meets with a reporter and gives him his report on the Bosch/Borders investigation. Mo and Bosch find a spot where the ground has been disturbed.

Fortune and her boyfriend are cruising by the studio when she gets suspicious. She makes him pull over and calls in an ADW. The cops respond to the area within seconds and this confirms her suspicion that she was being watched. Maddie suspects they were made. Fortune and her boyfriend go back home and make a pact to keep their noses clean.

By this time, Mo and Bosch have a team of forensics at the dig site. They find what appears to be a small family. Bosch later meets with Siobhan Murphy to tell her the news.

Honey briefly meets with a group of reporters to discuss the election and the story in the Times. Elsewhere, another group of reports asks Archer why he hasn't cleared Bosch yet. He says investigations take a long time.

When Maddie sees the report about the Gallagher family at the station she tries calling Bosch but doesn't get an answer. After this, Vasquez tells her that she was right and they did get made at the studio. Maddie tells Vasquez that she needs to see her dad. Maddie later tries to comfort Bosch.

Michelle finds Honey practicing her two speeches and gives her a pep talk. Vasquez goes to a family dinner and her nephew is revealed to be one of the robbery crew.

Maddie encounters Downey at Honey's campaign party. They briefly flirt with each other. Honey receives word from the election supervisor that she won the election.

Bosch and Robertson meet at a bar to discuss their situation. Bosch tells him that he screwed up with Curtis Dignan but Kurt was on Borders. While at the bar they also see that Honey won the election. Bosch also tells Robertson that the Gallagher case is going to fall on his desk. Robertson promises to keep him in the loop.

Honey gives her first speech as District Attorney.

Robertson stops at a taco truck on his way home to get some tacos. While there someone robs the truck and shoots him in the head. This is where the episode ends.

The episode begins one month after Jimmy Robertson was shot and killed. A couple is shown visiting an abandoned house full of homeless people and offering them food and water. After the lady and man leave one of the rooms, the lady texts SWAT and gives them the location and the description of the man she just saw. Seconds later, Diego Perra is arrested.

Sometime later, Chief Hughes gives a press conference announcing that they caught Jimmy's killer. Honey Chandler soon takes over and gives a very brief re-

count of how the arrest went down. Harry and Maddie Bosch watch the whole thing go down from the bar.

Bosch and Maurice 'Mo' Bassi meet to go over the Finbar McShane. Finbar's social media and financial accounts have been inactive for the past month. Bosch tells Mo that Finbar bought a 30% stake in Stephen Gallagher's business. If they find out where that money came from, they might be about to find out where Finbar is hiding.

Maddie and Reina Vasquez briefly discuss Perra and Death Row while Perra gets his mug shots taken.

Honey discusses the Perra case with several colleagues. It seems that she wants to swiftly and stiffly tighten their case. After a colleague suggests that there is one way, Honey tells the team to run a Perkins.

Honey and Raquel Bowers put a camera into Perra's cell. When he is booked in he admits robbing several taco trucks but claims that he didn't kill any cop. The whole thing comes to an end when Perra gets so upset that he asks for his lawyer.

The robbery gang discusses getting back into the game. Fortune/Victoria decides that they will sell off some of their old merchandise but they will be careful about who they sell it to.

Honey learns that Perra's attorney is L Roman Stallworth. She makes plans to meet with him later that evening. Stallworth immediately tells Honey that Perra is innocent. He also suspects that Honey had him set up with an undercover cop. Stallworth really throws her for a loop when he shows her footage of Perra returning home drunk the night of the killing. After returning home, he leaves 12 minutes later, supposedly sober.

Sometime later, Honey shares the video footage of Perra with Bosch.

Nestor Gomez tries pawning a watch but gets carded. He refuses to give the pawnbroker his ID. When he leaves the watch, the pawnbroker looks at an alert of the stolen watch.

Mo shows Honey surveillance photos of Patrick Currey partying at a nightclub. After he leaves, Honey speaks with Chief Hughes on the phone. She tells Honey that Perra is being processed with lightning speed.

While Bosch and Mo discuss the Robertson case, Bosch apologizes for being curt with him the other day. After this, the two of them speak with witnesses from the shooting. They don't get much useful until Bosch talks to someone named Jason Swift.

Elsewhere, Honey and her team work to prove that the Perra video is a fake.

Maddie and Vasquez get called to the pawn shop to speak with the broker. She describes Nestor and his shady behavior. The pawnbroker also gives them a picture of Nestor, which Maddie and Vasquez immediately recognize. Seconds later they are back at the station discussing this with a superior. They decide that Nestor is not the brains of the operation and Fortune is. They make a plan to rattle her cage and see who she goes to for help.

Honey and her team continue to argue over the Perra video. She doesn't think it is enough to win over a jury, whereas her team thinks it is. They also ask her for more resources so they can get the video thrown out or disapproved. She gives them the resources they need.

Maddie and Vasquez go to where Victoria works and claims they have a witness identifying her selling stolen merchandise. She denies it and says the witness is confused. Victoria is left stunned when they pull out the photo of Nestor at the pawn shop. She tells them that she doesn't know anything about this and they should talk to Nestor.

Bosch and Mo learn that the only camera in sight of the shooting went out the night before the shooting at around 3 am. Mo suspects that the whole thing is intentional. They begin to think that the murder wasn't so random.

Bosch briefly speaks with Siobhan Murphy about the Gallagher family. He offers his help but she claims that she has a cousin coming to help with the estate.

After speaking with Victoria, Maddie and Vasquez learn that she sent a text to a burner saying — LG@8. Vasquez suspects this means a meeting at Lemon Grove Park at 8.

Mo and Bosch discuss the Gallagher case. They decide that they need access to sealed federal files which are kept in a sealed box. Mo says he'll take a crack at it.

One of Honey's colleagues tells her that with the new resources she's provided, they've found that Perra's girlfriend's neighbor saw Perra's car leave the girlfriend's place an hour or so after Robertson was killed. Honey suspects he was likely stashing the murder weapon.

Maddie and Vasquez stake out Lemon Grove Park. Victoria shows up before too long and meets with some guy. The guy tries calming her down and tells her that the cops don't have anything. It takes a few minutes but it works. When the guy finally removes his hoodie, Vasquez recognizes him. She later lies to Maddie about not knowing who he is.

The episode ends with Bosch telling Honey that he thinks Robertson was assassinated.

Harry Bosch tells Maurice 'Mo' Bassi to wave the white flag at trying to access Finbar McShane's federal records. Mo tells him those are fighting words and then notices that Bosch has the Jimmy Robertson murder case open on his desk.

Bosch tells him that he needs to retrace Robertson's last steps.

Honey receives a call from Chief Hughes, who is not at all happy about Honey's filing. Honey tells her that she is taking the time to build an unimpeachable case. Hughes asks her if she has heard from the Mayor and hangs up. Later Honey discusses the case with her colleagues and decides that they need to speak with Perra's girlfriend again.

Maddie Bosch arrives at work to find that Vasquez has taken the day off. She and another colleague will be tailing Nestor Gomez.

Bosch speaks with the bartender that Robertson was with before he left for the taco food truck. All she really has to add is that Robertson's stuff is still stuck in her closet. She can't bear

to keep it and she can't bear to get rid of it. Bosch helps her go through the clothes and finds a parking garage ticket that says — Las Palmas 1 pm 11/14.

Vasquez confronts her nephew about the robberies. He tries to act like he has little to do with Nestor and Victoria 'Fortune' Hernandez but she clearly doesn't believe him.

Janice finds a Uno card on her windshield with a time and meeting location.

Patrick Currey receives word that Mo has been asking around about him.

The address on Robertson's parking garage slip leads Bosch to a DEA parking garage. Once there he speaks with a DEA agent about a case that Robertson was working on. The agent doesn't know much but promises to look into it. After leaving the agent, Bosch calls Perry Lopez to ask what Robertson was working on. Perry is extremely hesitant but promises to give Bosch five minutes.

When Honey's team goes back to question Perra's girlfriend she tells them that she heard messing with the sliding glass door the night the cop died. She supposedly reported this but the cops did nothing because nothing was missing.

Maddie and a fellow officer tail Gomez while Perry gives Bosch Robertson's case files. There was only one cause involving narcotics. Bosch asks Perry if he can get ahold of the murder book. He says that he'll look into it.

Honey's team discusses what they learned from Perra's girlfriend. This is interrupted when a coworker comes in and tells Honey that Currey wants five minutes with her tomorrow. Honey agrees to meet with him.

Vasquez goes to her sister to talk about Albert Torres. She tells her that Albert isn't a bad kid and he's been working with a roofing crew. He's also apparently spending time with their grandfather on the regular.

Mo meets with Janice and gives her his request. She is extremely hesitant at first but thinks twice when he reminds her that she owes him.

Maddie and a coworker follow Nestor to a Dollar Store where he meets Albert. Maddie happens to get a picture of Albert.

Bosch continues to look into Robertson's last Juan Doe case. He learns that Robertson ordered a fingernail analysis for what was supposedly a shooting death and surprisingly enough found a white chalk-like substance under the nails. The victim also had a blank key card in his sock.

When Currey meets with Honey he tells her that Emmett Archer became closed off and that's what hurt him the most in the end. He also tells her that he could be a good friend to her.

Vasquez visits her grandfather and learns that Albert and Victoria have been visiting him recently. When the nurse pulls Vasquez's grandfather out of the room, she searches it and finds a box full of stolen jewelry items.

Perry gives Bosch Juan Doe's key card as promised. Mo tracks it and finds that it comes from a hotel in Lancaster. The check-in was in late October.

Honey learns that Perra's DNA was not on the bullets but an unknown male's was. They are running it through CODIS as they speak.

Albert meets with Slippery Sam and arranges for him to look at some merchandise.

Maddie is back at the station going through the Melrose Robbery file when she notices that the report is missing some pages. She and a Sergeant decide to run him through LexisNexis to see what pops. This is when Maddie learns that Albert is related to Vasquez.

Later that night Maddie surprises Bosch while he is having dinner. They share a drink and she tells him that she might know an officer who is protecting someone potentially dangerous. He tells her that she has to decide how much of the gray she is willing to live with. He also tells her that this person could still do the right thing when the time comes.

Victoria asks Albert when he is going to move out of his mother's house. He surprises her by telling her that he was thinking about getting out of town with her. She tells him that she isn't going to pack up her life and they need money to do something like that. He tells her to let him worry about that for a change. When Victoria later gets up to get them a beer from the fridge, she sees a photo of Vasquez.

Mo is at home when Janice shows up with the file on Finbar he was looking for. She tells him that it was sealed because Finbar had an accomplice, who just happened to be a former intelligence asset.

Maddie shows up at Vasquez's place with some soup. Maddie tells her about tailing Nestor into a Dollar Store and then tells her that they need to talk about her nephew.

The agent Bosch met earlier tells him that Robertson's contact was a DEA agent named Nemeth. Robertson supposedly asked him about black ice and fentanyl for a Juan Doe case that he was working on. Bosch later tells this to Honey and tells her that the agent didn't give Robertson any information because there was no information to give. The conversation doesn't get much further because Honey receives a call from Corvus Pike. After hanging up with Pike, Honey tells Bosch that the DNA found on the bullets was tied to the Juan Doe case Robertson was working on.

The episode ends with Bosch saying that Jimmy was a hit and it was the sicarios.

Summary:	Bosch and Lopez continue investigating the Juan Doe case. Chandler begins to win the trust of her team. Maddie and Vasquez zero in on the follow-home crew.



The episode begins by showing a bunch of Spanish workers being picked up for work. After the van is nearly loaded, one shows up late and begs to be taken. The boss graciously takes him and then has the workers blindfold themselves as they are driven to the job site. When they finally arrive at the job site, the man who was late is made to get down on his knees and place his open mouth on a crowbar. The boss smashes down on the back of his head, knocking nearly all his teeth out while reminding him that the pickup

time is 5.

Reina Vasquez is waiting in the station parking lot when Maddie Bosch shows up. Vasquez tells her that the Albert Torres situation is going to tear her family apart and she should have filed a report as soon as she suspected him. Maddie tells her that she has her back. Seconds later, Vasquez is telling her superiors about her conundrum. They ask if Albert's mother, Mari Torres, could help talk Albert into peacefully surrendering himself. Vasquez says that Mari would never turn Albert in. One of Vasquez's superiors says that he knows how they can bring down Albert tomorrow.

Honey Chandler tells Diego Perra's lawyer about the unknown DNA on the bullets. Honey then offers Diego a deal through his lawyer if he can provide intel on the real killer. The attorney says that he will talk to his client.

Harry Bosch learns that the white substance under Juan Doe's fingernails is a substance used to kill algae. And, there only happens to be one company to make it, United Chemical. When Bosch later discusses this with Perry Lopez, they learn that there are two United Chemical plants on the West Coast. One is in Modesto and the other is in Lancaster. They make plans to investigate Lancaster first thing in the morning.

After speaking with her superiors, Vasquez receives a call from Mari, who asks her what they are going to do for their mother's birthday.

Bosch speaks to an associate about the Gallagher case and asks him for help tracking down William Jurgenson. The associate agrees to help him.

Victoria 'Fortune' Hernandez goes to her parents for help with her situation while the Spanish men from earlier unload a car full of drugs. While the car is being unloaded, the boss receives a call from someone about the Perra case. The caller appears to be worried that the case is going to point back to them but the boss not so much.

Albert receives a call from the police, claiming that a pipe burst in Albert's grandfather's room and they need help moving his things. Albert reluctantly agrees to help. Vasquez later receives word that Albert took the bait.

Maurice 'Mo' Bassi stakes out the Lancaster hotel while Bosch and Perry speak with the Lancaster Sheriff. He admits to speaking with Jimmy Robertson the one time. When asked about United Chemical, he calls to arrange a tour for them.

Albert learns that the Coventry call about his grandfather was a lie when he speaks directly to his grandfather.

Bosch and Perry tour the United Chemicals facility and don't discover anything interesting.

Elsewhere, Perra tells the DA about his food truck robberies. He also tells them that instead of being ordered to hit the Las Palmas truck, he was ordered to stand down from that location. It was supposedly a guy named The Pope who ordered him to stand down.

The Lancaster Sheriff is shown talking to the boss from the being of the episode about Bosch and Perry touring the facility. At the end of the conversation, the Sheriff plants a tracker on the boss's truck.

When the cops realize that Albert isn't going to show up at the nursing home they decide to put a tracker in the stolen merchandise. Vasquez goes in to put the tracker but realizes that the merchandise is already gone and has been replaced with a picture of the family. The picture indicates that Victoria got to the goods first.

The Lancaster Sheriff calls RHD Captain Rick Seals and tells him about Perry and Bosch looking into the Juan Doe case.

Nestor Gomez and Albert speak with their fence to buy more time so they can get to the merchandise. This is when they learn that Victoria has already beaten them to the punch and arranged a meeting to sell the merchandise tomorrow night.

Perra gives the DA a composite of The Pope.

Bosch and Perry try speaking with the clerk at the Lancaster Hotel but he is very uncooperative. After this, Perry is called back to Seals' office and Bosch orders Mo to head to United Chemical and watch the comings and goings.

Vasquez and Maddie decide to speak with Victoria's parents for information. The parents give them a burner and tell them that Victoria's prepaid number is on the phone.

The DA identifies The Pope as Humberto Zorrillo.

Bosch shows the maid at the Lancaster Hotel a photo of Juan Doe. She says that he did stay there but she doesn't know his name. She also says that guys came twice and tore the room apart but didn't find anything. When asked if they called the cops the maid practically laughs in his face.

While looking at Zorrillo's tattoos, Honey realizes that he could have been Robertson's shooter. She calls Bosch to share her discovery and it is all but confirmed that Zorrillo is the shooter.

Back at the station, Maddie and the others get a hit on Victoria's cell phone. The location is La Zona Rosa.

Perry speaks to Chief Hughes about his working the Robertson case. He tells her that he started looking into the case but didn't find anything. She doesn't believe him and asks him

what he has really been up to with Bosch.

Mo shows Bosch his surveillance photos from United Chemical. Bosch identifies Zorrillo and tells Mo about someone trashing Juan Doe's room. Bosch suspects that he was stealing Black Ice.

The cops stage around Victoria's location. While Victoria and The Fence are arguing over the price Nestor and Albert show up. After buying the merchandise, The Fence leaves Nestor, Albert, and Victoria to haggle over the money. This is when Victoria calls Albert out about his Aunt being a cop. Before things get much further, the group hears a helicopter outside and Nestor pulls a weapon on Albert. He takes the money and leaves but is stopped. Instead of dropping the gun, he points it at the cops and is shot. At the same time, Victoria and Albert make a run for it. Maddie and Vasquez end up in pursuit. Maddie takes down Victoria while Vasquez goes after Albert and catches him.

Bosch and Mo search Juan Doe's hotel room. After finding a bag of black ice in the mattress, they call Sheriff Deputy Jack Garrity. Instead of Garrity showing up at the hotel, Zorrillo shows up. Bosch waits on him inside the hotel room but he doesn't enter.

The episode ends with Zorrillo leaving the hotel room.

The episode begins with showing Humberto Zorrillo breaking into Sheriff Deputy Jack Garrity's house. While inside, Zorrillo receives a call, telling him they are increasing his load from 20 to 30 vehicles. Garrity never comes home, so Zorrillo puts his smoke out on one of Garrity's pictures on his coffee table and leaves. It turns out that Garrity is watching the whole thing go down from his neighbor's house. When Garrity finally gets the courage to return home, he finds Harry Bosch waiting on him.

Bosch tells Garrity how he knows El Fuerte has their hooks in him and how he played a part in Jimmy Robertson's death. Garrity tries to play the whole thing off until he learns that Diego Perra is in protective custody, blabbing.

Honey Chandler tells her team to call RHD and schedule an interview because they have a new suspect.

Reina Vasquez suggests Albert Torres work with his attorney to get a shorter sentence. He asks her how things will be between her and his mother. She says that they will have to see.

After Bosch hands Garrity over to Detective Gerard Willis he receives a call from Ken Gurbizss, telling him that they are on.

Garrity tells Willis everything he knows about Zorrillo. He also asks for witness protection in exchange for physical evidence and Zorrillo's location.

Gurbiz and Bosch meet with Gurbiz's contact to talk about the Finbar McShane disappearance.

Two men are shown meeting in Tecate, Mexico. One gives the other a boosted car and some supplies. The other pays him.

Gurbiz, Bosch, and Maurice 'Mo' Bassi meet to discuss Finbar's last known locations. They realize he is headed north and likely looking to scoop up someone else's cash in Tecate. This is as far as the discussion goes because Maddie Bosch interrupts. She sees the map of Mexico and asks what's there. Bosch tells her Finbar. Maddie makes him promise that he will go to Mexico and bring Finbar back alive.

Honey and Chief Hughes meet to discuss how Zorrillo will be prosecuted. They appear to agree on the death penalty.

After Garrity doesn't show up at the plant, Zorrillo calls his contact and reschedules the pickup.

Maddie briefly talks to Vasquez about getting back in the saddle at work.

Patrick Currey is shown giving his boyfriend some drugs. He is then shown rushing out of the house while speaking to someone on the phone. A lady walking her dog on the street overhears him and calls 911. Maddie and Vasquez get called to the house and save the guy's life by clearing his airway.

Bosch and Gurbiz meet Mo in Mexico while Vasquez visits her Mari Torres to talk about Albert. This doesn't go so well and ends with Mari storming off, telling Vasquez she wants nothing else to do with her.

Currey's fixer tells him that he should be in the clear but at the same time, he gives him a copy of Honey's psychiatrist files just in case he needs ammunition.

At a bar, Vasquez and Maddie get into a fight with a group of rowdy men. This leads to them getting kicked out of the bar.

Zorrillo and his team are just finishing loading a stash of cars with drugs when the DEA shows up and busts them. Zorrillo is taken into custody without a fight. Bosch receives word of this just as he and Gurbiz are entering a bar in Mexico that is known to host a poker game or two. While they are there they ask around about Finbar. That bartender tells them that he doesn't know who he is but the young boy from the beginning of the episode overhears them and later tells Bosch that he knows where Finbar is. Seconds later, Bosch, Mo, and Gurbiz are posted on a mountain just outside the cabin that was showing at the beginning of the episode.

Willis tells Honey that Hughes and the DEA will be taking over the Zorrillo case.

Later that night while staked outside Finbar's cabin, Gurbiz asks Bosch if they are there to kill or capture Finbar. Bosch tells him that they are bringing him back. Not much later after this, Mo sees Finbar come home. After he relays the word to Bosch and Gurbiz they decide to raid the cabin. It's only a few seconds after this that they take Finbar into custody.

Shortly after Gurbiz and Bosch take Finbar into custody they receive word from Mo that Tecate authorities showed up at the cabin with the young boy who told them where to find Finbar. They also receive word from their pilot that the Federales are blocking the airstrip. Learning of this causes Gurbiz to pull over beside the road and jerk Finbar out of the car. After some debate with Bosch, Gurbiz shoots him in the head.

Sometime later after getting back to the US, Bosch calls Siobhan Murphy and tells her that he got Finbar. Very shortly after that Maddie shows up. He tells her about Finbar but promises that he didn't kill him. This is where the episode ends.

Unfortunately, this doesn't pan out because Mo doesn't get a hit on the license plate. He does, however, discover that the driver is alone. Bosch decides to lure the pursuer to his office where he has a gun stashed. At the office, Bosch learns that he is being pursued by Renee Ballard. She is apparently after him because he wants the files that he stole

from her.

After Renee tells Bosch that she is working on the Flower Girl case, he realizes that there must be new evidence in the case. He tells her that he made copies of the files but the originals are at the Hollywood Station. She tells him those files are missing, so she needs his copies. He agrees to show her the old evidence if she shows him the new. She agrees but says that she will need to get approval.

RHD Captain Rick Seals tells Renee to set up a meeting with Bosch but go with a search warrant.

Honey Chandler bursts into Chief Hughes's and accuses her of big footing her on the Humberto Zorriilo case. Hughes doesn't have much to say in response.

Bosch is at home drinking and reflecting on the Flower Girl case when he receives the call from Renee, arranging to meet to exchange information. The next day, Bosch receives word from Honey that Seals applied for a search warrant for his property and person. Bosch thanks Honey for the heads up.

When Renee gets around to serving the warrant, Bosch tells her that it has been canceled and Honey has filed a new request to get access to the evidence that she has so that he can work the case. Sometime later, she shows up at his house with the original and a copy of the file. After she tells him about the new case, they spend several hours going through the evidence. Bosch also tells her how the killing stopped 13 years ago and has now resumed. After leaving Bosch's house, Renee places a tracker on his car.



Sometime later, Renee relays the information to Seals. He mostly seems interested in the fact that she didn't tell Bosch about the new DNA evidence. He also wants her to watch Bosch and make sure he doesn't do anything stupid.

Bosch and Mo set up a date with a Filipino girl they find online. While they are outside her house discussing their plan, Renee shows up. She tells him that she is working on the case and they need to do things right. Mo tells her that a search warrant won't work because the guy they are looking for likely has a VPN browser that guarantees his anonymity. She tells them to stand down and leaves.

Bosch is at home going through the Flower Girls case when Maddie shows up. They spend several hours going through the case before Maddie realizes that the same paramedic pronounced death in two of the cases, including the most recent. Even though Maddie doesn't think there is anything strange about the guy, Bosch calls Mo and gets a complete workup.

The following day, Mo gives Bosch and his associate a summary of what he discovered about Jeremy McKee. Bosch decides that they need to watch him and see how he acts. He also calls Renee to tell her that they've identified a suspect.

Bosch meets with Renee to give her his profile of McKee. This is when she tells him about the DNA and how Seals made her hold back from telling him. They make plans to get McKee's DNA after Bosch tells her that he's had his associates watching him.

Renee goes into a bar to watch McKee while Mo places a tracker on his vehicle. Before Mo can finish, Bosch receives word from Renee that McKee is on the move. Renee also fails to grab the beer bottle that McKee was drinking from. Mo tells Bosch that he couldn't hardware the tracker which means that it is only working on an internal battery. Due to their lack of success, Bosch calls Maddie and asks for a favor.

Maddie and Reina Vasquez pull McKee over when he blows through a stop sign. He immediately recognizes them from Hollywood but they deny knowing him. They also pretend to smell alcohol, which gives them the right to give him a breathalyzer. He passes the test, but this gives them his DNA.

Bosch and Renee tell Honey about the case and McKee but she isn't convinced that there is enough to work with. Bosch later relays the news to his associates which they aren't too happy about. This is when Mo also realizes that the battery is at 23%, so he will have to hardwire the tracker at some point.

Later, Mo breaks into McKee's house and finds the stolen Flower Girl files. Not long after this, the team loses track of McKee because the tracker dies. While Mo tries hacking McKee's password, McKee is shown staking out an apartment. About the time McKee goes to break into the apartment, Mo gets into the computer and learns that McKee previously connected with a chick on a new Filipino Flower site. After getting the address, Bosch and Renee race there.

Bosch and Renee break into the apartment just in time to stop McKee and save the Filipino girl.

Bosch and Renee re-meet with Honey to go back over the case. After this, Bosch speaks with Renee about working under Seals. She says closing the case should save her but he is retiring in six months. Bosch tells her that she does good work and hopes they will get to work together again. She tells him that he does good work as well but she used to have an old partner who said that doing this job can cause darkness to rub off on you. She believes that some of that darkness has gotten into Bosch.
