It is about knowing your partner and in the group we have an 'Odd Couple', Wes and Travis. The counselor, Dr. Ryan asks Wes to share some information about Travis; but he doesn't know much. Travis tells her that she is perfectly right about that one! But then she moves on to Travis and tells him that he has a diffi-

They are detectives and they work together. They are here to save their crumbling partnership. They are about to play a game, when their phones ring. They have a case to work on and they leave. It appears that Wes pulled his gun on Travis as Travis wasn't apologizing for a reason yet unknown. And that is how they end up in this therapy. They arrive at the crime scene. Wes

examines the body; white male and unidentified. Wes tells the cops that the victim was killed someplace else. He doesn't look homeless as he is wearing designer jeans and his finger nails are manicured. Just then Travis finds the murder weapon and it says 'Scouts'. They find a boy standing in the crowd suspicious and they chase him. They catch the guy. He tells the duo that he only took his cell phone and his shoes and wallet. Sutton agrees to put them back on the case. Next, the forensics expert, Ellen tells them that this particular scout knife was handed over in 1911. And the blood on the knife did belong to Toby; but she only managed to get a partial print on the hilt and those prints did not have a criminal record. By the way, Travis is dating Ellen and Wes hates it when Travis dates women at work. Back to the case, Judge Whitaker has a son named Zach who lives with his father and the mother died five years ago. They arrive at the Judge's house. There is a lot of media present.

Whitaker tells the duo that Toby was addicted to heroin for years and had finally agreed to go to the rehab and he was sober for the past nine months. He spoke to Toby three days ago. He had gone to meet Toby with Zach. But Zach isn't around now as he is upset and has gone for a drive. Whitaker tells them that Zach was a scout when he was a kid. They tell the Judge about the murder weapon and the Judge is not happy that his other son is being accused of murder. The Judge tells them that Zach has dyslexia. He tells them that Zach is a good kid. Next, the duo goes to the sober house Toby was kept in. They check his room. The manager Marcus and Vincent don't discuss about the patient's personal life. Just then a girl, Gretchen, walks in and tells them that the Judge and Zach killed Toby. She tells them that the Judge told Toby that he wishes him dead and that the family could be saved from a lot of trouble. Vincent tells them to not take her seriously.

But Gretchen also tells them that she and Toby broke off a long time ago. So, a jilted exgirlfriend is definitely on the list of suspects. But Travis feels that she doesn't seem to be the types who would kill somebody. He knows a lot about scary Exes. Just then Wes receives a call and he is told that Zach is found. And guess where he is; on the top of the Rosslyn Hotel, trying to jump off from the roof. The detectives reach atop. Zach tells them that he is sorry that his brother is dead because of him. Travis tries to instigate Zach and Zach decides to talk to Wes. Travis leaves. Zach tells Wes that Toby had asked for \$5000 from him and Zach did not give it to him. Toby wanted that money to pay off his dealer and he always used to lie to Zach while borrowing money from him. Zach thought that this too was a lie and didn't give Toby the money. And Toby lost his life. Wes asks him about the scout knife. He tells Wes that the knife was his but he gave it to Toby.

Just then Zach slips but they manage to save him. Travis does not buy Zach's story. Not many dealers sell their stuff on credit. Next, they arrive at the office and Ellen hands them the call list for Toby's number. There is a particular number that Toby dialed multiple times. It belonged to a guy named Dominick and Travis remembers Randi, an officer from Narcotics, mention that name a couple of times. They go to meet Randi. Dominick Suntory sold high end cars and it is known that he uses those cars to sell drugs. But Randi tells them that their dogs have never been able to pick up any scent. They go to Dominick's showroom. They ask him about Toby and Dominick decides to lawyer up.

And guess what the repercussion is for that one? Travis shoots the back of one of the most expensive and hard to find Lamborghini and they find a leak, but instead of oil there is a leak of white powder; heroin. They seize the vehicle. Dominick is ready to tell them everything about Toby. But Dominick wants to settle the matter then and there and does not want any complaint filed against him. He tells them that Toby was calling him for money and he needed 5k and Dominick wasn't even in town. He doesn't know why he needed that much money but he says that Toby sounded desperate. He gave him the money; but he also mentions that there was someone else in the car with Toby. He also says that he arrived this morning from Phoenix, where he was attending a car show. The two leave the showroom, go out and inform Randi about the cars and the drugs. Next, they go to a junkyard and there are guys who draw guns at the detectives.

But it appears that Travis knows their leader, Money; he is his foster brother. Contacts! Travis tells him that he needs his help to find a car. Money has received a recent mail regarding a 69 Cheval. They check the license plate number. Wes makes a note of it. They go to the house where the car is at the moment. They find Toby's girlfriend, Irene with his son, an infant. She tells them that after Toby saw his son in the ultrasound, he was a changed man. And she confirms that Toby took the money from Dominick to pay the bills and she was in the car with him. Next, Wes goes to meet Alex. She tells him that he was a better lawyer than a cop and he tells her that the people need better cops than lawyers. Next, the duo goes to meet the Coroner. But Travis is reluctant as he had a one night stand with her and he didn't call her up. Oops.

She tells them that the COD was hemorrhaging and that there was heroin in the blood. There is a puncture wound on his neck. They think that he relapsed. Wes thinks that he was forcibly injected. They go to the sober house and Vincent says that if a resident is found possessing drugs, he is chucked out. Wes still has his doubts on Gretchen. Travis decides to go to a store and get something to eat. He realizes that there is going to be a robbery. He informs Wes. Wes arrests the accomplice e sitting outside in the car. In the store there is a gunfight and Wes rams into the shops with his car. They arrest the guys. Ellen finds a match for the fingerprints; it matches with Zach's. They arrive at the office and the scene there doesn't look good. Sutton tells them that the DA is coming to the office. The news about Zach being a suspect is out and Wes thinks it is Travis who leaked it. Next, Laura arrives at the office and she isn't happy to see Wes and Travis on the case. Laura wants to know why Zach isn't arrested.

Wes tells her that there are several loose ends that they need to tie up and if they arrest Zach at the moment, his lawyers would make sure that they get nothing and his future also could be destroyed. They need two more days. Laura wants them off the case and the two get into an argument which leads to a tussle. They are definitely off the case now. Laura asks Scott and Gooding to make the arrest. Next, Ryan meets Wes and talks to him about the 'break up'. She tells him that they fight because they are alike. They are like brothers. Just then a thought strikes Wes and he goes to meet Travis. Travis is making out with Ellen. Wes is outside and tells him that Toby too was dyslexic like his brother, as it is a hereditary disorder.

All the numbers he dialed were on speed dials except for the last one. And owing to his condition, he must have mixed up the digits. They were tracking the wrong number. Wes apologizes to Travis. Wes realizes that Brady Gooding, the officer on the case was the leak. Wes tells him that he tried all possible combinations for that number and found out that the number belonged to Marcus, the guy from the sober home. Toby found out about someone who was using again and tried to report it. They get Randi's dogs along to make sniff out stuff from the sober home. They find the drugs in Vincent's room. The episode begins with Wes and Travis in a shooting vard and Wes is still not talking to Travis. Next, at the couple therapy session, the participants are asked to draw and Wes tells Ryan that he cannot draw. They are asked to draw a tree and Wes' tree is imaginary. Dr. Ryan is supposed to meet the guys the next day, as they would be observed and the rest of the group the next week. Next, they have their new case; a lady jumped off from the fifteenth floor of a hotel. Just then Dr. Ryan arrives and the boys leave with her. She is going to be with them the whole day. They take her to the crime scene. In the car, Travis learns that Ryan has a boyfriend and she lives with him. But

later Travis infers that she was talking to her boyfriend's son.

They arrive at the hotel. The victim's name is Justine Winfield. She is married, lives in the same town and she checked into the hotel for a one night stay. Wes manages to engage Detective Frank and Dr. Ryan in a therapeutic conversation and he goes inside to check the victim's room. Next, Wes tells Travis that there is no reason that an identity thief is carrying around that much money. Travis doesn't like Mr. Winfield.

Next, they are supposed to go to the coroner's office for the autopsy report. Wes tells Ryan that Travis had an affair with the coroner and now they aren't on good terms. They arrive at the office. Jonelle tells Ryan that she is over Travis and she is happy in her current, adult relationship. Back to the report, she tells them that this wasn't a suicide. It appears that the victim fought for a life and her earring was torn from her left ear lobe. Moreover she has blood on her tooth which does not match hers; which means that she did bite her killer and that the killer will be having a nasty bite mark on him/her. There is a puncture mark on her body; but the coroner tells them that she had no drugs in her system. She tells them that she can run a test to find out more about the puncture and what kind of a shot was the victim given. Next, they collect the victim's prints.

Travis finds a match. The victim is Olivia Fisher. She was arrested but not for fraud. She was charged for assaulting her husband and she said that she hit him in self defense as he hit her first. They then check the husband's details. They go to meet Fisher. They hear gun shots. They see that Fisher is shooting at his wife's belongings and setting fire to them. He tells them that his wife left him. Travis tells him about his wife's death. They take him for interrogation. He tells them that Olivia left him for some rich guy and he hasn't seen her since Monday. Wes thinks that since Fisher is drunk, they should get him sobered up and also get in a lawyer so that they could check for bite marks.

But the drunken husband undresses then and there and they see that there are no bite marks on the body. They know he is innocent. He tells them that he has to take anger management classes as it was court ordered. He tells them that he set fire to his wife's belongings because it was one of the things they taught in anger management classes. Just then the coroner calls Wes and tells him that Olivia was vaccinated for yellow fever. It appears that she was going to some place exotic. They need to get information about the flight tickets. But they need court orders and that would take weeks. But we know Travis isn't always by the book. Ryan is about to leave as her day is over. She thinks that Travis is the guy that everyone likes and that Wes is a guy who is more of prick; and she hasn't had much luck treating pricks. She leaves.

Next, Travis is at the airport, where he meets his foster mom. She knows that Travis needs something. She always knows when one of her kids needs something. Travis tells her that he needs a huge favor. She is a director at TSA and she manages to get him the flight manifest. Travis returns to the office. Wes tells Travis that h has cracked the case. All the notes that were found in the hotel room were organized and separated by the denomination; a trait that Mr. Winfield had. But the evidence that Travis has is definitive. There were two tickets booked one for Olivia and the other for Mr. Winfield. Olivia was on probation and hence could not travel under her identity. So she had to use Justine's identity. And she was having an affair with Winfield. They go to meet Derrick Winfield.

But Winfield tries to runaway. After a short chase, they catch hold of him. Derrick tells them that he was having an affair with Olivia and that they were going to start a new life together. But at the last moment he had cold feet and he realized that he still loved his wife. The money actually belonged to the Texas' gunrunner, Ronnie. He tells them that he initially gave all the money to Olivia but he doesn't know what she did with it. And now he is supposed to return all the money to Ronnie, as he has kidnapped his wife Justine. But Derrick tells them that he did not kill Olivia. Also there isn't any bite mark on his body. Derrick thinks that it is Ronnie who killed Olivia. But Travis and Wes figure out who the killer might be. They also tell Derrick that they have his money and they will help him get his wife back from Ronnie. They chalk out a plan and Ronnie gets arrested.

But it is not only Ronnie who is under arrest; Justine Winfield too is arrested for murdering Olivia Fisher. Wes checks for the bite mark and there is a nasty on her forearm. Summary: Wes and Travis investigate the murder of a woman whose death could

be linked to her involvement in a dating website. During their investigation, Wes discovers that his ex-wife has a profile on the same site

and has begun dating again.



The episode begins with Travis arriving at a house. Wes is already at the backside of the house; hiding. They are about to enter the house, when Wes tells Travis that they are supposed to use stun-guns. They enter the house and find who they are looking for; it is a raccoon. They manage to cage it. The raccoon has chewed of Alex's electrical lines!! But now, Alex and Travis find the animal cute. Wes tells Alex that he will fix the lines for her once he is back. At the therapy session, the participants think that Wes has not moved on and is still in love with Alex. Next, two couples are playing tennis and one of the couples finds a dead body lying on the other side of the fence. The duo arrives

The only thing she cared about is how she looked in those outfits. Travis infers that Darby was not looking for

a sport but was looking for a man. The store keeper gives them her address. They arrive at the building. The landlady tells them that Darby had told her that she was going on a tennis date; but she was a very through person. She did background checks on all her dates as she worked in a computer agency. They don't find her computer at her apartment; but the credit card statements show that she was a member on a dating site.

She also has a cat, Milo, who is her only friend. They get Milo to the office. They figure out her login password for the site and they log into her id. They see that Darby had three dates. They decide to make an account under Darby's name and then get in touch with those guys. Just then one of their colleagues tells Travis that there is a new girl in forensics and she is looking for him. She is Candle. She tells Travis that if Darby was a computer geek then she would have backed up all her files on the internet storage. She is also trying to trace Darby's computer. Later, Wes tells Travis that Darby hasn't yet heard from the three suspects. As Travis is checking out the women on the dating site, he finds that Alex too has a profile on it.

He tries to hide it from Wes but Wes takes away the laptop and sees that Alex has an account. Just then there is an alert on Darby's fake account. The cycle-guy who Darby was supposed to meet has messaged her and wants to meet her tomorrow. Wes is still upset about Alex's dating account. He goes to her house to fix the wiring and asks her about the dating site. She tells him that they are divorced and that he need not worry about her. Wes and Travis meets the cycle-guy; the guy who Darby was supposed to meet. He tells them that he didn't meet her as she did not turn up and he ended up hooking with the waitress at the bar. Next, at the office, Candle tells Wes about Ted and Paul, the two guys that Darby was supposed to meet.

Travis is surprised that candle actually likes Wes. Next, the duo meets Ted. Ted takes driving classes and is the 'driver of the year'. Ted tells them that he did meet Darby, but she wasn't his type and hence he never dated her again. Next they go to see Paul. He is a chemist. They arrive at his apartment but no one opens the door. Just then a guy walks out of the lift and he runs on seeing the cops. They chase him but it appears that he isn't Paul as the picture from the dating profile is not him. They go back to the house and this time Paul's mother opens the door. She tells them that she had set up his dating profile as she wanted him out of the house. But now the fact is that the guy they chased is actually Paul and his mother had used a different picture for the profile; she faked it. They enter Paul's room. They find a lot of 'pot' plants in his room. His mother hasn't been in his room for two years.

They also find Darby's tennis racket in the room. Travis remembers seeing a symbol on Paul's bag pack. He knows where they could find Paul. Paul is a pot dealer. They go to the institution and they find Paul. Paul tells them that he liked Darby a lot and he didn't kill her. She knew that he was a pot dealer as she had done a background check on him. He tells them that they did discuss about some of the guys she did a check on; they appeared to be a little shady. But they don't buy whatever Paul says and he is still under arrest for murder. Next, Wes is still checking the details of one of the guys on the dating site. Travis figures out that Wes is trying to find out about the guy Alex was just going to date; Tango Phil. They go to the place where Phil takes his tango classes and sees him kissing a girl.

They barge in and threaten to arrest him for lying online. They make him call Alex and force him to tell her the entire truth. Alex cancels her date with Phil. Wes feels that there is a possibility that Paul is telling the truth that he did not kill Darby. It is possible that during the background checks, Darby must have found out something about one of her dates and that he must have killed her as he did not want the truth to be out. There is nothing to hide about Paul as the whole world knew that he is a pot dealer. Wes calls Kate and asks her to check Milo's locket for the encryption code for Darby's files. Kat finds the code. Candle finds out who the guy is; it is Ted Houseman, the driving instructor. His actual name is Roger Williams and the FBI has been looking for him for the last seven years as he was the driver in a Swiss bank heist.

They go to get Ted and Ted tries to escape. Wes chases him in a car and Travis is in a helicopter. They arrest Ted aka Roger Williams for the murder of Darby Jansen. Next, Sutton visits Ryan. The episode begins with Wes and Travis deciding on a place where they would have their next meal. Travis tells him that since he decided the previous day, it is his turn today. Next, the two are in Ryan's office with food all over them. They tell the group what happened; just another fight. Next, we see that the Mayor of Beverly hills' is kidnapped by some masked men. Meanwhile, Travis is surprised to see Phil at the office. Phil is his ex-partner. He is with Beverly Hills PD and he tells them that the Mayor got carjacked on their turf. Phil is accompanied by his wingman, Morgan Watkins. They are called for a meeting. Morgan updates the group that the carjacking was

the work of a particular group and that this has to be top priority.

Wes and Travis are appointed to be as valets at the Regal Pacific. Just then Wes gets a tip that a similar kind of truck is spotted at a nearby area and that there is a restaurant around that area. Phil arrives and asks Travis to park his car. But instead they take Phil's car to the restaurant. When they arrive at the spot, the masked men are about to rob another car. They announce themselves. But the masked men open fire and later manage to escape.

Travis feels that Phil is going to get them suspended. When the duo arrives at the office, Phil acts absolutely normal. The episode begins with Wes and Travis staking out for a criminal. Wes tells Travis that he better be right about the information as half of the LAPD is also waiting for this guy. Travis seems positive about this information. Just then they see a guy around the corner; he is running and trying to escape. The cops are chasing him. The duo also chases him. The guy is arrested. Next, at the group therapy session, they discuss about 'performance anxiety'. Meanwhile, a middle aged couple tip their way into a famous club. The husband has promised his wife that he would take her to a famous club where she could meet some famous people. The bartender ignores his order for

an apple-tini. He is irritated and draws out his gun. He fires three shots at the ceiling and gets the attention he wanted.

He places his order. At the office, Travis tells Wes that with their previous arrest, they are really close to 400. The whole office applauds the duo for 398 arrests. Sutton tells them that with 400 arrests they would reach the LAPD region of honor. Sutton then tells them about the latest case. It is about the couple at the club. The duo goes to the club and talks to the bartender. She tells them that the man had an accent. She also tells them that he had a silver bracelet on his wrist with a lot of charms on it; like the ones in the play cards. But the wife did not say a word the whole time and she had the exact same bracelet on her wrist. Wes figures out that the couple like to play bridge; also that they were southerners. Travis adds that they were from the Texas Panhandle region. Wes does a search and finds information about the rich couple, Jim and Maria Bergen and they are from Texas.

They find out the Hotel they are staying at. Travis is slightly nervous. With these two arrests their number would be 400. But Wes considers this to be another takedown; just like the ones earlier. Wes plans the arrest; he would enter from the front of the Hotel and asks Travis to take the back. But then they have some confusion about the front and the back and they end up at the door of the room the couple is staying in. the couple hears the arguing and escapes. They lost the couple. Wes is wondering what just happened and Travis quotes Ryan' 'performance anxiety'. At the therapy, Ryan tells the duo that they should learn to communicate rather than blame each other for things that go wrong. During dinner, a girl walks up to Wes and asks him out on a date. She gives him her card. Wes looks confident when he enters office the next day. He shows the card to Travis.

The girl is Carine Thompson and she is a high flying executive. Travis warns him about 'performance anxiety'. Just then an officer walks in and updates the duo about the latest robbery that took place. It was the Bergen couple. They check the surveillance footage and feel that here is something odd about the wife. She doesn't talk or keep a watch on the door. They think that it is possible that she is not a partner at all. Travis finds out more about Jim. Jim worked as a claims adjuster for 20 years until his company went broke, and CEO looted the pension of the employees. Just then Wes gets a call. The call was from Maria's sister. Maria had given her sister her cell phone number to keep in touch. Now Wes has that number. They call the number. Maria tells asks them for help and she gives them a partial address. She sounds scared. They rush to the address.

They find two security guards with a piece of note. The couple has managed to get away this time as well. The note is written by Maria and it says that she fears something bad is going to happen as Jim is getting worse. He keeps talking about the end. She feels that Jim might harm her. Wes and Travis then go to the coroner with some pills they find in that house. She tells them that some are aspirins, some oil supplementary and the rest is an anti-inflammatory; prescription only. It is prescribed for chronic illnesses. Next, Wes is out with Carine and tells her about his life. Carine feels that he hasn't moved on and that she hopes he does. Meanwhile, Travis tells Amy that Jim was diagnosed with ALL (Acute Lymphoblastic Leukemia).

Wes sees Travis talking to Amy and he acts a little weird. Wes is irritated that he managed to ruin the date. At the therapy, both of them agreed that maybe they are nervous about completing the target. Moreover, both of them feel that might be at the hotel they were on the wrong side. So, we see that there is some real communication happening as they have stopped blaming each other. Wes asks Travis as to why was Jim Bergen shooting blanks as they found no bullets at the club. Travis has no idea. Just then they get a call and leave from the session. The Bergens pulled off another robbery. The manager gives them the details. But he also adds that the wife didn't say or do much. He tells them that when he asked her for a drink, while her husband went to the bathroom, she declined. Wes wonders as to why Maria didn't try to run when she had the time to. She is either too scared to run or she is lying that she is doing this against her will.

They then realize that if she acts this way then she gets to walk scot free and the money can be hidden with her. Moreover they figure out that the couple isn't on a crime spree but they are on a vacation. It is like they are ticking off a bucket list. They then check online and it appears that the couple is following a list they found online. So now they know the next place the Bergens would visit. Wes and Travis brief the team about the plan. The duo will be going to the last place in the itinerary as it is going to have some rich people attending. It is the museum. Wes and Travis are at the museum with the team. The Bergens walk in. Jim notices a cop and then draws his gun and points at Maria. Wes and Travis talk to him and tell him that they know the entire story. He is convinced and he drops his weapon. They arrest him. They then talk to Maria and tell her that they could let her go home.

They found all the money in her travel bag and also matched her handwriting from her 'to do' list with the forms she filled at the restaurants. But Wes tells her that they would put down in the report that she was held hostage and would let her go and the 30 grand they stole in the past few days would be returned to the store owners. Especially when he is being asked to play the role of a father and Travis is being told to play the cool, romantic love interest. Ryan then decides that the participants should now play the role of their partners; because by becoming them, you get to understand them better. Travis does an amazing job in enacting Wes. Next, we see a woman calling 911

and telling them that there is an intruder in her store.

She asks for help. She is sitting on a chair with both her hands tied. She then drops the phone and cries for help. Cut to Wes and Travis arriving at the crime scene. Travis tells Wes that he is going to act like Wes and show him how difficult it is to be with him. They enter the store. A cop tells them that the victim's name is Beth Boyd and she is the owner of the store. Someone broke into the store, tied her up and they strangled her. She gave 911 the name of her attacker; Kevin Boyd, her husband. Just then Beth's step sister arrives; she has been called to identify the body. Travis is still acting like Wes and the cop calls him a 'dick'. Travis then talks to the sister. She tells them that Beth and Kevin hated each other and they were going through a divorce. But they still had to see each other every day as Kevin owns the place next to Beth's shop as they had bought the whole row.

But when things went south, they couldn't decide how to split it up and so they dug in. just then Kevin arrives and asks Suzan, the sister as to what is going on. Suzan lashes out at Kevin.

They interrogate Kevin. Kevin tells them that he has been drinking last night and he doesn't remember a thing; but he says that he did not kill Beth. His lawyer is present as well. They make them listen to the 911 call in which Beth states that Kevin has attacked her. Kevin and his lawyer are at a loss for words. He tells them that it is Beth's voice but he isn't that kind of a man. Kevin is ready to co-operate. Travis notices a mark at the back of his hand. He tells them that it is from a dance bar and that he did not have it until last evening. He just doesn't remember anything. The duo decides to go to the bar.

The manager and the dancer at the bar tell them that Kevin was at the bar last evening and he left around midnight. The manager tells them that since Kevin wanted to keep his night going, the manager suggested that he could go to a casino which is sort of illegal. Travis is still going on with the role play. Wes tells him that now he would show him what kind of a maniac Travis is. Wes seems to go a little overboard. They do some interrogation at the casino and infer that the time window Kevin had could never support the murder. They feel that Beth just panicked and assumed that it was Kevin who broke into the store. There is someone else who wanted Beth killed. Moreover Kevin volunteered to give his DNA after he heard the 911 recording. Next day, Travis is in a suit and everyone notices him.

Sutton too comments that Travis has successfully captured Wes' essence. Wes notices that Travis has cleaned his desk and he is not too happy about it. Wonder why is that? Sutton then tells them that the forensics went through Beth's hard drive and found out that she was been harassed by an ex-con who used to deliver materials to her shop. She filed for a restraining order as well. But then she stopped when she learned that the company had lain off the ex-con. They meet him and he tells the duo that he did not kill Beth. Instead he is thankful to her as it was because of her that he is doing his current job which he is enjoying a lot. He addresses Travis as 'Sir'. That is a first! Thanks to the suit!!

Just then Wes gets a call and he tells Travis that the forensics has found some skin traces under Beth's nails and it matches Kevin's DNA. But Kevin's lawyer got him out on bail this morning. The duo then arrives at Kevin's store. The cops tell them Kevin is going to blow up the place as he says that he cannot live know that he is a murderer. They enter the store and try to talk to Kevin. He shows them the scratch marks on his body. He is convinced that he killed Beth as all the evidence is stacked up against him. But the duo isn't convinced. They asks him to let them take him in and run tox tests. The next day, Wes is dressed up in a pair of jeans and jacket; trying to imitate Travis and Travis has bought himself a new suit. The forensics expert tells them that Kevin was given a date rape drug. They go the restaurant Kevin remembers going to before he blacked out.

They interrogate Suzan as she owns the restaurant. She tells them that she had informed Beth that Kevin was coming over. Beth gave Suzan a bottle of whiskey and asked her to serve him from the same bottle. She tells them that she thought that Beth wanted him to pass out so that she could take his DNA and frame him for assault. She was ready to help her sister. But instead of passing out, he blacked out and killed Beth. They discuss this with Sutton. They feel that Beth tried to frame Kevin so that she could get all the property. So she tied herself to the chair and her death was an accident. Now it is Sutton's turn in the role play; but there is no way Beth could have tied herself to the chair the way it was shown in the pictures from the crime scene.

Moreover, looking at the knots, they infer that the person who had helped Beth was left handed. They listen to the 911 call Beth made. There is a pause when she says Help Me the second time. They get the recording digitized so that they could hear the voice of the other person. It is a woman. And the voice says 'I am sorry'. They go to meet Suzan and discover that she is left handed. She tries to escape. They arrest her. They tell Kevin that the sisters were trying to frame him; but then since Suzan's restaurant was bleeding and she needed the money, she thought of taking Beth out of the way so that she could get all the money. Kevin thanks them in believing in him and leaves. At the therapy session, our odd couple admits to the fact that they both need each other. Role play well played!

The episode begins at the group therapy session where Wes tells one of the couple there that they cannot let their son live in their house without some sense of responsibility. He uses an incident about a stapler, where Wes and Travis fight over a stapler. The other members feel that Wes is trying to control things as he has lost control over his life. Now, how did we get here? Next, we see the police are at a stake out in a neighborhood. They are monitoring the moves of a guy, when some other man walks up and shoots the guy. And then the man walks up to the guy and shoots at him once more. A police officer, Randy Fletcher, with her dog rushes towards the scene. The dog

rushes at our shooter and tries to stop him getting into the car. The shooter then fires at the police officer and then gets into his car and drives away.

Next, Travis and Wes arrive at the hospital inquiring about Fletcher. Fletcher is fine and will recover soon. Fletcher calls for Sutton. Wes and Travis have been assigned the case. Fletcher gives them the description of the shooter and tells them that her dog Hudson might have got a piece of his pants. She tells them that if they get close to the shooter, Hudson can identify him. She wants Hudson to partner up with them. Travis asks the team about the operation and its details. They identify the bullet casings. They also tell them that they were there to arrest a guy named Louise Garza, who works for Jones. But one of them thinks that this is not a business thing. It might have a romantic angle involved. A guy name Garza shot Barrod on the leg and Garza wouldn't testify against him as he wanted to handle the matter his own way.

They first need to get hold of Barrod, while Wes and Travis would look out for the drug cartel Jones used to buy drugs from; the long wolves. Next, Fletcher hands over Hudson's daily routine to Wes and Travis. They then go to the Long Wolves shooting center. Wes and Travis perform a small skit to get the guys draw their guns. One of them is left handed; this fits Fletcher's description and also the gun the man matched the name the forensics gave them. They take him with them. He tells them that he did not kill Garza as he was at a gay bar last afternoon; a secret he is keeping from the rest of the group. Hudson sniffs the guy and does not react. Wes checks on the guy's alibi; he is telling the truth. At the office, Travis tells Wes that he has a date tonight. Travis is making out with his date; but when they enter the bedroom, Hudson is on the bed and he starts barking at her.

Travis calls Wes and tells him to take the dog with him as Hudson is freaking out on Kelly, his date. Wes agrees on one condition; at the therapy Travis has to admit that Wes was right! Wes picks up Hudson from Travis' apartment. Next day, at the therapy, Travis admits that he lost his staplers. Wes doesn't want Travis to take care of Hudson. He is now starting to like Hudson. Travis does not agree with this as he likes Hudson too. Ryan suggests Wes taking care of Hudson at nights and Travis could take care of him during the day. At the office, Sutton tells the duo that he received a tip about Barrod's hideout. Wes, Travis and Hudson reach the place. Wes enters the house and Barrod escapes through the window. Wes chases him and Travis comes in from the other side and pins him down.

Barrod tells them that they got the wrong person. They take him to the station. Barrod's lawyer is there too. They bring in Hudson and once again he does not react. Well, Hudson exonerated Barrod! One of the officers tells the duo that the ballistics report says that the bullets of the gun found at Barrod's is an exact match to the ones that killed Garza. Wes says that it is not clear as to how that gun got outside Barrod's safe house. They can confirm nothing at the moment. The officer finds it ridiculous that the duo is basing their judgment on Hudson's reaction. At night, Hudson is with Wes and he is continuously barking as he is able to smell marijuana. The hotel manager asks Wes to make alternative arrangements for Hudson. Wes calls Travis; but Travis is in bed with Kelly and tells him that he can't bring over Hudson to his place.

Wes arrives at the office with Hudson. Travis tells him that the person who tried to set up Barrod made the call from a PCO in front of a gas station. He also informs him of the security camera mounted on top of the front door of the gas station. So they have a partial view of the pay phone. They take a closer look at the shooter's vehicle. Just then one of their colleagues arrives and tells them that they need to check on Hudson. Hudson is lying on the floor and he isn't moving. Looking at the bottle of solvent lying nearby, they assume that he drank it. But later the vet tells them that there was no solvent found in his system; instead there were traces of poisonous substance in his stomach. Someone tried to kill Hudson.

They infer that someone at the station did it; it has to be a cop. The vet then tells them that Hudson wants to meet them and that they can take him home. Sutton is giving a speech at a meeting; they have gathered to mourn over Hudson's death. Meanwhile, Travis and Wes take Hudson to the locker room as they want to find out who tried killing Hudson. Hudson jumps at a locker which belongs to J. Hawkes. They tells Sutton that Hawkes is the dirty cop. When he had gone to shoot Garza he saw that he was surrounded by cops. So he shot Fletcher and then tried moving their focus towards Barrod. They have information that Hawkes goes to the docks at 6 in the morning. They also go to the docks. Hawkes arrives at the docks; his ride is the one that was seen in the surveillance footage. They have surrounded the docks. Wes and Travis announce themselves.

Hawkes tries to escape but they get him. On seeing Hawkes, Hudson begins to bark. Hawkes is surprised to see Hudson alive. Next, Wes is sitting in his room and Alex arrives. He forgot Hudson's slushy at her place the other night. She has come to return it. She thinks that he should get a dog for himself. Wes arrives to meet Fletcher and Travis is there too. Travis wants to tell Fletcher that Hudson was poisoned when he was in his care and that he feels responsible for it. Wes is there to return Hudson's doll. They both go in. Travis offers to take Hudson for his afternoon exercise. Wes too wants to take him. they both take Hudson out for a walk.

The episode begins with our 'odd couple' arriving early for the group therapy session. The couples are discussing about their romantic issues. Well, our odd couple aren't really a couple; so they have nothing much to contribute in this discussion. Meanwhile, Jake along with the entire SWAT team arrives at a place with a convict. The convict has told them that they can find a huge amount of cash buried at that particular spot. The convict then digs to recover the money while the team stands watching him. He finds a box and opens it. But instead of cash there are weapons and grenades in that box. The convict draws a gun and points it at Jake.

The convict shoots a cop and asks the rest to put their weapons down; he has held Jake at gun point. He then shoves Jake in a car and drives away. Next, Sutton educates the team about Cooper, the convict who escaped. He tells them that 10 years ago, Cooper stole a large sum of money and hid is somewhere. Cooper escaped this weekend and the FBI wants their help. Sutton also tells them about the DA who he took along with him. He feels that there is a chance that the money is still in LA. He tells Kate and Amy to look up some of Cooper's old associates. He tells Wes and Travis to go and meet the author who wrote a book about Cooper. They go to meet the author and Travis asks her if Cooper contacted her. She tells them that this could be the best publicity for the book, but she hasn't been contacted by Cooper. She tells them that Cooper is a genius as he hid five million dollars in a populated city in less than half an hour.

Travis feels that there is something not right about the author; her empathy towards Cooper is bothering him. They then try to narrow down the area where Cooper could have hidden such

a large sum of money in such short time. They come up with the name of a building and the address. They arrive at the reception and the receptionist tells them that there is already another cop downstairs. They rush to the basement and just then there is an explosion and the sprinklers are set in motion. They see a man trying to escape. He fires at them. They run after him; but he escapes. They arrive at the office; Travis still feels that the author is the only connection Cooper has on the outside. He also feels that she is in love with him. But Wes does not agree with this theory. They go to meet Sutton and Travis tells him that he about his doubts regarding the author; Lisa Clarke. Sutton tells them that they will set up surveillance.

Next, our odd couple move into an apartment together and Travis tries to portray that they are gay. Wes isn't too sure; but Travis says that this could be their cover and no one will suspect that they are gay. Travis then sets up a camera to keep a watch on Lisa. Her phones are being tapped as well. Wes then sees that Lisa leaves her apartment. He radios the cops waiting outside Lisa's building. Wes hands over a device to Travis and Travis enters Lisa's apartment to plant that device. Travis walks into the kitchen to get some cookies. He then sees a box with some correspondence in it. Travis fools around with Wes a bit, plants the bug and then leaves. Sutton arrives with some fried chicken and booze. He tells Travis to get some more booze. Just then they hear Lisa's doorbell ring; it the pizza delivery boy. But they didn't hear her order for pizza.

They tell Travis to rush to check on the pizza guy. Wes arrives as well. There is a note in the pizza which for Lisa which suggests a meeting. The boy tells them that a man was waiting outside his shop and gave him 100 bucks to put the note in there. They ask him to deliver the pizza with the note. They put a microphone pen on him and ask him not to tell Lisa about them. Sutton tells the duo that Travis was right about Lisa. Well, Travis begins his victory dance!! Next day, at the therapy session, Travis praises Wes' cooking. On the other hand, Wes tells the group that Travis is a horrible roommate as he offers no help and he litters the entire apartment. He calls Travis a monster. Travis is angry and tells Wes that he didn't expect Wes to keep all this bottled up and wait to vent it out during therapy.

He says that Alex couldn't live with him for the same reason as no one knows what is going on in Wes' mind. Next, Lisa leaves for the scheduled meeting. The FBI and the LAPD are in position. Lisa reaches the park. A jogger arrives and talks to her. But they see that he is not Cooper. After a brief conversation, the jogger leaves and Lisa heads back to her car. Travis tells Wes that Lisa is playing them. She is testing to see if she is being followed. Kate and Amy arrive at the apartment and see that it is in a mess. Wes tells them that he is trying to teach Travis a listen and Travis tells them that he is driving Wes crazy for trying to teach him a lesson. Just then they hear a knock on Lisa's door; it is Cooper. Wes, Kate and Amy rush to her apartment. But before they could leave, they hear a gun shot. She shot Cooper.

Next, we see Lisa in the interrogation room. She tells them that she shot him in self defense. Travis tries his best, but she doesn't budge from her statement. Wes has no questions. Jake and Sutton see this as a dead end. Travis is frustrated as he saw her kill him. But there is nothing that can be done about it. The stolen cash is FBI's headache. Travis is pissed and he is about to leave to stalk Lisa as he is sure that the money is around somewhere and she knows about it. He is also upset with Wes as he did not support him with his theory. So this time, he goes alone on this mission as he does not want Wes to do him any favors. Travis is on a stake out; he is waiting outside the pizza joint. Minutes later, Lisa arrives. She goes in and pulls out a huge bag with the stolen cash in it.

Travis walks in with his gun drawn at Lisa. Just then the prison guard who was driving the car earlier with Cooper in it arrives and hand cuffs Travis. Travis now figures out that it was her idea to interview Cooper, get to know the prison guard and then device this whole plan. They are about to leave, and Wes arrives. There is a gunfight. But Lisa and the prison guard manage to escape. After a short chase, Lisa and the guard get arrested. At home, Wes tells Travis that he has really solved this case and that he has got great instincts.

He tells him that in the future he will try to support it. Travis tells him that his own house is spotless and that is because that is his own. He grew up in foster homes which were never a permanent thing and so if he had started to care about them, then he would be a mess himself. Hence, he never kept this stake out apartment clean and tidy. Wes understands.

arrive at the crime scene.

He is glad to see him. He tells Travis that it was a drug deal and they had got information about it and hence they had set up surveillance. But by the time they got there, the men were dead. One of the four dead bodies is their informer's. He also tells them about the witness. Well, it appears that someone wanted all the money for himself. The witness is still puking. Wes goes to check on him. But the door is locked. The witness is Charlie Perez. Wes calls out to Charlie. But on getting no reply, they break open the door. Charlie is not in; he escaped through the window. In the office, the whole team is discussing the case. But this time he went crazy and attacked him. Wes then gets a text message from Fred. After four and half hours of analyzing, Fred has come up with something. Fred found a spot of blood on the vehicle's tyre and this blood does not match with the four dead men and Charlie as well.

So there was someone else there! Fred through his sources has found out that this was done by El Igeniero. But Noone says that he has been in Narcotics and El is nothing but a fairy tale. Fred thinks otherwise. El is the gunman they are looking for. Fred and Noone have their difference in opinion. Wes tells them that they need to check on Charlie's cousin who also drives a limo; maybe Charlie might get in touch with him. Meanwhile, they would also take a look at Fred's lead. Wes and Travis are tired of working with their mentors. Fred tells Wes that his department of Missing persons is being consolidated; he is being forced to retire. But he believes that if they arrest El, he has a chance to stay in duty. Now there is a problem, Wes and Travis have promised the arrest on this case to their bosses; quite a sticky situation.

She then asks him if he is ready for the next step; private sessions. Saying that she gets up, sits on his lap, unbuttons his shirt and is about to kiss him, when the phone rings. Wes snaps out of his dream! It is Travis and he tells him that they have got a new breakthrough in the hijacking case. It is a guy named Barry, who tips off the hijackers about the routes of the trucks. He is using a personal email account. They are

waiting for Barry outside his house. Wes confides in Travis about his dream.

Travis is very interested and wants to know the details. Just then Barry arrives. They announce themselves and he tries to run. Why do they think that they can always get away? Barry is arrested and brought to the office. Wes and Travis see that Ryan is in their office. They go and meet her and she tells them that her fiancé, Robert was attacked last night. Robert walks out of Sutton's office and Ryan introduces him to Wes and Travis. Wes knows Robert as he has seen him on television. Robert is into building malls. Wes and Travis want to know what happened; but Ryan tells Sutton that they shouldn't as it could be a conflict of interest. Ryan leaves. Robert vaguely mentions that it was a case of mugging and he leaves. Sutton tells them to stay away as she is their doctor and that they have to crack a hijacking ring.

Wes gets Barry an laptop and asks him to email his guys about a truck that could be hijacked. He does as told and next we see that Wes and Travis are in a truck full of 800 air bags! Wes is discussing about Robert and Travis tells him that he should tell Ryan about his 'passionate feelings' for her. Just then the hijackers arrive and they decide to continue their conversation

later. They manage to arrest the hijackers and now, one hijacking ring is out of the list! They have solved this one and wonder which one to take up next. Wes sees that Steifvater, the officer who has been assigned Robert's case is doing the day shift and so they could check on what is happening on Robert's case. They go to him and it appears that he has a lot of cases and he is also being audited. He has no time to do a favor case for Sutton.

Travis manages to flick Robert's case file and they leave. It appears that Robert goes to check a construction site and he gets jumped over by two African-American who cloaked him on his way to his BMW. He didn't see their faces. They go to the construction site and talk to the night watchman. The watchman tells them that he is confused; one guy did hit Robert but he wasn't black. Robert told him not to call the cops. The watchman also describes the attacker. They check the site where Robert was attacked. They then see a rectangular hole dug and it is cemented; but the cement is wet. One of the guys at the site has equipment which works like an ultrasound. He runs it over that cement and they see a face! Who is that? A dead body for starters.

Next, Robert arrives and they show him the equipment and the face on the screen. He is shocked on seeing the dead body and Wes says that his mugging story doesn't sound too credible. He tells them that at times he needs to do certain things to keep his work going. He says that the head of steam and pipe fitters union, Aaron, is not a good guy and Robert had to give him some cash to ensure that his workers would show up. He then describes the guy. He tells them not to tell Ryan about any of this as they are about to get married in two months. Sutton is pissed as they have gotten involved in this case. Travis tells him about the sex dreams Wes has been having. It appears that Sutton had them too! He suggests that Wes should talk to Ryan about it.

Next, Wes and Travis arrive for the session and Wes tells Ryan about the dreams. Ryan says that it is normal and she asks Travis if he gets the dreams. Travis says a no. Ryan asks Wes to leave them alone. She then removes her dress and is about to walk up to Travis, when Travis wakes up from his dream!! He is having them too. They then go to the coroner's lab and she tells them that the victim was Craig Seward, a lawyer and one of the worst ones on the planet. She says that there is the assailant's DNA found in the victim's nails; but no match yet. Wes wonders why the Armenian mob would want to kill Craig. They need to find a connection between Aaron and Craig. One of the attackers that Robert described with the tattoo belongs to a guy named Carl. He served two years for aggravated assault. He is out on parole.

He is working in a dog shop. They go to the shop. They find Carl and when they say they are from the LAPD, Carl has a dog attack them. They jump on to the cages. Wes tricks the dog to walk into one of the cages and Travis chases Carl. Travis arrests Carl. During the interrogation, Carl tells him that he did not kill anyone. Just then Timothy walks in and Carl tells him that he did not call for a lawyer. Aaron has sent him. Sutton arrives with the DNA results; it isn't a match with Carl. Wes tells Carl that he did bury the body for his boss and so he isn't free yet. Timothy also represents Aaron. Timothy tells them that Aaron is ready to cooperate in this investigation. It appears that he has gotten a nose job done. They send him to the lab for the DNA swab.

Next day, at the therapy session, Travis tells Ryan and the group about Wes' dreams. Wes says that Travis is having them too. Ryan is not embarrassed. Most of them in the room has had the; even a woman has. It only means that they have accepted the therapy at a subconscious level. So, nothing to worry! Next, they call the night watchman and ask him to identify the attacker from a line-up. But the watchman says that the attacker isn't there. Robert will have to go public and by doing that Ryan will know about it. Sutton tells them that since they have started it, they have to live with it. They go to Robert as he saw the man who buried the dead body on his construction site. He is reluctant. But just then Ryan arrives and is shocked to see the duo.

They tell her that they are investigating the case. Robert decides to tell her everything. Later she tells the duo that Robert will identify the guy and also provide his DNA. The duo then talk to Carl and ask him to cooperate so that they can cut a deal with the DA regarding his sentence; as he will be charged with conspiracy. He tells them that Aaron sent him an email to collect something and then dump it at the construction site. Just then Timothy is sending a message saying 'KARL FLIPPED'. Travis sees that and takes away the phone. They arrest Aaron. Aaron is brought to the station and he is ready to talk. Timothy tries to run out, but Sutton manages to knock him to the ground. Next, we see that the duo explains the case to Ryan.

Aaron and his lawyer have been friends since childhood and Timothy and Craig went to law school together. Timothy ran into some trouble and he assigned Craig to represent him. He then started telling Craig about his deals with Aaron. Craig started blackmailing Timothy. Timothy

paid him for few months but then Timothy snapped. So he asked Aaron to handle this and hence Carl got involved. Now all of them are in jail. They apologize to Ryan. Wes notices that Ryan isn't wearing her engagement ring. She is also terminating their therapy. She refers then to another doctor. They visit their new therapist.

On arriving for the session, they find a man talking to himself. They think he too is there for therapy; but it appears that 'this man' is their therapist. Well, they need to find a way to get Ryan to take them back.

Summary: This is the Season 1 finale, Wes and Travis why they go to therapy.



The episode begins with Travis shouting out aloud; a part of therapy. It is Wes? turn and Wes cannot do it. Their new therapist is trying some new techniques and Wes and Travis are not able to cooperate. The therapist then cuts a deal with them; he tells them that their presence is bringing down the energy of the class and so he wants them to stop coming to therapy. Couple of months later he would call their Captain and tell him that they have improved and are doing better because of the therapy. They take the deal. Next, Wes and Travis are at a stakeout and Travis mentions that Pacman's birthday is coming up. Their suspects arrive. As they are about to an-

nounce themselves and arrest the two, some other guys from their department suddenly spring up and take the suspects down.

Next time, a little heads up will be appreciated! One of the guys tells them that Pacman's birthday is coming up and that they should stop by for some beer. Travis is agitated and is about to charge on the cop; but Wes stops him. The two then go to Ryan and ask her to take them back. Travis tells her that if she takes them back, they would tell her the reason they have been sent for therapy; why Wes pulled his gun on Travis. They begin their story by telling her about Pacman. The story begins with Pacman and Travis practicing at the shooting range. Just then they hear an irritated voice. Pacman asks Travis if he is still working the theory that someone is killing those working girls. He is asking because the guy from the task force from the missing person's department is saying the same thing.

He introduces Travis to Wes; the irritated voice. Pacman introduces the two of them and he recalls the line from a movie; 'this is going to be the beginning of a beautiful friendship'. So they

teamed up to find the guy who was killing all those prostitutes. After a few successful cases, they got promoted to Homicide. Initially, they did enjoy each other's company but then Pacman was the one who helped them get along. They decided to help Pacman as the duo had made progress and Pacman was stuck behind. So they decided to give some of their victory to Pacman to help boost his profile. This paid off and Pacman was selected for SIS; Special Investigations by John Crowell; the same guy who busted in on the duo's operation earlier in the beginning of the episode.

They didn't hear much from Pacman as he seemed pretty tied up with work and they thought that he was doing fine. This was until six months ago, when one day they receive a call from Pacman. He tells them that these guys are bad news. He feels that the whole department is corrupt and they are filling their pockets through embezzlement. He also says that they are planning something big. He heard them saying: We bought off Henry and a date, 22nd August. Pacman feels that his superiors doubt him. They ask him to calm down and that they will reach in sometime. But when they reach the place, the find Luke with the rest of the department; they have surrounded the area. They learn that Pacman is dead; he got killed and also that he was tracking down some robberies and was running surveillance when he got killed.

They then started to look into SIS; the more they looked, the less they liked these guys. They go to Sutton with this case. Sutton tells them that before they could make accusations on highly decorated cops, they better have evidence. Just then Travis gets a call from the hospital; the witness who was at the hospital was mumbling something about the shooting. They arrive at the hospital and see that the SIS is already in the witness' room. Wes tells Ryan that the witness did tell them that he did see a man who shot Pacman and the description matched John Crowell. They were going to start a formal inquiry. But the case got dismissed as they were unable to find the witness. But John Crowell did not only want to win, but he also wanted to gloat about it. Crowell arrives at the office with few of his guys.

He whispers something into Travis' ears and leaves. Just then Wes arrives. He sees that Travis is about to lose his control; he is shivering with rage. Travis takes is gun and is about to follow Crowell and Wes tries to stop him. But Travis pushes him aside. Wes had no other options; he pulled his gun on Travis saying that if he moved another inch, he will shoot him. The entire office witnessed this. Sutton arrives and orders Wes to stand down. Travis is devastated when his partner drew his gun on him. Ryan is shocked. She wants to know what Crowell whispered in his ears. Travis tells her that Crowell told him that he killed Pacman. Continuing with the story, Wes tells Ryan that he was suspended and was put on administration. He then told the board that he drew his gun on Travis to stop him as he knew that there was no stopping Travis.

The board ordered both of them to stay away from Crowell. They also had two conditions; one they go into therapy and two, neither one of them is to go near SIS. This worked perfectly for Crowell. And now that they know that Crowell is about to do something big; they aren't even able to sniff around. Wes and Travis start arguing once again. Travis thanks him for saving his career and life. But he also tells him that he is a different person now and that he can handle his anger. He promises Wes that he is not going to shoot Crowell. Wes states that he believes in Travis. Ryan tells them to go kick some SIS butts. Next, the duo arrives at a expo center. Wes has been following the case since Pacman's death. He tells Travis that Crowell and his guys come to this center and click pictures.

It appears that there is a gemstones jewel convention coming up; they infer that Crowell and his men are going to steal the gemstones. They meet Sutton who spent the night in the office, and tell him about the upcoming heist. Sutton tells them that if they go behind SIS, they will be rolling a dice with their careers. But he also wants them to do what is right! In the parking lot, Crowell and his men suit up for the heist. At the same time, Wes and Travis brief the team. The duo is at the scene. They hear the alarm go off and they rush inside the center; there is chaos. They announce themselves and ask the men to drop their weapons. One of the masked guys opens fire at them. A gun fight ensues and one of the SIS guys is shot. Another masked man arrives and drags his shot buddy along with him and they run up a flight of stairs.

The duo follows them. They go inside the warehouse and see a trail of blood on the floor. They follow the trail and see a man sitting against a pillar. Wes follows the other guy. Travis pulls off the mask from the man's face and realizes that he is NOT SIS. Wes is still following the other guy and tries to shoot him. Just then Crowell and his men come in. Crowell yells at Wes for shooting at his man and trying to bust their operation. Crowell says that this is harassment and that the

duo is not going to survive this. The SIS Chief confronts Sutton. Sutton then tells the duo that they have two choices; one get separated and go back to their respective departments where they came from and two, stay together and take a severe demotion. They go to Ryan and tell her what happened and also that they aren't a couple anymore, so no more therapy.

But they still thank her for her help. Ryan wants to know what happened and Wes tells her that they were wrong about this one. Ryan tells them that she knows that they suck at therapy, but she also knows that they are never wrong about their work. At the office, Travis is looking at the note; the details that Pacman gave him over the phone about Henry and the date. Travis tells Wes it is possible that Crowell and his men planned to rob the evidence warehouse where the gems were stored, and not the museum. Also they always thought that Henry is the guy who worked at the museum, but he could be a guy from this department. They run a check and find out that Derek Henry works for evidence collection. Next, we see that Henry is working his shift and four men wearing masks walk in.

Henry offers no resistance and they take him and make him sit on one side. They then pull out a bag full of jewels and are about to leave. Wes and Travis arrive and the SIS guys open fire. The duo shoots one of them down. It is getting a little difficult for the duo to hold against those guys. Just then Wes sees that one of them is standing under bags of cocaine. They shoot at those bags, and a cloud of cocaine surrounds that man. He falls on the ground. The man with the bag tries to run and Travis follows him, while Wes runs towards the other guy and grabs him. Travis hits the man trying to escape, with a cylinder. Obviously, he is Crowell.

The cops arrive and the SIS team is arrested. Next, Wes and Travis declare their victory to Ryan and tell her that Crowell is going down as one of the guys is ready to testify. Their suspension has been lifted and they have been reinstated. And therapy is 'no longer compulsory'. But they want to come back, as they feel it is working well for them. Yes, difficult to believe.
