

CSI Maxine Roby, who now runs the lab, met at Brass' place to speak with CSI Allie Rajan about the situation. They interviewed Brass about a possible motive, however, the exchange prompted him to

ask them to read the serial number of the attacker's weapon. He immediately knew who was responsible... Lucky!

Lucky was a sadistic kidnapper holding a very old grudge and he was never caught...

Brass asked Sara Sidle to return to help him with this case. Sidle went to met Maxine who got her acclaimed with her old job. Their investigation lead them down many rabbit holes including the deranged kidnapper suspect mailing them a decrypted old severed head in a box with a note which said, "Jim Brass this is just the beginning." evidence.

Hodges surrendered himself. There were a dozen counts stacked up to the man's jacket...

Roby lead Folsom and Rajan on the case to investigate the slain couple. Turns out it was the eve of their wedding day. Guess they didn't know it was bad luck for the groom to see the bride the big day before...

The murdered couple was Dr. Nate Kessler and Dr. Jenny Lee. The evidence revealed the killer who stepped on the woman's arm wore a size 14 shoe. Rajan went to speak with the bride-to-be's father and told them they needed DNA evidence from everyone in the wedding party in order to rule them out. They were looking for bigfoot.

At the wedding crime scene, Roby, unfortunately, had to inform Grissom and Sidle that they couldn't be involved in Hodges' investigation due to a conflict of interest. Sidle pleaded to stay

Turns out, the place is a swingers club- which allows their members to borrow the truck. If it is the killer's vehicle, it could be a wide array of suspects. Time to inspect the vehicle. They strong-armed their way to access a list of guests who possibly used the car that day.

Folsom and Rajan went to interview a man of interest but that exchange leads them to inspect a glitter room at the swinger club. They found a hidden webcam in the room. More digging revealed a laptop hidden in the fire chimney and a charred Polaroid photo in the trash. Throughout Folsom and Rajan's partnership, there were plenty of innuendos of them possibly hooking up but they felt awkward about it.

Back at the lab, the laptop revealed the couple was possibly being extorted for money and the key to it all was the burned photograph. They performed their CSI thing and re-engineered the photo to find the incriminating murder pic. Time to track down the club owner, Mr. Hassan, who had been away the whole time.

While being interrogated, they requested Hassan's large boots for testing. They found traces of blood. However, Roby watched the man and noticed his movement, and hypothesized he recently had a stroke as his hands shook and he couldn't get his boots off so well. She figured if he couldn't handle that task then he probably couldn't grip a gun...

Undersheriff Wyatt messaged Roby that Internal Affairs Detective Nora Cross will be taking Hodges' case to Washoe county, which effectively shuts out Roby and her extended team. At a luau, two men discovered a human body in their barbeque pit...

Roby's son, Bryan, a rather large adolescent was at a party and broke up a fight between two men. The party was too loud and cops were called. He accidentally pushed a police officer over and knew he had to submit to arrest, given the landscape of overzealous police brutality against Black men in this country.

Roby picked her son up, tearful about the ordeal.

Roby met with the arresting officer and Wyatt to square things away with her son. Officer Chung warned Roby to keep Bryan away from the party crowd. She redirected the cop to reflect on why he sought the Black man first.

Cross interviewed Grissom about testifying at Hodges' trial regarding his oversight back in the day. She also made him aware of her suspicions that he and Sara are now back in Vegas. He claimed it was in the assistance of their friend Jim Brass. Grissom felt it was no longer a good idea he investigates Hodges' evidence and offered Roby help elsewhere- so she tasked him with the new barbecue case.

The pit was intended for a whole hog but someone added the man with the pic after killing him. And the killer wanted to send a message with his creative murder. The team interviewed, Roy Kahale, the general manager of the hotel.

Back at the lab, medical examiner Hugo Ramirez identified the man by his pacemaker-like device. They found out he had donated one of his kidneys and required the device to regulate his internals. His name was Jeremy "JJ" Jackon and his family owned the hotel. Rajan and Detective

Will Carson went to speak with his parents and learned JJ had quit the hotel due to indifference with the GM, Roy.

Rajan and Sidle were tasked to sift through the dirt from the BBQ pit and found a white powder. They found some evidence of which led them to the pool.

Rajan and Carson paid Roy a visit to ask about the pool cleaning materials. Roy asked the pool boy Kai Manu to open the room. As the detective shed their suspicions of Roy, he immediately told them, he and JJ had differences but he didn't murder him. Suddenly, Kai blurted out that JJ got what he deserved as karma because "he was a rapist!" He explained that JJ raped his girlfriend Rachel and that she was legally suppressed by JJ's parents. The girl had overdosed a few weeks ago after a downward spiral after the ordeal...

Rajan visited Rachel's sister, Cynthia Koa, without Det. Carson. She had a heart-to-heart with the woman who shared that she was relieved someone took care of her sister's murderer.

Although Rachel's story was suppressed her rape kit wasn't. Rajan found it and discovered evidence of drugs in her system as well as an attack. However, JJ wasn't a match for DNA! Roby demanded Rajan follow the evidence, put her feelings (and public accusations of JJ) to the side, and find his killer.

Ramirez and Folsom consulted Rajan (the Corpse Whisperer) to determine what murder weapon was. And she found a shark's tooth... Warrants led them to discover many Hawaiian tribal weapons with the teeth were exhibited at the hotel. They confiscated all of the weapons from the hotel but they revealed no match.

Folsom and Rajan visited Tiffani questioning her about Tiny and Manuel. They were at the club but ran as the CSI approached. (Did anyone notice the CSIs had guns?) Penny goes outside and she continues to be sick, she bends down into the bushes, and then she sees something. Two crumpled pieces of paper, and puts them into evidence. Joshua is outside too and he looks up and sees that across the street the neighbors have a surveillance camera. Inside the house, there is a handprint on the wall, and Catherine gets it cut out.

Catherine thinks somebody wanted the Geice family dead, and this is a different kind of kill, an overkill.

Catherine is at the hospital, the baby is alive and well. Mary from Child Protection Services meets with Catherine who says she needs to get a buccal swab from the infant. Mary says no way, she is responsible for the child who is struggling to survive, and until she is stable, it is not happening.

Penny can't do it, she is freaking out and tells Catherine that she is losing it. Catherine tells her to put out her hands, they are shaking and she tells Penny that she is human. The best thing to do is work the case, so it doesn't work for you.

Joshua watches the surveillance video, the gunmen had a scuffle outside when one of them hesitated in shooting the pregnant woman. During that scuffle, one hits the other and on video, you can see that a tooth fell out when he got it. Joshua rushes back to the scene to look for that tooth.

DNA is taken from the hand print, it belongs to the pregnant woman, but she was shot outside.

Penny found some random evidence in the vacuum, she shows it to Catherine and she says she doesn't think it is random. Catherine doesn't want her to go down a rabbit hole.

The random evidence has the same DNA as the bloody handprint. Penny thinks it is a cry for help, the person wants to get caught.

In the video, the killers didn't look experienced, like they knew how to use the weapons. There was a shell casing left, it belongs to Edward Allen. They bring him in and he says he didn't do anything. He says he sold three shotguns on the street. And, he is on house arrest, he couldn't have done it.
