Summary: Detective Hendricks investigates a case of abuse involving a legendary D.J. that he idolized in his youth, even after his new police lieutenant gives him a break from the case.



The scene opens with a man singing 'Heartbreak Hotel'. That evening, at a convenience store, a man is lying in a pool of blood. Officer Sutton, Detective Dwight Hendricks, and Detective Charlie White are outside and Hendricks wants to know what happened when Sutton got there. Sutton retraces his steps and he tells that he thinks that the crook went through the window. But Hendricks believes that the crook is still inside. They find him in a cabinet and he comes out. When he puts his hands on his head, his pants fall down. Hendricks visits his mother's home and he finds the music go-

ing, the kettle on the stove, but no mother. He sees a stranger in the backyard. He chokes him and asks where his mother is. But she is there and is having dinner with Tony, the man Hendricks was choking. Tony is a new neighbor.

Hendricks is driving down the street to the police station and it is Elvis week. Everyone is stopping him and saying hi. Hendricks sees that the Boob lamp that they had in the station is in the trash. There is a new Lieutenant and she is the one that threw it out. Hendricks tells Lt. Tanya Rice, that things are different and throwing out the boob lamp is wrong because it gives the officers a little humor. She listens and tells that there is a 10-15 that he is taking that Hendricks tries to decline. An older lady is the 10-15 and she is not talking. Hendricks tries to lay his charm on her and she still is not talking. Hendricks finds out that the elderly woman is Dottie Collins. In the examination room Hendricks sees that Dottie has bruises on her back.

Hendricks wants to get the address to where she lives. At the house, Hendricks investigates and finds a leaky ceiling. He also finds the scene of the crime. Detective White arrives with the rest of the crew and Lt. Rice tells that Hendricks forgot to check in and file the right reports. Hendricks complains that she is worrying about the small things but Lt. Rice says that she is in charge. Hendricks organizes a team to go around the neighborhood to get information to what happened. They stop at a blind man's house and he tells that it might have been that nurse that was hired to take care of Dottie. He says that she had a strong accent that turns out to be a Haitian accent after back and forth of White and Sutton trying to guess the accent.

White and Hendricks go to a bar where Canoe, the head of the Haitians in Memphis, is playing pool. Hendricks shows the picture of the girl they are trying to find. Her name is Sebine and Canoe doesn't know where she lives, but she knows where she 'shops'. On stakeout, White and Hendricks wait for their suspect to show up at her store which means the drug dealer. She is a junkie and as White and Hendricks approach, she runs. They run after her by as she runs into the street, she is hit by a car. Hendricks runs up and the girl says that she tried to help Dottie Collins but 'he' is going to kill the old lady. Hendricks takes Dottie to a safer place to stay at and tells her that she made him who he is today. He tells that his father was Memphis P.D. but was killed when Hendricks was a child. He goes back to her house and there is someone at the door. It is Lt. Rice. She wants to know where Dotty is. He tells that she was taken to his mother's house and that there is a male suspect on the loose. She tells that he needs to take the weekend and rejuvenate. She brings up Hendricks's divorce and tells that she knows it is hard. Hendricks is upset that she would bring that up.

Despite Rice's words, Hendricks is trying to find Dottie's abuser. He finds Sebine's boyfriend T.J. Williams in a Rehab center and he says that he has not abused any old ladies. He calls White and tells that he wants a background check on T.J. Williams and White tells that Dottie's son just came in. White, Hendricks, and Pat Collins meet in a bar and Hendricks wants to send a message to Pat on the point that he left his mother in the care of a junkie. He apologizes but Hendricks takes him to the roof and shows him the edge. He promises that he will take better care of Dottie at home. Dottie is taken home with Pat and Mrs. Hendricks is surprised that she got the opportunity to have Dottie Collins in her home. There is a knock on the door and it is Tony. He gives her flowers for helping him out the other day. Hendricks is suspicious of Tony after hearing that his mother wrote Tony a check.

Hendricks is asking a little girl in a tree house what she saw and she tells that she is not allowed to talk to strangers. Hendricks picks up one of the Barbie dolls and plays with her. He asks again and she tells that she saw a bad man at Dottie's house and it turns out to be Pat Collins, Dottie's son. The girl tells that he and the Sebine were kissing and Pat pushed the red car that hit Sebine into the wooded area. Hendricks finds that car. They take Pat to the interview room and Hendricks is furious. White tries to calm the situation down and Hendricks exits. Lt. Rice is there and tells that Hendricks can't treat Pat like that because he has no evidence. She tells that the red car is registered to T.J. Williams, the guy in the Rehab center. Hendricks knows that Williams is innocent and is backed up by all the police force too. Lt. Rice takes both White and Hendricks off the case.

But Hendricks goes back to the little girl in the tree house and is on stakeout at Dottie's house. After a while of waiting, Hendricks falls asleep. When he wakes up, Dottie is gone and so is Pat. Hendricks takes this as a chance to go inside. He sees that the bucket that he put for the leak is full and goes and investigates in the attic. He finds a freezer taped up and there is a body inside. It is the real Pat Collins. They play an interview of the real Patrick Collins and he tells that he used to have his mom do things to get money and the guy pretending to be Patrick Collins said that he would take care of Dottie. His real name is Ray Pruitt. In the interview room, Hendricks is with Ray Pruitt and tells that he is sick in the head. But Ray is not ashamed of what he did and Hendricks is disgusted. Lt. Rice tells Hendricks to be in her office tomorrow morning. That evening, Hendricks finds Tony picking up on a girl and tells him to stay away from his mother. Hendricks goes and sees his mom and she doesn't want him to come around for a few days.

The next morning, Lt. Rice is leaving a message for her daughter who she has not seen in two months. Hendricks walks in. He starts telling her that she is right and that it is good to have order. But Rice tells Hendricks that she was wrong and that he did a good job. As he walks out, he invites her to a bar where in the beginning a man singing 'Heartbreak Hotel' is actually Hendricks. Lt. Rice exits her office and the boob lamp that she had accepted to allow has had a

bra put on it. She goes to the bar that Hendricks told her about and they all listen to Hendricks on the stage singing an Elvis classic.

Summary: After a missing truck driver's son tells his classmates that his father was kidnapped, Dwight and his partner set out to search for the missing man and help the son and the boys mother who may be hiding a secret of her own. Dwights Mother continues her relationship with her neighbor despite Dwight not trusting him. Dwight has romantic problems of his own when his ex-wife starts sending him mixed signals.



The scene opens with Charlie White talking with Dwight Hendricks are walking and Charlie tells that he is offered a part in a play. As Charlie is practicing his Italian accent, they come up on teenagers. They see a billboard spray painted. Dwight stares one of the kids down and the teen runs and jumps over a fence. Thinking they've lost him, Charlie is angry. But Dwight tells that the teen will come back. Sure enough, the teen is being chased by a dog and jumps right into Dwight and Charlie's hands. Charlie laughs and messes with the kid.

The next scene shows Dwight looking at Alex and they start kissing. The curtain rod falls down in her apartment. Dwight offers to fix the problem but she says that it is alright. She is upset that she has to have dinner with her mother. Alex gets out of bed and tells Dwight that she is going to fix things and that Dwight needs to get to work. Dwight and Charlie go to a school and find that Mike and Scotty were fighting. Mike tells that Scotty has been lying and saying that his dad is in the FBI. Scotty tells that his dad was kidnapped by Terrorists and that Scotty heard the fight last night. He was going to get the shotgun but he was too late.

Mrs. Hendricks visits the station and meets Lt. Rice. She compliments Mrs. Hendricks's pants and offer Tea upstairs. Dwight and Charlie go to Scotty's home and the mom confirms that Scotty

is lying about the FBI. Billy is hauling cotton and took on extra work. They return back to the station and Lt. Rice tells Dwight that she met his mother and they have a lot in common. Tony comes in asks Dwight about his mother. He tells that he wants to make things right and that he messes up last time. Dwight tells that he is never going to be buds with Tony and he could do whatever with his mother. A detective enters and tells that Billy Groves never checked into work and that he left his truck in repair.

At the repair, they talk with the owner and he tells that Billy was there, dropped off his truck and got a ride with someone. Dwight asks if Billy was friends with them and the man tells that the people beat up Billy and threw him in the back of the car. Dwight and Charlie wonder why he didn't call the police and he tells that he never liked Billy and that he got what he deserved. Back at the Grove's home, Cloe is recanting her story and is now telling Dwight, Charlie, and Officer Sutton that he came home and was arguing with me. At the mention of Scarecrow, Sutton says, 'Oh no.' He pulls Charlie and Dwight to the side and tells that Flynn is a gun runner and thinks that Billy is running guns for people.

They visit Flynn at the gun shop and he is not talking. Dwight asks to see two guns in the counter. He asks Flynn if he watched the 'Good the Bad the Ugly' and starts taking apart the two guns and mixes and matches them around. Flynn is not happy and finally tells that Billy told him that he is going to 'greener' pastures. Dwight tells that Billy was into selling marijuana. They get the drug sniffing dogs at the Grove's home and find the shed that is FULL of marijuana. They find the body of Billy buried in a shallow grave. They sit down with Cloe again and once again her story changed. This time Billy came in and was yelling. She says that Billy pulled a gun and that it just went off. They get more information and find out that Troy, the older son was there and that they were wrestling around with the gun and it went off. Troy calls and she tells him to stay there.

They go to where Troy is and he is in an abandoned arcade. Lt. Rice is there and tells that Troy is is there and he is armed. She volunteers to go in. With a bullet-proof vest, she goes in unarmed. She starts talking to Troy about his father and he tells that he hates him. He tells that the gun went off and it was an accident. They talk about how smart Cloe is for wanting to protect Troy and Scotty and Troy puts down the gun. Lt. Rice shows that she has nerves of steal and Dwight is impressed. However, he feels that Troy said that he got the gun from the closet and Scotty tells that Troy has a gun underneath the mattress. There are holes in the story.

At the house of the Groves, Dwight has Cloe, Troy, and Charlie recreate the scene of what happened. Over and over they repeat it until Troy messes up and tries to go upstairs. He tries to cover himself and it is clear that it was no accident. They escort Troy to the patrol car. Dwight has dinner with his mother and Tony and they talk about how happy the two couple are. Tony has a new nickname for his mother. Paul. Dwight is unimpressed but ignores it. Meanwhile, Charlie is acting in *The Godfather Parts 1, 2, and 3* all in one night at the Community Theater. Tony and 'Paul' are hitting it off and Dwight tries to talk up his father when he worked for the MPD but it is not phasing him. Dwight starts to play with the salt shakers and finds out that that the mom did it.

They go back to the station and they have Cloe in the examination room. Dwight tells that the 'burn on her cheek' is actually from Cloe firing the gun left handed. Lt. Rice talks with Cloe and tells that she is gambling with Troy's life because he could be tried as an adult. She thinks about it and still is going stick to the story that Troy killed Billy. Dwight questions Troy again and tells that his mother is going to say that he killed Billy. He tells that prison will be good for him. Dwight walks out and sees Scotty and says that the boy needs his mother. They let Cloe go back to Scotty and the scene cuts to Dwight playing the guitar and singing. He gets a call from Alex, his ex-wife, and lets the machine pick it up. She is saying that she needs to see him again. She is having problems including burning food and smoke alarms going off. He doesn't pick up the phone.

Summary: Hendricks investigates the disappearance of a teenage pageant contestant, and tries to help his ex-wife get on her feet with her catering business.



The scene opens up with a man standing on the edge of building. Office Sutton attempts to talk to the man. Sutton tells that he has purchased an apartment and they agree that Sutton is going to buy a water feature from his store when the incident is all over. But Seiro Houston, the man on the ledge, is distracted by the helicopter. Sutton tries to grab Seiro but they both fall. Luckily they fall only a few feet but Sutton finds himself handcuffed to the building. Dwight Hendricks and Charlie White are on scene and try to talk Seiro from jumping. Asking the same questions that Sutton asked, Sutton fills

them in. Dwight picks up that Seiro is upset of a woman. Dwight tells that Seiro needs to get off the building ledge and make up to his wife and ask her to take him back. He listens to Dwight and is taken into custody. Charlie tells that it was impressive that Dwight could do that.

Dwight enters into the station where there is Elizabeth Hatcher in Lt. Rice's office. Her daughter Ivy, a Miss Southern Appeal contestant, has gone missing along with her car. She is 17 years old. Dwight and Charlie go to Elizabeth's home and Glenn Hatcher, Elizabeth's husband, is there. Charlie asks what highway Ivy would have taken. The Hatchers have guests arrive and George, the butler, is instructed to take Dwight and Charlie up to Ivy's room. Ivy's sister Jess enters and shows the detectives Ivy's diary but it is written in 'Jevilee', a language Jess and Ivy made up. Jess says that she could translate it. Dwight finds a love letter by J.M. Dwight has an idea who J.M. is. Dwight and White arrive at the pageant and meet Jimmy Masterson, who is the pageant director. Dwight thinks that he wrote the love letter to Ivy. But he tells that he has not been involved with Ivy and that he has an alibi. Dwight smells 'Wild Turkey' on Jimmy's breath and Dwight tells that she shouldn't go anywhere.

Dwight visits Alex and he asks, while she was Miss Southern Appeal, if Jimmy ever tried anything with her. She tells that Jimmy was only the dorky son of the director but Dwight tells that he was 35 years old at the time. Dwight tells Alex that she needs to start to get her catering business up and running and to get the word out. Alex says that Dorothy Sutherland made out with Jimmy. Dwight gets a call and it is Reginald. He tells Dwight that Jimmy's alibi doesn't check out and there are some developments.

At Mud Island River Park, they find Ivy's car. Lt. Rice tells that they car has been wiped down but there is a thumb print in blood. Jimmy is talking with the Board of Directors and Charlie and Dwight grab him and take him in a room. Dwight tells Charlie to hold Jimmy down as he pulls out knife and needles. Jimmy gets scared and admits that he has a drinking problem. He tells that he passed out on the bench and was in the Drunk Tank last night. But claims that he doesn't know where Ivy is. Jimmy makes the announcement to the other contestants that Ivy Hatcher is missing. The girls start panicing and Lt. Rice gets the microphone. She tells that they need to get their heads together. One of the contestants, Miss Southern Perl' tells that she took Ivy's phone. Dwight... Kate Caldwell, 'Miss Bluff City' and Bobby Tyme are in their dressing room and they tell Dwight and Charlie that Charlie tells to put the dog in Bobby's hands on the ground. Kate tells that there was a fight the night Ivy went missing. Elizabeth tells that Ivy wanted another car but in the morning, all was peaceful. Dwight asks Lt. Rice if Alex can cater the precinct. Lt. Rice says that it is a good idea and looks forward to meeting Alex.

Reginald and Sutton tell their Sutton translates the message Dwight gets from Jess and tells that Ivy has been spending time over at Bic's Bar. Dwight and Charlie asks Bic about Ivy and he tells that she has been ordering fries, cheeseburgers, and other junk food. They ask if anyone ever looked at Ivy and he tells that he will ask his bouncers, the Marines. Dwight gets a call from Reginald and he tells that there is an armed intruder at the Hatcher home. They arrive and George tells that the intruder said to give him the paintings or Ivy is dead. They have the intruder at bay and Dwight and Charlie aim their guns at him. He turns around and it is Jimmy, who is claiming that it is all a misunderstanding. At the station, Lt. Rice is questioning Jimmy and he tells that he found the note on Ivy's stand and decided to use the money for his 'specific needs' and tells that he had to borrow from the pageant and that he blew it all. He tells that Ivy fainted twice at rehearsal and tells that the Hatchers are the bad guys because they have all the money.

Dwight looks at the ransom note and notices the watermark from the Country Club. The ransom note was written on Country Club stationary. The Hatchers are brought in and deny that they wrote the ransom note. Lightfoot enters in and he is bleeding. He tells that the wife stabbed him but it is alright. Jess arrives and tells that she finished translating. She tells that the Hatchers have been locking Ivy in a shed in the back. Dwight and Charlie arrive and George shows the shed. Bic's is a mile away and that would explain why she would go there. They exit the bar and Dwight tells that there are no cameras in the parking lot. However, a familiar face sparks Dwight's attention and they bring in the gas station attendant and found that there was a camera pointed at Bic's parking lot. As they watch the video, they see that Kate 'Miss Bluff City' walking in the bar after Ivy.

Officers escort Kate to the station and Charlie starts to question her. She denies that their meeting was nothing and Charlie tells that the beauty pageant girls are all the same. Kate tells that she is not a dumb girl and quotes Avid. But Charlie quotes Johnny Cash. Alex enters and tells that her stock is gone. She tells that Dwight is going to start craving her tofu sandwiches like mad. Dwight tells Kate that Ivy was pregnant and that is why she was eating all the junk food at Bic's Bar. Dwight asks who the father is and figures out that it is one of the marines at the bar.

All the marines have alibis except for Raleigh, who has been missing for 2 days. They rush to his apartment and find Raleigh in the kitchen and Ivy runs in to see what is going on. She is unharmed. Ivy tells that Raleigh didn't do anything. She narrates her story that Ivy and Raleigh fell in love. After she found out that she was pregnant, Raleigh was called for a 3rd tour and they had to do something. The ransom note was their idea. She is turning 18 at midnight and tells that if her family finds out, then they will never let Ivy be free.

At the station, Alex tells that she found all of her sandwiches in the trash. She is angry that Dwight put the staff up to it and to buy her food. Dwight doesn't understand what the matter is. Lightfoot tries to tells him that it is best to let her do her own thing and not to get involved. Dwight snaps back and tells Lightfoot to take control and it was not right that his wife stabs

him and he should not let it go. The Hatchers return and they want to throw Raleigh in jail. But Dwight feels that it is not fair to send Raleigh to jail over this and tells that they should get only probation. Lt. Rice sent an email to the District Attorney saying the same thing that Dwight says but Dwight tells that released Ivy and Raleigh 20 minutes ago. Lt. Rice is happy with Dwight.

Dwight visits Alex again to apologize to her for trying to get her catering business up and running. He tells that he needs to be a friend and not to try to fix things for her. He attempts to go inside but she stops her for a second then pulls him in. At the station, Lightfoot sends his wife to jail for stabbing him while at Alex's place, Dwight and Alex are kissing. As always, the episode ends with Dwight singing and playing the guitar.

The scene opens at Fat Red's Barbecue where Dwight, Lightfoot, Charlie, and Greenback are enjoying Red's famous ribs. Red comes over and gives them a pitcher of beer on the house. Eloise is timid around him. Suddenly, they are interrupted when a black teenager comes in looking around suspiciously. Dwight tells the team to take the sides just in case the robber is armed. The kid pulls a gun and Greenback picks him up and slams him on the bar and arrests him. He apologizes for the black kid's behavior and that it does not reflect on him as a black man at all.

Rice takes him in the office and yells at him. He tells that it is her fault that he is doing this and that she shut out her ex-husband. She tells that Rodney needs to take responsibility for his actions and she won't be paying his bail.

The credit card was if tracked to Ronald Warsaw and there is a history between him and Red. Dwight tells Lt. Rice that her son can go and that boys will boys, but Lt. Rice wants him to get the time that he did the crime for and tells Dwight to stay out of it. Dwight and Charlie meet with Ron and he wants to talk to lawyer. Dwight calls him dumb and gets him to confess that it was Eloise put him up to it. Dwight and Charlie visit Eloise and Dwight tells that Red dominates over her but she keeps her cool. Later that evening Dwight enters Lt. Rice's office and tells that she needs to go to him. She tells that he needs to stop meddle. However, Dwight tells that she is the one meddling and she snaps that Dwight is meddling in everyone's life and she tells that he needs to get out of her office. He takes off the tie. In the bar, Dwight sings "Polk Salad Annie" and the next morning goes to Alex's house. She tells that she has a lot of chores and he tells that he understands that he needs to back up and stop meddling. He has brought a tool box to her and tells that he knows that she can stand on her own two feet. He leaves.

Leonard laughs and tells that no one is going to believe him. Gene laughs and Leonard points a gun at him and tells that he will kill him. Dwight and Charlie enter with the rest of the team and stop Leonard from

killing him. Dwight performs with Delilah Boswell on stage and they sing together.

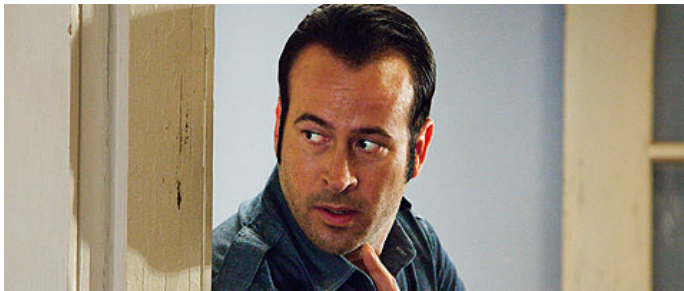

Charlie tells that is what Tyler and Meg did and Dwight tells that Tyler never paid on the plane and that they gave it to him because of the pictures of the check. Charlie tells that is how Tyler is going to get the Solar Toaster off the ground and tells that he needed an investor.

At the station, Dwight and Charlie meet with Bennett Barns, the co-owner of the solar toaster, and tell that he has motive to kill because of the failure of the product and that he needs to explain. Bennett tells that Donald created a GPS remote control that has the power to tell machines where to go. Dwight and Charlie return to the plane and find Charlie's 'Ghost'. Dwight gives Donald the GPS and that it was him who killed the two because of the fact that Tyler got all the attention and tried to make the plane crash. But Donald tells that he created the mechanism for his mother and that he helped them escape. He tells that Meg sent him an email and tells of her plans. Rice meets up with Dwight at the bar and he tells that he doesn't think that the case is going anywhere. Lt. Rice tells that money warps family. She tells that a couple needs financial security and it is hard. Dwight tells he went through the bills and he is only paying on a storage unit. At the storage unit, Dwight and Charlie open it and there is a smell. Dwight notices the box on the left has been opened. They open it and the body of Meg Oney falls out.

Charlie tells that they ran the plates from the boat and it gave the location of Tyler Oney and he is taken to the station. Dwight tries to get him to talk and he tells Dwight to write it all down and he'll sign it. He tells that he is done. He is a little crazy and tells that he is going to write a book about his experiences. Dwight tells that he'll have plenty of time for it. It is Lightfoot's 40th birthday and Lightfoot tells that he should be in the woods communicating with nature. Charlie tells that he is only 1/16 Indian. Greenback shows up and tells that Martin Eek instead.

Dwight sees that Ms. Austin is there and Lightfoot tells that Dwight is going to sing. Dwight sings 'Caught in a Trap'. Later, Dwight is looking at the books of his father and finds wads of money in all of them that are ripped in half. Dwight visits Ms. Austin and asks about wads of money that is cut in half. She tells that it means that the police officer was dirty and so was the partner. She offers Dwight a glass of wine but he tells that he needs to go.

She says that she wants to discuss some funds

that were withdrawn from her account. Marissa, the teller, looks it up and confirms that \$20,000 was withdrawn but it is not theft. It is a transfer from the bank to a personal account. The person who did it is Carl Rice, Lt. Rice's ex-husband. Lt. Rice says that she needs to put it back and she fights with the teller to put it back. Marissa calls over security and Rice tells them to back off. Dwight, Charlie and Sutton go to lunch and Sutton says that Charlie needs to change how he eats lunch and says that he is on a new diet and it has worked really well. They get a call for a Code 407, man with a gun, and Charlie asks for them to wait 5 minutes. Dwight and Sutton tell Charlie that a man with a gun comes first.

They arrive on the scene and one of the neighbors says that a white man went to the old black man's house and the old man grabbed the young man and will not let him out. A hand sticks out and fires a gun. Everyone ducks. Dwight tells Charlie to cover him and that he is going inside. Charlie calls Dwight crazy and Dwight goes to the door. The old man answers the door and Dwight says that he is a detective and wants to know what is going on. He says that he is going to kill the boy if Dwight does anything. SWAT pulls up and the old man tells Dwight to back off. Dwight says that he knows the man and asks to go inside. The neighborhood is gathered and the SWAT commander Hudson says that she has experience in hostage negotiations and asks why did Dwight go inside? She says that she is setting up a team to go in if he doesn't come out soon. Inside, Dwight recognizes the old man as Sebastian LeGrange, a famous recording studio owner that helped record all of the great singers of the Memphis past. He asks if he could give

the young man water. When Dwight takes off the tape the man says that his name is Jeffrey. He tries to give his last name but is cut off. Sebastian says that the young man is the devil and that he has come to take him back to 'The Farm' Dwight doesn't understand because he never heard of Sebastian being a criminal.

Dwight is inside the bathroom and calls to Charlie. He says that they need to run the name Jeffery Mc. and see who it is. He comes out of the bathroom. Sutton is walking around and sees a camera crew. He wants to share the story. Back inside, Dwight and Sebastian talk and Sebastian hears the Police helicopter and he points the gun to the young man's head. Dwight says that they are news helicopters and Dwight shows him the news. He is shocked that his house is on television and they turn to another channel and Sebastian sees Shirley, his daughter. Outside Lt. Rice is talking to Shirley and she says that she hasn't seen her father for 12 years and that she doesn't want to upset him more. Dwight calls Lt. Rice and she says that Jeffery is a processer and that Sebastian is being evicted. Dwight looks at old photographs and there is a 5 digit number 24601 and it is a prison ID for Leroy Hitch and that Sebastian is not who he says he is. Shirley wants to know who Leroy Hitch is and Lt. Rice says that her father is Leroy Hitch.

Dwight says that he knows the true identity of Sebastian and calls him Leroy. He tells Leroy that he will only serve a few years and he says that he didn't do anything to her. He says that he was in love with a white girl named Emily and that he wrote her a song for her and they were talking about going to Chicago. On Christmas eve, he snuck in the back door and found her dead. Leroy says that he was sentenced to life in prison without the chance of parole. He escaped from there and started a life in Memphis. Until today when the man comes and says that he wants to take him back. Dwight tries to tell him the man was there with eviction notices. Dwight asks Leroy if he still remembers the song. Leroy plays the song loud enough for the neighborhood to hear too. Dwight says that he knows that Leroy didn't kill the girl. He says that he will prove that Leroy was innocent. In the bathroom, he says that Charlie needs to go to Louisiana and she tells Sutton to go with him. They arrive in Arden and they look at the case file and Charlie says that they never ran the prints on the murder weapon. Charlie calls Rice with the print results and Leroy's prints were on the knife. Dwight is inside and demands Leroy to tell the truth and he says that the cops got it mixed up and he says that he played the song the day before for her younger sister. Leroy is startled by a noise and accidentally shoots the gun into the floor. Dwight says that they need to call his Lieutenant and tell her everything is fine but it is too late and tear gas gets thrown through the windows and SWAT enters. They get Leroy, Dwight and Jeffery.

Dwight arrives in the station and everyone claps. Dwight asks where Leroy is and Lt. Rice says that Louisiana wanted him back. Dwight claims that Leroy didn't do it and Rice says that Dwight is going to give himself a heart attack. He tells Rice to give him a couple of sick days. Dwight drives to Arden police department and Lt. Rice is there too and says that she hates Louisiana and says that when Dwight has a feeling, he usually is right. They enter the station and go through the case box. They find a cracked snow globe and Dwight says that Leroy didn't have any money for a gift. They visit Emily's younger sister, Miranda and mention that Leroy played the song and Rice asks if she ever told others that Leroy and Emily were dating. She says that she didn't but says that Brian Turlock gave Emily the snow globe and that he was devastated when she told him that Emily was dating a black man. They ask if Brian is still around and she says that he is their Mayor.

They visit Mayor Turlock and state they are asking questions about Emily. He says that it was horrible and that they got the right man. He says that he had no problems with Leroy dating Emily and that he even helped give blacks voting rights. He says that he was in the college the night Emily was murdered and says that he has a conference meeting to attend. Outside the town hall, Rice is talking with Marissa from the bank and says that they have not received any paperwork to take the ex-husband off the account. Dwight walks behind her and says that he has an accountant and she says that he is meddling. She asks if his ex and him are still at it, and Dwight says he is not. She says that she has a girlfriend that would love him and Dwight asks if she wants his accountant's name. Rice suggests they work the case

Dwight and Rice return to Miranda and tell her that Brian didn't mind Leroy. Miranda says that it is her fault that Emily got killed because she told Brian and he must had yelled at Emily and caused Emily to yell at Leroy. She says that Brian called from the university and said that his car was soaked from the rain because he left his windows down. Dwight calls Sutton to get the weather report on that Christmas Eve for Fayetteville, where the Mayor was attending the

University. The weather information proves that Brian was not in Fayetteville and probably in Arden which had rain on Christmas eve and that he probably wiped the weapon clean and the prints are because Leroy touched it. Dwight says that Emily had head wounds from a blunt object. They go to the station and look at the cracked snow globe and they run the prints and it is the Mayor. The police officers escort their Mayor to prison and Leroy is set free. Leroy and Dwight sing 'I shall not be moved' and the episode ends.

Tony comes over dressed in a suit and tells that it is a beautiful day to have a nice meal. Dwight is a little leery of Tony and his splurge of money at a fancy hotel restaurant. He orders tomato soup and Paula starts to choke. Dwight helps her and an engage-

ment ring pops out. Dwight asks if the ring is for his mom and he tells him yes. Paula accepts and Tony tells Dwight, 'Welcome to the Bellew Family'. Suddenly, a bride enters the hotel and asks for a police officer. Dwight tells that he is an officer. The bride tells that her soon to be husband, Greg, has run off. Thinking it is just pre-marriage jitters, Dwight tells her to give him time. But she plays a message that was recorded to her voice mail from Greg. It is a fight and a man's voice too.

Lt. Rice and Charlie arrive and Sutton fills them in that the bride's name is Hilary Orlen, daughter to Councilman Orlen and the groom is Greg Watson. His family Don and Laurie Watson are there too. Don tells that he talked and gave him diamond earrings to give to Hilary. A man stands up and says that he and Greg were drinking at the bar until 1:30am. But Dwight looks at the sign and it says that bar closes at Midnight. Sutton recognizes the man to be Collin Stevens, a basketball player. He tells that everyone loves Greg and Dwight tells that they need total honesty. Dwight asks if Greg went with him to the Leopard Lounge Strip Club and his parents deny it. But Collin tells that he came but didn't look at the girls. Sutton takes the initiative to go interview the girls at the Strip Club and tells that they might have some 'information'. Dwight notices that there are cameras in the wall statues. Larry the security guard tells that he can't give footage without a search warrant but Dwight tells that Larry owes him because of the fact that he stuck up for him in high school that got him elected for president. He gives Dwight the security footage from the other night but there is a problem. All the security tapes are stolen. Larry allows them to look in Greg's room and tells that he could get into trouble and for them to hurry up. They find Greg's cell phone on the night stand and Dwight goes into the bathroom. He sees that the

shower curtain has been ripped and that there is water in the shower still. He looks down and sees a spot of red. It is blood. The dig up the tile and hit it with a lamp and find that it is a large amount of blood.

Lt. Rice tells that the blood is Greg's blood type and that it is probably personal and that there is a political issue. Dwight tells that the person that killed Greg knew the hotel. Sutton tells that the strippers tell that they didn't see anything and he 'believes them. He tells to make sure, he is going to give them the 'once over' again to make sure. Dwight and Charlie meet with Hilary and tell that they found Greg's blood and she cries. They move onto Councilman Orlen and they ask if Greg had any enemies and he tells that everyone loved Greg. He pauses when he tells that they got together for dinner. Councilman Orlen tells that Greg and Don got into an argument and that Greg came back frustrated. They visit Don and he tells that Greg got up in the middle of dinner and tells that he jumped up quickly. Sutton tells that there have been robberies in the hotel and a man found an employee going through his things and the man got a broken nose. That would explain things would be easier if it was an employee behind the murder. They look for the murderer and in the kitchen, Dwight sees a girl with Diamond earrings. He stops her and she runs to Manuel. They take them both to the station and Manuel tells the girl that the detectives don't speak Spanish and that they just need to deny it. But Dwight surprises when he speaks Spanish back and he tells that he took pictures of Greg's room and that the argument that they heard from the phone was about Cocaine and Collin is involved. Sutton plays a message of a voice mail from Collin and he tells that he will bash his head in if he doesn't stay cool.

Lt. Rice meets with Collin and he comes clean about the cocaine but tells that he had nothing to do with Greg's disappearance and tells that Greg was seeing a girl on the side and that the number should be in Greg's phone. They locate the home of Rachel Stein and a girl answers the door. She sees the badge and tells that her paperwork is good and she uses 'it' for medicinal purposes. She tells that Rachel is not there and that she had to go out of town. Dwight sees a car in the yard and sees Rachel's ID badge. He unlocks the door and finds folders. They point to a Green Street Port Complex. It is a mall that is going to be built and Dwight sees that there are pages ripped out. He uses a pencil and finds out that Orlen is going to get kickbacks for stopping this and that Greg is messing with big people. Meanwhile, Lt. Rice and Paula are working out and Lt. Rice tells that Paula needs to make sure that Paula needs to make Tony her second wife. Rice tells that when men get married to a 2nd wife, it is a 20 something girl. She tells that she needs to stop him from telling her to make him a sandwich and Rice tells Paula to have him keep up his body. They laugh.

Back at the hotel, Dwight and Charlie tell Councilman Orlen that Greg was approached by the Green Street Port Project and asks about Chester Bayon and Orlen tells that he is a corrupted. He gets agitated to think that they hurt Gregg. Sutton tells that Chester is under investigation for tax evasion and that he already put \$5 million of his own money into the project. That gives him motive if Greg wanted to shut it down. Sutton points out Chester and tells that he always eats at the hotel. Charlie tells that Rachel never made it to Chicago. Charlie and Dwight sit down with Chester Bayon and they question about Greg and Dwight suggests that Chester killed Greg and Rachel because they were getting in the way. He tells that Dwight is crazy. A woman walks in and gives Dwight a dirty look. Dwight tells things work differently around here. The woman that gave Dwight the look is at the station and Sutton walks by and drops money into her cup. She gets upset that he ruined her latte. The woman is Sgt. Birdie Thorpe. She is introduced to Lt. Rice and Thorpe tells that it is nice to meet her and asks if she works out in a flirtatious tone. Lt. Rice tells her to stand up and tells her to watch her tone. She asks what she is doing there and Dwight tells that Thorpe has been building a case on Chester and Thorpe tells that Chester set up a meeting tomorrow with Rick Stanislaw at the Green Port construction site.

Charlie, Dwight, and Sutton listen in on the conversation about girls for a circus. They leave and Dwight spots a car that was there before. They approach the car and Sgt. Thorpe is above them. Dwight gets the trunk open and the bodies of Greg and Rachel are in the back. Greg's body is positioned strangely. He is holding his side and finds a piece of paper. At the station, they open the note and it is a bank statement and sees 500,000 was wired to HLO account. Dwight finds that it stands for Hilary Lorraine Orlen. Dwight meets with Councilman Orlen and tells that Chester is going to turn on him and Dwight tells that he is a murderer. Orlen tells that he knows the town better than him and that everyone gives up their morals. Dwight sees that Councilman is wearing the cuff lings that she was going to give to Greg and asks when he got the cuff lings.

He tells when he meet for breakfast with Hilary.

Dwight and Charlie meet with Hilary and tell that they know about her giving the cuff lings before Greg was found dead and that it was her that arranged the murder and tried to pin it on Chester Bayon. They tells that they are going to find the man who did the killing and that Hilary is going to jail. She tries to say that her father is a good man and that his reputation should not be tarnished. Dwight tells that it was Hilary that tarnished the history of her family and handcuffs her. As she walks off, Councilman Orlen tells that it is never going to stick. The episode ends as always with Dwight singing. This time it is 'Don't be Cruel'. He points to Tony when he sings the words Don't Be Cruel.

(Taking Care of Business). He is interrupted by his mother and Tony and they have a baby. A little girl named Bella shows up and takes Dwight to the woods. Bella is running away from Dwight and he comes up to a blue tarp in the grass. He lifts it up and it is him. Dwight is startled awake and he is in his office with Lt. Rice telling him that he hit it, while she is pulling on her clothes. Dwight wakes up to the

phone ringing and it is Charlie. Dwight is no longer dreaming. Charlie tells that they have a shooting that happened but the victim has amnesia. Dwight hangs up the phone and looks in the mirror, shuttered by the dreams he just had.

Dwight arrives on the scene and Sutton tells that the man got shot and they don't know who he is. He shows that he had only a pack of gum and a bus pass. Dwight wants to know why a man from the Suburbs was doing in the run down neighborhood. Dwight sees a piece of paper on the ground and Sutton tells that the man had it with him. A 'hippie' crystal falls out and Dwight tells that it is a gypsy trick to steal someone's wallet. They go see Ms. Angelina and she tells that Dwight is going to have to make a choice and that he is coming to a crossroad. Charlie tells her to come clean and she gives up the wallet she stole. The shooting victim is a Zachary Drake. Dwight asks Ms. Angelina what Zachary wanted from her and she tells that Zachary asks if he was going to hell or not.

Dwight visits Dee-Dee at the restaurant and he gives Dwight another tape of music. Dwight tells that he had a dream about his sister Bella. He tells that his grandmother did too. He tells

that he will see him tomorrow. Dwight tells Lt. Rice about Zachary and tells that he lives with his wife and kid in Germantown and that he was in town for the psychic read. She tells that he should visit the wife. Dwight sees that Lt. Rice is putting her resume into a company called 'Platinum Security' and wants to know what is going on. She tells that her ex-husband hasn't given back the money that he took and that she has to take on a job that is better paid. Dwight tells that she needs to do something and she tells that she is handling things. Lightfoot tells Dwight about the Men of the MPD Calendar and tells that he wants him in it. Charlie jumps in and says that he will do it and so does Sutton, but it is clear that Lightfoot only had intended to have Dwight join.

Dwight goes to visit Noreen Drake and she tells that she doesn't know why Zachary is acting strange and tells that he has been dead for three years. She tells that she doesn't know him any more and that he is not himself. She tells that he goes out drinking with a high school friend and Dwight and Noreen go back on forth and finally come up with Martin Mathews as the person they sold Zachary's old car and that he has never been the same. They visit with Martin Mathews and he is not sober at all. He tells that Zachary and him were not friends and that he bought his car off him and that is all their friendship went. However, at the station, Dwight and Charlie find out that there have been money wired to Martin's account every month from Zachary. Sutton comes in and has his best suit with him. There is a line of muscle-clad men in the hall and he asks one of the female officers and asks if they are all for the Calendar. She tells that they are.

Back at Martin's, Dwight and Charlie break in and find that Martin had a shredding party and they find pictures of a trunk with a red substance in it. They recognize it as Zachary's old car that he sold and they go around back and find the car. They open the trunk and find the blood. Martin is there with a rifle. Dwight points his gun on him and tells him to put the gun down. He realizes who they are and laughs and tells that he almost shot them. He puts down his gun and stumbles over because he is so drunk. They bring him back inside and tell him that he lied to them and that he has been taking money from Zachary every month. Martin tells that it was a bribe to not go to the police about the blood in the car. Dwight has an idea and he goes to the Evidence Room and pulls out Bella's old file. Lt. Rice asks what he is doing and Charlie tells that he is looking at Bella's files because he has a thought of who could have killed her. He tells that he had a dream about her the same night they found Zachary. He tells that it is not a coincidence. She tells that she had a dream too and that she was an Eagle and tells that she can't take care of everyone. Dwight tells that Rice is leaving.

They visit Noreen again and ask about the car. She tells that she doesn't know anything about the car besides that Zachary would not let anyone take it. She tells that Zachary was busy with a time capsule thing for his High School and that gives Dwight the idea to go dig it up. Upon uncovering it, they find an envelope with Zachary's name on it. Inside it there is a barrette. Dwight flashbacks to Bella having such a barrette and tells Charlie that they have her killer finally. At the station, the crime lab tells that the fingerprints that they retrieved from the results are that of Zachary and the doctor tells that they will run the blood that was found in the car. The doctor in charge messed it up years ago to what Charlie tells, was hitting the bottle too hard. Dwight and Charlie visit Zachary and tell that they are going to arrest him once he gets a release from his doctor. Dwight visits Bella's grandmother and she tells that he is a bad cop and that he allowed for the man to walk free for so many years. Dwight can hear the tension in her voice and asks if they own a gun. She tells that she doesn't but Dwight sees a hippie crystal on your nightstand. He goes to visit Ms. Angelina.

When he arrives he grabs her cell phone and sees that Angelina called Bella's grandmother the night Zachary was shot. She tells that Dee-Dee shot Zachary because of the fact that he knew it was him that killed his sister. Later Dwight is in the restaurant and Lt. Rice comes in and tells that she heard of the decision he has to make. Dwight juggles with the fact that he might have to arrest Dee-Dee too. Lt. a glimpse at Bella's grandmother. He walks up to her and she thanks him for being a good cop. Lt. Rice tells that she is staying with MPD because her ex-husband wired the money he took out of her account and put it into her account. Sutton gives Dwight thumbs up and Rice tells Dwight thank you. The episode ends as it always does with Dwight singing a song. This time it is 'I Want to Be Free' and Charlie, Sutton, Rice, and Lightfoot are looking at the 'Men of MPD' Calendar and it has Charlie and Dwight in it. Sutton made the front cover. In the back you can see that Gary Shilling showed up for it as well.

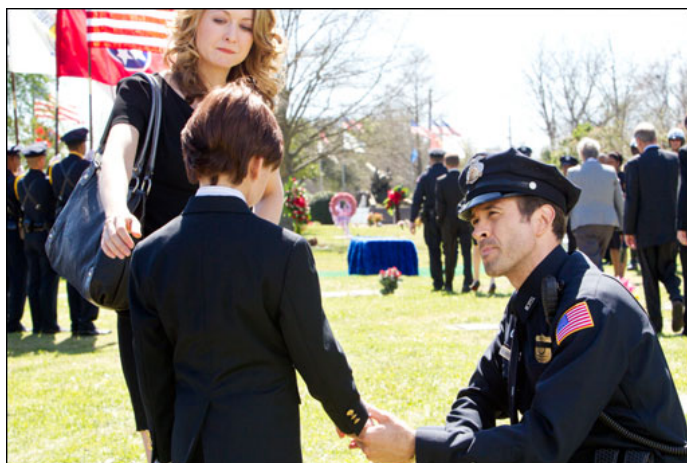

Rice, who wants to promote Whitehead up and out of her department.



The scene opens with Dwight and Whitehead arriving on a scene of a crime. A police officer has been shot. His name is Don Ekler and Dwight says that he knows him and says that he was a good guy. He asks Officer Sutton to look around for the gun that killed Don. Lt. Rice comes up and tells that his partner, Clay Williams, went for some coffee and Dwight tells that they are going to need to get the schedule for the patrol car. Rice tells that she took them so that they wouldn't get 'borrowed'. She tells Whitehead and Dwight that Don was being investigated by Internal Affairs. She says that she wants

Dwight to work with Internal Affairs on this and make sure that they honor Don. Whitehead takes offense and tells her that she can't split them up. Dwight agrees and asks if they could have someone else. She says that she has to report this to Don's wife and tells Dwight to go with her. Dwight tells Whitehead that it is nothing and says that they just have to find the killer.

Lt. Rice and Dwight go to see Stacy Ekler and Rice tells Dwight that they are going to find enough information that is going to confirm that Don was a good cop. If not, then they need to avoid giving him honor for it. The door opens and Stacy is there. She asks what is wrong. Jack, Don's son comes up and Dwight distracts him so that Rice can tell Stacy the bad news. Outside, Dwight talks to Jack some more and Jack tells that Don yelled at him for touching his gun. Dwight says that he knows the anger that was felt and says that he shouldn't touch guns and if he sees one, he needs to report it. Rice tells that she has a list of Don's associates and tells that he can share it with Internal Affairs. Later at the station, Dwight and Whitehead talk to Officer Williams and he says that Don told him that he did something that he wished that he didn't do.

He says that Don told him that it has to do with 'The Whiskey Snake' bar. Dwight goes to meet Internal Affairs Detective Ryan and she introduces herself to him.

Meanwhile, Whitehead and Lt. Rice visit the person involved in a fight at 'The Whiskey Snake'. He says that there were two people who jumped him. Lt. Rice tells that the report only mentioned one. The man says that a police officer matching Don's description was there too that took one of the men aside and yelled at him. Rice says that Don let a man go on an assault charge, but not enough to cause him to get fired. Rice tells that she saw that Whitehead took the Lieutenant exam. She tells him that she will give him some time to study and says that anyway she can get him out of her department, the better. Meanwhile, Dwight sits down with Detective Ryan and she says that Don was allegedly part of the White Supremeness group. Dwight gets upset with her that she is trying to destroy Don's reputation. Back at the station, Sutton talks to Greenback about how he was when he first started on the force. He says that he imagined that he would get robot parts. Greenback says that the bullet had a special armored tip on it and says that the killer wanted to kill Don.

Dwight and Ryan go to Stacy's place and she doesn't understand why Internal Affairs is involved. Dwight says that he is going to look for Don's interest. Joey Ekler, Don's cousin comes in and tells that he is going to the funeral parlor. Dwight asks if they could talk to Jack. Afterward, Dwight and Ryan find a bunch assault rifles and illegal guns in a box. They get back to the station and Dwight is fighting for the honor of Don while Ryan is claiming that they have proof. Lt. Rice intervenes and tells every to dress in their best uniforms for the funeral. Lt. Rice tells Ryan to go to her office and asks her what she knows of Dwight. She tells that he sings on the side and Rice tells that his father died in the line of duty. Rice tells her to finish the investigation before they point the blame on anyone. Later at the Wake, Officer Williams gets up and tells that Don was a good man. Dwight starts singing 'When the Saints Go Marching'. Everyone joins in on the song and they give their final goodbyes to Don.

The next morning, Dwight is hungover when Ryan comes in. She looks around and sees all of Dwight's collection and is amazed. She tells that she has a lead and he says that he will get his pants on. They go to a trailer and hear someone running. The man runs away and they chase after him. After they get a ways out of the way, the trailer blows up. Afterward, the ambulance and fire crew come and Dwight and Ryan give descriptions. They conflict, but get the right description. Greenback says that the man was making armor piercing bullets. Rice doesn't think that Don was right, but Dwight tells her to give him until sunup to find the guy. She tells that he has until then to find the killer. At the station, Dwight's mother brings in Dwight's father's old hat and tells that he can wear it. Whitehead brings in wrenches and Dwight recognizes them to be a certain brand where only one place makes them. He says that the guy who tried to blow them up works at the store.

Later that evening, they bring in the guy and he tells that he was only paid to make bullets. He tells that Don was there when he took the job, but he was trying to tell his friend who is in the gang to get out. Dwight goes up to Lt. Rice and ask if that is enough for a good honor burial. She says that it is. She tells that Ekler's 'friend' might show up at the service. Later at the funeral, Dwight walks up to Jack and tells him that he is there for him. After the funeral, Dwight sees a man leaning against a car. The man punches Dwight and the officers take him into custody. Whitehead talks to him at the station and pretends to play a radio and tells that the walls have ears. The man writes down names of people involved in a raid. Later that night, Dwight and Ryan are on stakeout and Ryan tells that his team are doing good in the investigation and asks why he sings. Dwight says that he likes to perform. She reaches for another SD card and they kiss.

The next day, they look at the pictures and Lt. Rice comes up and tells that the FBI thought that the militia was out because of the arrest of the leader. She says that the trial is not over yet on it. Dwight realizes that the judge residing in the case has received death threats. They find Judge Winslow and find that he doesn't have his vest on. Suddenly there is a gun fired and Dwight shoots at a truck and kills the guy driving. Dwight shows the pictures of men to Stacy and she says that Joey has been a security guard in the area where Judge Winslow is. Sutton shows pictures to the man who was assaulted and he picks out Joey as the second person. Sutton takes him to Dwight and he says that Don knew about the militia members and Joey tries to go away. Dwight tells that he is protecting others. Joey admits that he was the one who killed Don. Later, Lt. Rice asks about the paperwork and Whitehead says that he is done with it. He says that he is not coasting. The episode ends with Dwight meeting with Ryan about the

report. She tells that it is already written and Dwight smiles when he reads it.

Back at the station, Lt. Rice gets off the phone with the Mayor and tells Dwight that the Mayor wants the burglars caught. Dwight tells that they are going to do the best they can. Rice puts on the

news where the press secretary to the Mayor tells everyone to call in if they have any information for a reward of \$50,000. Dwight does a countdown and then suddenly every phone in the station rings.

The Memphis Police Department is littered with people who think that they have information on the burglaries. One citizen, Keith Grant has something of interest. Whitehead and Dwight are interested in his knowledge of the information on the case. He says that the burglars have been using PE4 and not C4 explosives and says they are out of PE4. Keith tells the two Detectives to look into construction sites. Later, Dwight and Whitehead check out the last known associates to the Fox Meadow Burglaries. Dwight asks what is up with Whitehead and he says that he is re-branding himself. Dwight tells him that he doesn't like it. They get back to the station and

Lt. Rice asks about Keith. Dwight says that they are following the leads and Lt. Rice says that a construction site was hit and PE4 was stolen. Dwight realizes that the Robbers now have an entire load of PE4 to continue their crime spree.

They go to Keith's place and he is excited that the construction site was hit because it proves that he was right. Dwight and Whitehead start to suspect Keith for being involved and he laughs. They look at his journals on the Fox Meadow Burglaries and the Detectives ask to take them. Keith asks if they have a warrant. Dwight and Whitehead get back to Lt. Rice and ask for a warrant, but she tells them that they are going to have to go to Keith and play nice to get the journals. She suggests that they bring him on as a consultant. Later, Keith comes into the station and Dwight tells that he is a consultant that has some important information. Whitehead comes in late and Keith chastises him. However, Whitehead tells that he is sorry. Keith starts to tell about what he knows and Dwight tells him to get to the point. He passes out papers on his findings when Lt. Rice comes in. Keith gets distracted and can't really talk. Dwight asks why he has Miles Ahomana as a suspect. He tells that they had a suspect named Miles Hart and Keith says that Miles came back through the country as Miles Ahomana.

Keith, Dwight and Whitehead get to Miles's house and Keith asks about Lt. Rice. They tell that they are on the job now. They get inside and Shane, a son of one of the wealthy homeowners, says that he has to give her over to the wolves. She has a hard time talking to them and Whitehead tells her to smile, but the homeowners don't like it.

Back at the station later, Whitehead, Lt. Rice and Dwight talk over the case. Dwight says that Miles couldn't do the robberies because he has a fracture bone in his leg. Dwight gets a phone call. Keith was jumped in his apartment. Dwight gets there and finds that Keith's journals are gone and he doesn't have copies. He tells that he lost his wife through a divorce because of his obsession with the case. Dwight agrees and says that it will be only one song. He sings. Afterward, Dwight gets a call and says that he is on his way. He gets to the house where Rice and Whitehead met with the concerned citizens. Dwight talks to Mrs. Vereen and she tells her son Shane not to drink. Shane tells that he is concerned and is only having a drink.

Later, Dwight tells that it is interesting that the house wasn't broken in the same and suspects that Shane is the burglar. Dwight gets over to Mrs. Vereen's home and asks about Shane. He says that Shane is involved in the burglaries and she admits that she saw him leave right after Dwight left. She tells Dwight to bring in Shane safely. Dwight and Keith go to Dr. Jeffery Gibbs, a drug counselor. He tells Dwight that his clients don't fight drugs because drugs don't fight fair. He says that he doesn't know where Shane is. At the station, Miles is there and Whitehead says that they know about the Fox Meadow Burglaries and Miles says that the statute of limitations is over on it and confesses that he was the one. Whitehead loses it and Greenback asks if he needs to interrupt and Lt. Rice tells him to give Whitehead a moment. Miles says that he 'hypothetically' taught someone his secrets. Whitehead threatens to beat him up and Greenback tells him to come with him.

Dwight gets off the phone and Keith shows that he has a friend on social network of a friend of Shane's girlfriend. He shows a picture and Dwight sees that Mark Coopersmith is her father and lives in Boon Lake. Keith gets excited, but Dwight ditches him. Sutton offers to take Keith on a ride in the patrol car. Later in a car, Dwight and Whitehead wait for the warrant and Dwight tells Whitehead that he has changed as a cop and says that they are both getting older. Dwight tells him that he doesn't have to re-brand himself. They get the warrant and go to the door. They are interrupted by Shane aiming a gun at them. He says that he thought it was someone else. He says that he did the break-in as retaliation for his rich friends turning their back on him, but

after that his partner wanted him to keep going. Dwight asks who his partner is and they realize that it is Jeffery Gibbs. Later, Greenback finds that Gibbs keeps a storage facility and Dwight and Whitehead go there.

When they arrive, Keith pulls up and tells that he wants to go in with them, but Dwight handcuffs him to the car. They go inside and find that Gibbs has all the things from the burglaries. Keith tries to get out of the handcuffs, but hides when he sees Gibbs coming with a gun. He turns on the radio with his foot and inside, Dwight hears the music. He says that Keith is warning them of something. Dwight goes out and is tackled by Gibbs. They fight and Gibbs runs off. However, Whitehead hits him in the chest with a baseball bat and they arrest him. Later at the station, Keith tells Dwight that he never 'Deputized' him so Dwight does and tells that their relationship is over now. Keith says that it is alright because he has \$50,000 to spend now. Sutton brings in Miles and he tells that he is suing them. However, Sutton says that he can be charged for the Fox Meadow Burglaries because he left the country afterward and therefore, it doesn't matter. The episode ends with Dwight walking into Lt. Rice's office to find Keith singing to her. She tries to tell Dwight to help her, but he walks away smiling.

says that they don't have a choice. Dwight sees a man sitting down and Sutton says that his name is Ted Creskoe. He says that Ted wants to report a missing person. Dwight sits down with Ted and asks about the missing person. It is Jill, Ted's 21-year-old daughter, who has been missing for 4 years. Ted says that he hasn't had the chance to tell that Jill's mother Lila passed away and says that Jill always sent a card once a month and she hasn't written a card for a month. The last card was a 'see you soon' card. Dwight tells that he will see what he can do.

Lt. Rice is in her office talking on the phone when Dwight and Whitehead walk in. Dwight says that a daughter of a man is missing and she tells them to go find the girl. Greenback tells that there are no hits on the picture. Dwight looks through Jill's mail that Ted had and they get a location of where she could be. Dwight and Whitehead get the information that people know her, but don't really know her. They realize that Jill was a waitress because of the people who saw her say that she had an apron on a lot of the time and paid in change. They get to the 5th restaurant and the waitress tells that she will be right with them. Dwight stops her and Whitehead asks if she has ever seen Jill. She tells him to tread lightly and she realizes that Dwight and the rest of the station know about the engagement. He says that she should be happy. She tells that she didn't know about the wedding and tells that if her daughter needs to call if she wants her to go. Whitehead goes up to Sutton and asks if he wants to go to the range and fire a few rounds. Sutton says that he doesn't want to, but Whitehead says that he wants to observe his style. Whitehead gets a call from the State Trooper and they go to find a woman that was rushed up the river. Dwight says that the woman that they found was beaten before drowned because her skull was split open. At the shooting range, Sutton tries to give Whitehead some pointers and he isn't listening. Sutton shows Whitehead that he is so good, that he made 6 bullets go in the same hole.

Ted gets escorted into the same jail cell as Derek and watch. Greenback is put in the jail cell with them and says that he is being accused for killing the girl. Derek tells him to back off and tells that Jill was a piece of trash. Ted gets upset with Derek and he punches him. Dwight says that they didn't kill Jill because they didn't care about the Medical Examiner report. They go back to Lisa's restaurant and find the place locked. Around back, they see Jill's dog inside and break in because the dog is telling him that he is being held against his own will. They get inside and find the sweater that thread was caught on the car door. They get Lisa in the station and they tell that murder is a serious offense. Lisa tells that she didn't kill Jill and says that Derek

didn't either. Greenback says that the body is not Jill. Dwight says that Jill may have reinvented herself again. He goes back inside and tells Lisa that he will make sure that Jill is not going to go back to Derek. Dwight finds Jill at a motel and tells that he is going to make sure that Derek is not going to touch her again.

Back at the station, Ted waits as Dwight and Jill go up to him. Ted says that Lila loved her so much and Jill tells that she missed her and Ted tells that he wants to apologize to her and says that he is sorry for all the time that she didn't get to spend time with her mother. The episode ends with Dwight going up to Derek and tells him to stay away from Jill, Whitehead getting lessons from Sutton and corrects his shooting and Lt. Rice calling up her daughter and talking to her after years. Dwight ends with singing 'Always On My Mind'.

Summary: Dwight and Whitehead are on the case of a reported missing person, but they are shocked to discover that a nun may be their prime suspect. And when Sutton discovers an abandoned baby in his car, he turns to Dwight's mom, Paula Ann, to teach him baby basics.



The scene opens Sutton responding to a disturbance call at a retirement home. An elderly man tries to tell Sutton all the details of what is going on and Sutton says that he will handle it. He knocks on a door and a man answers the door with nothing but a cake to cover his private parts. He apologizes and says that he thought that Sutton was someone else. He tells that it is alright and for him to keep it down. However, Sutton realizes that the room that he thought was the room reported to have the disturbance was elsewhere. A door in the corner of the hall slips open and Sutton approaches.

He finds the place tossed and finds a man in a pool of blood on the bed. He calls it in and Dwight and Whitehead arrive on scene. They see that the man was beaten and left for dead. However, they see that there is someone else's blood on the bed too before the man. They find that the man's name is Sam Walter, a Defense Attorney. Dwight says that they need to look into his work and see if any of the clients are to blame for this.

Meanwhile, Greenback tells that Sam is on the lease of the apartment and that Sam and his wife live in Germantown. Lt. Rice thinks that Sam was having this on the side to cheat on his wife because a couple of residents saw a young woman with Sam. Greenback says that Sam's wife is not home and she isn't picking up her phone either. Rice tells that they may have themselves a suspect. Dwight and Whitehead get to the office of Sam and sit down with his secretary. She is emotional and says that Sam was working with things off the books. She shows them a list of people who Sam was working with. They get back to the scene of the crime to find Sutton cleaning up. They hear a baby and Sutton sees that it is in the back of his patrol car. Dwight picks her up and Whitehead says that she is wrapped up with the same sheet inside. They get inside the station and they feel that the wife of Sam killed Sam because he had an affair with the young woman. Greenback says Sam got a check from Peter Branson every month and then Sam wrote a check to someone else in the same amount. Sutton comes in with the baby and tells that Social Services are not in. Lt. Rice grabs the crying baby and sings what she wants the Detectives to do. She tells Sutton to play Nanny until Social Services are in.

Greenback has Peter Branson come into the station and asks why Sam was getting checks from him. He says that Sam was helping him and his wife adopt a child because they can't have kids and the State won't let him adopt because he is a former felon. Greenback tells that Sam is dead and Peter asks about the baby. Greenback is interested on how he knew about the baby and Peter says that he didn't kill Sam because Sam was helping him get a baby. Whitehead says that Sam's wife was on a cruise and didn't know anything about it. They realize none of the other residents have no clue who the woman was. However, Dwight sees a homeless woman on the street. Dwight asks if she has seen a pregnant or have a new baby. She tells that a young girl was nice and gave her a 'God's Path' shirt. Dwight gives the cookies that Whitehead got from the residents. They go to 'God's Path', a half-way house for women. They talk with the nuns there and they tell that they have no information. Dwight realizes that one of the nuns is not maintaining eye contact and Dwight tells that they're going to have to take them all in. Sister Catherine speaks up and tells that she is the baby's mother. They take her down to the station and Lt. Rice tells that she can't believe that they are talking to a nun about this.

Dwight walks into the room and asks about the baby being in the back of the Police car and she tells that she had the baby at the apartment and Sam was helping her. However, after she was recovering, a person banged on the door. Sam told her to take the baby and run. Dwight asks who the baby's father is and she tells that she can't tell him that. Dwight tells that he doesn't believe a word she is saying. Meanwhile, Sutton is watching the baby and has her on the copy machine. Greenback tries to make copies and Sutton tells that he can't move the baby because she will start yelling. Dwight's mother comes in and tells Sutton that he did a good job and says that the baby is asleep. Whitehead says that Sister Catherine's story checks out and says that the nurse told him that the father of the baby is tall, but that is all she could tell. He says that they told him that Sister Catherine used the name Christie. Lt. Rice comes out and asks where they are. Whitehead says that since illegal adoption was the thing, the father probably wanted a bigger cut.

Dwight and Whitehead are on stakeout and see Sister Catherine comes out and is stopped by a man. Dwight runs up and the man runs off and drives off. They question Sister Catherine and she tells that it is her father, Harlan Thomas, was who was trying to attack her. She tells that Harlan was the one who was going to get a \$25,000 finders fee. Sam called Harlan that the deal was off and that Harlan was the one who killed Sam. Dwight asks why she didn't tell them before and she tells that she didn't want to believe that he could kill someone. Whitehead and Dwight get back to the station and tell Lt. Rice the update. Whitehead pours what he thinks is water only to find milk in the jug. Sutton comes in and tells that the milk is for the baby. Lt. Rice goes through Sister Catherine's bag and finds car keys. Lt. Rice tells them to find the car to find the baby's father. Dwight and Whitehead manage to find the car and find that the father of the baby is Damon. They tell that they have Sister Catherine. The father of Damon says that Christie is not a nun. He shows a picture of her and Dwight says that Sister Catherine is not the baby's mother, she is her aunt.

They get back to the station and Lt. Rice is not happy with the update. Dwight goes into find Sutton and his mother practicing putting on diapers on cans and tells that he needs to borrow the baby. Sutton asks when Dwight is going to settle down and have children. He tells them not to worry about it and walks into the interview room with the baby. Sister Catherine lights up and tells that he has had enough of her lying. She tells that her sister Christie and Damon are fine. She agrees to give him the address. He takes the baby and sings her to sleep. Sister Catherine tells that her father used to be good, until Christie's mother died. Greenback tells that apparently Harlan has a debt of \$25,000 that he has to pay to a bookie. Sutton comes by and Greenback tells Sutton has spit-up on his back, but Sutton doesn't care. They get a call that tells that they have a location of Harlan's car. It is right outside the station. Dwight goes out and tells the person in the car to get out. It is Damon, the baby's father. He tells that Harlan has Christie and he says that he has to get the baby.

They go to the hotel and see that Harlan is holding Christie inside with a shotgun. Lt. Rice tells Sister Catherine that she needs to talk to her father because she can reach him better than they can. Social Services come by to pick up the baby. Paula Anne goes into see Sutton with the baby and tells that the Social Services have come. He says that babies are so cute and that it was a nice time spending time and taking care of one. They say goodbye to the baby. Back at the hotel, Sister Catherine talks to her father and manages to get him out of the hotel and Christie

is saved. They hug and the father is escorted off to prison while Christie and Sister Catherine hug. Later, Sister Catherine comes in with cookies for the station and tells that the baby is under Damon's father's custody until they decide what they want to do. Dwight tells Whitehead that if Sutton asks, they named the baby Pereira. Whitehead agrees only if Dwight gives up his half of the cookies.

The scene opens with Dwight playing the guitar and watching Lt. Rice meeting with someone. Whitehead says that there was a fire at the movie theater. Lt. Rice asks to talk to Dwight and says that it will only take a minute. Dwight meets Special Prosecutor Hillyard Sherman from the U.S. Attorney's office. He tells that Tim Mason is getting offered pardon from being insane when he killed his father and says that Dwight and Paula Anne have to sign off on it. Meanwhile, Whitehead meets with the Fire Chief and he says that they found a Gothic Lamp as the source of the fire and that they picked

up a kid named Bryan who was hit on the head. However, the kid remembered that he had Pot Brownies' in his car and ate them all up before the cops could see. Whitehead says that he is going to have to wait until Bryan is off his Chocolate High. Back at the station, Dwight is looking at the form that Sherman gave him and tells Lt. Rice that he is going to talk to Mason himself. She says that she isn't going to fight him.

Back at the movie theater, Whitehead talks to the owners and asks about Bryan's behavior. The Fire Chief comes out and shows the burnt remains of a film. The wife of the owner says that those were Elvis's early films and that is tragic that they were destroyed. Lt. Rice pulls up and tells that Dwight needed a few days off and she is going to be with Whitehead. He asks if she is taking over and she tells that she isn't. She tells that Whitehead is in charge this time around. He walks away confident and Rice rolls her eyes. Meanwhile, Dwight packs and Paula Anne comes in. She tells that they can send in the forms. He says that he is going and Paula Anne says that

she is going with her. Sutton has a box and it is full of Bondage toys. Whitehead and Lt. Rice think that Bryan was supplying Ecstasy to kids during RAVE parties. Whitehead tells Lt. Rice to interview Bryan when he comes off his high. Sutton is shocked that Whitehead gave Lt. Rice orders and she tells that Whitehead is running the investigation this time.

On the road, Dwight asks why she is quiet and she tells that Dwight's father's case was taken care of and complains about Dwight's driving fast. Dwight tells that there was missing minutes on the day that his father was shot when the witness couldn't see his father and Mason. He wants to know what happened. She tries to tell that there were no missing minutes and Dwight doesn't care. A little later, Dwight gets pulled over and Paula Anne gets him out of it by flirting with the cop. Whitehead talks to Bryan and asks why he was unconscious outside the theater. He says that he doesn't know why. Whitehead shows the pacifier they found and says that Bryan was hosting RAVE parties. However, Bryan says that Dave, the owner, and his wife were and they were adult sex parties. Whitehead says that he is going to talk to Dave. Paula Anne stretches and tries to convince Dwight to go back to Memphis and forget about Angola. Dwight shows the wad of cut money. He says that only dirty cops have cut money and needs to know what it is about.

Back at the theater, Whitehead and Lt. Rice talk to Dave and he tells that he never hosted the sex parties and that a couple named Mystic Harry V, are the hosts. Lt. Rice thinks that Dave wanted to go for insurance fraud and Dave says that his insurance lapsed and that he has no insurance on the theater. Whitehead and Lt. Rice go to their shop and tell that they have the keys and have access. Harry V and Mystic tell that they were at a party last night and Whitehead demands a list. After threatening prison, Whitehead gets the list. Dwight and Paula Anne get to the prison and Mason apologizes for killing Dwight's father. He says that God's found him. Paula Anne gets emotional and tells Dwight that she can wait in the car. Neil Decay, one of the members of the sex club, is brought in and Whitehead tells that Rice can take this one. Dwight sits down with Mason and tells him to talk. Back at the station, Decay tells that he had an argument about how he saw his girlfriend come out of Dave's office and he told him that he was showing her Elvis prints that he had. He says that he never burnt down the place and tells them to look at the skinny guy that was yelling about the same prints and saying things like, 'It's not about the money'.

Back at the prison, Mason tells that he was a different man back then and he says that he did unspeakable things. Dwight asks about the Mafia truck that Mason got things off of and shows the dirty money. He says that he doesn't know anything about it. Dwight tells that he is the one standing in the way of his freedom and Mason still says that he doesn't know and Dwight says that he knows that his father was on the Take, but says that he knows that he wanted to get out of it. Dwight tells Mason that he can rot in prison. Dwight calls Whitehead and tells that he needs a favor and asks who Mason's cellmate was in prison. Paula Anne asks if they can go home and Dwight says not yet. She tells that solving the case is not going to bring his father back. He says that he still needs to know. Back at the station, Sutton tells Whitehead and Lt. Rice that the Elvis movies were worth 50,000 a piece. Lt. Rice tells that she found out that Dave had an insurance policy on the movies. Back in Angola, Dwight talks to Mason's old cellmate and he tells that he doesn't remember because he only told what other people told him. Dwight walks the streets walks into a bar and meets with Rihanna, an old friend. He walks in a room later to find her almost naked on the bed.

The next day, Dwight wakes up next to Rihanna and she asks what he is going to do about Mason. He says that he doesn't know. Whitehead talks to Dave and tells that the fire was caused by him. Dave says that he and his wife would never burn down the theater. However, when he gets choked up, he admits that it was him. However, Whitehead can tell that he is lying. They go to the Memorabilia shop and wait outside for Ernie Madsen, a guy who was on a chat site saying that he is going to cash in on a score. Ernie pulls up and Whitehead tells the girl in the car to take a walk and gets the keys. They open the trunk and find the Elvis movies. Ernie comes out and says that he bought them from Meagan, Dave's wife, fair and square. Whitehead suspects that Megan snuck out while Dave was sleeping. Meanwhile, Dwight goes to a restaurant and asks why Paula Anne isn't ready to go. She tells that she isn't going to the Parole Board meeting because she knew that Dwight's father was on the Take. Back at the station, Whitehead shows Megan the signed confession for assault and arson from Dave. He says that she doesn't have to let him take the blame.

Dwight speaks at the hearing and says that his father was the best father anyone could

ever have. He says that Paula Anne and him are not going to stand in the way of Mason's release. Dwight walks out of the prison and throws away the cut money. Later, Lt. Rice goes up to Whitehead and says that he did good. Lt. Rice says that the case was a test for her and Whitehead tells that she did a good job too. The episode ends with Dwight and Rihanna singing together 'Knock On Wood'.

says that she will not stop driving. Sutton asks Rice if she really asked someone at the DMV. She tells him that it had to be done.

Dwight and Whitehead go to the scene of the crime in which Jimmy was accused of robbing. Detective Merrand comes by and tells them that three men robbed a boat with guns. Dwight asks why they picked up Jimmy. Merrand tells that they found three wetsuits in Jimmy's boat shop after searching for boat shops around the area. Whitehead says that is not enough, but Jimmy asked for a lawyer right away. Dwight says that armed robbery doesn't fit Jimmy's character and Whitehead says that 15 years is a long time for people to change. Dwight goes to the Precinct and finds Jimmy. He tells Dwight that he doesn't need his help and tells him that he will tell him mom that Dwight tried his best. He goes outside and tells Whitehead that Jimmy turned down his help. Whitehead asks what got him into this behavior. Dwight tells that Jimmy stole his girlfriend years ago. Whitehead asks if the girl is blonde hair, blue eyed. He says that she was and then turns around to find Margo, the old girlfriend and Jimmy's wife. She tells that Jimmy needs Dwight's help and he says that he will see what he can do.

They get back to the station and Dwight says that he can't believe that he got sucked into this and Whitehead says that he is 'that guy' where everyone goes to. Dwight asks Sutton to get all

the information on Jimmy off the books. Sutton likes the fact that they are going under the radar with this. Whitehead asks Dwight for \$20. Dwight gives him \$10 and a couple of dollar bills. Whitehead says that proves his point that Dwight is 'that guy'. Later, Lt. Rice drives by to find her mother on the side of the road. She is being escorted into a police car and she sees that her mother crashed in a car. She goes over and her mother blames her for destroying her confidence. She tells that she shouldn't be driving and she tells that she is trying to put her into prison. Dwight and Whitehead go to the owner of the boat that was robbed. The man has a watch that was reported stolen. He says that he had to get it back and so he put a word out to some fences to track it down. Later, Sutton finds Winston Spady, the owner of a salvage yard. Sutton asks if Whitehead thinks that Jimmy is guilty and he says that anyone who steals another friend's girlfriend is bound to be a criminal.

Dwight and Whitehead go to the salvage yard and meet Winston. He says that he doesn't have any pocket watches and tells that he never sold one. However, when Whitehead tells that he will drag him to prison, he tells that 3 men came in looking to sell things. Whitehead tells that Winston is going to give descriptions to a sketch artist. Dwight goes back to the Precinct and tells that he got Jimmy's bail reduced and Jimmy's mother is posting it. He thanks Dwight for the help. Dwight asks about the men in the pictures and he says that he doesn't know them. Dwight tells that he will talk to him later at Jimmy's shop. Meanwhile, Whitehead is talking to Rice's mother and she asks why he is. Whitehead tells that Rice has to pick her mother up from the Beauty Parlor in an hour. Dwight plays the phone call and they hear a whistle. Sutton says that Jacob Hill is the man that got away. Sutton says that it is a horn that is blown when a bridge is being raised. The SWAT team gets on scene at a factory and bust inside. They shoot and Hill goes in a room. Dwight sees him trying to choke and kill Jimmy. Dwight shoots Hill and Jimmy is safe. Meanwhile, Lt. Rice gives her mother new glasses and says that she needs to retake the driving test again and get her license. Back at the

factory, Marrand is glad that Dwight's friend is alright and Dwight tells Jimmy that he shouldn't have went back to the men and he says that he thought that he could have gotten them out of the hole they were in. The episode ends with Whitehead telling Dwight that he saved Jimmy from doing something worse.
