Summary: Los Angeles, 1931. On the heels of an unsavory investigation involv-

ing a famous comedian, Perry Mason — a PI struggling to make ends meet — and his right-hand man Pete Strickland are hired by attorney E.B. Jonathan, Perry's mentor, to solve a perplexing case: the brutal kidnapping of one-year-old Charlie Dodson, whose parents Matthew and Emily were targeted for a \$100,000 ransom. After meeting with Herman Baggerly, a millionaire elder at the Dodsons' church, Perry, E.B., and E.B.'s legal secretary Della Street ponder why a family of unmistakably modest means would be extorted for such a steep price.

Perry Mason is a hardboiled private detective who lives on a small, rundown dairy farm. He spends his days doing run-of-the-mill work like spying on Hollywood actors to ensure they aren't breaking their contractual morality clauses and his nights having sex with the robust female pilot, Lupe.

His dairy farm sits on the precipice of an airfield, which just adds to the overall dumpy look of his dairy farm. Despite all of this, Mason is attached to his home and not keen on selling it, despite the fact he's broke.

It appears the "main" case of Perry Mason will pertain to the kidnapping and murder of a young boy named Charlie.

We're introduced to a couple frantically trying to complete the demands of an unseen presence, one who demands they leave him \$100,000 in an open suitcase before retrieving their son from a nearby trolley car.

Unfortunately, when they reach their son, wrapped in a plaid blanket, they discover he is already dead, with his eyes sewn open.



Fast-forward to later in the episode when Mason is approached by attorney E.B. Jonathan, who recruits Mason onto his team to solve the unsavory case for a man named Herman Baggerly.

Jonathan, his assistant Delia Street, and Mason, head to a meeting with Baggerly, who asks them to look into Charlie's case because he doesn't have faith in the police department to get the job done.

We meet Charlie's parents, Matthew and Emily Dodson. They're severely shaken up by their son's grisly death. It becomes apparent why Baggerly may not feel the police are up to the task, since they happen to walk in during an unsa-

vory interrogation between two cops, Detective Holcomb and his rather cruel partner.

During the arguing and questioning in one room, Mason explores the house. He starts taking pictures of anything that catches his eye, including a ceramic turtle and a framed photograph of Sister Alice.

While investigating, Mason runs into Emily and the two have a brief but emotional conversation about Charlie. Mason reveals he has a son of his own, a nine-year-old named Theodore.

At Jonathan's office later, he, Mason, and Street try to figure out what they know about the case so far. Their current theory is that Charlie was stolen from the house while Matthew was away at work and Emily was asleep.

It begins to sound like the person who kidnapped Charlie knew a lot about the Dodson family, considering they were aware of their schedule and financial records. They knew they could ask for \$100 grand, which suggests they had insider intel.

The next day, Mason gets a chance to peek inside the railway car we saw in the opening scene, where the Dodson's found their son's body. There, he runs into Holcomb's menacing partner who wants to arrest Mason. But he counters by giving him some information — which is that he heard a car rammed into the trolley on the fateful night Charlie was discovered, something else we saw happen in the cold open.

In the morgue, Mason takes a few photographs of Charlie's body. He and the coroner remove the stitches from Charlie's eyes and Mason pockets one string inside of a matchbox.

Unfortunately for Mason, things take an ugly turn from there as he attends the Hammersmith Picture's New Year's Eve party, mainly so he can finally get paid for the naughty pictures he took of movie star Chubby Carmichael and up-and-comer Velma "Red" Fuller.

Originally, Mason was only instructed to see what he could find on Carmichael, but since the two stars crossed paths, he asks for \$600 instead of the original \$200, especially since the images could do serious damage to Velma's image.

Well, Mr. Hammersmith does not like being toyed with and he certainly doesn't like anyone surly enough to talk back to him. He has some of his goons rough Mason up, including burning him with the heated end of a pistol. Then he disses him by giving him the original \$200... minus \$199 for being a smarta\*\*, basically.

Mason leaves empty-handed and worse for the wear, severely pissing off his partner Pete, too. Both men needed that payday.

It's not surprising then, that Mason turns to alcohol to bring in a lonely New Year's Eve alone. He makes an angry phone call to the woman we can assume is Theodore's mother and his likely ex-wife. Theo lives with his mom and it doesn't seem like Mason is on particularly good terms with his estranged family members.

In the final moments of the episode, a drunken Mason begins to realize something. He rushes into a room of his house and pulls out all the evidence he has on the Charlie Dodson case, spreading everything out on the floor.

He then pulls out the matchbox and a picture of the ceramic turtle and says, "So you like turtles?"

Worth noting is that Holcomb's seedy partner is definitely a corrupt cop. At one point, he enters a room with a suitcase for three men. He places the suitcase in front of them, apparently a payment of some sort, except when they open the box — it's empty.

He then quickly shoots one man in the head and brutally crushes the other with his foot, while the third man escapes, suffering from a few bullet wounds himself. However, he doesn't make it far before falling to his death.

All the cop says for reason of lashing out violently is, "They made the car."

Summary: Following one of her trademark barn-burning sermons, Evangelical

preacher Sister Alice offers the Dodsons the church's full moral and financial support — much to her mother Birdy's dismay. During a routine domestic intervention, beat cop Paul Drake is re-routed to a gruesome crime scene, where he follows a confounding trail of evidence. Mason is left incensed by a jaw-dropping admission from Baggerly and, after pressing Emily Dodson on her husband's alibi, finds himself confronted by an outraged Della Street. Detectives Holcomb and

Ennis use Drake's findings to their own advantage.

The episode takes a deep dive into Mason's wartime memories. The episode is bookended with cinematic flashbacks to his time serving in France.



Haunting and gritty, they are some of the hour's most profound sequences as we learn Mason killed several of his fellow soldiers to put them out of their misery. He was discharged for his deeds and carries the weight of those deaths on his conscience.

In present-day, Mason makes several startling, and gruesome, discoveries in the ongoing case of Charlie Dodson's murder.

It appears neither of Charlie's parents is as innocent as we were led to believe in

the first episode. Matthew Dodson is arrested for conspiracy kidnapping, as District Attorney Maynard Barnes drops the bombshell that Matthew is the secret son of Herman Baggerly.

Neither Matthew's lawyer, E.B., or even his father believe Matthew is actually capable of harming anyone. The truth is, Matthew is an illegal gambler and that's where he really was the night of Charlie's death.

For now, Matthew is under arrest for what they called a "hanging crime," although Maynard offers E.B. a deal. If Matthew pleads guilty, they'll pin the murder on one of those dead bodies procured by corrupt cop Ennis from last week's episode.

As a refresher, you'll recall that Ennis killed several men and shot a suitcase in an apartment complex. Well, Officer Paul Drake, a policeman we are first introduced to in this episode, stumbled upon the bloody crime scene while handling a domestic dispute.

Drake is a Black cop who suffers from the times. Holcomb and Ennis aren't exactly kind to him and Ennis even tries to dissuade Drake from believing what he saw at the crime scene. Drake followed the blood trail out of the room and saw that it led elsewhere, meaning there is likely another body — something we know since we saw the murder scene play out in the first episode.

Obviously, Ennis doesn't want that getting out so he tries to convince Drake that he saw wrong, that perhaps the blood led from the roof down to the room instead of the other way around. Drake pretends to agree with him, despite being much smarter than either cop would give him credit for.

He is also forced to change his official report, something he admits to his wife, who is pregnant. Still, Drake can't shake the feeling of something more ominous occurring in apartment room 206, so he returns to the blood trail down the ledge later.

In the stairwell, he discovers what looks like a dental plate, one that looks strikingly familiar to one discovered by Mason elsewhere in the episode.

Mason discovers that Matthew Dodson is not the only Dodson to have a dark secret. He trails Emily and uncovers her infidelity with a man named George. At George's residence, Mason uncovers one of the most grisly scenes on the series yet.

Inside the house, he finds yet another corpse, this one has taken a shotgun to the face. George is definitely dead and mason starts poking at the remains — ick. He finds a strange dental plate embedded in the carnage. Hm, might that be related to the one Drake picked up in the stairwell?

Also hidden away inside of George's home is an alligator figurine, one crafted similarly to the turtle figurine from Charlie's bedroom. Funnily enough, they both come from the same place, the Los Angeles Alligator Farm.

Tucked inside the alligator are damning love letters between Emily and George, highlighting their torrid affair. Mason confronts Emily and she tries to deny it but is obviously horrified and heartbroken when she learns George is dead.

The episode also dives deeper into the Radiant Assembly of God and its involvement with the characters' lives. We finally get to meet charismatic Sister Alice, who is beloved by many.

Her invigorating sermons are seen as prophetic and of utmost importance by many. Toward the end of the hour, she goes off-book, much to her mother's annoyance, and during the ceremony held for Charlie, Alice begins talking about the men who hold the power. She empowers them to find the real culprit behind the man who killed Charlie Dodson, casting her doubt on Matthew's arrest.

Sadly, as Alice leads Emily out to see her son's burial, they're intercepted by Holcomb and the other police officers who arrest Emily for similar charges to her husband. She doesn't even get to see her son be moved to his final resting place, something Mason appears to feel guilty about in the aftermath.

The final moments of the episode see Della Street visiting Emily in prison, giving her what looks to be Charlie's blanket.

The episode picks up the day after Emily Dodson is arrested at her son's funeral. A confident D.A. Barnes showboats before a crowd of eager press: "Justice for Charlie Dodson, the noose for his mother!" he exclaims while posing for the cameras.

E.B. Jonathan's putting on his own show while getting a clean shave. In a barbershop packed with reporters, the lawyer speaks to his client's innocence: "She was conned by some cons." Della

does need to help him, however, when he forgets some of his rehearsed lines.

Over at the Radiant Assembly of God, Sister Alice spins her latest sermon, the collection plates jingle with the generosity of her faithful congregation, and Perry Mason waits for a meeting with her holiness.

Following the service, Alice, Mason, and mother Birdy discuss former choir boy/deceased kidnapping co-conspirator, George Gannon. Alice — receiving an IV cocktail of "vitamins and saline" — is more interested in helping Mason find God than the kidnapper. "God left me in France," he responds. The two exchange some playful barbs, but Birdy's all business. Turns out George, who helped the church with bookkeeping, was vetted by the Elders and had great references.

When we catch up with Emily, she's in her cell being coached by E.B. Her arraignment's coming up, and he wants to be certain she and Matthew look like a happy couple in the courtroom. All's going well, under the circumstances, until Mr. Dodson casually chimes in with, "Did you f—him in our bed?" Things escalate quickly, and Matthew ultimately blames Emily for their son's death. The scene also introduces the prison matron, "Stone-face Barbara," as E.B. affectionately calls her, who's tasked with staying with Emily at all times.

At the morgue, Perry and Pete bribe their chatty coroner friend for a peek at fedora-hatman's corpse. Detectives Holcomb and Ennis have already been by to secure the deceased's personal effects, but the private eyes don't leave empty-handed. Upon turning the body on its back, they discover the throat-crushing injury that ultimately killed him. Over lunch, the two can't make sense of this fresh clue: if George was so ruthless, gunning a man down before "making applesauce with his Florsheim," would he then kill himself?

While Pete looks into George's church-provided references, Perry pays a visit to Officer Paul Drake's commander. Unfriendly and uncooperative, he offers Perry plenty of insults and a single-paragraph report from the crime scene. Mason turns his attention to the secretary, who he butters up to find out where he can track down Drake. But the patrolman, who's busy writing parking tickets, quickly dismisses Mason. In the distance, dirty Detective Ennis watches their brief encounter.

At Emily's arraignment, E.B.'s feeling confident because he's "old friends" with the judge. But when the proceedings begin, he immediately embarrasses himself fumbling through his notes. While he's distracted, a despondent Emily pleads guilty under her breath. The packed courtroom goes wild, order is called, and the judge asks Emily to repeat her plea. E.B. presses her to say, "Not guilty," but the damage is done and her bail is set at an exorbitant-for-the-time \$25,000.

Later that evening, Pete's treating himself to a steak while annoying his fellow restaurant patrons with foul language. He's celebrating the results of his investigation into George's references. Before helping the church with their finances, it seems the god-fearing suspect was lending his accounting skills to the Lucky Lagoon Casino.

Meanwhile, Patrolman Drake's shopping for produce and enjoying a day off with his lovely wife — until Ennis shows up. Adding threatening and creepy to his list of unsavory traits, the corrupt cop touches Mrs. Drake's pregnant belly, insists on paying for their groceries, and suggests the officer not talk to Perry Mason.

Clutching a basket of goodies and traveling with a small choir, Sister Alice visits Emily in prison. She puts a sweater on Mrs. Dodson and assures her she's not alone. In trying to comfort her, she hints at her own troubled past, suggesting Sister Alice has some dark secrets of her own. But Emily still blames herself for Charlie's murder and says as much in the crowded cell. Chaos erupts, leading matron Barbara to accuse Alice of "inciting the populace."

Mason's having a much better time, enjoying a "date" with his pilot girlfriend at the Lucky Lagoon. While his lady cleans up at the roulette table, he questions the casino owner about his former employee George Gannon. The P.I.'s thinking George may have met his co-conspirators at the casino, but his former boss describes him as "dull as dishwater." In fact, George wasn't fired but left voluntarily when he found God. A discovery he apparently couldn't stop talking about through his "cheap dentures."

The next morning E.B.'s prepping for the day, but something's amiss. The episode's already shown him off his game twice, and now he's staring at blood in his sink. He checks his gums for the source. Outside, Della beeps the car horn, then rings the doorbell. The lawyer is clearly distracted, staring at a hummingbird outside, but acts perfectly fine when Della finally lets herself in.

Perry starts the day by taking another crack at Paul Drake. He accuses him of kowtowing to the D.A. and being strong-armed into changing his report. Drake responds by escorting Mason behind a billboard and punching him in the gut, twice.

Ennis doesn't witness this latest encounter between Perry and Paul because he's busy visiting a whore house. Not for pleasure — this time — but to collect his take. Eyeing a light envelope, he threatens the madame with shutting down the operation. But she has her own warning to deliver. Pointing to a picture of George in the paper, she says, "Mr. Wu is not happy." Ennis tells her Wu needn't worry. He looks worried, however, when she reveals Mason was sniffing around the Lucky Lagoon.

Mason brings his new intel on George to E.B. Perry doesn't peg the dead suspect for a "throat-snapping gunman," but the lawyer doesn't care. He's only interested in whether or not Emily was involved, and getting her bail reduced. Their individual concerns come to a screeching halt when E.B. opens a letter. "I think we got fired," he says while staring at the note.

Following his latest meeting with Perry, Drake's back home drinking and feeling guilty; not so much about sucker-punching Mason, but because the P.I. saw right through him. He confesses this to his wife and says he doesn't like Ennis having his claws in them. She balks, telling him not to risk his job, focus on his priorities, and keep his mouth shut.

Alice and Birdy are preparing for the day's service, an elaborate production that will find Alice as a passenger in a prop boat, saving sinners lost at sea. She attempts to convince her mother of Emily's innocence, saying, "God's testing us." But Birdy wants to keep away from the "murderer among us."

E.B. is also desperate to help Mrs. Dodson prove her innocence. Seeking financial help in the wake of Baggerly firing him, he meets with a former legal partner. Much like the "old friend" that determined Emily's bail, E.B. has similarly misjudged this acquaintance. Not only will he not loan him money, but he also holds him responsible for nearly getting them both disbarred back in the day. Whatever this shady history involved, it could bring them both trouble if D.A. Barnes does some digging. "I can save this girl," begs E.B., but the acquaintance suggests he settle with a plea deal and be done with it.

Herman Baggerly is also good with throwing Emily under the bus. At his plush estate, he pushes his recently-cleared son to move on and let his wife take the fall. He lays it on pretty thick: "She laid with the man who murdered your son." Still, Matthew's feeling his share of guilt, admitting he was "mean" to Emily sometimes. But Herman's looking to the future, recruiting his bastard son to help him build, "A city of faith, far from the corruption of L.A." He lays blueprints in front of him for, "The Town of Girard."

At least Emily has Della Street in her corner. E.B.'s determined assistant pays her a visit so she can sign a new retainer. But the officer at the front desk gives her a hard time and refuses to let her in. Street spies matron Barbara in the waiting area — not at her post watching Emily — and quickly does the math. She busts through the officer to find Emily literally having her arm twisted by Holcomb and Ennis behind closed doors. She scolds the two detectives, who look like puppy dogs that have just been caught defecating in the house. "You're all in big f—ing trouble!" she shouts.

After commiserating with Pete over getting fired, Perry exits a bar to find Drake waiting for him. The patrolman tells Mason the truth about the blood trail up to the roof, and how he altered the report at Holcomb and Ennis' strong urging. Paul then tells Perry he'll deny they ever had this conversation, before handing him a handkerchief containing the dental plate portion he discovered in the stairwell. The P.I. stares at the clue, "What is this, teeth?"

Back at the Radiant Assembly of God, Alice is putting on her show, rising from the floor of the fake boat, the "SS HELLSUPONUS." As her congregation goes wild over her surprise appearance, she begins her sermon. But she has trouble focusing and starts hearing voices before collapsing.

Meanwhile, Perry and Pete race to the morgue, hoping to catch George before he's cremated. They arrive and begin checking toe tags. Pete's squeamish, but Perry threatens to tell his wife about his apparent numerous infidelities if he doesn't help. This spurs his partner into action, and they quickly find George on a slab. Perry fits the denture piece into the corpse's mangled mouth and muses, "Who killed you, George?"

As Birdy tends to her unconscious daughter, the church elders try to distract the audience. The press isn't easily fooled, however, as reporters hover over Alice, snapping photos and scribbling in their notebooks. They get a front-page scoop when Alice comes to. Smiling at her mom, she tells her not to worry about Charlie Dodson. She's received a message from God. As the screen fades to her faux ship floating in a real ocean, she whispers, "I'm going to resurrect him."

Summary: Mason and Strickland lean on Virgil, again, for extra-legal assistance.

Following Sister Alice's recovery from a frightening episode, Birdy urges her daughter to renounce her claims about baby Charlie. E.B. faces the reality of his financial situation and takes his frustrations

out on Della.

The episode wastes no time exploding the powder keg Sister Alice lit last week. Following her fainting spell — and Charlie Dodson-resurrection revelation — she' recovering at home. She's visited by concerned members of her congregation, including a young couple and their little girl. Dressed in her Sunday best, the child offers Alice a bakery box and a kind smile: "Do you like sweets, Sister?" But the sugary treats turn out to be a pair of slithering snakes, dumped on the unsuspecting preacher. While the family's escorted out, the mother yells, "The Lord refutes you!"

Based on E.B. Jonathan's morning newspaper, the press has also pounced on the Sister's proclamation. "BACK IN A JIFF!" reads the headline above a picture of sweet baby Dodson. But E.B.'s more concerned with getting his client's bail reduced. Sitting before the judge, he and D.A. Barnes argue their cases. Given the department's detectives' attempt to force a confession from

Emily, the judge places her in protective custody but refuses to reduce the \$25,000 bail. Worse news for E.B., Maynard reveals Matthew Dodson has decided to testify against his wife.



Perry and Pete are having a better time, sharing a bottle and regaling coroner Virgil with tales of their P.I. shenanigans. The latter's loving the attention until he finds out why the pair have taken him to Mason's house. They've smuggled George Gannon's across-county corpse into Perry's basement, hoping to convince the coroner to do a "proper autopsy." Virgil's romanticized vision of the private investigators' lives drains from him as quickly as the color from his face. He wants no part of this.

Back at the preacher's estate, the Sister's doctor reveals she suffered an epileptic seizure. He strongly recommends rest for several weeks, but the Elders are more concerned with their financial health than Alice's well being. Elder Brown — and the other dozen or so white men in suits — bring Birdy up to speed on their concerns. They want the Sister back on the pulpit, redacting her claims of bringing the Dodson baby back from the dead. They're not only worried about the "ramifications of her message," but the fact that Alice continues to support Emily publicly. "We can no longer afford to teeter on the whims of hysterical women," says Herman Baggerly. Elder Brown adds, "You will censor the Sister or the spigot will be turned off."

E.B.'s also receiving some unfortunate financial news, as his longtime bank is refusing to loan him the money for Emily's bail. Sitting outside the meeting, Della learns the law firm has been treading water for some time.

Coroner Virgil's day isn't going much better. George Gannon's body — strategically dumped at a golf course by Perry and Pete — is lying on his slab ready for that "proper autopsy." Meanwhile, Mason informs E.B. of this promising development and brings him up to speed on the blood trail, dentures, and what he believes to be a "fourth man" that masterminded the kidnapping.

Armed with this fresh intel, E.B. confidently brings it to Maynard, demanding the charges against Mrs. Dodson be dropped. But Barnes fires back with evidence that E.B. misappropriated funds from some former clients. He essentially blackmails the dumbstruck defense attorney, offering him three options — a plea deal, trial, or disbarment.

Despite setting E.B. straight, Barnes is worried. He orders his detectives to a men's room meeting, where he rips into Holcomb and Ennis for not securing Emily's confession. "You couldn't break a f—ing housewife?!" He also asks about this "fourth man" and demands to know who killed Charlie Dodson. The dirty cops ensure the case is tight, Perry's a bum, and there are no other co-conspirators. Maynard isn't buying it.

Back at Sister Alice's mansion, mamma Birdy's feeding her daughter soup and trying to convince her she "misheard" God's message. But the preacher believes it was real, that God is in her head. Despite her convictions, she meets the press and members of her congregation the next morning. Clutching an Elders-approved statement, she speaks from her front lawn, conceding her revelation was a product of her "arrogant, sinful pride."

As Birdy and the Elders look on — cautiously optimistic their troubled ship's about to be righted — a man rushes to the front of the crowd with a gift. It's not another box of snakes, but a blanket for Charlie Dodson. "He'll be cold when he comes back," says the believer. Alice's eyes widen, a smile stretches across her face, and her lips let loose: "Emily Dodson is innocent, Charlie Dodson is in purgatory." She promises to resurrect the boy on Easter Sunday. The crowd goes wild — with equal amounts of support and cries of heresy — while an enraged Elder Brown repeatedly shouts, "Blasphemer!"

While this episode's a little light on Perry screentime, we're treated to a fun scene reminiscent of the premiere's subtler moments. Mason's in a phone booth talking to his son, apologizing for the late arrival of the boy's Christmas present (remember that returned-to-sender package from "Chapter One"?) Morals clause-breaching actor Chubby Carmichael catches up with him during his call. His indiscretions have made the front page, so he returns the favor by beating the crap out of Perry.

Later that night, Mason nurses his wounds with another evening of smoking and sex. As he and his girlfriend debate the pros and cons of resurrection, she notes the case is getting to him. He responds by getting up, wrapping himself in a blanket, and obsessing over his wall of clues and evidence.

Back at E.B.'s office, Della arrives to find her boss frantically digging through old files. Panicked over Maynard's claims, he's scrambling and scared. He takes his frustrations out on Street. Not a smart move. She effortlessly puts him in his place before throwing his car keys at him — "Drive yourself home!" — and exiting behind a slammed door.

Stealing a page from Perry's stress-relieving playbook, Street heads home for sex and cigarettes. In bed with her girlfriend (whom we meet for the first time in this episode), Della discusses her frustration and anger over Emily's presumed guilt and her "son of a bitch" boss. She decides to take the next day off and see how E.B. fares without her.

This leaves Perry to find E.B., who's spent the night in his office, sleeping on the couch. He immediately calls for Della to answer the phone when he wakes. Mason's looking for info on Matthew's initial interview with the detectives, but E.B.'s fussing over the fact he slept in his shoes. Groggy and unsteady, he sits while Perry helps him remove his wingtips. E.B. ponders his old age — talking of hemorrhoids and arm-length nose hairs — before the pair reminisce of a time when they were both much younger. Perry produces George's new autopsy report, but E.B. is distant and despondent.

Mason and Strickland return to the hotel room the Dodson's occupied the night they retrieved Charlie. They attempt to retrace the kidnappers' steps, again coming to the conclusion a fourth perpetrator was involved. They determine this mystery suspect must have been close by, so they could quickly scoop up the suitcase and flee the scene undetected. Outside, they discover a sky-way bridge leading to a nearby building.

Following this fresh lead, they find themselves in an Elks Club. Posing as potential members, they poke around and discover a kids' talent show/fundraiser is taking place in the club's auditorium. Perry sneaks in and takes a seat by Detective Ennis. While questioning the lawman about this extraordinary "coincidence," he outbids him on a pair of gold-plated antlers. Ennis, whose daughter is in the show, claims he's a member of the social club, attending three meetings a week. Perry asks if he was there the night of the exchange. "I dunno. Run me in and find out," says Ennis. Without missing a beat, Perry hits back, "Will you hold up as well as Emily Dodson?"

As the episode heads into the home stretch, we finally catch up with Emily. E.B. visits her, and she tells him she wants to go home. Backed into a corner by Barnes' disbarment threat, he tells her the case is "complicated" and pushes the plea deal. He puts on a brave face and tries to justify his recommendation, but cracks when Emily tearfully questions whether admitting guilt to the tune of 20 years in prison is the best move. "No, we won't do this, will we?" he says about the plea deal. At his request, Emily repeats, "I'm going fight," but asks, "And you're going to help me, aren't you?" Holding back tears, he responds, "I promise I'll do what's best."

The next morning, E.B. goes through the motions of his morning routine. He prepares his bird feeder, gets dressed, and combs his hair. Rather than leaving the house for work, however, he pulls a comfy chair into the kitchen. He then cranks up his stove's five gas burners, opens the oven door wide, and takes a seat. As fumes hiss, he removes his glasses, slowly inhales, and takes one final look at the hummingbird outside his window.

The episode begins with Perry and Della going through the motions of putting E.B. to rest. Both of them are startled and saddened to discover that he had no relationship with his family. Hardly anyone turns up for his funeral.

Despite this, his death does draw the two closer together as they bond over drinks and we learn more about Della's past.



She was born into money but ran away when she was only 25, answering an ad in the Examiner for what eventually became her long-running job with E.B. and associates.

Both Della and Perry are feeling the stress of Emily's impending trial. Without E.B., she gets saddled with a corrupt lawyer named Frank Dillon who is sitting cozy in Maynard Barnes' pocket. Luckily for Emily, she has Della on her side.

She is savvy enough to remove all of the important evidence they have on the case and stash it away at home, even enlisting her girlfriend to help her hide it.

When Dillon asks for the defense plans E.B. was working on, Della feigns giving him everything. Laden with ineligible notes from Perry and case files that lead nowhere, Dillon is led to believe the defense has nothing and the prosecution will have a slam dunk.

Della eavesdrop on a phone call as he dials into Barnes and tells him as much, agreeing to meet up with him at an undisclosed location so Dillon can tell him everything he's discovered.

Mason then pays Dillon a visit later and delivers a brutal verbal beatdown. He also physically roughs him up by throwing books at him and even choking him with a particularly large volume.

Enraged by the attorney's duplicity and mishandling of the case, he visits Della and goes on a rant that sounds almost like a closing argument. Maybe Perry was the one who kickstarted the crusade against Emily, but he's definitely turned a corner now and he's pissed off by everything that's happened to her.

His spiel inspires Della with an idea. Suddenly she starts typing away on a typewriter before pulling out a statement that would assign Perry as Emily's new lawyer. They flub it a little to say he'd formerly been working with E.B. as part of an internship of sorts.

All he has to do now is pass the bar exam and he's in — Perry is certainly Emily's best bet since literally no other attorney in town wants to touch her case with a ten-foot pole. They consider it career suicide since everyone thinks she's guaranteed to lose.

Also of note is Pete proves his merit in Episode 5. He chats with another police officer who doesn't have nice things to say about Ennis. After doing more digging, Pete even meets with Ennis as the brothel we saw him visiting before.

Pete tries to make Ennis see him through sympathetic eyes by throwing his partner under the bus and attempting to buy him off with a prostitute. Later, Pete assures Perry that Ennis is as crooked as they come and wasn't impressed by his lack of loyalty. He's willing to follow Perry to the case's end, even if he doesn't get paid.

After doubling down on her plans to bring Charlie back to life, Alice has split the congregation. Half of them stand outside the Radiant Assembly of God holding baby dolls with stitched eyes and calling Alice a heretic, led by Elder Brown who wants to take the church back from Alice and her mother.

Meanwhile, inside, Alice gives an impassioned sermon and shows off her "healing" powers, pledging a miracle by helping a disabled man in a wheelchair seemingly walk again. It's obvious he cannot actually walk on his own, as he stumbles across the stage with the crowd helping him along the way, but it doesn't matter because Alice sounds as energized and manic as ever. Her most loyal constituents are eating it all up, especially Emily.

But why wouldn't' she? Thanks to Alice, Emily is out of jail on a \$25,000 bond that the church paid for from their donation pool. She also has a cushy place to stay with Alice even giving up her own bed for the woman. Birdy is obviously not pleased, but Alice is the one with all the power. She threatens to fire Birdy if her mother doesn't do what she wants.

Toward the end of the episode, Alice finally takes Emily to visit Charlie's grave. Overcome with grief, she pushes aside all the flowers and throws herself on top of the dirt pile, sobbing. Then she asks Alice if they'll have to dig up Charlie's body to complete the resurrection.

Paul Drake and his pregnant wife Edwina attend church and listen to an empowering sermon from a civil rights speaker.

Edwina doesn't necessarily think fighting back against racism and segregation is smart, as she doesn't think it's worthwhile to try to change something that will never change. Of course, the opposite argument is that nothing can change if no one ever tries to fight against it.

Later, Paul, Edwina, and some of their friends enjoy a nice day at the beach. But suddenly, a police officer shows up and kicks them all out, saying the beach is closed. It's an obvious point of disrespect, as she doesn't even believe Paul is an officer himself when he tells him.

In bed that night, Paul is distraught at the inequality and the way he's been treated by his own colleagues and the world at large. Seeing his misery, Edwina says she's changed her mind and thinks he should do what he feels right. Considering what he knows about Emily's case, if Paul chooses to testify despite Ennis's warnings, it could make a big difference at trial.

Summary: Perry is having difficulties functioning in court, especially when new

details are revealed.

The episode begins with P.I.-turned-lawyer Mason behind the defense table. But far from the seasoned investigator we got to know beneath the fedora, Perry struggles a bit to find his footing in the courtroom. Following a polished, powerful opening statement from D.A. Barnes, Mason stumbles over his words and literally chokes, coughing his way through much of his opening remarks.

Thankfully, the trial's second day goes much better for Perry Mason, Attorney at Law. Matthew Dodson's on the stand, reading one of Emily's lurid love letters to George Gannon aloud. While he plays the sympathetic cuckold during Barnes' well-rehearsed questioning, Perry effortlessly draws out his dark side. He calls Dodson out on everything from his gambling debts to his secret-millionaire-daddy. Matthew loses it on the stand, directing his anger at Emily: "I hope they hang you, you lying whore!"

While Mason's trying to make a case for Emily's innocence in court, Pete Strickland's still hunting for evidence to support it. On top of trying to find a connection between Ennis and the

goons the dirty detective executed in episode 1, he's sniffing around George Gannon's residence. Digging through the deceased's mail, he discovers two un-cashed checks — paid by the Radiant Assembly of God to a mystery business coincidentally located at George's address.



Back in the courtroom, Barnes calls a surprise witness, a weaselly gentleman with an equally weaselly mustache. He's a hotel manager, bursting at the seams to tell the tawdry tale of Emily and George doing the deed in one of his rented rooms, while poor baby Dodson cried behind a closed door. The jury looks disgusted, Emily looks guilty, and Perry looks pissed.

But Mason holds his anger until later that evening at Sister Alice's house, where he unleashes it on Emily for neglecting to inform him of her liaison at the Star Hotel. The preacher scolds Perry for

his harsh words but complements his performance in court. He responds by telling her not to attend the trial, as her presence and support aren't doing Emily any favors.

Mason returns to his home/makeshift law office to find mountains of evidence boxes, an intentional overkill response from Barnes to ensure Perry's team has "everything" going forward. At least Pete has some good news: He's made that connection to Ennis and Charlie's kidnappers — apparently they crossed paths in Denver, where the detective worked as a Pinkerton. He also shows Perry the suspicious checks, signed by Elder Seidel from the church.

The next day, patrolman Paul Drake takes the stand. He sticks to the detectives' phony report, confirming the crime scene blood trail led outside. He continues to lie, albeit more reluctantly, when Perry questions him. Mason notes the unusual length of the supposed 40-foot blood trail and the lack of pictures chronicling its existence. Per Pete's urging, Perry's also armed with one half of George Gannon's denture plate. He keeps his word to Drake, however, and decides not to reveal the incriminating evidence.

Mason and Della pay Sister Alice's church a visit to snoop through their ledgers and inform them of the checks found at George's house. The duo says Gannon was likely stealing from the church, possibly looking to pay it back with the kidnapping ransom. They also question a suspicious signature, "J.H.," on the books used to record the finances of the church's many subsidiary businesses. While Perry distracts the defensive Elder, Della slips a ledger into her purse.

Meanwhile, at Drake's precinct, the patrolman's receiving a fat envelope of cash. Happy with how he performed in court, his corrupt commander is rewarding him. But Paul doesn't like feeling "owned," so he heads to Perry's house with the other half of Gannon's false teeth. He pours his soul out to Mason over the fear he feels every day, then slips the dentures into Barnes' evidence dump. Mason's onboard with the ruse.

While Perry and Paul plot the introduction of this new evidence, Barnes coaches Ennis for his cross-examination. He grills him hard on the blood trail, being first on the scene of Charlie's murder, and — to Ennis' surprise — paying off the watch commander to get assigned the case. Ennis gets defensive, while Holcomb gets mad: "Maybe that's something you should have shared with your partner. Mason's gonna rip you a new a–hole up there!"

Back at Birdy and Alice's place, the mother and daughter are having a disagreement. Alice has secured Emily's permission to exhume Charlie's body for his resurrection, while Birdy has secured six suitcases — presumably filled with more cash than clothes — to make their inevitable escape. She wants to run, but the Sister plans on sticking around and accepting whatever "ruin" might come in the wake of Easter Sunday.

With Perry busy practicing law, Pete and Della have picked up his P.I. duties. The former's in Denver digging up the kidnappers' past relationship with Ennis, while the latter's at the department of city records requesting the church's "articles of incorporation." As she pores over the documents, she discovers a real estate acquisition prepared by "Jim Hicks" (a.k.a. J.H.) Interestingly enough, Herman Baggerly is also listed as "Chair" for the business. Strickland's making

progress too, finding a cranky old man who bears a scar from a scuffle with one of Charlie's kidnappers.

Out of the morgue and on the stand, coroner Virgil's a bit out of his comfort zone. When questioned by Barnes, he confirms the facts of Charlie's autopsy. This is just a formality, however, as the D.A.'s using his testimony as an excuse to disgust the jury with morbid photos of Charlie's corpse. Perry tries to counter this by introducing the dentures, but Barnes quickly calls a sidebar. The lawyers end up in the judge's chambers, where it's decided the new evidence is inadmissible. George Gannon's second autopsy is also tossed out. Perry cries corruption, to which the judge threatens him with disbarment and, perhaps worse, "Wiping his hind parts with his investigator's license."

Fearing the fallout of his actions, Paul Drake sends his wife out of town. He puts her in a taxi destined for her aunt's house, where she'll be safe while he makes things right. Meanwhile, Mason's sweating the loss of his ace-in-the-hole evidence during a court recess. Thankfully, Della pays him a visit and perks him up big time with the juicy details of what she found at the city records office.

Back in the courtroom, prison matron Barbara is committing perjury, claiming she heard Emily confess to suffocating her son and stitching his eyes open. Barnes enthusiastically dives in and argues Emily is not only a co-conspirator but the murderer. The room erupts in chaos, order is called, and throngs of hungry press follow Emily and Della to their waiting car. Street tries to cheer Emily up, but the accused isn't worried in the least. She's convinced the D.A. will drop all charges once Sister Alice resurrects her son.

We next meet Ennis' lovely wife, who tells the visiting Detective Holcomb his partner can be found in the garage tinkering with his beloved automobile. But this is no social call. Holcomb demands the truth from Ennis, who offers a vague confession: "I got hired to do a thing. That thing went a little off." Holcomb isn't happy. He shows this by taking a hammer to Ennis' car. He feels betrayed by his corrupt partner but also wants this whole thing squashed. If there's anyone left alive who can finger Ennis, Holcomb wants that rectified.

Back in Denver, Pete's continuing to score the goods. Upon finding the old man who had a run-in with one of the kidnappers, he digs into the city's accounting records. He's looking for the person who would've been responsible for paying this thug, as well as Ennis — in his Pinkerton days — for whatever shady jobs they were doing. With plenty of help from a foulmouthed bookkeeper, he discovers the man with the checkbook is none other than Elder Seidel.

Armed with Della's discovery of the church's dirty real estate deal, Perry gets back to his investigating roots. He hits the road — berating himself in a mock E.B. Jonathan voice while driving — to seek out the mysterious J.H. When he arrives at the address printed on the deed, he knocks on the door and states he's looking for Jim Hicks. Out comes a man in overalls, shotgun at his side: "You that Dodson girl's lawyer? I've been waiting for you to find me."

tive. The trial is chaotically interrupted; Pete loses Seidel. Mason's farm is auctioned; Ennis runs amok. Easter arrives; Alice and Birdy

come to a crossroads.

In a stretching field along an abandoned road, a young girl picks flowers. It's a flashback: the child is Alice, who's busying herself while her frustrated mother tries to fix their broken-down automobile.



Birdy's relieved when a stranger in a bowler hat arrives and offers a gallon of gas. It's the "Christian thing to do," he says with a smile. But Birdy and Alice, having come all the way from Saskatoon, Canada, are also out of money and food. A tank of gas isn't going to cut it. The stranger offers additional help in exchange for some time with Alice. Birdy complies: "The Lord has sent this good man to rescue us. Go and thank him," she directs her daughter.

Present-day Alice drifts from this dark,

disturbing memory at the dinner table, where Birdy is saying grace. While Emily Dodson patiently waits to dig in, her hosts engage in an awkward exchange.

Birdy: "Something on your mind, daughter?"

Alice: "Wondering what the Lord has in store."

Birdy: "Well, we'll know soon enough, won't we?"

Indeed, we'll all know soon enough. By episode's end, in fact. But there's plenty of ground to cover before Easter Sunday.

Perry's walking through the woods with the mysterious Jim Hicks, introduced last week as someone with a suspicious connection to the Radiant Assembly of God's finances. Before literally digging up answers beneath a scarecrow, Hicks tells Mason the land — purchased for cheap by Elder Seidel and Herman Baggerly — was intended to be the "village for the Olympics." Using a shell company and George Gannon's shady accounting skills, they'd planned on making a killing.

Meanwhile, Paul Drake's doing some digging of his own. At a social club, he meets with his precinct's secretary. She's got a soft spot and wandering eye for the patrolman, so she's agreed to bring him a gift. Drake's apparently been playing hooky, suffering from a "stomach bug," so he's recruited his flirtatious friend to fetch the Dodson case police report.

The next day, on Good Friday, Sister Alice is saving souls from the comfort of her radio studio. As performers reenact Christ's crucifixion for listeners, former church Elder Brown storms in with his anti-Alice supporters. He's also brought the man the preacher "healed" last week. It seems the miracle didn't stick, and the man wants answers. Alice tells him — as well as anyone else tuned in to the "Radiant Hour of Power" — that he lacked faith.

Back in the courtroom, Perry has Hicks on the stand. Despite the smelly garbage drying on his suit — courtesy of an unhappy protester outside — the fledgling attorney is killing it. His witness spills the beans, telling the court the church was essentially stealing from itself, writing checks to a fake company so it could claim it as an asset.

Sensing the jury's confusion and boredom (not to mention us viewers at home starting to scratch our heads), Mason has Hicks break everything down in simple terms. During Hick's time as the church's accountant, the parish extended itself too quickly. They invested in the radio station, wrongly assuming that putting Alice on the airwaves would bring in the big dollars. Saddled with insurmountable debt, Elder Seidel pressured Hicks to cook the books. When he refused, George Gannon was given the task of finessing the church's crooked finances. Seidel came up with the schemes, Gannon kept the ledgers clean. Seidel also bought Hick's silence by gifting him a parcel of land from the doomed real estate investment.

Stunned, but not yet down for the count, D.A. Barnes begins to argue the lack of proof supporting these damning allegations of financial misconduct. But then comes Mason's massive mic drop: He presents piles of ledgers — we now know what was dug up beneath that scarecrow — that Hicks kept over the years to cover his own ass.

During a court recess, Perry gets more good news. Pete's back from Denver, where he's connected one of the kidnappers to Detective Ennis and Elder Seidel. The former two worked as heavies for Colorado Fuel and Iron, where the latter served as chief financial officer. Determined to get Seidel singing like a canary on the stand, Perry sends Pete to put a tail on him.

The hits just keep coming when court resumes. Herman Baggerly is now on the stand, reluctantly admitting he was the Radiant Assembly of God's go-to financial lifeline when its debt got too deep. But Matthew Dodson's wealthy daddy turned off the spigot after the Olympic village

deal went south. Three weeks after Baggerly stopped bailing out the Elders, his grandson was kidnapped to the tune of a \$100,000 ransom — the same amount the church owed its lenders. With a very satisfied smile stretched across his face, Perry takes a seat. But his thunder is stolen by Elder Brown's brigade, who storm the court with a smoke bomb.

With the trial cut short for the day, Perry and Della track down Emily in the hall. They tell her the church doesn't have her best interest at heart and suggest she avoid the cemetery on Easter Sunday. But Mrs. Dodson's already inebriated on Sister Alice's Kool-Aid, believing everyone will be begging for her forgiveness once Charlie rises from the grave.

Meanwhile, Pete's keeping a close eye on Seidel, who, coincidentally, is in the process of being denied a bank loan for the church. Once outside, the Elder spots his tail and attempts to evade Strickland by blending in with a crowd of protesters. To Pete and Perry's dismay, Seidel disappears. This leads to a friendship-killing fallout between the two. Pete even suggests that Perry hire Paul Drake for future sleuthing jobs (a callback to the character's role in the original Perry Mason, and possibly a nod to his future on HBO's version.)

Perry sees another close relationship fractured this episode, as his girlfriend informs him she's purchased his house. She has half-jokingly threatened this throughout the season, but an auction triggered by Mason's unpaid property taxes presented an opportunity too good for the pilot to pass up. She plans to build an airstrip where Perry's childhood home sits, but promises not to disturb his parents' graves. "Isn't that f—king generous," replies Perry before leaving.

Della's also at a social engagement, albeit a far less contentious one. Enjoying cigs and spirits with Deputy D.A. Hamilton Burger — who we learn has a thing for young waiters — she asks if he can stop the planned resurrection with a court order. We also discover the pair are good friends, comfortably exchanging playful banter as easily as talking business.

Having scored the doctored police report from his coworker, Paul Drake's on the case. He's scouting a motel where the kidnappers stayed, possibly with baby Dodson. After striking out with the manager, a motel maid secretly offers Drake the goods. Not only were the suspects there with a baby, but another man and his "Chinese wife" were called in for assistance when the little one wouldn't stop crying. Paul delivers the intel to Perry, and the two conclude Ennis — and an acquaintance from his favorite Asian whorehouse — were actually the "married" couple in question.

Speaking of the scumbag detective, we finally catch up with Ennis at the episode's 40-minute mark. He's meeting Seidel on a remote road, helping the corrupt church Elder flee town and avoid court. Upon admitting he'd fold under pressure if Mason forced him to take the stand, Seidel ponders his crimes: "What we did to that baby..." Ennis cuts him short, "Yeah, no one wanted that. We were just trying to help." But it's all lip service, as Ennis just wants to send him on a bus to San Diego. At least that's what he tells him. In reality, he wants to eliminate this loose end. He stabs the Elder dozens of times, then makes it look like a robbery-gone-wrong.

Perry and Paul pay a visit to the whorehouse. Due to his race, Drake is turned away. Mason makes it in and is immediately instructed to pick his pleasure from a book of cartoon porn. Embarrassed, he mumbles something about "milkmaids" and points to an illustration of a woman squirting breast milk onto a man wearing a diaper. Once alone with the sex worker, he begins questioning her. There's a language barrier, but he learns it was another woman, who's now dead, that was taken to the motel by Ennis. Upon receiving this lead, Perry's dragged outside by security, where he gets what's gotta be, like, this poor guy's third beating this season. Drake comes to his rescue, however, in a satisfying scene that makes a strong case for the two starring in a buddy-cop spin-off.

Beaten but undeterred, Perry pays his friendly neighborhood coroner a visit. Virgil reluctantly shows him the body of an Asian "Jane Doe" he believes was a prostitute. Based on the tracks of needle punctures in her arm, he also surmises she's a heroin addict. Mason asks what the effect would be on an infant nursing from a "junked-up mother." The coroner somberly replies, "He'd suffocate."

As "Chapter 7" heads into the home stretch, we're finally invited to Sister Alice's Easter Sunday festivities. With what looks like the entire city of Los Angeles in attendance, Alice, Birdy, and Emily arrive at the cemetery to bring baby Dodson back from the dead. Perry begs his client to leave and asks the Sister to abandon the service. Neither of them listens.

With one hand on Charlie's exhumed casket and the other raised to the heavens, Alice begins. But the coffin is empty. Absolute mayhem ensues. Fistfights erupt, flashbulbs go off, Perry gets gut-punched — again — and Emily drags herself toward her dead son's vacant grave. "I don't care anymore. I just want to be in there," she cries. Birdy's posse scoops up Alice, while Perry picks up Emily and escapes with Della, just as someone cracks the windshield of their car.

But the chaos is just beginning, at least for Sister Alice. Birdy instructs their driver to take a detour, abandoning the motorcade aiding their escape. Their car stops before a crowd of people in the street. Birdy exists the vehicle, wades into the gathering, and emerges cradling a bundled baby. "Charlie Dodson lives!" she screams to stunned onlookers. As a shell-shocked Alice approaches, her mother says, "You did this. This is your miracle." But Alice clearly isn't down with whatever Birdy is cooking up.

Sensing her daughter is not onboard, Birdy leans in and whispers, "There's too much at stake. There's nothing else out there. It's just you and me, Alice." The Sister looks at her mother with a dead, ghost-like stare — not unlike the one she shot the pedophile at the episode's start — before breaking into a sprint. While Birdy instructs the press to report on the "miracle baby," Alice continues to run full speed from the scene.

The episode ends with a close-up shot of her running — mouth agape, blood streaking down her face — as if her life depends on it.

Meanwhile, Emily's in Della's bedroom nursing the shiner she got for her troubles at the cemetery. No longer consumed or distracted by the possibility of Charlie rising from the grave, she seems more focused and level-headed. She's made peace with the fact she'll likely be found guilty. The mourning mother just misses her baby and wants to know where his body has disappeared

Her trial is also hurtling toward its conclusion...or so it seems. Ennis is on the stand, getting grilled by Perry. We see flashbacks of all the dirty detective's misdeeds, from grabbing Charlie's ransom money to staging Gannon's suicide. But it's all a fake-out. We're only seeing what could

happen in the courtroom, as Perry and his team are actually rehearsing the cross-examination in his living room. Paul Drake's role-playing as Ennis, but Hamilton Burger is insisting Mason will never get a confession out of the crooked cop.



The savvy deputy D.A. suggests that Perry not call Ennis to the stand at all, but rather rest the case on the proof that the church's debt equaled the requested ransom. This safe strategy wouldn't put Ennis behind bars, but it would raise enough reasonable doubt to free Emily. Della has a different idea. She wants Perry to put his client on the stand, arguing that Mrs. Dodson's in a better place, mentally. Mason tears into Street, attacking her personally and coming off like a real a-hole.

The next day, Perry meets up with Pete Strickland. He brings the foulmouthed P.I. up to speed on the case, detailing how Charlie overdosed on the prostitute's tainted breast milk. They also conclude that Elder Seidel is likely face down in a ditch somewhere. Mason informs Strickland that he's just about out of moves but has one play left that could save Emily. He offers his disgruntled former partner a sorta-apology, then asks him to carry out this mysterious job for him.

Flashing back to the day after Christmas, we're given a look at what happened the evening Charlie was kidnapped. Emily's holding her son, waiting for her husband to come to the dinner table. But Matthew Dodson's got business/gambling to attend to. He storms out behind a slammed door, while she smashes his dinner plate on the floor. She then gives Charlie a bath before reading him a bedtime story. As the baby drifts off, the phone rings.

It turns out Emily is recounting this story from the stand, telling Mason what unfolded that night. The call was from George Gannon, who phoned to distract her while the kidnappers abducted Charlie. She also paints an unflattering picture of Matthew, claiming he was an unkind, absentee husband and father. In her affair with George, she claims she found the love and affection that was missing from her marriage. She tells the jury she had nothing to do with the kidnapping or death of her son.

But that doesn't stop Barnes from trying to convince them otherwise. He digs into the defendant, discounting her sympathetic story as desperate lies. He focuses on her affair with Gannon, reminding the court the two had sex in a motel while her baby cried from an adjacent room. He ultimately gets her to admit Charlie would still be alive had she not gotten involved with George, who hatched the misbegotten kidnapping when he realized her father-in-law was Herman Baggerly.

On the courthouse steps, a well-dressed man cuts through the swarming press to slip Emily a note. Meanwhile, Mason's being taunted by Ennis for not catching baby Dodson's killer. Perry slugs the detective's very punchable face, leading Holcomb to come to his partner's rescue. The detective threatens Perry, then tells him he'll see him at Emily's hanging. Ennis flicks a lit cigarette at Perry for good measure.

Mason's evening doesn't get any better. While preparing his closing, his former girlfriend brings him a bottle of booze and \$7,000 to close the deal on his house. Perry threatens to slow the sale with litigation, then offers her a kind "f— off." At Della's place, Emily is enjoying dinner and opening the letter she received from the mysterious man outside the courthouse. Inside the envelope is a card with a baby's footprint stamped on it.

The next morning, Perry's delivering his impassioned closing argument. He puts himself in the jury's shoes, saying he wants justice — and vengeance — as much as they do. He's empathetic, stressing he'd be the first one to hang Emily if she were guilty. Ultimately, he stresses that her having an affair does not make her a murderer. Surprisingly, Barnes keeps his closing short and sweet, spinning the same old broken record about Emily's infidelity.

While waiting for the jury's decision, Della brings Perry a sandwich. He apologizes for being a jerk to her earlier. On top of making up, the two playfully discuss the possibility of working together after Emily's case concludes. The jury finishes for the night without reaching a verdict.

Paul Drake, on the other hand, is making some definitive moves. Specifically, he marches into his corrupt commander's office — after missing his last five shifts — and puts his badge, gun, and bribe money on his boss' desk. 'Nuff said.

After five days of deliberation, the jury comes to a decision. They're deadlocked. A mistrial is called.

As a satisfied smile stretches across Mason's mug, Barnes scowls. But the D.A. lets out more than a grimace outside, where a member of the press questions him about losing the trial. He gets in the man's face and says he intends to retry the case. He also claims the outcome won't affect his possible mayoral candidacy. Mason, meanwhile, plays faux disappointment for the press, preaching the unnecessary abuse his client was subjected to.

We next catch up with Strickland, who's finishing up that errand Perry sent him on. He's meeting with one of the jurors, delivering the second installment of an agreed-upon payoff. To Pete's surprise, though, it was all for naught, as two other members of the jury were also holding out.

That night, Perry and crew are celebrating their victory with cake at Della's place. But Pete passes on the sweets in favor of a serious sit-down with Mason. He informs Perry he's going to work for Hamilton Burger as the deputy D.A.'s lead investigator. His first case will involve the Radiant Assembly of God's shady finances. Perry is not pleased.

Emily ditches her own party to visit Birdy. Turns out the infant-footprint note is an invitation to meet the "miracle baby." Mrs. Dodson cradles the child while commenting that his size and eye color are different than her boy's. She knows it's not Charlie, but her maternal instincts still kick in. With tears in her eyes, she gives the baby her deceased son's plush turtle toy.

Emily may be free and moving on, but Perry Mason's not done with us yet. The episode's final 20 minutes offer a satisfying montage, tying up pretty much everything else. We see Strickland on the stand, testifying about the "crooks" at the Radiant Assembly of God. We also find Perry's former flame entering his house, discovering a note in the now-empty bottle she'd gifted him: "The price was fair. Look after the cows." Then we see Birdy — apparent leader of the new "Holy Church of the Reborn Babe" — preaching from a small, outdoor stage. Emily, wearing a snow-white dress and flowers in her hair, sits beside Birdy, cradling the baby. "I knew that he was my son, delivered from death," she says to the believers stuffing contributions into pails being passed around.

At E.B. Jonathan's old office, "Perry Mason" is being painted on the door. Inside, Della is negotiating with her boss. She agrees to continue handling secretarial duties until they get on their feet, but she wants to become a lawyer — with Perry footing the bill. She envisions "Mason and Associates" becoming "Mason and Street." While a client waits outside, Perry also receives intel from his new investigator, Paul Drake. It's an address for a diner in Carmel, Calif. When they finally invite the client in, she introduces herself as Eva Griffin. "I'm in trouble," she says. With a grin, Perry replies, "You've come to the right place."

We next see Detectives Holcomb and Ennis on the grounds of the Lucky Lagoon. They're bantering with the casino boss and collecting their take. As Holcomb divvies up the cash, he tells his partner that his family will be taken care of if anything ever happens to him. Then a man forcefully pulls a sack over Ennis' head and drags him into a fountain. It ultimately takes three men to drown him. Holcomb takes Ennis' badge and cash off his dead body, then offers him an apology, "Sorry, Joe."

Finally, we catch up with Mason, who's made his way to that diner in Carmel. While he sits at the counter, a waitress with short, dark hair comes in to begin her shift. It's Alice. The two lock eyes before heading outside. He hands her a pamphlet for her mom's new church, which is apparently gaining quite the following down south. But he's really there to satisfy his own nagging curiosities. He wants to know what happened to baby Dodson's body, and if Alice truly believed she could bring him back. She offers no straight answers.

Instead, she speaks of how they're both lonely and destined to remain that way. It's an almost-but-not-quite romantic exchange, concluding with Alice giving him a tender kiss on the cheek. They bid each other farewell with half-smiles.

Now all alone, staring at the stretching, blue sea before him, Perry reaches into his coat pocket. He pulls out the matchbox box containing the thread used to stitch Charlie's eyes open. He pinches the thread between his fingers, gives it one last look, then blows it into the ocean.

So, instead, she decided to do the job. She entered the house and found a woman seated on the sofa with a needle stuck into her arm. She was intoxicated and mistook Clara for someone else. As the woman tried to stand up on her feet, she collapsed on the sofa and had a seizure. Clara immediately hid as she noticed a man enter the house. The distraught husband held his wife in his arms while Clara sneaked out with a letter addressed to them. The man in question was Camilla Nygaard's lawyer, Melville "Phippsy" Phipps. Therefore, Phippsy was the man who contacted Ozzie Jackson and hired the Gallardo brothers to murder Brooks McCutcheon.

Della realized that the stakes were higher than she had anticipated after her brief yet significant conversation with Hamilton Burger. After his first big win as a defense attorney in the Emily Dodson case, Perry Mason strictly stuck to civil disputes. Even though he had won the case, the thought that he could not save Emily troubled him. While civil dispute cases were simpler and more profitable, he missed having a sense of purpose. When the Gallardo brothers were charged with the murder of Brooks McCutcheon, their family reached out to Perry for help. Hesitant at first, Perry agreed to take the case once he was convinced that the brothers

were innocent. To prove the Gallardo brothers innocent, it was important to blame the murder on someone else. They suspected Brooks' father, Lydell, of getting his son killed to protect the reputation of his company. Brooks never paid attention to his father's advice, and most of his business ideas remained unsuccessful. Perry and his team also realized that Brooks was not the respectable businessman that the prosecutor tried to establish. He abused women behind closed doors, and one of his victims was his ex-secretary, Noreen. Noreen was admitted to San Haven

after he nearly strangled her to death. Brooks paid her brother to maintain silence and moved on to his next victim. With the help of the San Haven file that Holcomb brought in, Mason and his team discussed Brooks' atrocious practices in court. With Councilman Taylor admitting to his sister's suffering at the hands of Brooks and Della Street's remarkable demonstration, Mason and his team raised reasonable doubt.

The most important revelation in "Perry Mason" Season 2 was that the Gallardo brothers were responsible for Brooks' murder. Mateo and Rafael lost their sister and their home to the Mc-Cutcheons. Therefore, they did not think twice when they were paid to kill Brooks McCutcheon. The local street thug, Ozzie Johnson, had contacted the brothers, and after a grueling interrogation, he revealed that he was paid by the husband of a regular junkie to get the job done. After staking out the corner street for days, Paul noticed the blue car that Ozzie had mentioned. Clara was with him, and she volunteered to find out the identity of the blue car owner. While the woman, Constance, overdosed, Clara stole a few letters addressed to them. It was Melville "Phippsy" Phipps who had asked Ozzie to appoint the Gallardo brothers to murder Brooks Mc-Cutcheon. Since Phippsy had no reason to act alone, it was obvious that he simply carried out what Camilla Nygaard had asked of him. Camilla Nygaard, the oil empress, was troubled by the attention Brooks was bringing to their illegal business. The Feds were after Brooks for selling fruits and vegetables on the black market, but they had yet to find out the larger conspiracy behind it. The produce was used as a cover to transport oil to Japan for military purposes, As a result of Japan's invasion of China, there was a ban on trade and commercial activities, so Lydell and Camilla found an illegal way to continue their business. She murdered Brooks to protect her interests, and she was not guilty about it.

The situation completely changed after the prosecutor found the murder weapon kept in Perry's office safe. Mason wanted to protect the brothers and brought the gun from their home in Hooverville to his office. Judge Durkin sentenced Mason to four months in prison, and in a way, Mason was glad that the judge did not declare it a mistrial. The trial came to a conclusion, with the DA's office and the defense counsel coming to an agreement. Perry used the heap of evidence that Phippsy handed over to him and his team after he was blackmailed by them to cut down the sentence for the brothers. Hamilton Burger agreed to allow one of the brothers to go free while the other had to admit to the murder and was to be sentenced to 30 years without parole. Mateo confessed to murdering Brooks McCutcheon in court, but before being sent off to prison, he discussed how his social and financial conditions had affected his judgment. Rafael returned home and continued to pursue his interest in art. Just like in most cases, the one with the least power was punished. Of course, Mateo was responsible for the murder, but there was a larger conspiracy behind it that involved going against the interests of the nation.

While Camilla Nygaard was not proven guilty in court for the murder of Brooks McCutcheon, the evidence that Phippsy stole from her safe caught the attention of the Feds. Hamilton Burger was initially reluctant to take a step against his blackmailer, fearing the worst. But with the negative copy of the photographs in his hand, he felt confident enough to see Camilla Nygaard's fall. Della struggled to cope with Camilla's betrayal the most. She looked up to her and often sought advice from her during times of crisis. While going through the photographs Camilla kept in her safe, Della realized that Camilla had her men follow her as well. Camilla knew about her affair with Anita, and she later would have used it to her advantage whenever she saw fit. Della felt nothing but disgust for Camilla, and she confronted her one last time. Camilla could sense Della's lack of respect for her when she ignored her orders. Camilla justified Brooks' murder by blaming him for being a spoiled brat who deserved nothing better. She compared her situation with Della's, admitting that one has to do certain things to protect themselves. Camilla will never forgive Perry and Della for ruining her life.

Members from the Bureau of Investigation came to her house to interrogate her about her involvement in the illegal oil trade, and even though she knew she was in deep trouble, she, in her typical calm voice, tried to convince herself that she was in control of the situation. Lydell fled the country as soon as he realized that Perry and his team had found out the truth. The FBI was hunting for him, and his close associate Walter Crippen asked him to remain in Japan.

The episode ends with Perry preparing to leave for prison. He did what he had to to protect his client, and he did not regret it. Della and Perry celebrated their little win (they saved the brothers from the noose) the night before Perry went to prison. To find justice, they had to take illegal measures, and Della wondered if that could ever truly be defined as real justice. Such questions

had often troubled Perry, and after dealing with the Gallardo brothers' case, he realized that the little right that they could do amidst all the wrong was worth fighting for. This, in a way, indicates that maybe there will be a season 3 of "Perry Mason," and Della will continue to be an integral member of Mason and Associates. Before going to prison, Perry met Ginny Aimes. He admitted his mistake and hoped for a second chance. It seems Perry and Ginny will take a romantic trip to Yosemite in the autumn after his release. Perry kept the picture that the blackmailer had taken of him and his son. He barely had time for his boy, and even though the picture was taken for all the wrong reasons, it was the only happy moment that Perry wanted to look back at over and over again. He is aware that such moments are rare, and his lifestyle and profession would distance him further from his son.

Della and Anita are still going strong, but they cannot come out in public. The reporters assumed that Della and Hamilton were in love, and they continued to pretend to make it all the more believable. They have realized that their careers can be jeopardized if the truth ever surfaces, and after the blackmailing, it only makes sense that they are being extra careful. Meanwhile, Paul decides to quit working for Mason. He instead accepted Melvin Perkins' offer to work for the community by gathering information against the councilmen who objected to giving out permits for community projects. Pete, too, decided to stop working for the DA's office. After nearly marring his friendship with Perry, he decided it was not worth his while, and before leaving, he urinated in Tom Milligan's expensive bottle of cognac for one last laugh.
