Summary: Attorney Keegan Deane gets a new client as payment of a poker debt.

The client seems like a simple guilty plea but turns out to possibly be the case of a lifetime. Meanwhile, Deane is constantly on the move, avoiding debt collectors while trying to collect his fees from deadbeat

clients.



The episode opens in a bar, Keegan Joye is watching a game on the TV with a group of people, and cheering. The team scores so Keegan orders a round of drinks. His friend Roy walks him to the bathroom. Once they are inside, Roy slams into the wall, and says "Victor needs his money." Keegan promises him he will pay him \$15,000.00 tomorrow. Roy leaves the bathroom and Keegan stumbles out. He picks up a random girl from the bar, and takes her with him to a party. Keegan and his new girlfriend head to the backroom so he can play poker until the sun comes up. Keegan

wins \$5300.00, but the lawyer Jerry doesn't have the money to him what he won. Jerry hands over the business cards of one of his clients as payment.

Keegan wakes up in a kitchen, surrounded by his brother's kids. His brother tells him that he "needs to find somewhere else to crash." His brother Ben reminds him that he was only supposed to be there for one or two weeks, and it has been four months. While Keegan and Ben argue about his living arrangements, the girl he brought home stumbles out to the kitchen. Ben kicks her

out and makes her climb the fence in the back-yard. Scarlett, Ben's wife, emerges and lectures Keegan and Ben about the random women in her son's bed.

Keegan receives a phone call from Matty, and promises to help him get his driver's liscense this weekend. He walks outside to get the newspaper and realizes that his car has been towed because he parked in a no-parking zone.

Scarlett agrees to let him drive their SUV as long as he drops their daughter and all of her friends off at school. He has to promise to drive safely though. En route to school with a car full of kids he gets pulled over by the cops for a busted tail-light. Keegan tries to explain to the cops that it isn't his car, but the cop ID's him and realizes his license is expired. Keegan has to hand the keys over to the cops, and he has to call Scarlett and have her come pick up all of the kids.

Keegan finally arrives at his office, and realizes that the client that was supposed to pay him \$15,000.00 has paid him \$15,000.00 worth of fish. His secretary has made a deal with a restaurant to buy the fish for \$25,000.00, but Keegan can't deliver it to the restaurant because his car got towed. He manages to convince his secretary to deliver the fish to the restaurant.

Keegan heads to court with his client. Once they get in the court-room Keegan learns that the prosecutor is running late and court is delayed. The prosecutor finally arrives, it's Ben's wife Scarlett, she was running late because she has to go pick up all of the kids that Keegan left on the side of the road.

Keegan's client has already confessed to murder, but now he is pleading "not guilty." Keegan heads to the judge's chambers with Scarlett and the judge and begs to be taken off the case. It was supposed to be in and out, but now that the client is pleading guilty the case could be dragged out for four or five months. The client is in jail and he has no way of even paying Keegan, which means he will have to work for half a year for free. This is the client that his poker buddy Jerry gave him as payment for his poker debt.

Keegan takes his client aside and tries to convince him to plead "guilty." Keegans client insists that the police forced him to confess, they gave the confessions and told him to copy them.

Keegan heads his friend Nikki's house. But, Nikki isn't exactly thrilled to see him. Keegan reminds her that as a prostitute she is supposed to make him feel good, not yell at him for being late. Nikki finally caves and hooks up with Keegan... for \$500.00 an hour.

Keegan leaves Nikki's house and receives a phone call from Roy, he wants to know where their money is. Keegan and his secretary are trying to sell his fish to a Japanese restaurant. The Japanese chefs tell him on a scale of 1-10, his fish is only a 1. They will only pay \$10,000.00 for the fish. Keegan refuses to make the sale. He wants the \$25,000.00 that they promised him on the phone.

Keegan heads back to his office and sits down with his secretary Leann and tries to make sense of his serial killer case. Keegan is starting to believe that his client is really innocent. He thinks he was forced to confess by the Chief of Police just to clean up a bunch of unsolved murder cases.

Keegan heads back to court and questions the Chief Of Police about writing out his client Jack's confessions. Chief Michaels wrote a book about nailing all of the murders to Keegan's client. Keegan declares, "he will not rest until the LA police is held accountable for any wrong-doings against his client." When he is done proving his client innocent, he plans to sue the police department in civil court for hundreds of thousands of dollars.

Chief Michaels gets lectured by the mayor after court. The mayor and Chief Michaels want Scarlett to tell Keegan to "back off." Scarlett reminds them he is just doing his job.

Keegan heads to therapy after court, and his therapist reminds him that he is self-centered and only worrying about himself and not his client. His therapist confesses to him that she had a dream about Keegan last night. It turns out his therapist is actually his ex-wife, their son Matty interrupts and makes fun of Keegan for his "free therapy sessions."

Keegan takes his son Matty out on a driving lesson. Matty tells his Dad to cover for him and tell his mother he slept at his house last week. Keegan receives a phone call from Roy, he wants to know where his money is. Matty freaks out because he doesn't know how to merge and comes to a complete stop on the freeway. Keegan hangs up on Roy, just as they are rear-ended by another car. Their car gets towed, and Keegan has to catch a ride back to town with the two-truck driver.

Keegan heads back to the court-house for an interview with "On The Record." After his interview, his client Jack in questioned. Jack freaks out on the news anchor, and basically states he manipulated the Chief of Police. Keegan yanks him off the air.

Keegan and his secretary Leann head back to the office. Their fish isn't looking so good, his "eyes are turning milky." Roy is still calling for his money, which Keegan doesn't have.

Keegan visits Jack in jail and shows him he has proof that Chief Michaels wrote his confessions.

The mayor gives a press conference stating that Chief Michaels has been let go, and he personally thanks Keegan for his discovery.

After the press conference the mayor pays Keegan a visit. He tells Keegan that he has made his life "extremely difficult" and tells him to expect revenge.



Summary: Keegan's new clients are three reformed Amish men who own a bakery.

They are accused of attempted murder but in actuality, they forcibly shaved the beard from an elder who wanted to retrieve a woman who the elder thought was being forced to remain in Los Angeles. Ben and Scarlet hold a recommitment ceremony while Keegan meets a new girl

that seems to be the perfect woman.



Tonight's episode of Rake opens with an Amish man knocking on the door of a house, three men open in the door. A young girl named Mary appears, and then the three men attack the stranger on their doorstep.

The next morning Keegan and his friend/roommate Ben are trying to make coffee. Keegan is stressed out by all of the planning Ben and his wife Scarlett are doing for their recommitment ceremony. Scarlett, Ben's wife emerges, and says Keegan is just jealous of their relationship because he can't commit to anyone.

Keegan heads to his office with his

secretary and learns that his new Amish clients have posted bail for their attempted murder charge. Keegan goes to court, and gets "randomly selected for a full body search" by the security officers.

Keegan finally gets in to see the judge, and manages to get his case continued by showing the judge documents in Bulgarian.

After court, Keegan visits his Amish clients. Jebediah, one of his clients, owns a bakery. Jebediah is accused of trying to murder his Bishop with a razor blade. Jebediah denies trying to kill the Bishop though, according to him he was "just trying to shave him."

Keegan uses the app Luann downloaded on his phone called "Joyride." Every time he needs a ripe he just has to open the "Joyride" app and tell them where he is, and a random person picks him up. The woman that picks Keegan up recognizes him from television, and realizes he is a lawyer. She needs legal advice, and wants to know what determines "fair market value." Then she begins hitting on her, so Keegan shares his bread with her from Jebediah's bakery. He wants to see Brooke, his joyrider again soon, so she tells him to add her as his "preferred joyride driver" on the app.

Keegan meets up with Ed, the lawyer representing the Bishop that Jebediah shaved. Ed reminds Janet, the prosecutor, that the Bishop's beard is a symbol of his faith and by shaving it off Jebediah committed a hate crime. Jebediah is facing u to 15 years in prison for shaving the Bishop.

Keegan heads to court and begins questioning Bishop Goode. Bishop Goode reveals that he went to Jebediah's house to "fetchy Mary." Mary ran away from his Amish town of Paradise, and he was instructed to bring her home.

After court Brooke picks up Keegan, and they listen to a hockey game. Brooke reveals that she likes to gamble, because she studies statistics. They pull over to make out, and Keegan invites Brooke to Ben and Scarlett's recommitment ceremony.

Keegan stops by his prostitute Nikki's house, but she smells Brooke's perfume on him. Keegan reminds her that he pays her to sleep with him, so she shouldn't really be jealous of him. Nikki denies she is jealous, she just doesn't want her other clients to smell the "cheap perfume" on her.

The next day Keegan heads back to court with Jebediah. Jebediah claims that the reason the Bishop wanted Mary to go home is because they are a radical Amish group, and before there were just men in the group. But, now that Mary is with them, there is a chance they will start reproducing and the number of people in their radical group is growing.

After court Roy calls Keegan and reminds him that he now owes his boss \$63,000.00. Scarlett stops Keegan after court and tells him that his restraining order against his stalker Margurite has expired. Scarlett agrees to apply for an extension on the restraining order though.

Keegan tries to discuss the case with Mary, but she isn't cooperating. Keegan reminds her that if she doesn't help him and give her information on the Bishop, Jebediah will go to prison. Keegan heads back to court fueled with the information from Mary. Keegan proves to the court that Bishop is a fraud, and has shaved several Amish men. Jebediah and his brothers are found not guilty of attempted murder, but they do have to go to jail for six months.

After court Keegan and his Joyrider Brooke make their way to Scarlett and Ben's recommitment ceremony. Ben and his mother are both impressed with Keegan's new girlfriend. The mayor's wife happens to be at the ceremony, Keegan tries to charm her into "telling her husband to lay off," but she doesn't want to hear it.

Scarlett rushes Keegan outside, and tells him that he is right. She wants to cancel the recommitment ceremony because she thinks it is "phony and self-serving." Keegan tried to guilt her into going through with the ceremony. She brings up the affair she had with Keegan ten years ago before she married Ben. She confesses that she is afraid of commitment. Keegan convinces her to go through with the ceremony, and she heads back down the aisle. Ben is waiting for her at the altar.

When Scarlett is halfway down the aisle, there is a commotion. Ben's father has collapsed. Brooke confesses that she was having sex with Ben's Dad in the bedroom when he collapsed. Keegan is furious, he curses Brooke out and then heads off to the hospital with Scarlett and Ben.

At the hospital Keegan and Ben discuss his Dad's health problems. He is going to be in critical condition for a few days. Keegan breaks the news that "him and Brooke aren't going to work out." Ben assumes Keegan screwed it up, little does he know Brooke was screwing his Dad.

Summary: Keegan's new client is a mother who faked her son's cancer diagno-

sis and defrauded the insurance company. Keegan also causes skate-

boarder Tony Hawk to bail on Finn's school charity auction.



We open with Kee in a poker game with skateboard legend Tony Hawk. Kee teases Tony about his "tell," but goes too far when he says it's girly and on top of that, wins the hand. "The Hawkman goes down," Keegan gloats, "Faster than a 1080 on a mega-ramp!" Tony gets pissed and now he refuses to show up at a fundraising event at Finn's school. Kee worries not a bit about disappointing his son, confident Hawk will get over it. Two goons show up and haul Kee off and it has nothing to do with Victor this time. Kee owes \$11,000 to a Chinese lady named Debbie Lee. He lays his homeless-

ness problem on her and she wants him to rent an apartment from her aunt. She wants his watch too.

A lady named Carol Grady takes her kids to school. One of them is in a wheelchair and has a bald head. As the older boy wheels his brother away, other mothers offer Carol sympathy and she offers them baked goodies. The police show up and haul Carol away for fraud in handcuffs.

Kee gets the case (how does Keegan get these cases?) and just as he's thinking there will be some sweet publicity, Leanne informs him his client is guilty. She's seen the tests and little Bobby is perfectly healthy. Mom worked for an oncologist and faked the tests. She's been pocketing the insurance checks and even stole from the police toy drive. No possibility of a mistake. The child hasn't even had chemotherapy and Carol shaved his head herself. Kee confronts his client with these facts but she pretends to be hurt by the accusations.

Just like in the last episode, A Close Shave, Kee pays a visit to one person who really cares if Carol goes to jail. Carol's oldest son, Greg, continues to play his role until Kee gets through to him that his mother will be in the slammer a long long time unless that money turns back up. Greg confesses that Mom spent it all, \$318,000, and he tells Kee where.

Even though he's been in trouble at the casino in Greg's info, Kee heads over there "on business." He is warned that any gambling is cash only. Spying an old lady walking away from a slot machine, he goes over and drops a coin in. The next spin is a jackpot of over \$15K. (That would never really happen on one coin, would it?) Collecting his winnings, Kee shows Carol Grady's picture to the casino cashier and gets the lowdown on the extent of her gambling addiction. It ain't good news. He also calls Debbie and says he has her money.

At Carol Grady's trial, between the clean medical tests and the casino cashier, the prosecutor easily proves Carol knew what she was doing. Leanne says it wouldn't be that bad if the money went to mortgage payments or the water bill, but gambling? Leanne arms her boss with "everything social media has to offer" on the jurors so Kee goes to work on their addictions. He persuades them that Carol was helpless in the face of her addiction and the pressure placed upon her by the casino, who thinks of her as a "whale." gambling jargon for the big losers. They supply with her a town car and other free perks, all designed to "keep her close" and exploit her gambling addiction. "Could you stick to your diet if a doughnut truck showed up at your house?" he asks

Keegan pays a visit to Mikki where their session is interrupted by her pimp, Jules, another creditor who can provide a beatdown unless he gets paid for 10 sessions. Each session with Mikki is \$500 so there goes \$5,000, but he still has enough to pay Debbie.

Throughout the episode, Keegan keeps trying to get Tony Hawk back on board for the school auction. Besides not disappointing Finn, he also wants to impress Stacy Mullen, Finn's very attractive English teacher. Tony Hawk won't takes his calls and, through his manager, offers Ian Ziering or Heather from Celebrity Diving in Tony's place.

At the fundraiser, Keegan covers Tony Hawk's absence. There's the pressures of being a celebrity skateboard person. Tony Hawk needs their prayers. Kee's ex-wife Maddie is there with her boyfriend, Bruce. Kee gets Bruce into a "pissing contest" on an auction and ends up owing \$12,000 for what he thought was going to be a week-long trip to Kauai. It's a bench decorated by third graders with paper cutouts. There goes Debbie's money and Kee again finds himself at the mercy of her ugly goons, er... cousins. He is forced to rent the Echo Park apartment but on the plus side, Debbie's aunt thinks he's hot, there's a Chinese restaurant downstairs and he's got a nice bench.

Kee gives Finn a set of keys to "the man cave." The episodes ends with one last encounter with Tony Hawk in the casino. Tony has banned Kee and his whole family from his skate parks and his roller coaster. Keegan says "I can be a poor sport, too. Let's play."

Summary: Keegan's next client is a brilliant financial planner for the city who

is accused of murder, then eating his victim. While that is going on, Keegan continues to defend himself against the IRS while his call-girl

girlfriend disappears from his life.



The episode opens with Kee at Mikki's place. What initially sounds like dirty talk turns out to be a highly unusual request to make of a prostitute, even if you consider it a close relationship. Kee wants her to pull out his aching molar with a huge pair of pliers. She tries but somehow manages to knock it back in place instead. More on Mikki later.

Then Kee heads over to the funeral service for Ben's father, betting on sports games on the way. While Ben struggles to eulogize his father, Kee is listening to the game live but somehow manages to lose control of his earphones. Everyone can hear the game. One guy even cheers. After the service, while friends and family

gather, Kee helps Ben get over his guilt. Ben's dad bullied him and made him feel like less than a man. Probably a worse sin, Ben's dad liked Kee and thought Kee had balls. Kee encourages Ben to let his real emotions out.

This is where Ben asks Keegan to take over the cannibal case. The mayor's former top economic advisor, Graham Murray, is charged with first degree murder in the death of Paul Wilson,

a young accountant. Murray then had the accountant for dinner. Ben assures Kee that even though Scarlet is prosecuting the case, it will never go to trial. Bonus: Murray has great stock tips. The mayor, who already hates Kee, is plenty pissed about the plunge in his popularity over this crazy story, while the reporters are having a field day.

Keegan meets with Murray who doesn't seem to have a handle on how revolting cannibalism is in our society, but there's good news. Kee's secretary, Leanne, has researched the law thoroughly and cannibalism isn't a crime. If Kee can prove that Murray didn't murder the guy, he's off the hook. There is a video on Murray's phone that proves Wilson committed suicide, but Murray's wife destroyed the phone. She thought she knew her husband after 17 years of marriage but now he's pulled the carpet out from under her. Worse — he fed her CPA and told her it was chicken!

A statement by the deceased's mother on the stand gives Kee a hunch that turns out to be correct. Wilson sent the video to the one relative he was closest to, his sister, Dena. Murray is cleared of the murder charges but the judge still remands him for psychological evaluation. He thanks Kee and reminds him to invest in Australian iron ore (because the Chinese will need steel).

Ben's Keegan-hating mother, Frances, make a second appearance where she tells Kee exactly how much she loathes him and he says it's just because she can't scare him. Frances thinks she does scare him. Kee gets the last shot in as they sit down to the table to eat. He informs everyone that people really do taste like chicken. Stomachs churn.

Mikki decided to quite the hooker trade without even giving Kee a goodbye kiss. Kee goes to see her pimp, Jules, who informs him that it happens all the time. A girl makes her monetary goal and moves on. Kee begs for Mikki's number but Jules can't do it. Kee gets a little too insistent and Jules warns him to back off before he finds himself at the mercy of his hungry dogs. Jules tells Kee that Mikki has his number and will call if she wants to, but Kee should be smart for a change. Forget her.

Kee runs into Mikki on a college campus where he was supposed to meet up with an expert witness. He chases after her to a lecture on deceptive trade practices and tells the class that he is filling in for the professor. He then describes what Mikki did to him and she gets up and leaves. When he catches up with her, she shoots down any fantasies that their relationship was anything more than business. She explains that if a man wanted a nurse or a dominatrix, that is what she was. Kee wanted a friend and she played her part, but now it's over. Kee is dumbfounded.

Roy was on hand to remind Kee that his gambling debt has now soared to \$67K and Victor wants half of it by the end of the month. Roy punches Kee hard in the bread basket and Kee asks Roy to punch him really hard in the jaw. That knocks the bad molar out and saves the cost of a root canal.

Kee's tax evasion trial gets another adjournment because the prosecuting attorney can't communicate well with the "Bulgarian" mover whose affidavit established Kee's financial records were damaged after a heavy rain. The mover asks Kee how he did on the stand — in perfect English.

When his ex-wife, Maddie, accuses him of sleeping with Stacy, Finn's English teacher, Kee has a pretty good idea what his son did with the keys to the man cave, but tells Maddie he can't help it. He's a sex addict. Later, he tells Finn he knows and wants Finn to tell Maddie himself so he doesn't have to. Disappointed that Finn claims to be in love, he's even more disturbed at Finn's bad grammar ("her and me, we're different"). Wow, that's all we can say. Kee's agreement to keep Finn's secret makes this storyline rise to a whole other level of not funny.

Kee was warned by his secretary Leanne somewhere along the line that a rumor is afoot: Kee's stalker Margaret has been sighted in the lobby where they work. At the end of the episode, Kee returns to his apartment to find Mikki waiting outside for him. Before he can find out why, a car comes careening up the sidewalk while Kee yells "Margaret."

Rinaldi's restaurants are in different locations and he has a wife and family to go along with each. Now he is charged with bigamy and somehow this case lands on Keegan Deane's desk. There were also lady troubles galore in this episode, some with the potential to explode in big ways in the future.

There's Margaret, the stalker who tried to run Kee over last week right before Mikki's shocked eyes. Kee and Mikki go to the police to make an attempted murder report. Mikki is surprised that the officer knows Kee's name before he even gives it. The officer blatantly informs her that any statement she makes will end up in the trash, as the Mayor's grudge against Kee

continues to fester. Margaret later sneaks into Kee's apartment and leaves him a Valentine's Day gift — her heart (cow or turkey?). She calls him up at home to make sure he sees it.

Mikki tells Keegan why she came to see him. No, she didn't miss him. Another client, a powerful attorney, is giving her a bad time. Clay Randolph began his relationship with Mikki as the one who wanted to be dominated. He's now evolved into the one who wants to dominate and inflict pain. Kee agrees to get Randolph to leave Mikki alone.

The Mayor's wife, Gloria, uses her favorite vowel "O" (as in ohhhhhhh) to flirt with Kee at a reading event for kids, when he shows up looking for Randolph. Kee's favorite vowel was "I" but it should have been "U" and "O" (as in uh-oh). But later, he needs Gloria to get Scarlett out of a DWI charge she was already getting off the hook for until he showed up.

Scarlett also is having grave reservations about her marriage and you get the sense that she's really in love with Keegan! Scarlett's husband, Ben, is having a crisis over his job because he will never be the attorney his recently deceased father was.

Kee's son, Finn, is still getting "extra help" from Miss Stacy Mullen, his English teacher. Kee's ex-wife, Maddie, still thinks Kee was the one dotting Stacy's i's. Kee goes all caveman when Maddie tells her boyfriend Bruce to uproot a bush in the yard: "Nobody touches that bush but me."

Last, and probably least, was Leanne's dilemma. Her boyfriend, Bevan, was sent to Scotland for 2 years and she just knows that he will cheat on her because "he's got a penis." Kee offers clumsy comfort, telling her Scottish girls aren't attractive. "Coincidentally," a new waitress at Rinaldi's is straight outta Scotland, and she's not exactly the Loch Ness monster. Another detail that came out of this — Leanne is in the US illegally, otherwise she wouldn't even be working for Kee!

The bigamy case went to trial with the judge's ex-wife prosecuting the case and persecuting her ex with a continuous barrage of emasculating comments. Of course, Keegan doesn't have a case but the judge is only to happy to let him try to defend his client to annoy his ex. Kee tries to show what a great family man the chef is, that he truly loves both his wives. Unfortunately, a third wife is found where Rinaldi was planning on opening a third restaurant. But we assume Kee got paid because the episode ended with him dining at the local Rinaldi eatery, chatting with the Scottish lass, trying to remember Leanne's boyfriend's name.

After a friendly warning to Clay Randolph turned into an elevator scuffle, Kee handled the situation by paying Randolph's wife a little visit. He tells her that Randolph was shelling out \$1,000 a week to help a man named Mikki get back on his feet after some serious health problems. Randolph walks in on this and Kee gives the wife a sex toy that he says is the "Balinese God of Plenty" which she gives a place of honor on a shelf.

Summary: Keegan has to try and lose a case to make the city look accountable

for Lucy's daughters wrongful conviction — after it's revealed Lucy has been charged with jury tampering after sleeping with a juror. However her motives are soon questioned when new evidence appears. Finn continues seeing his teacher. Mikki and David's relationship has a

weakness that Keegan is keen to exploit.



In this episode Kee takes on the case of a mother who has gone to extreme lengths to get her daughter out of prison. Lucy Marks has had plastic surgery to totally change her appearance and seduces juror, Patrick Murphy, taping their "sex talk" about about how they convicted her daughter. Kee is totally impressed with Lucy's maternal dedication and "fake boobs for justice," and they quickly roll into bed together. When she asks him if it's unethical, you just know she's taping his reply: "I don't have any ethics."

Mayor Marcus Barzmann is pissed off

because, once again, he's being made to look like an idiot. He makes it crystal clear to Scarlet Leon that he wants Lucy Marks acquitted. His wife, Gloria, was supposed to have lunch with him. She's sitting there waiting for word on that, when her husband says "cancel my lunch," not even aware of who he was supposed to break bread with! The thing is Kee is supposed to get Lucy convicted, that's what his client wants. Don't ask us why, if they explained it, that went by us in the hubbub, but Scarlet and Keegan make a \$1,000 bet on which one of them will be able to lose the case, which has been set before a very lenient judge who lets attorneys get away with a lot. Kee manages to push even her too far, going out of his way to alienate female jurors with talk of PMS and irrational female decision making.

Ironically, Kee's own advice to Ben is what makes him turn on his client. Ben has been having a tough time trying to fit in his father's shoes now that he is head of the law firm. Kee advises

him to take charge, take a day off, fire someone. Ben stands up to another attorney, an obvious impediment to his progress, and gets a hold of files that turn something up on Kee's case. The murder victim's secretary got such a big severance package, it smells like hush money to Ben. So yes, it turns out that Lucy's daughter is guilty of murder. Finding out that Lucy knew all along that her daughter was guilty puts a big damper on Kee's enthusiasm for Lucy and the \$1,000 bet. Lucy threatens to make his life a living hell, but Kee says she'll have to get in line for that. The case ends in a mistrial and Lucy Marks takes her doctored Kee tapes to the press with a new attorney.

The Mayor goes through Gloria's cell phone and learns of her flirtation. He admits to neglecting her, as Gloria tells him she's aware that he is having an affair when all she did was kiss Kee. The Mayor was just watching Lucy Mark's press conference with taped statements Kee made (yes, the no ethics one was prominently featured). He says Kee preys on vulnerable women and vows never to let him hurt Gloria again.

Maddy follows Finn and his English teacher, Stacy, and finds out about their affair. She is enraged that Kee knew about it. Kee warns the teacher to step off or she will be branded a pedophile and sex offender but Finn is furious at his father because he believes he is in love with Stacy.

Mikki has begun dating David Potter, the prosecuting attorney on Kee's tax case. Kee is angry and asks if she has revealed her working girl stint to him. Mikki told her new boyfriend that she knows Kee through her cousin, Angus. After Kee loses the tax case and the judge orders a garnish on his earnings of 70% (70%!!), Kee tells David a tall tale about Angus molesting Mikki. What did we learn from the scene where he reveals to a wary Mikki what Kee said? Her real name is Mikayla.

charged with a robbery he didn't commit. It is Jarvis's third strike felony; Keegan must somehow defend him without a plea deal, since the mayor has refused those from Keegan. The clever ploy of insulting the judge to the point of contempt and mistrial does the trick. At his financial and career crossroads, Keegan accepts a job at Ben's corpo-

rate law firm.



Keegan Deane must defend Reggie Jarvis, an innocent man, against a robbery charge. Trouble is, Reggie already has 2 strikes against him and if Kee loses Reggie will be going away for life, because the mayor has fixed it so Kee's cases have to be prosecuted to the fullest. There will be no plea deals for Deane.

But first we get to meet the elusive Victor, who has consolidated all of Kee's debts and wants 4 grand a week from Kee until it's paid off. He staples a nail in Kee's hand to drive home how serious he is. Kee then gets picked up by a man who takes him to Mayor Barzmann. The

Mayor is pissed over his wife's flirtation with Kee and thinks Kee should relocate. Kee points out that Gloria contacted him and the Mayor should pay more attention to her. Barzmann has his driver drop Kee off somewhere outside the city.

Reggie Jarvis has been sponsoring Luke at AA and is taking him to a meeting. They stop at a pharmacy to pick up aspirin for Luke's "headache." Luke robs the place and Reggie gets arrested as the getaway driver, even though he didn't know anything about it. Reggie knows Keegan Deane from AA. In fact, it was Kee who so inspired him that it turned his life around. Kee talks to Luke who assures he will testify Reggie knew nothing about the holdup, but on the stand, Luke blames the whole thing on Reggie!

In a chat with Ben, who has stepped up taking control of his father's law firm, Kee gets the idea to do something to make the judge declare a mistrial. That will give at least give Reggie a chance to get another attorney before a retrial. Kee also tells Reggie that he's not the hero Reggie thinks. He only went to the AA meeting to get close to a stewardess. Reggie pays Kee, who goes off to do some gambling but Roy shows up and collects the money for Victor.

Kee and Leanne have been relegated to a basement room for an office by Raghu, the building manager. Kee knows he has a crush on Leanne and tells her to use that to get them a better office. Then he tells Raghu that Leanne said he has smiling eyes and pillowly lips. Raghu gets the idea out of this conversation that Leanne is a virgin. "Adjacent," Kee says. When Raghu tries to put the moves on Leanne, she kicks him out at the point of a mop. Raghu suggests that Leanne treat men in a very different way "or you're going to be virgin adjacent forever."

Kee enlists Mikki's help in getting the IRS garnishment at least delayed through the influence of her boyfriend, David Potter. She reluctantly agrees but before she can figure out a way to bring it up, David asks her to move in with him. For the rest of the episode, she cuddles with David and doesn't answer Kee's calls.

Scarlet is seriously considering running for D.A. She is friends with Gloria, the mayor's wife, who is still upset that her husband is cheating on her but tells Scarlet that she has already done something stupid about it (flirting with Kee), and doesn't plan to do it again. She dumps the rest of her salmon lunch in her husband's desk drawer.

Maddy goes off to a wellness retreat with Bruce. Kee wants to bet that she will sick of Bruce and not be able to stand him anymore. Maddy scoffs but that is exactly what happens when they go through some very strange rituals, that include Bruce giving birth to Maddy and then wanting to breastfeed her.

Ben wants Kee to come and work for him. Kee laughs at the idea at first but by the end of the episode, he is going to get on board.

Leanne is over at Kee's apartment cleaning his refrigerator while he gets acclimated at Ben's firm. She is expecting him to get her hired as his assistant over there and Kee was going to do just that until he found out that he was assigned a sweet young thing named Cindy. Every time Leanne brings it up after that, he pretends he can't hear her. Kee is given a new briefcase from Ben so he can dispense with the paper bag he usually carries files around in. There's a bottle of scotch in it and that's not all! He gets a signing bonus of \$25,000! Surprisingly, he calls Leanne and says it will go a long way to catching up with Roy. (We ex-

pected him to head for the nearest casino).

The Mayor still wants Keegan to leave town. When an in-person reminder fails, he puts Chief Bernie Michaels on the case of making Kee's life miserable. Bernie is in Kee's apartment when he gets home and says he's planted a kilo of coke somewhere in there and is going to send over some uniforms. He asks if Keegan wants to bet on who will find it first. By the time the uniforms arrive, Kee has torn the place apart. Turns out he's been played. They say they're just there to pick up a PBA donation.

When Roy picks up Kee's payment from Leanne, she just got hung up on by her boyfriend, Bevan. Roy finds Leanne very appealing, unlike his usual opinion of British gals. Before you know it, they end up in bed. Shocking! Then Leanne finds out that Roy is married and his wife is with child. Do they feel guilty? No, they go at it again – in Keegan's bed! We think he was even more shocked than we were to find that out.

Kee's ex-wife Maddy is having a bit of trouble making Bruce understand that she broke up with him. She arrives home to find him cooking jambalaya in her kitchen and talking to Finn. She throws him out. Finn says he liked Bruce but Maddy says that is not the determining factor in her relationships. Bruce invents a new juice, names it the Maddy and leaves a gift basket on her doorstep.

Robert Ebell, that thorn in Ben's side, suggests Ben put Keegan on first chair in the case they have been trying in court for 11 months and let Kee conduct the cross-examination. People are talking and that's a way to prove that he hasn't made a mistake in hiring his screw-up friend. Kee promises Ben he will look at the case overview and fully intends to do so. He gets sidetracked by Mikki, who brings over a bottle and some wine glasses she bought to replace the ones she broke at David's place. She wants Kee to tell her which ones are the best. They start drinking the liquor she bought in them. The scene shifts to the next morning with Kee in bed but the woman with him is the Mayor's wife, Gloria! Kee got very drunk when Mikki was there and Gloria took advantage of that to have her way with him. Gloria says she is leaving her husband and goes home to tell him.

When she gets home, classical music is playing and the Mayor is locked in the bathroom and won't reply when she calls for him to open the door. She summons Bernie Michaels, who forces the door open and find Barzmann dead with some contraption around his neck. It's not suicide. The Mayor wasn't really cheating on Gloria. He was practicing auto-eroticism and killed himself accidentally. Gloria does not want that kind of scandal and instructs Michaels to fix it. She doesn't care how he does it as long as he does it.

In court and hungover, Keegan tries to stall and cover up for his lack of knowledge of the case. Judge Siebert, who is sick of this case, isn't having it. Keegan pulls a magic trick out of his hat by noticing there are staple holes marks in the photocopy of the original agreement the dispute is based upon. He forces the witness, Thomas Myers, to admit on the stand that there was more than one page to the agreement and wins the case for Ben's firm. One little problem though. Robert Ebell says the firm's budget was based on being able to bill hours on that case for at least 8 more months. Ben reminds Robert that it was his idea to put Ben on first chair, even though he thought it was a bad idea.

Everyone except Keegan is upset over the Mayor's death. Scarlet was going to get Barzmann's endorsement for District Attorney and was going to announce it at a dinner event that there was no time to cancel. After dancing at the dinner with Maddy and getting drunk, Kee makes a stop at Bernie Michael's house to taunt him. Now that the Mayor is gone, Michaels is finished, Kee drunkenly gloats. Michaels makes a call to a guy named Tommy. He wants a meeting to discuss "a person of interest" in the Mayor's murder.

The episode opens with Keegan and Gloria, the mayor's widow, just finishing up some Afternoon Delight in the mayor's office, on his desk. Kee pumps Gloria for information on the cause of death but she does not want to talk about it. The best he can get out of her is that Marcus Barzmann was under a lot of stress. Kee deduces that could have led to a massive coronary and goes off to see Debbie at a cockfight to place a bet on it. Even though Victor has told Debbie not to accept any more bets from Kee, she allows him to bet \$5K with 10 to 1 odds and invites him to bet on the chickens. He declines.

At Ben's firm, he finds out about Holly Phillips being accused of her husband's murder which was initially ruled a suicide. Holly looks a lot older than her husband did but they were the same age. There is no proof that she committed the murder yet her prior attorney wanted her to take a plea deal. Holly warns Kee that she wants an acquittal so unless he wants to get fired, he better not offer any plea deals.

As Holly leaves, Leanne shows up and hears him say his assistant Cindy will show Holly out. Keegan mollifes Leanne with some money and car vouchers and says Cindy is a temp and quite possibly a lesbian. He sends Leanne off on a mission to find the anti-aging doctor that Holly said her husband went to.

Bruce, meantime, is still giving Kee's ex-wife, Maddy, a problem. She arrives home from grocery shopping to find Bruce doing Brazilian fight dancing in her front yard. Bruce says he is trying to prove he will never abandon her unlike Kee. She tells him she is the one who threw Kee out. Maddy calls Kee and asks for his help with Bruce's stalkerish activities.

After opening arguments in Holly's case, two uniforms ask Keegan to come down to the station, informing him he is now a person of interest in the Mayor's murder. Kee laughs it off but the next morning, it's all over the media, even the Chinese language newspapers, and a throng of reporters are at his residence. Some are even going through the garbage. People start throwing candy bars and other things at Kee after this, calling him a murderer. Kee goes over to Maddy and gets rid of Bruce and asks if he can stay with her a few days to avoid the media.

David and Mikki have their first major disagreement and, wouldn't you know, it's over Keegan. David thinks it's just too good to be true that Keegan has been implicated in the Mayor's murder. He deserves it because he is a liar and a self-serving sociopath. Mikki says lying does not make someone a bad person and insists Kee would not murder anyone. David picks up on the familiar use of the nickname but Mikki explains it away with some lying of her own about cousin Angus.

After establishing that Kee has no alibi for the night Marcus Barzmann died, Bernie Michaels proceeds with his revenge plans for his own prior disgrace. Even though Kee won't say he was in bed with Gloria at the time, he expects her to be able to get him off the hook, but Michaels knew about their affair and threatens Gloria with a co-conspirator charge. There will be no help from that corner. David Potter shows up at the jail after Kee is locked up and explains how he learned that the Mayor was "a gasper." A thorough IRS examination revealed the 38-inch waisted Mayor was buying 72-inch belts from a shop in the Valley, specializing in things like auto-eroticism accessories. David says he would really love to see Keegan locked up but not for something he didn't do, and besides, "Michaela" has a soft spot for him. So far, Keegan has not slipped up by using her nickname in conversations with David.

Ben gets Kee out of a jail by threatening a lawsuit for unlawful arrest. That leaves Kee free to get Holly Phillips acquitted by impressing upon the jury that, without proof, they cannot convict her, even though he now knows that she is really guilty. Leanne's reconnaissance with the antiaging doctor proved Holly was really the patient. She was sick of waking up next to "Dorian Gray." Her husband was furious because he liked her to look old. It got him admiration as "the hot young guy who stays with the old lady because he loves her," while he slept around with younger women (including Cindy's roommate).

Under pressure from Ben to take a stand for Kee's innocence, Scarlett gets Gloria to come over where Kee confronts her about not helping him. They cook up a scheme that will benefit both of them enormously. Gloria takes over her husband's job as acting Mayor and discredits Bernie Michaels as a rogue ex-cop who went off the deep end. He is shipped off for psychiatric evaluation while Gloria announces that the cause of the Mayor's death was a massive coronary. More money for Kee to pay off his debts with. After collecting from Debbie (less what he owes for interest, rent and padlocks for garbage cans), Kee cannot resist betting on The Sky is Falling, a chicken Debbie says is guaranteed to lose against Mother Mercy. But Kee likes the Chicken Little story and bets on Sky, then watches in dismay as Mother Mercy shows no mercy.

has a confrontation with Finn's teacher.



Max Fawcett is a vindictive agent trying to get Jules (as we had known him up until now) locked up for assault.

Darnell is Jules' real name. Jules is just an act and a persona Darnell invented to use for his brothel business so he "wouldn't scare off white boys" like Kee, but he can't afford for people to find out the connection because his husband, Blake, also has a legit fro-yo business called Blakeberry, so he reaches out to Keegan Dean to get him off the hook for this bogus accusation.

Scarlet runs into a bit of a problem with running for District Attorney. Gloria Barzmann, now acting Mayor, has second

thoughts about that endorsement her deceased husband was going to give Scarlet. Mikki gets a marriage proposal from David Potter, who gets shot while trying to apprehend a purse snatcher. Gloria thinks David is a "hero" and decides to get him to run against Scarlet. After David is hurt, Mikki starts calling herself his "fiancée." But she can't really marry David without coming clean about her past, can she? She admitted to Kee that David doesn't even know her real name and neither does Kee. Mikki asks David if he's sure he can handle Gloria's offer. David says he really wants it and he has nothing to hide.

Finn's teacher, Stacy, leaves him for a "younger" guy. A loser with zits who just turned 15! Maddie is so appalled that she accosts Stacy at the school. The predatory teacher tells Maddie

it is her own fault her son sought comfort in her arms. Maddie loses it and punches Stacy and Ben has to get her anger management. Her rage with ex-hubby Kee surfaces in the first session.

Kee and Leanne can't get any of the witnesses to cooperate in clearing Darnell as to what really happened in the Darnell-Max altercation at the Little League game. Kee also runs into a problem with the judge, who upgrades the charge to a felony. Darnell's husband, Blake, turns "Jules" little black book over to Kee to use as leverage in making sure his man won't got to jail. A lot of people are in the book who want their names out of it: Ben is one of them and so is the judge, but all the judge (who calls herself an "old lesbyterian") will trade is a continuance of the trial. Max doesn't give a damn what Kee does with the book so Kee has to find another angle, and he does. Max is Dutch Sullivan's agent, star of hit movies like Tokyo Rampart ("I'll go wasabi on his ass"). Rumors that Dutch is gay are interfering with him getting a part Max covets. The black book plays a part in getting Dutch the Jack Missile part in 4 films and Max drops the charges against Darnell.

Funny parts of this episode include the bickering between Darnell and his husband, Blake, and Cindy and Leanne over who is Kee's real assistant. Darnell thinks he is in emotional jail and tells Kee if he knew what marriage would be like, he would have told the gay rights people to get lost. When everything else is sorted out, Darnell and Blake get in an argument at the Little League game and Max makes a pass at Blake!

Kee finds out that Cindy is not a lesbian when he asks for her help in figuring out the phone system. Cindy trades barbs with Leanne but when she says that Leanne's problem is she's in love with Kee, Leanne scoffs and shuts Cindy down by asking her if Kee has asked her to show him the phone system yet.

The funniest part was Roy wanting Leanne's number. Leanne has been asking Kee if Roy has mentioned her and Kee claims Roy hasn't said a word about her. Roy really has been pestering Kee non-stop for Leanne's number. Roy can't stop thinking about Leanne and her "sweet fruit." Kee tells Roy never to mention Leanne's fruit to him — under any circumstances! When Roy finally agrees to make half of Kee's payment to Victor, Kee gives him the number. Instead of Leanne being happy about it, she is mad.
