

Jason, a marine away on base, video chats with his baby daughter and wife. An alarm sounds. They cut their talk short. Jason heads out of the bunker and sees in the distance that one of his own marines is attempting to climb the wire. He drives out to him. The soldier stands Jason angrily.

Lawyers Trey and Abe stretch out, getting ready to work out in a field with other men. Jason's wife shows up and tells Abe about Jason. She needs his help. Her husband was killed by one of his own.

Abe heads to the office the next day. He asks his colonel if he can take Jason's

case. She gives him a hard time at first but his determination makes her give in with Trey as his co-council.

Abe heads to receive Jason's body in his dress blues when he discovers that the killer Ian Moorehead was brought on the same plane as Jason. He meets the female officer Maya Dobbins, who plans to defend the killer.

In court the following day Maya tells the court that Ian doesn't remember killing Jason his commanding officer. The reason being is that he has sustained brain injuries from IEDs. After some back and forth the judge grants them both a trip back to the location of the murder.

They head overseas back to the Camp Habibi base where they speak with the doctor on base. Maya wants to know why Ian was allowed to continue on active duty with possible CTE judging by the brain scans they all looked at in court. The doc isn't looking to divulge much, stating that its against medical policy. Maya and Abe could both benefit from the medical records. They team

up to try and appeal to several leaders to get their way. When that doesn't work they track down marines who once worked on the base.

Trey helps from his end. He tracks down a former marine who shares that no one at Camp Habibi ever failed the screening for head injuries known as MACE. If they couldn't pass it, the test was given repeatedly until they could. Maya thinks Abe and Trey need to make a deal with her client now that they know he isn't really responsible.

Abe heads back to see Jason's wife. He tells her what is going on and how he wants to make this all right by taking down the doctor at the camp who allowed this all to happen. Jason is the reason he is a lawyer — he owes him this. She agrees through tears. Abe calls Trey to tell Maya she has a deal. Abe gets to work with Trey speaking to Ian who is going to be their star witness so they can file a malpractice suit against the doctor. The problem is he cannot remember anything.

Abe heads to some superior officers he knows using his former marine father's name with the hopes they night grant him access to the medical files. An old buddy of his fathers won't grant him access but he takes a look himself. He reports back to Abe its a go, he has some evidence.

In court, Abe and Trey detail how Doctor Hewitt at the camp gave his staff the command to pass all MACE exams. They introduce a medical officer who followed those orders and can confirm Hewitt's command. The prosecution tries to paint a picture that the medical officer is just angry because he was denied a transfer. Next, they call their own witness, a female officer who told them about the MACE test being passed by all. She gets nervous on the stand and tells the court she cannot remembrance. The judge calls an end to the day.

After court, they learn that she was threatened. She had an affair and if she testifies that will be divulged to her husband. Abe doesn't know what to do. He talks to the colonel who has faith he will see this through and figure something out.

Abe heads to see Jason's wife to give her an update when she tells him she isn't a child. She knows not everything is going to go her way. They get to talking and she shares that Jason has always loved the marines but he didn't know how long the marines would love him. The comment is odd. Abe and Jason's wife break into his email. He was going to send her an email about what he meant. They find a draft. He was going to expose Hewitt for passing MACE. Hewitt must have known it.

Abe tells Trey and Maya that Jason's murder was at the hands of Hewitt somehow. They head to court armed with a list of men whose life was altered by Hewitt. On the stand Hewitt doesn't respond, showing any emotion. The judge tells Abe to stand down with his attack. Abe drops the news that he has a video as well of Hewitt in the car with Ian, driving him to the fence where he later killed Jason. Hewitt knows they have him. He would like to change his plea.



Summary: Leaked information may have led to an attack on a female Marine

poised for a promotion; a woman is considering suing the Marine Corps for her husband's wrongful death and may ask Capt. Abraham

to testify.



The first woman about to promoted to captain of a marine infantry unit was attacked. Lt. Emma Sloan on leave and was heading home from a bar when several suspects approached her in a parking lot. They beat her up and left her for dead because they had heard about her promotion. It was supposed to be a secret until Sloan was safely deployed and unfortunately, the news got out because a journalist like Christine Vickerman was more focused on how long it has taken for such a promotion to be finally offered to a woman that she didn't even consider

She's a Marine and was trained to fight within close quarters. She got more than a few hits in and men from her unit came out to help when they heard the commotion. Her friends were suspected at the time as being the guys to attack Sloan and she had been the one to clear their names. She remembered everything that happened. Sloan knew her attackers weren't from her unit and she told everyone as much. What she ended up describing helped Major Ferry and Lt. Li find her attackers.

There was just a couple of guys that washed out of training. It seems that since they failed to become Marines they started going on websites that describe how it was easy for women and so they more or less became despicable human beings that preached men's rights as if that was a thing. They also heard about the article and that's when they began looking for her. They wanted to make a point when they attacked her and now they were facing years in prison. But the whole thing had set off Lt. Li. Li hated how women were treated for wearing the uniform and she wanted to punish all those culpable for what happened to Sloan. And so she went to Ferry about seeking out this leaker.

It was this leaker's fault that news of the promotion got out and it led directly to the attack. Sloan was so badly injured that she was going to miss her deployment and her promotion won't mean anything if she can't lead her platoon. Li wanted justice for that and so she worked with Ferry to find the leaker, but once they did, they found out there was a problem. Their leaker was a woman who championed for women's rights in the military. Brigadier Anne Marie Daly was admired and respected. Li looked up to her and so did her boss. Turnbull didn't even want to believe that Daly could be responsible for the attack on Sloan and so Li had to find proof. She contacted Sloan and told her what she suspected before she asked the young woman to help in entrapping Daly.

No matter what Daly has done in the past for women like Li and Sloan, she did go running to a journalist on multiple occasions to brag about what was she was doing to make this and that happen. She had also been given an order by a superior officer and ignored it. Daly broke command and Li wanted her punished appropriately. She asked Sloan to call up Daly and complain about how her promotion was in jeopardy. Sloan did just that and not long after their call, there was another article. This time it was about the injustice done to Sloan and how she deserved her promotion. It was also credible evidence against Daly and so she was arrested.

Only Daly had great lawyers. She had Captain Maya Dobbins who reluctantly took her case, but she also had a private attorney who works with Dobbins found evidence against Sloan. Sloan was the only credible witness against Daly and so she had to be discredited. She was called onto the witness stand and she told the judge and jury what happened. She was then cross-examined and it was proved in open court that she lied on an official document. Sloan had to write an essay into the Marines and she talked about surviving an earthquake while she was volunteering on the Appalachian Trail. And she was actually miles away from the Trail and even the earthquake meaning she made up this story to look good for the Marines.

The evidence against Sloan was so bad that the prosecution had to settle this case. They offered Daly the chance to receive less pay and to remain in the Marines, but she basically sunk Sloan's career and any chance of her being promoted. Daly was later confronted about the choices she made and Turnball told her that one day she would feel guilty about destroying someone's bright future. Sloan had the chance of being something they could have only dreamed of and it wasn't until she remembered this that Daly changed her mind. She fired her other attorney and relied solely on Dobbins as she pleads guilty. It would mean her career was over and that was something she will struggle with. And at the same time, it helped protect Sloan.

If this case ends up being sealed then Sloan doesn't have to worry about a court-martial or being tossed out of the Marines.

So this case came down to believing in one woman succeeding means they all succeed, but Captain Abraham didn't partake in this case because he was off giving evidence in a lawsuit against the military for what happened to Jason Hunt.

Hunt was a friend of his and so there was no questioning of his loyalty to the memory of his friend or the man's widow.

Summary: When a dying Marine confesses his involvement in covering up the

murder of an Iraqi civilian more than a decade ago, Abe and Trey are assigned to prosecute the accused killer — a sitting U.S. congressman.

Also, Maya helps her brother prepare for his state senate race.



A retired marine made a confession on his deathbed. Lance Corporal Christopher Cavallo served overseas in Iraq and he remembered when his unit was attacked back in 2004. His friend was helping an Iraqi kid when someone began shooting at them and the rest of the unit determined where the shots were coming from, but his lieutenant at the time had made the call on which man in the building was guilty and promptly executed him. It was an unlawful killing. The unit didn't know if this man had killed

their friend and what Lt. Robert Jones did could be considered for revenge. The legal team, on the other hand, was called unlawful killing and Cavello died not long after he made his confession. And so it was up to the legal team to more or less work/investigate this case.

Turnbull left it up to Li, Abe, and Ferry to find out who this Jones is. He needed to be asked about the day in question and so did the platoon. The boys gave the hard part of tracking down Jones to Li because they didn't think it would be a thing, but it was. Li found out that Robert Jones now goes by Bobby Jones as in Congressman Bobby Jones of Indiana. Turnbull also told the boys that they should focus first on the platoon and they tried. They got nowhere with those guys because their stories were inconsistent and so the boys saw the congressman. Congressman Jones was quick to deny the story. He

said that with Cavello living on the streets and most likely involved with drugs use that the man wasn't credible. He even added that Cavello could be used by someone with motives of their own and so he tried to kill the allegation.

Jones began contacting everyone from his platoon and he wanted them to say that Cavello was crazy, but Gustavo Antico pushed back on these claims because Cavello was a friend. There were once good friends and so Tico decided to tell the truth. He contacted Ferry and he said that Cavello was right. He witnessed Jones execute an unarmed man and he was willing to testify. The boys later got Turnbull to sign off on a court-martial and then she got chewed out by her boss. Colonel Riggle demanded to know Turnbull's voting record and he wanted to get rid of the case entirely. He was only convinced to stand down when Turnbull reminded him that he was in charge of appointing the judge and the panel.

Riggle tipped the scales against Abe and Ferry before they even got to court. They were given an old values type judge and the man went as far as to tell the panel that they didn't need to believe the evidence presented to them. It was basically calling Cavello a liar. The judges want allowed to do that yet he did because he was a Republican and he wanted to save his fellow Republican. The Congressman's lawyer was allowed to do whatever he wanted and that included accusing Cavello of being confused about the murder Kadir Fa'iz. The man was dead and they were slinging mud at him to prove a point. They managed to come up with their own witness to testify that Jones had killed Fa'iz out of pity.

Tico had admitted he didn't see the act. He had been ordered back to the car and he only turned around after he heard the gun go off. Therefore, he couldn't say what happened in the lead up to the murder and for that matter, it was still murder. A mercy killing doesn't lessen it and the witness the defense came up with had previously said that he didn't remember what happened. He went from not recalling any of that time to suddenly knowing that it was a mercy killing and so the boys took Attorney DeWitt to a higher authority. Riggle may have stacked the deck but everyone could see the witness was a fake and so a solution was brought up. It was suggested that the charges be bumped from murder to manslaughter and the boys had to take it.

When former AQI strategist Anwar Nadoo escapes from Camp Delta One, better known as Guantanamo Bay, Gunnery Sergeant Miles Wicks is found complicit in the escape. Nadoo somehow gained access to a gas grenade and subsequently set it off to aid in his escape. There was a van waiting to drive Nadoo off base.

Even though Guantanamo Bay was on lockdown, a second gas grenade was set off in the control room. When guards broke into the room, they found Wicks wearing a gas mask. He was deleting se-

curity footage.

Colonel Glenn Turnbull's assigns Captain John 'Abe' Abraham and Lieutenant Harper Li to prosecute the case.

Initially assigned to defend the Marine is Major Trey Ferry and Captain Maya Dobbins; however, Major Santiago Acevedo is assigned to defend Wicks by the Commandant of the Marine Corps.

The Commandant assigning defence counsel is highly unusual. Because Wicks is serving under Marine Corps Security Force Regiment, that's Quantico jurisdiction. Trey is right. It makes absolutely no sense. "Why does the Commandant want his pet Hollywood lawyer on defence?" Try asks Maya. The captain agrees that "it is incredibly weird."

Even though Wicks deleted the security footage, the NCIS cyber team were able to get some of it back. The footage clearly shows Lt Col Jesse McCoy was involved in Nadoo's escape. When Turnbull asks as to the whereabouts of McCoy, Harper tells her commanding officer, because "no one's seen him since that video was shot, ... we don't know" where he is.

The prosecution seemingly has this case in the bag. It's an open-and-shut case. Without explanation, the prosecuting attorneys are strangely denied access to the key evidence which would secure them a win over the undefeated Acevedo.

When Abe is finally able to get a judge to sign off on him obtaining documents from Rapid Range, all the information he needs is redacted. Consequently, the documents are utterly useless.

After Abe speaks with his commanding officer, later in the evening, she eats dinner with her estranged husband. Glenn gets him to provide her with the documentation for Abe's case. While he cannot use it in court, he does use it to influence the defence attorney.

The documents Glenn receives are 1040 tax forms. Since Wicks and McCoy are Marines, their employee ID numbers should begin with 5399, but that is not what we see here. Their employee ID numbers begin with 5302. If you are an employee of the Central Intelligence Agency, you should recognise 5302 because that is what your employee ID number will begin with. Wicks and McCoy are CIA intelligence assets within the Marine Corps. Consequently, the so-called prison escape the other night was not as much an escape as it was a CIA op.

When Abe goes to Acevedo, the prosecution attorney tells the major he is dropping all charges against his client because it's just a show trial. In place of the current charges, because they are both CIA assets, Abe plans to bring a charge of fraudulent enlistment against both Wicks and McCov.

A member of the armed forces who enlists or accepts an appointment without being regularly separated from a prior enlistment or appointment should be charged under Article 83 only if that member has received pay or allowances under the fraudulent enlistment or appointment.

Elsewhere, Trey and Maya attempt to get Warrant Officer Rami Ahmadi reassigned back to them. Lt Glen 'One-N' Eick simply is not capable of filling Rami's shoes. It was in '1st Civ Div' that Rami got transferred out of Turnbull's office.

When Trey visits Lt Col Skylar Maddox, he lays down an ultimatum. If Maddox does not restore Rami to his previous post, "Trey's office is prepared to offer special treatment to her staff. Any time one of them comes up for discipline, they will go at them as hard as they possibly can. Maddox will lose time and manpower. Trey's office will never settle out to non-judicial punishment, not where the Human Resources and Organisational Management Branch is concerned." While this was a bold move on the major's part, Trey fails to get the Lt Col's attention in the manner he was hoping for.

When trying to find ways to get Rami back, it comes to the attention of both Trey and Maya that Maddox might be having an extramarital affair.

While adultery is not listed as an offence in the Uniform Code of Military Justice, Article 134 prohibits conduct which is of a nature to bring discredit upon the armed forces, or conduct which is prejudicial to good order and discipline.

Maya visits Maddox's office but backs out of confronting her about a possible adultery charge.

Summary: Abe and Harper's investigation into the accidental overdose of a Ma-

rine takes a turn when they can't find any fingerprints — even the deceased's — on the pill bottle, leading them to believe he was murdered. Also, Abe receives a warning about testifying in a lawsuit against the Corps, and Maya is concerned that her brother does not have his men-

tal illness under control.



The episode begins in the courtroom as Captain John "Abe" Abraham questions an NCIS field Agent Chong about the opioid crisis. He explains that when a narcotics case comes in he investigates it; but Abe is warned by the Judge on his line of questioning. Chong reveals that when they were informed about a drug deal possibly going down they found a bottle on Cleary. Abraham rephrases the question and he admits it was Staff Sergeant Emery Cleary who had the bottle of oxys on him. Capt. Abraham is ad-

vised to stop antagonizing Defense Attorney, Captain Maya Dobbins.

Maya is given her chance to question Agent Chong, who is forced to admit that he may have arrested her client without cause as he didn't have any unusual amount of cash on him; informing him of Cleary's prescription for the medication but they are interrupted when Lt Harper Li walks in late, showing a video of Corp. Jax Tanhop who is dead from a drug overdose. He is under Staff Sargeant's softball league and died of an accidental drug overdose. Abraham asks for a continuance, which is granted.

Abe returns to the office, where he welcomes Warrant Officer Rami Ahmadi home and to the Marine Corps. He gives Abe the coroner's report and a photo of the pills in Jack's car. Abe says

even if they can't find Cleary's fingerprints on the bottle, he would like to build the case the old fashioned way; suggesting they look up Jax's next of kin, something Rami already did. Abe asks him to inform Capt Li they are headed over to see his former wife. Rami stops Major Trey Ferry to remind him about his wife's ultrasound and reminds Dobbins she is needed in NYC for her brother's fundraiser. He excuses himself as she welcomes him home.

Rami finds Li in another room, telling her that Capt Abraham is off to question the Mexican, offering to be her filter for calls. She doesn't need it. Meanwhile, Colonel Glenn Turnbull checks on Adam Turnbull who is trying to put on his prosthetic leg, but he admits it hurts to put it on. She offers to help but he says he doesn't need her help as she is an adult; she leaves the room but rushes back in when he falls. She checks his arm, which is badly cut.

Abe and Dobbins drive together, him wanting to know how she is dealing with the Adam part. She reveals that it is weird to not be able to pick up the phone and call Bard. Her phone rings and it is Alex Hunt; they are allowed to talk as he is a witness in her lawsuit, they just can't be together. It ends up being his niece inviting him to her birthday party; his sister Alex quickly tells Dani that Abe has to work and hangs up on him after apologizing that Dani doesn't understand everything.

Abe and Maya question Jack's widow, who can't believe he was taking oxys; insisting she cannot help as she doesn't even know who Cleary is. She says her ex is in prison now, Jack wasn't always in a good mood but he was a good guy; something she really needed to believe in. As they leave, Maya can't help but wonder if she was telling the truth because if she was lying, she could be court marshaled too.

Rami calls Abe, giving him bad and weird news, saying Cleary's prints were not found on the bottle nor in Jack's car, but the strange part is no one's prints were on the bottle; making Maya question how the pills got in his system if his prints weren't on the bottle; Abe says it sounds like a straight-up murder!

Back at the base, Li, Abe, and Dobbins work on finding a motive. Dobbins gives them a file on Garth Bader, saying Corp Stanhill broke Bader's jaw 9 months earlier. Bader has two assaults on his record and they can't rule him out. Dobbins feels her client is just someone who uses pain meds, but Abe doesn't buy it. They head out to talk to Bader.

At the Walter Reed Military Medical Center, Adam is told he took a nasty fall, and his arm is broken now too. He doesn't understand how it took them two months to fit him for the leg and he can't get it to fit; the Doctor informs him that they see this more often, especially with above knee amputation and since they are fitted to the millimeter they can get a gel padding into it; but now his rehab is put on hold for months; Adam disappointed that he cannot get back to his unit. He knows there is urgency but Adam is told he is back to being "in patient" and no one knows for how long.

Garth admits he has been in plenty of fights but insists he is past all that, going through EA, a program for people with anger issues. Abe and Dobbins catch Garth in a lie as he said Stanhill didn't just make fun of his name but also hit on his girl. He is, however, able to give them an alibi as he was in a meeting, even though they are anonymous. Garth's girlfriend, says Jack was always at the bar and never acted like he was married, even going home with a couple of women she knows; revealing he had a place of his own. Abe and Dobbins review everything and realize that Ina Stanhill did have a motive to kill her husband.

Rami interrupts them asking if Abe has a relationship with a Winston Guyger, saying he would like to see him and is there in the building. Abe goes outside to see him, saying it is an honor to see him after 25 years; confronting Abe on being part of the lawsuit. He feels Abe and the institute he is serving needs to respect those who have been in the military before him. He demands that the lawsuit cannot happen and Abe needs to get out of this as the case and him are being discussed by people. People who would not be happy that he came to see Abe, leaving after he issues a dire warning to him.

Dobbins arrives at the bar for the fundraiser, as her brother tries to convince the bartender, Krista about where he is from. He admits he is gay, telling Maya that he is not under the delusion that people are watching him and tries to tell her that he is okay. Unfortunately, when the meeting begins, the brother notices that people are wearing earpieces and he cannot focus on the meeting. Matt asks one of the guests to remove his hearing aid, so Maya dumps her wine glass and asks if they can talk tomorrow; asking Matt to escort her out of the restaurant.

Abe and Li meet with Jack's wife, revealing that he has been cheating on her; but she doesn't

understand why he would rent a place instead of just a hotel. Li and Abe want to know if she had access to the bank account, causing her to admit she knew about all the women and the apartment, saying her and Jack had a contract marriage. Li and Abe reveal to Major Ferry about the fraudulent marriage; he says one is dead and the other admits to the scam and suggests they go back to where the spouses worked. Li shows him that specific battalion has seen a 50% surge in marriages in the past 14 months; making them wonder if the Staff Sgt knew about the scams. He wants them to figure out if this all ties into the murder of Jack and is intrigued that this scam has already cost the military a quarter of a million dollars in this year alone.

Dobbins sits at the bar where one of their sponsors finds her drinking and reveals that her Uncle Pete is similar to Matt. Dobbins is told her brother cannot run because of his delusional behavior and offers to talk to him, but feels it should be Maya that speaks to him; she agrees.

Dani opens her present from Abe, asking if he will help her build the Lego set he bought her, but her mother tells her it is way past her bedtime. She thanks him for coming as Abe reveals that he was warned about the lawsuit. She tells him that she has been thinking and since the case is going to take years they can't sneak around, wanting to know if the case is worth him missing out on the kids' lives and what they were building together. She knows Jason is gone, but she wants everything they had back. She hasn't made up her mind, but it is something she is thinking about.

Glenn tells Adam she will be back in the morning, but he encourages her to go back to work and live her life. She agrees to come at the end of the day, turning off the light confessing she doesn't know how to do this, nor how to take the pain he is in and make it hers. She knows it doesn't work like that, saying she sees Adam wishing to do so many things for him, hating that she cannot do anything and is only trying to focus on the next thing they tell them to do. She cries, saying they will make new plans and he will get back to his unit. Adam admits the reason he was pushing himself so hard in rehab is that he wants to get out of there and get the medical separation. She is shocked to learn he is leaving the Marines. He wonders how many people just like him have done a tour in this bed; how many people have given up their limbs for this. He feels that losing his leg means nothing and he doesn't want any part of what the Taliban is doing, beheading people. Glenn walks out of the door with tears in her eyes.

Glenn returns to work, asking to speak to Trey alone. He says everything is fine but needs a few minutes. Abe and Li question Sgt Kal, saying he is facing 13 charges of the fraudulent marriages but he doesn't seem concerned because if they slap his wrist on the matchmaking he will help them; admitting he knows who killed Jack. Li stares at her phone, with Bard's number on it when Abe and Trey come in and she reveals the name Kimber Sprat who may have killed Jack. Since his death was an overdose, Sprat was the one who was a pharmacist; obviously a civilian and if she is the killer they can hand it off to county. Abe tells Li how difficult it will be dealing with the local police because he feels like he is equivalent to being in the Corps.

Matt meets Maya at the waterfront, where their father used to take them. Matt feels they should talk about strategy before tonight, but Maya admits she has heard from their sponsor and he finds out that there isn't going to be a fundraiser and he needs to bail on the race. He is upset that his medical condition will be revealed if he stays in the race. He asks Maya if he is getting worse, but she tries to reassure him that he will be better than okay as he is the smartest person he can do; but just not this. He thanks her for her support and promises to figure something out. He stands up and says he needs to head back to North Carolina and talk to the volunteers. She asks him to stay the night because she doesn't want to see him alone, but he kisses her forehead, promising to plan a visit soon.

Capt Abe and Lt Li come to the pharmacy where they confront and question Kimber Sprat. She says she loved Jack and they were going to get married. She insists that he was a player, but she knew all about it as he assured her they were going to leave that all behind. He said he was divorced from Nina and they were going to apply for the license. She looks at the photo and informs them that she could never have prescribed these pills as they were the "big daddy" ones, which haven't been manufactured in years and the only way to get them is on the streets.

Abe returns to see Alex, admitting he didn't think about them nor Dani. He wants it all back and if she is still where she was last night, he wants her to see where they can go without the lawsuit. Alex says she is going to the office on Monday and going to end the suit.

Abe walks into the office humming when Rami approaches him, wanting to know what he can do for him. Rami says Li has requested him to meet her at the Sheriff's office as there is

a breakthrough in the court case. They arrested a dealer, who had the pills that were in his possession. Abe and Li show him all the photos of Jack's girlfriends; he doesn't recognize any of them but suggests they show him the women's hands. Abe shows him a photo Nina, Jack's wife and he nods that it is her.

Maya leaves a message for Matt who has checked out but no answer. Maya reveals that Matt is heartbroken about how everything he ever wanted being canceled. Maya is told that Matt is stepping aside due to a health crisis and usually someone close to the candidate will jump in their place; they are hoping Maya will run for office in place of Matt. She feels flattered but says she is a Marine and cannot run for office. She is told that she is from the area and believes the same things Matt does, and if she is reading her right, this is why she signed up in the first place — a story that ends with her in office.

The court is back on when Major Trey Ferry argues against the death penalty as Abe feels that Nina participated in this to gain her husband's death benefits after he told her that he was filing for divorce. Judge Lt Col. N. Talley is told they offered the defendant a deal where she would see freedom after 25 years but Trey says she wants to make her case to a panel; the motion to dismiss is denied and now her life is on the line. Ferry and Dobbins are asked for a moment to discuss the fraudulent marriage and is granted the sentence they offered. Ferry asks for a continuance, saying he needs to keep a doctor's appointment, as his wife is pregnant and really needs to keep it.

Trey and his wife see their baby on the ultrasound screen, listening to the very fast heartbeat. Trey realizes there are two heartbeats as the technician leaves to get the doctor.

At the office, Rami tells Glenn that there have been two phone calls from the review board. She is shocked saying this is her first year eligible and Rami encourages her to return the call, feeling she is about to become a General. Trey Ferry is nervous but says they cannot go because his wife is showing signs that are consistent with early labor. He doesn't understand, so he is asked to wait.

Abe returns and Rami tells him he tried to call him, but there is a room full of people waiting for him, including Chong. Abe is told he needs to go with them as Li tells them they are apprehending him with charges of mutiny. The charge refers to something that happened on March 5, 2010. He knows it is a setup, but agrees to go with them and is escorted out the building.

Abe tells Trey that he'll be a father someday.

Glenn was named brigadier general, one of six in the Marine Corps.

Maya confronts Geiger at an oncology clinic in Hawaii.

Abe recalled that he went after the Taliban leader with one other Marine, Pfc. Dixon.

Maya decides not to quit the Marines to run for office.

Geiger admits there was a conspiracy to frame Abe but he was on morphine and dies before the drugs wear off, so his testimony couldn't be used.

The Taliban leader got away and an airstrike would have killed him. Kit hammers home the fact that 43 others were killed before the leader was eventually killed by a drone strike five years later.

Abe blamed himself because Dixon was captured and eventually beheaded while following Abe's order to create a landing zone. Kit said Abe mutinied by not following orders, while Maya argues that the order was unlawful because of the rules of engagement protecting civilians.

Abe is cleared by a split panel, 5-4.

Matt drops out of the race.

Rami becomes a citizen.
