

Summary: High profile Sevvy Johnson is found not guilty of murdering two

women, and eight years later, he's suspected in his new girlfriend's murder. The former county prosecutor who lost the first case returns

to try and convict Sevvy this time.



The episode begins with Maya Travis stopping on the side of the road to take a call, learning that the murder trial of Sevvy Johnson if coming to an end after 8 grueling months. Ezra Wolf tried to paint the story as a case of racism; Maya Travis found back to find him the movie star guilty of two murders, Maya and Ezra meet in the elevator before being surrounded by an angry mob, rooting for both sides. The verdict is read and the jury finds Sevvy not guilty on all charges; devastating Maya.

At home, Maya Travis reviews the photos of her victims and the murder scene,

frustrated at the loss. Her assistant, CJ tries to assure her that she did everything she could, but she doesn't feel that matters.

8 Years Later — Monroe, Washington

Maya is enjoying horseback riding when she finds Riv in the barn with the new cold that was just born. She seems to be thoroughly enjoying farm life when she spots Matthew Collier on her front porch, revealing, "He has done it again!" asking her to come back and promising this time they will get him.

The media outlets are revealing that Jessica Meyer, the girlfriend of Sevvy Johnson was found five days earlier bludgeoned to death. In the corner of the TV screen, Ezra recognizes Sevvy and rushes out of the bar; just as Maya makes her way back to LAX. She is sure she is going to only stay for a couple of days, confessing she cannot get his former victims out of her mind. She can't go any further than looking through old case files and says she will not go through this again.

At the funeral home, both Star Johnson and her brother, Gabriel are sure he is innocent. He doesn't like how her family is looking at him. Matthew brings Maya back to her old place where she immediately finds her gun. Ezra pulls Sevvy away from Jessica's family; saying he is making a scene and the best advice he could take is go home and stay low.

Matthew and Maya review their case files when Matthew asks her to check out Loni Kampoor. She refuses to go back into the DA office, she admits she is still a lawyer and knows the rules. He admits it is great to see her as she notices that he got married to Effy, the reporter. She reveals she is with a cowboy but they are not married.

Sevvy watches the news but tells his baby girl, not to listen to the news as it is people just talking, Matthew will with witnesses, but all he wants is for Maya to find him something; just as she questions if he really thinks Sevvy is stupid enough to kill again. Just then he gets a call from Sevvy who is at the precinct willing to answer any questions. He says he is there without counsel as he doesn't want them wasting time on him while the real killer is out there. He says Gabe doesn't believe he killed his mother, Jessica as he knows he loved his mother. Maya feels they are getting nowhere in interrogation and having Matthew a piece of paper, saying it will definitely shake things up.

Questioning continues as they want to know if he ever hit Jessica, wondering if she cheated on him. He tells the officer to "piss off". He starts to laugh and walks up to the one-way mirror, asking if Maya is back there and she will never get him as he is an innocent man!

Sevvy grabs Ezra, saying he cannot go back to jail; meanwhile, at home, Maya watches an interview between Sevvy and Jessica. She calls Matthew saying she is coming back, shocked to learn that Alan Wiest is the current DA. Many people are not thrilled she is there but Matthew says he is the lead on the case. In their meeting, Maya reminds them that Sevvy had 8 years to think of his mistakes and he definitely won't make the same ones again. They are checking for blood, DNA and surveillance. CJ says she came in to check Ben Mitchell story but so far things are checking. Maya wants them to observe the googly eyes, which shows Jessica looking to see if what she is saying is approved and desperately avoiding conflict. Maya says Jessica was simply a decoration in his house, just like his wife before.

Maya feels none of this feels good, but Matthew begs her for a few weeks to help him get Sevvy into jail. Ezra meets with his law firm and says their life is completely his until they prove Sevvy is innocent, and all the idiots on social media could either be for them or against them. He introduces them all to Ares Ahn saying he is their guru; so they need to get the jury to like them; making American fall back in love with Sevvy Johnson.

Maya comes to see CJ, who is checking Jessica's pings on her cellphone. There is no storage unit, but Maya knows CJ is pissed off at her for leaving LA; they were supposed to be "ride or die" and she simply vanished on her. She wants to know if Sevvy took Jessica to Bora Bora as that is always his first makeup gift after he gives his woman a severe beating.

Mr Meye stops Maya in the streets, asking if she is there for his daughter. She offers her condolences, but he knows she is there if Sevvy is the one who murdered his daughter. He doesn't want her anywhere near this case because had she won the last case, his daughter would still be alive.

Maya's confrontation with Jessica's father is all over the news, as Matthew doesn't think this will convince her to stay. He admits she has been through a lot, even though she ran. His girlfriend feels he can't be the fall guy if this all goes South.

Maya goes to the ocean where she calls Riv, telling him she misses him. Ezra is confronted, saying he can tell his bosses that his cash cow is coming in and the bosses will be paid in full. Ezra is whacked with a crowbar, reminding him that next time won't be so nice. Maya is able to get through the paparazzi while Wiest is presented with a photo that proves Mitchell and Jessica's relationship was not all business. CJ is told to dig into it further and to show the photo to Matthew and Maya, but she says she will only show it to Matthew. Wiest says that before Johnson's trial, Maya used to be fun.

Cj watches the video and notes Star's name. Maya is suddenly awakened by a loud noise, she

retrieves her gun and approaches the door; finding Riv, who was simply worried about her. He admits to seeing the news, holding her as she reveals last time the media was so much worse.

Sevvy meets with CJ, who talks about their first house and how they raised three kids in that house. She says a detective came by her house and left her something, just like last time as they always want to talk to the ex. He swears he didn't do it but she feels he didn't just like he loved, her and Cassandra before her.

Riv and Maya wake up together; he says they have a good 7 hours before their flight and she could show him the Hollywood sign. She admits that they asked her to stay but this it, not the world she wants to be in. The doorbell sounds and she thinks it is a reporter, planning to open the door with a mean face. CJ reveals that Jessica did hide things but simply not under her name. They find Star, who says Jessica had a storage locker in her name. Maya wants Sevvy to be innocent, reminding her that she doesn't need to do anything wrong to feel guilty.

Ezra holds a press conference, while Star gives CJ and Maya access to her storage locker. Ezra says hehe won 8 years earlier and this is simply a vendetta to get him back. The Mayor wants to see Wiest, who tells his receptionist to tell him that he isn't there. Maya and CJ open the storage locker as Wiest says Ben Mitchell is the killer and the only reason he got off his because he was a white man. May and CJ find evidence in the locker, including a video of Jessica with bruises all of her face and her admitting he did it again. She says her dad tried to warn her as she reveals the bruises all over her belly and back; Maya says that probably causes and Matthew says he is getting a warrant.

Maya returns home, telling Riv she can't leave until this is over. He worries if she takes this on again, he will lose her as this isn't her fight. She feels she needs to do this for all of Sevvy's victims. He asks her why she never sold the house, believing she kept it because she is not done there. He begs her to get done so she can get home to him. She kisses him as she promises she will.

Cj comes to see Wiest, informing her that Maya is staying but she is the lead prosecutor and everyone else is fully on board. CJ says she looks forward to working with her. Maya orders everyone to tear the place down to the studs without making any mistakes. Ezra calls Sevvy, ordering him to get rid of anything he doesn't want them to find before they get there; Ezra thanks CJ for everything, saying he owes her one. Sevvy gives Gabriel Johnson something to get rid of before the police arrive, all too willing to let them in.

Several people working for Sevvy get rid of various evidence in different places so they cannot find it. Ezra stands with Sevvy as CJ, Matthew and Maya face him. Maya asks him, "Miss me!"

The District Attorney's office is in turmoil. Wolf's tactics have their public image look bad as he uses the media to his advantage. Besides this, the lawyers argue among each other. Alan Wiest takes notice of Matthew Collier's tactics as he brings Maya back to handle the case. To Alan, Matthew is using Maya as insurance if their case ends up like their previous one.

Meanwhile, Loni Kampoor clashes with Maya, frankly revealing her disagreement with Maya handling the murder case as well as blatantly questioning Maya's abilities. On the other hand, CJ

Emerson finally confronts Maya for her eight-year sudden absence. A lot happened since their last case, and this makes Maya's not so smooth welcome into the office. Indeed, Maya's return not only causes the public eye to turn to them; it also caused her former colleagues to turn their back on her seemingly.

Wolf's plan to make the public fall in love with Sevvy once again significantly shapes the fate of the murder case. He and Ares Ahn, stage a brunch between Sevvy and his family at Jessica's favorite restaurant. Star Johnson took considerable convincing before she agreed to go to brunch

with them. Once the Johnsons reach the restaurant, Wolf and Ares monitor the events taking place.

Star, unable to hide from her remorse, decides to leave, speeding past the media. Sevvy then diverts the press to him to let Star go peacefully. With the media surrounding him, Sevvy is obliged to leave a statement. To Wolf and Ares' surprise, Sevvy saves face by telling the media that he and his family are there to grieve the loss of Jessica and that the police have his full cooperation if they deem it necessary to solving Jessica's murder.

Wolf's tactics did not stop at the Johnson Family image alone. Ben Mitchell, Jessica's Fitness Training client, experiences what he fears the most as Wolf releases a video of him throwing Jessica's necklace in a dumpster. While the police had previously declared him irrelevant to the case, the new video changes everything.

Maya and their team find something suspicious in Sevvy's mansion during their search: a burner phone, a considerable amount of money, and keys to a car. While the evidence they found is inconclusive to the case, it lands them closer to formulating their lawsuit. Because of this, Maya and CJ decide to head out to the crime scene, hoping to find a different lead. Luckily, Maya's skills led her to a bonfire possibly put out hours after Ben finds Jessica's body.

Wolf's media stint prompted Maya and CJ to visit Ben, knowing that the media is after him. In his residence, Ben insists on his innocence and tells the truth about the necklace. Jessica dropped the jewelry during a party they attended, and he meant to give it to her the morning he discovered her body. With that said, Maya reassures Ben that things will go back to normal so long as he tells them the truth and that he has the patience to wait for public scrutiny to fade.

Using her connections, CJ manages to set up a meeting between a potential witness to the crime. Also, CJ's traces the car keys they found in Sevvy's mansion registered to a car owned by Ben. First, Maya and CJ have a word with Ben and his lawyer, stressing the fact that he lied to them. Ben was helping Jessica escape from Sevvy, but she still chose to stay. Frustrated, Ben and his lawyer leave the interview room. Maya does not wish to convict Ben, but if the evidence continues to point to him, they have no choice.

Their interview with the witness, Edward Zo, clears Ben's name. Edward reveals that he saw Ben panicking when he found Jessica's body. However, it was too late for Ben. He broadcasted live, insisting on his innocence before taking his own life.

Now that the other suspect to the case is dead, Maya decides to use Wolf's tactics against him. Using the footage found in Jessica's locker, Maya shifts public focus to Wolf instead, declaring him Ben Mitchell's killer. The episode begins with Sevvy Johnson squeezing his girlfriend, Dia's arms demanding to know if she killed Jessica Meyer; but she is able to prove she was out of town and forgives him for hurting her. Meanwhile, Maya Travis talks to Riv who is at their ranch, as she wishes she was there to feed the horses and both are tired of being alone. Riv encourages her, feeling she may win this case quicker than she thinks; a noise distracts her and she hangs up the phone to investigate. With a gun in hands, she finds a jewelry

box with a note that says, "Welcome Back!" she stores it with dozens of others/

Ezra Wolf has a live interview, saying he hasn't been able to verify the video and the press conference only proves that Maya has a vendetta against Sevvy. He smirks when asked if he is responsible for Ben Mitchell's death, but he claims his suicide is a travesty and should not be used as a publicity stunt, but it seems like Maya will do anything to win. After the interview, Ezra is told he has a problem controlling his client, revealing where Sevvy went the previous night.

In the morning, Sevvy is confronted by his son, Gabriel who demands to know where he was and shows him the press conference showing Jessica's bruises; he shouts that he was only trying to be a good son and that Sevvy knew Gabe would run the extra mile to prove he is a good and loyal son. He rushes out, saying he doesn't have to believe his dad at all.

Maya learns she is a meme on social media as CJ reminds her of the old rumors of Maya and Matthew Collier having a secret love child. Maya reveals she got a present from her stalker/biggest fan, but they need to drop this discussion as she needs to focus on the case. Matthew calls her into his office, saying they are not a team and he is the one who handles the media. She doesn't think they have enough to arrest Sevvy, but they are hoping to get someone from his outer circle to talk.

Ezra is on the phone with Loni Kampoor who defends her lack of knowledge on the press conference, but he orders her to figure it out. Sevvy is getting his IV infusion when Ezra arrives

giving Sevvy a guilt trip as he is making it hard to make it appear like he is a grieving boyfriend if he is out getting a booty call from another girl. He warns him that this isn't 8 years ago, and Maya just took a knife to their jury pool and any fans he had left. Ezra gives him a new phone with only his number on it. Ezra learns there is a way in and out of Sevvy's place that no one knows about; realizing they are screwed because the only thing they had going for them is the security cameras didn't catch him leaving the house the morning of Jessica's murder. Sevvy wants him to figure it out.

Loni says Maya's press conference took a lot of balls and is offering a white flag. She encourages Maya to use her team as CJ comes in with information about his Sevvy's newest side piece. The kitchen manager gave her a receipt, asking if she is ready to meet Sevvy's other woman and they head off to Dia's house. Maya immediately gets into her face, saying Sevvy did this on purpose to use her as an excuse and she really isn't anyone special. Maya tells her she is under arrest for a DUI from earlier, taking the name "bitch" as a compliment from Sevvy and Dia.

Sevvy is furious as he loses his career, fans and family; begging Jules Johnson to talk some sense into Gabe, even though she feels he won't listen to her because she isn't his mother. He denies that he is hiding anything from her, but if she wants to keep everything they built together, she will help him.

Dia insists that Sevvy is innocent, while Maya questions whether Sevvy ever hit her and if he hasn't done it, its only because she hasn't been around long enough. She calls Maya a "white bred bitch" and Loni says she is like a raptor in heels. CJ feels Loni is selling it in interrogation, as Maya can't believe what is being said about her. Loni plays the victim card and becoming nothing to the men in their lives. She asks if Dia wishes there was a way she could take her power back.

Charlie escorts Dr. Lisa Abboud to his office, wanting to talk to his ex about Sevvy. He suggests that she help them and maybe she used the private entrance the morning of Jessica's murder. She feels he is desperate but he reminds her that he always wins; she smugly tells him that he will have to win this one without her.

Maya greets Effy at the door when Matthew comes outside as she reveals they flipped Sevvy's mistress who has agreed to wear a wire, but she needs his approval before moving ahead. Matthew is concerned that they believe he already killed three women, Maya doesn't think they will get a confession but he could say something incriminating. She taunts him about running behind his nice, safe desk; so he either trusts her or he doesn't. He signs the papers, saying he always trusted her and she needs to keep her safe.

Ezra finds Lisa, after she discovers the CD of Connor Zane, reminding her he was the rising rockstar she used to treat but died from an overdose; only being saved by Ezra and now she owes him, threatening to make the case reappear if he has too. She knows he is ruthless, wondering if he would actually destroy her in order to get what he wants; he immediately says yes.

Dia is prepped for her meeting with Sevvy, saying they need him to talk about anything about Jessica and his ego is what will get him talking. She reminds Dia that she can sell this and they send her out for her rendezvous with Sevvy. CJ reassures Maya that they have taken every precaution to make sure Dia is protected. Matthew wakes up, quietly crawling out of bed to call Maya; she reminds him this is below his pay grade now. He says he wants her to know he supports her as she knows he misses all of it; he wishes her good luck as Effy confronts him, saying she knows he is tempted to fall back into bad habits. She reminds him that she didn't give up her career so they could play the runner up to Alan Wiest; he promises it is all going to happen for them. She claims to trust him.

Dia sets up the room for Sevvy's arrival, nervously waiting on the bed. Gabriel sits at the bar, asking for them to change the channel as he doesn't want to see Ezra's interview on his father anymore. He is told the TV is for everyone and if he doesn't like it, he can drink in his own living room. The drunk recognizes him as Sevvy Johnson's son and wants to know how he lives with himself, taking his Daddy's money especially since everyone knows Sevvy killed his mom. A fight breaks out and Jules rescues Gabe.

Sevvy has a drink while waiting for Ezra. He shows him paperwork from his doctor, saying that he was knocked out from the medications she gave him that morning. He says Lisa's reputation is sterling and he can make this stick. Ezra reminds him that being innocent and proving it are two very different things. He wants Sevvy to memorize the words and tomorrow they will use it like the Bible and preach.

At the hotel room, Dia takes off the bracelet Sevvy got her as she looks at a photo on her phone. She quickly writes down that she is writing a wire and loves him. The door opens and it is Buck Neal, Ezra's fixer. Maya wants to see what he has to say; Dia is shocked to learn that Sevvy sent him to break up with her. He pulls out \$50 grand out of his pocket, encouraging her to be a good girl and take the money.

Dia storms out, saying she will sell this and steals keys from the valet; Maya ordering them to follow her. She is heard on the wire saying that she was going to save his ass. As they give chase they lose audio when she gets out of range. She bangs at the gate, demanding Sevvy Johnson to open the gate in front of the press.

Sevvy lets her in as she angrily confronts him about trying to pay her off like some whore. He is able to prove that Ezra took his phone and even though Wolf broke up with her, it was done with the right intentions. He suggests they lay low until things cool off. She is able to bring up Jessica's tapes and how they only show one side of him, and she wants the world to see the side he sees. Maya, Loni and CJ are thrilled that she is back on script.

Sevvy says he did not put those bruises on Jessica, but as soon as he is out of this mess he will be with her for real. Sevvy confesses that Ezra has it all figured out and has made a fake alibi with his doctor. He suggests she take the private way out to avoid paparazzi.

Jules tells Gabe she is glad she got to the bar when she did and that his dad isn't the only one worried about him. He admits nothing is okay and doesn't know what to do as he feels really alone. She touches his face and leg, promising to help him through this. Meanwhile, Maya meets with Ezra discreetly as she plays the recording of Sevvy confessing to Dia. He realizes she ran a wire on Dia as they bicker about who can take the high road; Maya says this is about ending the road for him, as she plans to get him disbarred. She also knows about Sevvy's secret entrance now and it will drive a massive hole in his case. She taunts him that Sevvy is going down for murder and Ezra is going with him!

Matthew brings her a reward for pulling an all-nighter; reminiscing about their first wire and the treats they had. Maya feels he should have been there as she never saw him happier than being in the trenches. She doesn't judge him for his career choice while she was away but she has to wonder if this is really him? He leans in and gently touches her hands, admitting he didn't know how hard this was going to be having her back. Before it can get overly emotional, he tells her to enjoy the treats and leaves.

Loni finds Ezra in the parking garage, angry that they ran a wire on Dia. She says she wasn't part of the plan and he is furious that she is lying. He threatens her with "We'll see!" as she steps into the car terrified. Jules returns to the bar and meets up with the patron who fought with Gabe. Maya arrives at the office, asking CJ what she found. CJ believes she is able to fill on part of the gap missing in Jessica's timeline, possible witness to her state of mind the night before the murder. Matthew Collier learns the expose is probably Ezra Wolf making noise because she busted his alibi.

Meanwhile, Loni Kampoor is secretly taking photos of Ezra and some men leaving a ware-house; she pays the janitor money to learn how often Ezra goes there. Ezra returns to his office and when Area Ahn is unable to find a current photo of Maya; Ezra calls Buck, who tells him he is working on it.

Maya is called into Alan Wiest office, where he introduces her to Ken Sanders, the PR consultant. She is not interested in the help as she feels she is one piece of evidence away from nailing Sevvy Johnson.

Sevvy goes to see his son, Gabriel Johnson after learning he got into a fight. He lets Gabe know he can come home anytime as they are now living in the city; Gabe says there is no way he

is moving home. Julianne "Jules" Johnson reminds Sevvy he needs to give his son some space but he gets frustrated that Gabe won't talk to him. She tells him the more he holds on, the harder than will break free as no one wants to be controlled. Sevvy leaves, knowing he placed a tracker on his son.

Maya and CJ walk to The House of Pies, where they see footage of Jessica meet with Julianne Johnson!

Buck shakes hands with Riv, still talking about buying a thoroughbred; he walks back through the barn when Riv holds a gun to his head. Riv learns he is really Buck Neal, who says footage on his "girl" is worth a lot right now. CJ issues her a warning when Riv sends her the photo, as things are going to get much rougher. They knock on Jules' door, who slams it in their face; Maya tells CJ it is time to do some digging.

While looking at the footage Buck obtained, Ezra feels Maya should have just started on the farm; but has no second thoughts on what they are doing.

Jules calls Sevvy demanding to know why Maya Travis was just knocking at her door. He promises to find out, but hangs up when he sees that Gabe went to Star Johnson's place; not even taking Sevvy's call.

The legal team is in the middle of a meeting when Wiest walks in, wanting to know if Maya and Matthew are lovers, showing them the expose on the news. Both adamantly deny have any involvement with each other, but Loni shows the link and there is no denying the people in bed look extremely similar to Maya and Michael. Maya calls Riv, who said he didn't watch the video because whatever she did is in her past. He reminds her that he loves her and has her back no matter what. Michael says Effy is fine. The tech team calls it a "deep fake" and are becoming more and more common. He has to go prepare a statement over the scandalous news.

Gabe wants Star to tell him the truth about their dad, Sevvy. She reveals that he used to hit her mom but Gabe isn't sure if he did with his mom as he was very young; both feel guilty about introducing Jessica to Sevvy. A very drunk Gabe says he couldn't have known but he helped him; that is all Star gets out of him before he passes out.

Mayor Stephanie Russo walks into Wiest's office, saying they need to talk about Maya Travis' tape which is everywhere. She feels Maya's credibility is shot and he has to fire her. He insists Maya hasn't done anything wrong but she wants to make one up and let her go. She casually mentions that she thinks Matthew Collier is planning to put his hat in the ring for elections, causing Wiest to pause.

Sevvy meets with Ezra, informing him that Maya showed up at Jules' house. He tries to reassure him that things are about to get better. Together they sit down with Matthew holding a press conference about the deep fake video that has popped up in the media. In the midst of the conference, a message is sent to the tabloids, making it seem like Matthew and Maya met at a hotel approximately a year earlier. The mixed tape is completely fake but the photos are real. At this point, Ezra tells Sevvy if they are able to cast reasonable doubt there really is no case.

Maya insists she was there for a horse conference but she didn't see Matthew. West admits he was 100% on her coming back but he was a bit naive. She has more baggage than LAX and the office cannot handle it. Matthew barges in, saying Maya Travis is the only one who can take down Sevvy Johnson; Wiest tell Matthew the decision has been made and they could quit in solidarity if they choose.

Maya and Matthew were apparently in Seattle at the same time, or at least he thought he saw her. She wishes she had said goodbye, but Matthew thinks he can convince them to keep Maya on; if she is willing to stay.

Ezra runs into Loni, who feels he is disgusting. When pressed, Loni blurts out that they have footage of Julianne meeting with Jessica the night before she was murdered. They don't know what the meeting was about as Julianne stone-walled them. Ezra leaves, pleased with what he learns.

Star confronts Gabe about what he said in his drunkard stupor and he reveals the night they learned the cops were coming, he took a bag for their dad and buried; he has no idea what is in the bag but Star says they need to go find out.

Sevvy sits in his home theater when his phone vibrates, informing him that Gabe is on the move. Ezra has drinks with Jules; where she admits Maya was there but she has no idea until he mentions the House of Pies. She admits that she met with Jessica there a few times on how to co-parent the children and didn't reveal it because she didn't want to be involved in the trial.

He advises her to make sure her alibi holds up when the cops discover this new evidence and she was the last one to see Jessica alive.

Maya is all set for her interview on the Southland morning show; hosted by Effy Collier. Effy jumping right in it about being busy being a prosecutor but also sleeping with her husband. Maya thanks her for allowing her to set the record straight and all this stuff is from a cheap Lifetime movie. She admits had they ran into each other it would have been great to catch up as when they were doing the first trial; her and Matthew were in the trenches together and people love to assume when a man and woman work together they automatically are having an affair. Maya brings out how these rumors are so sexist. The trial is a battle and she is coming out swinging. She will smile when they arrest Sevvy and it will be a real smile.

Ezra is not impressed with how Maya was able to turn it around and fires his IT guy. Riv comes off the elevator and sucker punches Ezra in the face before quickly leaving. His staff tells Ezra he had that one coming. After the interview, Effy tells Maya that she knows her and Matthew spent the night together and it will never happen again.

Madam Mayor calls Wiest saying they should not fire Maya, so he calls to get Maya on the phone. Star and Gabe arrive at the campground where they used to go as kids and he shows her the spot. He digs into the ground and is able to retrieve that bag. The siblings look at each other as inside the bag are photos of Jessica, men's running shoes covered in sand; they feel they need to take it to the police but Sevvy shows up and asks them not to.

Sevvy insists this is not what they think, as the family is not a lie and their love for each other is not a lie. Gabe feels he can't trust his memories any more than he can trust his dad. Sevvy threatens him that if he doesn't give him the bag he will regret it. He attacks Gabe, but Star steals the bag as Gabe whacks him over the head with a shovel. Gabe is devastated that Star poured fuel on the bag and burned all the evidence; saying that is her dad and couldn't do it.

Maya returns home and finds Jules at her doorstep while Loni mocks Ezra about his black eye, feeling he deserved it. Loni reveals that she knows about his gambling addiction and his law firm is on the brink of bankruptcy. What will Sevvy do when he learns it is his money that is only keeping the doors open? Loni tells him that this is over and she is out!!

Jules wants everything she said off the record; if she is put on the stand she will deny speaking to her. Julianne and Jessica have been meeting for months, and Sevvy would never change as he abused both of them. She says Jessica was all set to move out, until the night before her murder because she believed Sevvy changed. She accuses Jules of being jealous and wanting to get rid of her. She is not saying Sevvy killed her and never will.

Maya returns to Gabe, asking if he knew the name Calvin Taylor but he doesn't recognize the name. He admits immediately that he hit Sevvy with a

shovel after he tried to grab the bag. Maya learns that Sevvy was conscious when Gabe left the scene. Matthew questions Loni about her whereabouts and she lies that she was with Maya looking at lab results; he brings her in for the lie detector test. Maya retrieves the folder from Leo, the deputy at the door. She unlocks the bag and reviews the file on Calvin Taylor. She urgently asks for a search warrant and a special master once she sees what is inside.

Sevvy wakes up, kicking Ezra out of his chair, learning there is no word on Gabe. He wonders when it is ever going to end worried that Gabe goes to the police and tells them about the bag. Ezra says there isn't a bag as Star took care of it. Loni takes the test, denying any contact with Ezra Wolf, Matthew sees the results and she is cleared to pick up her phone. She rushes to the bathroom and vomits but when she comes out of the stall Matthew is standing there and says, "I know it's you!"

Loni is brought back into Matthew's office who reveals that her right eyebrow goes up every time she lies. He demands to know what she told Wolf and she admits that she told Ezra about the tape of Julianne and Jessica at the diner. She also told them about the search warrant

because she was angry, feeling betrayed when Matthew made Maya lead on the case. She hates what she did and regretted it ever since and it's over between her and Ezra. Matthew orders her to sit down when she attempts to leave. He tells her he wants to fire her but he can't because if it gets out that one of the prosecutors on the case was Ezra's mole it would destroy everything. This is between the two of them but if Maya finds out, she is gone and she needs to turn over her passwords for all her devices as he will be watching her like a hawk.

CJ finds Buck in the park, asking if he prefers to be called "Calvin Taylor." CJ says she saw him in action 8 years earlier and she is there as a professional courtesy, revealing they found his prints in Jessica's car and on her computer. He won't reveal the name of his clients, even though CJ believes Ezra and Sevvy hired him to kill Jessica. He says if he did kill Jessica, they wouldn't have found his prints anywhere. He stops her, knowing that she is raiding his office right now and tells her that it was "well played."

Maya arrives at Buck's office while Ezra attempts to stop her, using client/attorney privilege. She reminds him that back then, Buck was working for Sevvy and Sevvy isn't a lawyer. The Special Master returns from the office and gives Maya the zip drive. She tells Wolf that she remembers how things work, complimenting him on his shiner and wishing she had given it to him.

In the car, Maya sees all the photos of Jessica as Ezra returns to Sevvy, saying the surveil-lance footage is going to screw them, but Sevyy disagrees as Jessica was a quiet girl who wasn't cheating. Ezra reminds him those papers will make him look like an insanely jealous boyfriend and it makes it worse that Sevvy tried to get rid of them. Ezra tells him that as long as Gabe stays gone and there is no bag, so no worries. Star walks in the room, saying no one has seen nor heard from Gabe. A knock at the door returns Sevvy's phone, but he is shocked to learn that Gabe is at the DA's office and talking to Maya.

Maya returns to the office shocked to see everyone leaving. Matthew says they found the mole who was a janitor and they would never make a case against a contract worker. Maya still wants to talk to him but Matthew says he already did. He tells her that he confessed since he would fail the polygraph. Maya knows the truth about the search warrant and that Johnson was trying to get rid of evidence; she reveals they have a visitor and it's time for Matthew to meet him.

Ezra sits outside with Star, Sevvy walking behind him as Wolf tells her he wants to help her. She doesn't need his help as Ezra explains that Gabe is talking to Maya right now, including the fact that she burned a critical piece of evidence. She can't control what Gabe does, but Ezra pushes saying she could go to jail for being an accessory after the fact. Sevvy stops her from walking away, promising that Wolf will protect her but they need her to help them first. She shrugs her dad's hands off, knowing that the point is this plan is to protect him and he believes his own BS. She tells Sevvy to reveal which part of her soul she is about to sell.

Maya and CJ tell Matthew that Gabe is telling the truth and there is evidence that Johnson had a clear consciousness of guilt. They cannot make the arrest but Gabe's testimony would really resonate with jurors. He agrees to testify but Maya and Matthew warn him that this will get a whole lot worse. He doesn't care as long as Sevvy ends up where he belongs. Maya says they are going to take him somewhere safe, where Sevvy can't find him; but before they are able to escort him out of the building Gabe is arrested for assault with a deadly weapon, thanks to Star. CJ says this is Ezra Wolf's game, even though Maya says this is her witness. Gabe begs for them not to take him as Maya says they are playing right into Wolf's hand.

Maya, Loni, and CJ sit in the office as Maya feels this is on her because Gabe came to her and she let him down. Maya reveals that Gabe is broken after she told him how his mother died and doesn't think he can come back from. CJ says they will make Sevvy pay and that is how they will help Gabe heal. Matthew shows Loni a bug they found in her wallet, wondering if Ezra has been listening to every word they say. Loni acts defensive, swearing she had nothing to do with it. He is furious she betrayed everyone in this office and demands to know if she didn't do this; who did?

Riv wakes up on the couch, finding dozens of boxes with dates on them sitting on the coffee table. He calls Maya, wondering if she is coming home soon. He says he is okay but wants to stay with her until this over; she says that would make her very happy. There is a bug planted in Maya's place. CJ mocks Maya about having a gorgeous cowboy who comes to the city, cooks for her and doesn't care if she stays out all night.

Maya stops her on one of the photos, asking about the yoga mat. If it was new, what was Sevvy's DNA doing on it. Maya looks through the evidence, showing CJ everything they found in the trash can; both shocked to learn that Jessica took out the yoga mat the morning she was murdered and Sevvy was there! Matthew is about to leave as Maya hugs him saying, "We've got him!"

Gabe is brought into lockup as Ezra drives Star home, saying she did the right thing. She tells him she spent years defending her father and what people thought of him; that no matter what anyone thought she knew the truth. Maya tells LAPD to look at all his favorite spots, but they bet that he ran as the last known location of Sevvy's car was at the airport; Maya decides to call Ezra Wolf.

Meanwhile, Ezra is getting his black eye covered, when Maya reveals she has a warrant for his client and his car is at the airport; something Wolf feels is a mis-

understanding as innocent men don't run. He tells Maya that Sevvy had said something about going to Napa for a wine tasting while she orders him to produce his client; Ezra hangs up and informs his assistant that Sevvy is on the run!

Sevvy is given champagne by Marie while they are in flight; he certainly believes he is free until Wolf calls him on his phone but he rejects the call. He looks at a website about Dubai, smirking.

Alan Wiest holds a press conference, praising the prosecution team for having Sevvy Johnson charged for the murder of Jessica Meyer. They are actively searching for him, revealing which airport he left from but cannot comment on the specifics of the investigation but are obtaining the flight plans. Maya stands in front of the microphones and tells Sevvy he should turn himself in because wherever he is; they will find him and anyone assisting him will be charged as being an accessory. Marie sees the press conference as Sevvy begs the pilot to land as fast as he can.

Matthew Collier walks with Wiest, Maya, and CJ while they review their plan. CJ offers to call her ex to see if he can gather any info. Matthew is called into Wiest's office, questioning his

reasoning behind putting the entire staff through lie detector tests; he reminds Matthew whose photo is sitting in the lobby, and this is his house; something Matthew keeps forgetting. Wiest demands to have a report of what was discovered as soon as Sevvy Johnson is in custody.

CJ lets Maya know that if Sevvy is heading to a place without extradition, he would have to stop in the East to refuel; she is certain someone will report him because he is a famous guy. In the plane, Sevvy asks Marie to get him another drink but when she leaves she takes a photo of him as Wolf is desperately trying to get a hold of Sevvy. Julianne "Jules" Johnson barges into Ezra's office demanding to know where Sevvy is. He openly admits that she is the only one Sevvy will listen to but she insists that she has no idea where he is. He holds her arms, saying Sevvy is a fugitive and he is going to need her to stay; she agrees.

Matthew rushes into the room with the photo the flight attendant took of Sevvy, saying they are landing in Atlanta so Maya wants US Marshalls and Atlanta PD to meet the plane when it lands. Wiest is calling the local DA to bring him up to speed; they have 25 minutes to get it done. The news comes on revealing that Sevvy is landing in Atlanta; something he has no idea about as he asks Marie about the refueling, she tells him the pilot needs to know his next destination so they can file a flight plan. They all watch the news which shows Sevvy's plane descending at the airport and police are on the ground.

He is furious when he sees the plane surrounded by squad cars. Sevvy pleads with the pilot to not open the door when he takes a call from Jules. She instructs him to put his hands on top of his head and walk out like a man because their beautiful children are not going to lose their father today. He apologizes and hangs up. The plane door opens as Sevvy comes out with his hands in front of him and surrenders to the police.

Angela Ashley walks up to the tarmac, saying Sevvy Johnson is her client and she would like a moment alone with him. They board the plane as Maya asks, "Who the hell is that?" Ezra asks the same question to Charlie, who tells him that Sevvy didn't hire her, but Jules likes her. Ezra receives a call from Sevvy where Angela explains she can get Sevvy out of this, saying he flew to Atlanta to pick up the newest member of his defense team — her! She's spent 6 years in the Innocent Project and she reminds him that he has no choice as it looks right now that Sevvy is a flight risk. Ezra welcomes her to the team.

Angela answers the questions of the press, but Maya can't believe the press is buying into it. She now worries if a Judge will buy what he is saying because if the Judge does, they are completely screwed. They are encouraged to get some sleep and deal with the arraignment in the morning.

Ezra walks Jules outside the building when Buck Neal arrives. Buck reveals that Jules wasn't having any income until Jessica died and suddenly she is back on the payroll. Ezra believes that is a motive, telling Buck to dig deeper with the neighbors. Ezra reminds Buck if Sevvy knew what was good for him, none of them would be there.

River "Riv" Allgood reviews all the footage of the house and spots the stalker walk up but covers the camera with his glove. He is about to snoop through the boxes but Maya walks in, kissing and missing him. She's a bit nervous about being back in court and goes to bed; Riv says he will join her in a minute.

The next morning, Maya tries to convince CJ that she is okay and could do an arraignment in her sleep. Lindsay Meyer arrives, telling Maya that her parents are not coming, apologizing for her father's words. Maya knows it won't be easy to see Sevvy in court, but they are going to make him pay for what he did. Sevvy's handcuffs are removed as Ezra says Mr. Johnson is ready to give the court's his plea. Maya informs Sevvy of what he is being charged with first-degree murder. He says he is absolutely NOT guilty!

The Prosecution sits in a room, where they learn the bail hearing is set for tomorrow. Wiest cautions them because his Angela Ashley story is gaining traction. CJ is going to check if Sevvy made another flight plan. Maya says they have Gabriel "Gabe" Johnson who is released and in a safe house; Matthew feels having the defendant's son sitting on their side makes a big statement. Maya asks Matthew to walk her out, telling him the bail hearing is everything because if Sevvy walks tomorrow it sends a message to a potential jury that their case is weak. She wants him sitting at the counsel table with her; which he quickly agrees to.

Ezra welcomes Angela to his office but she wants to get right to work, saying the devil is in the details. He gives her a desk in the lobby as that is her stature. He makes it very clear that he is Sevvy Johnson's lawyer and she can have her 15 minutes of fame but he runs the show as he is the show! She feels he is "all show" asking again for the files, something Charlie gives her, unwillingly.

Jules visits Sevvy in jail, ordering him not to lie to her. He admits he was scared when he abandoned a 9-year-old child. He needs a favor, needing her to ask Vic, who is an NBA star to post bail. He insists he didn't kill Jessica; she produces Power of Attorney paperwork, telling him if he signs those she will talk to Vic. She says she needs to protect the family because no one knows what is going to happen to him and he needs to do this for her, then she will help him.

Buck returns to Ezra's office, saying he had a productive day, showing him a video of Jules; Ezra points his finger at the screen calling her a very, very bad girl. Ezra comes to see Angela, calling her "Georgia". She questions his good mood and he informs her that he has the silver bullet that he needs to win the hearing, confident that it might not even make it to trial. He won't reveal the information, asking her how her babysitting skills are?

Sevvy continues to protest his innocence when he meets with Vic; saying it would mean a lot to the judge if he posted bail; promising not to run. He talks about his kids but Vic tells him not to use the kids to manipulate him. Vic says he will think about it as Sevvy thanks him. Angela explains that Wolf is shutting her out as he plays "Master of the Universe." Sevvy tells her that Ezra saved his life and knows what he is doing.

Maya and Matthew talk about their strategy in the hearing when Wiest walks in, asking to speak to Matthew in private. Maya receives a call, letting her know that Riv called the LAPD, reporting she has a stalker. She figures out that CJ told him but she doesn't have time to deal with it right now. Wiest confronts Matthew about the janitor being fired and wants to know why there was no polygraph test, even though he confessed. He questions why there wasn't an officer present when Matthew questioned him, but he felt the man would be more honest with him alone. Wiest calls him on his lies as the man had been transferred and gives him 5 seconds, to tell the truth. Matthew stands up, is persistent that it was the janitor who made one mistake but if Wiest wants to overrule his decision and ruin the man's life; go ahead!

Maya is sitting at home when Riv comes in, she is upset that he filed a police report without telling her. He knows how dangerous the situation is, to the point that CJ put up cameras outside the house. Maya feels it is just some poor sap; Riv informs her that LAPD disagrees, saying he is obsessive. She doesn't want Riv to protect her, saying she isn't a woman who needs saving as she can do it herself. Maya reiterates how important tomorrow is to her so Riv says she is as obsessive as her stalker. He gathers all the gifts this sicko has left her and wants to bring them to the police station. He opens the desk but everything is gone; Maya terrified, tells him the stalker was there in the house!

The following morning, Maya doesn't want to hear any news about Sevvy Johnson's case; admitting to Riv that he was right to bring the cops in. She just wants him to put it away until after the hearing. Her ride arrives, she squeezes Riv's hand when he offers her good luck. She gets into Matthew's car, both ready to do this.

They walk into the courtroom, reassuring Lindsey that Sevvy won't get out; Gabe is sitting directly behind her. Sevvy walks in and meets Angela and Ezra, nodding to Vic and Jules, but angry when he spots his son, Gabe there. The Judge arrives, wanting to hear from the people first. Maya says they have it all, including motive when a video of Jessica telling them Sevvy beats her and she was planning on going to the police. His opportunity was when he had a secret entranceway to his property. His consciousness of guilt was him trying to destroy evidence as soon as he knew a search warrant was imminent. They have evidence from the crime scene and DNA evidence that proves he was there in the morning of the murder. Matthew takes over, claiming he is a flight risk which is what half the nation already knows.

The defense stands up as Ezra doesn't feel like fighting them on every point, but he can provide an affidavit from the pilot of Sevvy's plane who was making the flight plane to come back to LA. He has trust and support of the community as Vic Marshall, 5 times NBA champion agreed to post his bail. Judge Song reminds him that he was going to keep it short. He says he did his homework and has evidence the prosecution would have found if they didn't have such tunnel vision; evidence that proves in fact that Julianne Johnson is the murderer.

Sevvy is shocked as Ezra shows them a video of Jules driving down the highway away from the crime scene; Jules and Vic leave the courtroom. Maya stands up saying there is DNA evidence that Sevvy was at the crime scene, not Julianne's. Sevvy encourages Angela to take over so she stands and addresses the court, revealing that 22% of the DNA evidence that was taken by the

State has not been analyzed; another 17% gave inconclusive results but if they were all done, they would find out if Jessica's killer was at the crime scene. Sevvy is granted bail but is furious with Ezra because he brought the mother of his children into this; informing Ezra that he now works for Angela.

CJ and Maya lounge in their office as they fret over this happening all over again; CJ was certain bail wasn't an option as he killed two people now. Matthew brings in booze, wanting to toast to Wolf's face when Sevvy demoted him to the second chair. CJ is going to leave this to them as she has a little girl at home. Maya knows Wolf has a flair to the dramatics but they need to be ready. CJ reminds them not to drink and drive.

Jules is outraged when she barges into Sevvy's house, confronting him on Ezra Wolf calling her a murderer and he let him. He defends Wolf's actions as he was only protecting Sevvy and got him out. She doesn't think he has any sense of morality after all he has done. Sevvy throws it in her face the things she has done, including driving on the highway. She confesses she was screwing Vic Marshall as it was going on for months, the kids and everyone knew but him. Sevvy accuses her of only caring about money as she reminds him she is the mother of his children and has earned every penny she has gotten from him.

Sevvy realizes this was Jules' plan the whole time, she throws salt in the wound saying on top of that she gets a man who is thoughtful, kind, gentle and unlike him, he has never raised a hand to her. Sevvy rages as she begs him to hit her because she is sick of covering up for him. She tells him to take a swing as the reporters outside are his judge, jury, and executioner and if she leaves there with so much as a single hair out of place, then it is his ass. Sevvy grabs her, saying if she goes down for this, no money, house nor kids will save her from going behind bars. She tells him she is not afraid of him anymore and calmly walks out.

CJ comes to Riv, revealing to her that the stalker was in the house, messed with the cameras and then broke in to take all of the boxes back. They are both suspicious with the timing, right after Riv went to the police. CJ believes he was listening, and they are going to find out how.

Angela moves to the upper office; she tells Ezra to get some sleep as they have a lot of work tomorrow and she likes to start early; smiling widely as he leaves. Matthew and Maya are throwing darts at Ezra's picture as they continue to drink. She snuggles up to him on the couch, saying she is the one who left for a normal life. He remembers, saying if things were different. He is about to kiss her but she tells him she can't. Meanwhile, Riv and CJ check the house for bugs; finding one on the wooden beams in the living room. Riv shouts that he is a sick son of a bitch and this is over and he is coming for him. It is the security guard, Leo Foster who did it and is listening as Maya tells him "good night" before leaving the building.

Matthew is cleaning up when Wiest returns, saying he should have fired the janitor because then he would have never figured it out that Loni Kapoor is the leak. He remembers that Matthew brought Loni in and mentored her but took the biggest case in her career away from her; something that pissed her off. Wiest wanted to confront her, but she conveniently called in sick. Matthew swears he had his reason, but Wiest now has to figure out what he is going to do. He could fire him, have him arrested or tell Maya who will never forgive him; but he won't because it was the right play because the office couldn't take another hit as they are trying to win. Matthew is glad they see eye to eye on this.

Sevvy turns off the fire by the pool, dimming the lights when he goes upstairs. He overlooks the city when Lindsey raises a gun to him, saying he murdered her sister and now he is going to pay.

that belonged to Sevvy, and things escalate with Maya's stalker.



The episode begins with River "Riv" Allgood finding Maya Travis hitting the punching bag really hard. She denies that she is avoiding, saying this is just aggression therapy. Riv reveals him and CJ Emerson found a bug in the house, causing Maya to not understand the escalation; but Riv feels he provoked him by telling the "scumbag" he was coming for him. Maya praises Riv, with him fixing the security in the house and Maya begins to carry a gun; glad that he is there.

Ezra Wolf finds Angela Ashley in the

office super early, he says he only came there to grab his dry cleaning from Charlie as he is having a "me" day. He throws it in her face that Sevvy Johnson made her first chair and now she has to wear all the hats; she feels she just needs to be a damn good lawyer. Ezra wants Charlie to report back to him everything Angela "Georgia" is doing while he gathers rope for Angela to hang herself with.

Lindsey Meyer aims her gun at Sevvy, demanding that he tell the truth and face up who he is and what he did. Sevvy doesn't know what she wants him to say, but she insists he stole her sister Jessica Meyer; pulling her away from her and their family. Sevvy continues to insist that they loved each other, but Lindsey plays several voice mails from Jessica. She confronts him about how things were tense between him and her sister because he abused her. Lindsey doesn't want him speaking for her sister but demands him to say that he murdered her sister; something he doesn't do, asking her to shoot him, reminding her that she will spend the rest of her life in prison and Jessica's real killer will go unpunished. Lindsey says she will take that chance!

Lindsey suddenly drops to the floor, screaming about her hand, as Buck Neal arrives, asking Sevvy if he is okay. Sevvy tells Buck to take care of the situation, covering his ears as he walks away. Buck calls Ezra, revealing that Lindsey was at Sevvy's when he got there; she had a gun

pointing at Sevvy and now she is bleeding pretty good. Ezra feels this is the perfect time for Angela to learn about a day in the life of Sevvy Johnson, asking Buck to pretend they never spoke.

Maya arrives at work, finding CJ waiting for her in the parking garage; saying she is her personal bodyguard. CJ asks about her booze fest with Matthew Collier; Maya reassures her she simply has a hangover and that was all that happened. Meanwhile, Sevvy has Angela at his side as the police take photographs and interview both him and Buck. Lindsey screams that he is a murderer and won't get away with this as she is escorted out of the house. Sevvy chastises Angela for calling the police, explaining how Ezra would have handled it but she reminds Sevvy that he is the one who made her first chair. She tells Sevvy to get some rest because she is going back to the office, he pleads for her to stay but she needs to focus on the case. She reveals Ezra turned off his phone, taking a "me" day, suggesting Sevvy do the same.

At the DA's office, they are frustrated that the judge believed Ezra when he blamed Julianne "Jules" Johnson as the real killer. Maya redirects their conversation, saying the bail hearing was yesterday they now need to focus on what happens next. First, they need to get Julianne off the table as a suspect, they can't work on verify it and are certain Jules' words will be shredded on the stand; Maya insists they need more. Alan Wiest walks in, informing them that Sevvy was almost shot this morning by Lindsey Meyer; but she was stopped when Buckshot the gun right out of her hand. Maya is furious that as long as Sevvy walks around in this world, he ruins another life and they need to stop him. CJ gets a message from Detective Vincent North, saying he found something.

CJ and Maya drive over to a scene as North says he has something they would like. After combing through a homeless camp, they found someone wearing a jacket with dried blood on it; the man claiming he found it in a ditch on the PCH. North shows them a photo of Sevvy two weeks before Jessica's murder and he is wearing the identical jacket. CJ says if this is Jessica's blood on it, this is a game changer.

Wiest visits Loni Kampoor at her home, asking her if she has vertigo from playing both sides. He tells her she missed a lot of action the past few days; he is not there to fire her because the DA office needs the win and he wants Ezra gone from the defense counsel by sending Loni back into the wolf's den.

Maya finds this too convenient because Sevvy did everything to have Gabriel "Gabe" Johnson get rid of the evidence. She worries that when somethings are too good to be true, they really are. Maya returns to the office, needing to speak to Matthew, revealing what the police have found. She believes this doesn't feel right after all the crap Wolf has been pulling. She wants to keep the lid on the jacket until forensics comes back and he agrees to have her back. She has to leave as Angela requested a meeting with her.

Sevvy pours himself a drink as he hears helicopters flying outside his home. He leans down and attempts to clean up the blood, only making it worse. He quickly holds his head, rushes to clean off the blood from his hands and begins washing down his pills with alcohol. Ezra is getting measured for a suit when he gets a call from an unknown number, they then leave a text for him to answer. He learns it is Loni, who reveals that SID is interested in his witness list; wondering if there is anything that ties her to him. He brushes it off, saying it is only a fishing expedition and not to worry. He tells Loni he will be in touch, she tells him not to.

Wiest praises Loni at how good she is at that; saying if Wolf thinks they are investigating him, he won't know which lie to cover up and make a mistake when he scrambles to cover all of them up. Loni has to wear a wire to gather enough evidence to nail him. She feels when Maya wins the case, Wiest will get all the credit.

Maya meets with Angela, who says Maya is a hero to a lot of people; talking about the last trial and she was a huge inspiration. Angela doesn't want a deal as she plans to prove Sevvy's innocence in court. She is there to simply make sure they have an open line of communication, so any time she needs to contact them, Maya should contact Angela. She wants everything the DA's office has; Maya lies, saying she has everything. They shake hands, saying they are both on the side of truth, they just disagree on what that is. Maya says it was smart and risky to do what she did in Atlanta, but warns her that if she leaves an opening Wolf will attack.

Maya tells CJ that Sevvy's new lawyer is a badass who has a phenomenal record, making Maya more eager to know about the jacket before they share it with them; both feel it is quite magical that this piece of evidence showed up the day after the bail hearing. They wonder who

planted the jacket.

Sevvy comes back downstairs and walks towards the patio, where he demands to know who is sitting there. The woman turns around and it is Jessica saying, "Hey Babe, I'm home!"

Ezra sits with Buck, revealing that CJ called and he is being investigated; asking for a list of his witnesses. Buck doesn't think they need to narrow it down, but they should start with Maya Travis. He wants Buck to find out what she has on him but be sure to cover his tracks. Ezra proposes a toast to defeating Maya again, but Buck won't take a drink.

Sevvy asks Jessica how this is possible, she tells him not to ask that; wondering if he missed her. She looks at him with her black eye, as he tells her it has been hell. She uses makeup to cover up the bruising, telling him that no one has to know. She asks Sevvy to come to her, Sevvy touches her hand, asking if this is real. He says he remembers what he said to her right there, saying she was beautiful and afraid she would break. Jessica stands up, still holding his hand, saying he did try to break her and now it is time to face what he has done. He looks out, suddenly realizing he is alone, but begs Jess to forgive him.

Maya is at the FBI and the agent is ready to see her. At home, Riv scans the backyard, finding a small hole in the fence leading to another yard; he breaks into the empty house, finding a ladder and the attic is open. Once in the attic, he finds it looks directly at the house, sitting down he hears all the conversations him and Maya have had in their home.

Maya confesses that she transferred the jacket to the FBI, because she didn't want it to fall back on anyone but her. She doesn't know if it was a cop who planted it or someone else; CJ warns her that Wiest is going to go nuclear when he hears this. CJ informs her whether she likes it or not, she just started a war.

Maya comes down the stairs, thanking the agent and asking for the results as soon as possible. Leo Foster remains at his security post as Matthew approaches her, saying if the jacket comes through that could be enough to get bail revoked at the preliminary hearing. Sevvy, in the meantime, continues to see visions of Jessica. He begs for forgiveness, saying he never meant to hurt her, using a sob story for what he did. She tells him that he lies about everything to cover up the darkness; he couldn't even confess to her sister because he doesn't know if he killed her or not. Sevvy is confused, not knowing what he has done.

Ezra returns to the office, telling Angela the only thing she needs to worry about is their client. She believes Sevvy is probably sleeping and could do the most for this case by working from the office. Ezra calls Charlie up, who gives him all their encrypted files on a thumb drive. Charlie says no one from the DA's office nor LAPD called, he reassures her that he is the only counsel she needs and remains calm.

Ezra closes all his windows, opening a safe with his thumbprint and removing some envelopes. CJ calls in her ex, for a huge favor. Maya learns from Riv that the person who was bugging the house, but she is unable to hear any more of his conversation; getting disconnected as he asked her if she has her gun. Maya runs to her car when she hears noises in the garage. She opens the glove box and finds a note, "You don't need a gun, Maya. I'll protect you."

Maya comes home frazzled, calling out for Riv. He is grabbing her things, wanting her to stay in a hotel for a few nights, revealing that the guy is spying from the empty house next door. He called the detective, but he wants her to get out of there. She protests that Riv stays behind and admits that the stalker stole her gun and she put in a report. She knows Riv, saying he can't take this into his own hands because she needs to know he is safe. He finally relents, saying her and him in a hotel... it could be worse. Maya gets a message to return to the office, promising to meet him at the hotel.

Buck informs Ezra that he tailed Maya Travis this morning and she went to the FBI. Ezra fears that this could be it and he is going down; Buck isn't about to let him wind up in a bad spot. Buck says he needs to go as he needs to protect Ezra's sorry ass; a job that is never dull.

Sevvy continues to tell Jessica he loves her, she holds him as he apologizes. She tells him if he is truly sorry, he would have let her sister kill him. Sevvy opens his eyes and sees Jessica's head is covered in blood. He calls to speak to Angela, but Charlie says she isn't in the office and will transfer him to voice mail. Charlie then calls Ezra, mentioning the rope he was talking about.

Maya walks into the office, where Wiest confronts her about giving a key piece of evidence to the FBI without his approval. She feels she didn't have a choice since he only cares about politics. He says doing this shows they don't trust the LAPD and that hurts the case an entire office. She knows Sevvy Johnson killed Jessica but she firmly believes someone planted that jacket; it is

either the nail in Johnson's coffin or the door to his freedom and she needs to know which one it is. Wiest feels she did this because she is seeking redemption but she reminds him she had a life outside of this and now that is falling apart. CJ brings up a list of police that was involved in the case 8 years prior and the only name that stands out is Detective North!

North took the kids out of the house when Cassandra was killed and stayed with the kids until the family came. Maya remembers that North was the firsts detective at Jessica's crime scene; something they all find is awfully convenient. Wiest is furious as Maya hates being right about this.

Ezra walks into Sevvy's house, calling out for Sevvy, finding him curled up in a corner. Ezra asks what happened as Sevvy says he can't do this on his own; Ezra tells him he isn't going anywhere.

Wiest tells Matthew that the chief of police is pissed but he is going to send over Detective North's internal file. Wiest talks about the view as Matthew says that is half the reason he wants that office; Wiest tells him to enjoy it while they can because they might not be there for long. Wiest sees Matthew getting closer to Maya, wondering if he is still going to let Maya take the fall if this blows up in their face. Matthew says he has no idea what Wiest is talking about but after what she did today, she is on her own.

CJ brings over shots, celebrating that Julianne Johnson's alibi checks out and this is one more notch closer to putting Sevvy Johnson away. Maya feels the city is bad for her liver, blaming Sevvy for a lot. Maya tells North that he found the jacket so he is MVP of the week; he wants to know if the blood on the jacket is really Jessica's. CJ believes they will prove the jacket was his; all agreeing that Sevvy needs to go down. North says him catching the case was not luck when the call came in, he immediately took it out of rotation; there was no way he was going to miss the jury telling Sevvy he is guilty. Maya leaves the table.

Riv stares out the hotel windows when he gets a message that there is a motion at the front door of the house; he races off to investigate when the camera stops working. Buck walks through the house, looking through papers when he is attacked from behind. A fight ensues with the intruder aka Leo having a wire around Buck's neck. He kills Buck, leaving him on the floor.

Angela tells Maya they are there for only the jacket and if she starts fishing, they will walk. Sevvy swears he doesn't know the last time he wore the jacket, so Sevvy shows him the dates and where it was found. Sevvy insists that someone else put it there to frame him because he wouldn't be so stupid as to place it there. Maya reminds him about a similar mistake 8 years prior; when Ezra and Angela object and say this is over; Sevvy kicks out his attorneys to speak to Maya alone.

James Meloy confronts CJ on what she and Maya did to North the night before; insisting this doesn't make sense and reminds her that she is going to burn 15 years of goodwill with the LAPD. He is concerned she will go down in flames and she will because she is wrong!

Maya continues her questioning about the blood on the jacket, but Sevvy feels it is impossible that the blood on the jacket is not from him hitting her. Him abusing Jessica Meyer had stopped because he changed. He went into intensive therapy to look at himself and his faults and flaws; it was Jessica who helped him get it under control. He questions if Maya has ever been in love, something she won't answer.

Angela stresses about the private conversation as Ezra says this is the way Sevvy acts; he calls Charlie to make sure there is some camera time as he promises something juicy. He spots Loni walking by and excuses himself, finding her in the stairwell. He tells Loni that he needs information but she swears she doesn't know anything. She advises him to not dig himself any deeper.

Maya tells Sevvy if she wants therapy, she will take her own trip, but thanks. Sevvy recalls that day he was wearing the jacket and he put it back in the closet without a spot on it, which means someone else put her blood on it. He admits that the only person who can help him here is her. Maya dismisses him. Maya tells Matthew and CJ they need to get Detective North there, she still thinks he killed her; as for the jacket, she actually believes Sevvy.

Ezra holds a press conference, revealing the LAPD believes one of their own is framing his client, even bringing in the FBI to investigate a key piece of evidence that was planted. Angela says everything the LAPD has brought in is tainted and unreliable. Sevvy wants to address the press, saying they love the drama of lawyers vs. lawyers but he doesn't care about that; a woman he loved was murdered and he seems to be the only person who is trying to find the one who actually killed her; that is why he is willing to sell his Malibu home, to put up a reward for information leading to Jessica's real killer. He is willing to offer \$18M to bring the person to justice.

Julianne "Jules" Johnson watches the news conference, revealing that Sevvy Johnson's offer has everyone seeing green. Suddenly there is a knock at her door and it is Gabriel "Gabe" Johnson who says he can't take staying in the hotel room anymore. She quickly brings him inside as he is furious that Sevvy has spent years abusing her and now he wants to pin the death on Jules. She orders him to pull it together as the time will come Sevvy will pay. Gabe grabs a bottle of alcohol as Jules reminds him that he has all the power, not Sevvy. She tells him not to let Sevvy take any more from him than he already has. She offers him to stay with her, rather than the hotel.

Angela feels this stunt Sevvy pulled was foolish, saying this is going to bury them in dead-end leads. Charlie hands Ezra the keys as Angela attempts to stop him, saying they need to shut this down, but he suggests she learn how to roll with the punches. Sevvy is also upset that Ezra is leaving, but he smirks, saying if one of those crazies come through; they are to give him a call.

North wants to know why Maya and CJ brought him in. They question him about the morning he found that jacket alone. North says he hasn't worked the streets since he was a uni. He does admit that he was there 9 years ago for the other murders Sevvy committed and got away with. He feels they are trying to trap him, telling them to screw off and if they want to talk to him again, they can call his union rep.

Ezra goes inside Buck's place, sitting with his cane; but once he lays on the bed, he notices something taped to the ceiling. When he opens it, it is filled with thousands of dollars in cash, something he thanks his old friend for. He calls Charlie to get himself a bookie.

Riv and Maya meet with the Detective who says they have widened the scope of the investigation and cannot give them a clear date because it seems Maya Travis has a long list of enemies. He wants to talk to Riv more in depth, but Maya feels this is payback for the blowback on Detective North, also removing all her protective detail, saying she is all on her own now.

Matthew meets Riv in the parking garage where Riv reveals LAPD is stalling the investigation into Maya's stalker because of their investigation of North. Matthew learns just now that the intruder also bugged the house; Riv wants him to call in a favor or do whatever he has to do to get the security detail back on Maya. Matthew says the political part is very touchy right now, but Riv reminds him that he is the only reason Maya came back and Matthew owes her at least that much.

Maya asks Loni if she has heard from their blood splatter guy, but Loni is preoccupied with Buck's history, even going back to being a foster child; growing up in Alabama. The analyst is not available until tomorrow making Maya wonder where the Loni who busted her chops when Maya first arrives, go? Loni has something to tell Maya.

Ezra returns home with a box and somethings when he hears the TV really loud upstairs. He finds Nemo and his crew, eating and drinking while watching sports. Nemo makes him sit beside him, saying their payment plan was made in good faith, based on mutual respect. Nemo also found out that Ezra bet huge on the game and now feels disrespected. Ezra is sure the game will go his way and he will have more than enough to cover his debt to Nemo. Nemo tells Ezra to kick back and watch it together and he better hope they win.

Gabe gets the keys from Jules' purse, saying he needs to speak to Maya immediately but Jules attempts to stall him until morning. He feels he needs to tell Maya that he is the one who planted the jacket; admitting he didn't do it but is willing to say anything to end this. Jules plays on his feelings, but tells him he cannot do this — he cannot like, not about this. She pushes him to stay with her and the two is to kiss.

Maya is staring out the window when Matthew walks into the office. She reveals it took everything she had to get on that plane and return there; the only thing making it bearable was knowing Matthew was on her side. She calls him a liar, explaining everything Loni confessed to her. She doesn't want him to make this worse by patronizing her. She berates him, saying she trusted him but clearly she shouldn't have. He tries to make amendments but she doesn't believe a word he says, anymore.

James brings Cj to Vincent North's house, saying she isn't the enemy here. Meanwhile, Jules wakes up with a naked Gabe in her bed. CJ finds Maya in the evidence room, having a hard time believing its true that Matthew lied to her. Maya says it was Loni, not this supposed janitor Ron. She questions why she came there, giving up her good life as everything there is falling apart. CJ reveals North didn't plant the jacket, explaining North didn't even have access to Jessica's blood. Maya feels horrible for pissing off the LAPD, accusing one of their own of no reason. Maya is positive the jacket was planted, and if it wasn't North, then who?

Angela is meditating on her chair when Sevvy gives her a stack of papers of 50 tips to follow up. Angela says she likes to win but this case is not a winner; it could have been but there is just one problem — Sevvy! Winning the bail hearing was the worst thing she could have done because if he was in jail, he couldn't have screwed things up so badly. Angela doesn't think he needs two controlling lawyers, so she is leaving. She could have won this for him but his ego will destroy him. She advises him to remember that innocent people go to jail all the time.

Charlie walks in, saying she is worried about Ezra, who always answered when she calls. Meanwhile back at Ezra's place, Nemo and his crew are shoving Ezra's head under water until he almost drowns. Nemo tells him to relax as he isn't going to kill him since dead men cannot pay. His men hold him down as Nemo removes his sock and shoe, saying he has to go back with something for his boss. Ezra promises to pay and to get Charlie to wire him the money. Nemo gets one of Ezra's toes cut off before Sevvy rushes in, saying he will pay off his debt but they are to never show their faces around there again.

Julianne arrives at the office, wanting to talk to Maya. She wants to know if a person came forward, saying they put the jacket by the road; doing it because they saw the case falling apart and didn't want Sevvy to go free. Maya wants to know how this hypothetical person got their hands on a jacket with Jessica's blood on it? Jules only wants this person to have community service and no jail as her condition. Jules says Jessica gave her the jacket a few weeks before she died with the blood on it, in case something happened; she didn't want to turn the evidence over because Sevvy is the father of her children and with Jessica being dead there was no reason to protect her anymore.

Maya wants to know if she will say all of this on the witness stand, and Jules says she will put her hand on the bible and swear before God, to every word!

Sevvy brings over a drink for Ezra, revealing Dr. Carys Daly is on her way for a favor to Sevvy; something she wanted very clear to Ezra. He jokes that it is only one toe and he will be fine. Ezra says Buck was his only friend; making Sevvy calling him a son of a bitch but at least he is a survivor. Both of them, one way or another they will get through this; the two toastings before Carys arrives.

Maya asks Leo if he has seen CJ, offering to walk her down after he heard what happened this morning. He gets on the elevator with Maya to bring her to her car. Wiest finds Loni in his office where she had dropped off her letter of resignation, saying he is done telling her how to be. Him, Matthew, Wolf, they all treat her like a pawn and "Screw you all!" Before she leaves the room, she informs him that Maya knows everything.

Matthew shows CJ the bug he found in the War Room, oddly it is the same kind and if it was in the war room, it means the stalker has security clearance. CJ rushes off to find Maya but she is walking with Leo in the parking garage. He is able to pry out of her that she is staying in a hotel, but he seems to press his luck when he offers to follow her there for her own safety. She declines his offer saying Riv is waiting for her. She spots cuts on his wrist and tries to get into her car, but he slams the door saying he believes he said too much.

The episode begins with Maya Travis being confronted by Leo Foster in the parking garage. She tells him she needs to get back to the hotel where her boyfriend, Riv Allgood is waiting for her. Suddenly, Leo rambles off a date of the first pair of earrings he sent her during the first Sevvy Johnson trial. He was upset that she vanished 8 years ago, as she tries to tell him that he should have just told her they were from him. He talks about all the things he knows about her; asking if Riv knows her to like him and is he willing

to do anything to make her happy. He admits he killed a man for her; she knocks him to the ground, giving herself enough time to get into the safety of her car, but he pulls her back out and the two struggle for her to get the keys. She runs towards the building after she gashes his face. She runs down the stairs to another garage, screaming for help; CJ Emerson has her gun drawn, reassuring Maya that she is safe.

Matthew Collier checks over Maya, who assures him that she is okay, other than a few scrapes. Alan Wiest is as shocked as everyone that Leo has worked there for years and people never know. Matt confirms that he deactivated his security clearance and tripled the guards around Maya; the police are checking the area as surveillance shows Leo leaving the parking garage. Riv rushes in, holding Maya. He looks from CJ to Matt, confronting him that Maya needed more protection but Wiest comes to his defense saying this is on LAPD who pulled the tail on her; promising to wake up the Chief and have them both shadowed until Leo is caught.

Ezra Wolf walks into his office with a cane, telling everyone if they stare at him they will become unemployed. He is surprised to see Sevvy in his office saying there was a bit of commotion in the office last night and Angela Ashley quit. Sevvy is busy looking through all the tips that came in, but Ezra said Angela was right that 18 million dollars will bring out all the crazies. Sevvy shows him the tip that could prove someone was lying, as there is video showing Jessica

Meyer getting into another man's vehicle. Ezra tries to convince him not to go astray and dark but Sevvy said it was after that trip that Jessica was acting distant and that is why he hired Buck Neal in the first place. Ezra says they will check it out, but Sevvy insists on going with Ezra to Las Vegas to check it out on his own, telling Ezra to figure out what to say to the judge because that is why he pays him the big bucks.

Maya thanks Wiest for having 2 units on her; he questions her about Julianne "Jules Johnson visit the previous night. She is willing to testify that she planted the jacket; Wiest shares that Wolf is trying to torpedo Gabe Johnson, showing them a signed affidavit from Star Johnson who insists Gabe followed her and Sevvy into the woods and assaulted Sevvy without provocation. Maya knows it is a lie considering there is no mention of a duffel bag at all. Wiest is concerned the jury may believe it as they already caught Gabe in a lie. Matt reveals he called the hotel they hid him in and he's been gone for two days; Wiest tells them this is a problem and they need to flip Star as their case is hanging on by a thread.

Maya arrives at Jules' place, not wanting to explain the police that is with her; Jules invites her in as Maya is about to ask a favor but spots Gabe in the backyard revealing she's been worried about him. Jules reveals he is staying with her now. Maya tells them both that Star is on record saying the bag never existed; Gabe swears she is lying. Maya tells Jules she thinks there is a way to fix this problem Wolf is causing; she wants Jules to get Star to come in and do a deposition admitting she was coerced into the statement but Jules says Star is her father's daughter. Maya reminds her if Star gets on the stand and lies, she will go after her for perjury. Jules is aware of the stakes with Gabe reminding her that Maya on wants Star to tell the truth; Jules agrees to do what she can.

Ezra is on the phone, getting permission for Sevvy to go to Vegas, but he worries going there could be Sevvy's demise as Maya's case is getting weaker and weaker but if they start turning rocks without knowing what is underneath is gambling. Sevvy is told he cannot fly, so they are taking a road trip.

CJ meets Detective Vincent North at Leo's house but it is futile as there is nothing that could lead them to find out where he went; no family and no friends. CJ sees the wall and scrapbook Leo created about Maya. They found some audio files, confirming they he planted bugs in the war room, her house and her car so he could know her every move. CJ meets with Maya and Riv, suggesting she lures Leo out by driving around and letting him find her. Riv wants to go in Maya's place feeling he is the bigger target because he is preventing Leo from being with Maya; CJ agrees, saying James Meloy can help as the LAPD is on their side now. Maya reluctantly agrees as both Riv and CJ feel this is their best bet.

Matthew meets with Effy and Brianna who is a political consultant Effy met the previous week. She let it slip that he is planning to announce his DA run soon. Brianna has a plan, saying the Johnson case has become a complete disaster, but he could resign and denounce Maya Travis and Alan Wiest for incompetence; then announce his running for DA with a plan to clean house at the DA's office. Matthew says she is blunt as Brianna says if he decides to do this, he can call her and she will get him there. Matt tells Effy that he will not do it as she calls him a loyal man, something she loves the most about him; he's already saved Maya once and there is no saving her so he should be thinking about himself now.

Riv and Maya know they cannot go back to the hotel, Maya suggesting to stay at a friend's place; giving explicit details of the spot as Leo listens in. They exchange I love you as she promises to be careful before exiting the car. She stands with CJ who says now they wait; Maya looks concerned.

Sevvy is fitted with a tracking device, saying he can only travel to and from Las Vegas with only one night stay over; any violation and he will go to jail. Wolf warns him that Maya will be able to track every move they make but Sevvy doesn't care as he only wants to know why Jessica went to Vegas. Sevvy promises to not let Wolf out of his sight to gamble, Sevvy taking the keys to drive.

Riv sits in the cabin with James, who encourages him to be patient. CJ checks in with them; Riv admitting he likes CJ as James tells him that she would kick his ass if anything happened to Riv. She handpicked the surveillance team outside, both frustrated that they have women who have the "I can take care of myself" mentality. Riv says he is a cowboy and chivalry will never be dead. Suddenly there is a noise outside causing both men to get up.

CJ is looking over surveillance of Leo walking down a hallway a few times in a week, both

thinking he has to be stashing something. Jame says there is no sign of Leo outside and it's probably the winds picking up but when there is another noise, James goes to check it out as Riv grabs a gun after being told to stay inside. CJ, in the meantime, checks the room at the end of the hall, finding a ladder and the bags Leo kept with him; inside is duct tape and blood on the ladder. Riv holds the gun checking the house, drawing it higher when he spots a shadow. CJ rushes in, relieved to see Maya, okay, revealing she found a murder kit and fresh blood in the basement. She is concerned that Leo is still in the building, Maya orders her to put the room on lockdown as she tries to call Matt. Unfortunately, Matthew is being tied up to a pipe by Leo, who says he has quit the fight in him; holding a knife at him.

After some coaxing, Leo says there is no helping him as something went wrong and it is too late. Matthew attempts to talk to him, suggesting he could arrange for him to talk to Maya. Leo says no one knows Maya like he does, listening to hours of her voice, getting to know the real Maya Travis and what she really was. He says Matthew knows deep down and all Leo wants to do is help her, taking risks for her but she doesn't care and there is a price for that. Matthew works on getting the rip ties off his wrists.

Riv calls out for James but gets a call from Maya who reveals that Leo isn't going to the cabin as he is still in the office. CJ walks down hallways with her gun drawn, following bloody finger-prints into each room. Leo feels Matt should be grateful because he and Maya have something special but Matthew denies it. Leo says he is a lucky guy because at least he knows Maya will miss him when he is gone. Leo lunges at Matt who is able to free himself and a physical fight ensues, but Leo is able to stab him in the stomach before CJ arrives and repeatedly shoots Leo.

Sevvy thanks Ezra for coming with him, but he tells Sevvy they can't stay at the MGM as he has been banned. Sevvy has to ask if there is a place he hasn't been black booked for life from most places but he does have a plan.

Maya rushes after Matthew who is being taken away by EMS, who is hurt but says he will live. Matt denies Leo saying anything, saying it is over since Leo is dead. Maya stops herself from saying something, but Matthew says, "I know. Me too!" before he is loaded into an ambulance while Maya sheds tears. CJ is put on administrative leave, fretting that she killed someone but Maya assures her she is a hero for saving Matthew's life and probably hers too.

Star feels like she is being ambushed when she arrives at Jules' place and sees Gabe and Samuel Johnson at the table. She apologizes, saying she cannot do this. Gabe isn't mad at her, telling her that this whole thing has screwed the both of them. Jules encourages her to stay and make peace as Sam says this is just dinner and the best families always learn how to solve their problems. Jules prays as Star and Gabe stare each other down.

Ezra comments how Vegas feels like home, but Sevvy says a place that steals your money. A knock at the door brings Ezra to saying he hopes this brings the right people. He opens the door to Stephanie Reynolds who confronts Ezra about being in her hotel. He wants a favor but she gives him 90 seconds to clear the room. He shows her Sevvy, saying that he is on trial for another murder he didn't commit and it looks like this casino may be implicated, revealing Jessica Meyer spent a weekend there and it might be the very reason she was murdered. Stephanie knew it was going to be a bad day, so Ezra asks her to dig up the footage of Jessica and he promises to keep it out of the news

Maya returns home, where Riv is happy to see her; Matthew is in surgery but Maya feels this nightmare of a day is over with. Riv says the day had him thinking about a few things and their future. He produces an engagement ring, saying after all the insanity, their future hasn't been more clear. He feels this case has taken too much from her and wants her to put it in the past so they can have their future on their farm, forever. He gets on one knee asking if she will marry him, she smiles and he isn't hearing a yes. He doesn't want her to say it. She has thought about it but can't just leave as this is her work. Riv reminds her that it used to be a part of her but now it is all of her. He feels she is being destructive, causing her to tell him that he clearly doesn't understand her at all. He says he is in the wrong place and leaves to go pack his bag.

Jules talks to Star as they do the dishes together, saying it was nice tonight even though Sevvy couldn't be there. Jules reminds her that lines have been drawn and she can no longer protect him; as Star needs to stop too. She reveals that she knows her and Gabe are telling two different stories about the woods. Jules is trying to unburden her daughter, asking what really happened.

Star breaks down, saying she didn't know what to do, Jules pushing her to talk about the bag

as Gabe listens from the hallway. Star tells her to stay out of it as Jules tells her Gabe told her there was evidence in the bag she burned. She realizes her mother is recording her and Gabe says it is not a trap, they just want dad to pay for what he did. He reminds her that Jessica was her friend and they should do the right thing for her; Star calls the entire family toxic and rushes out of Jules' home.

Sevvy is anxious as they wait for word from Stephanie. Star calls her dad, telling him that she is done with all of it. She is not going on the stand for anyone, not going near the trial and she is done with this family forever. She hangs up on Sevvy before he gets a chance to respond. He tells Ezra that Star won't testify but Ezra isn't worried, saying they will get her back. Sevvy is upset that Star said she hated him, but Ezra says he hasn't spoken to his daughter in 6 years and their kids can only hurt them if you love them but if you don't, they don't care what you do; as he knows.

Their chat is interrupted when Stephanie returns, showing them the security footage where Jessica is being picked up Andre Spencer who runs the tactical shooting club; who trains clients with deep pockets. Sevvy had no idea since Jessica hated guns, claiming to him that she never shot one in her life.

Sevvy and Ezra go to the gun range as Sevvy demands to know what he was doing with Jessica. Andre figured someone would come eventually, admitting he is a big fan of Sevvy. He says they took care of her, surprised Sevvy didn't know about it. He shows them footage of Jessica who bought the whole place out, saying she needed her training to be quick and private. She said it was for a part in a movie, but it shows she was a quick learner, handling the firearms with ease. She specifically used the same type of gun they had at home, next to the bed they slept in. Sevvy is shaken, thinking Jessica was planning on killing him.

She reveals the only reason Maya is there is because Effy convinced Matthew to bring her back so she could take the fall if this case went south. Effy informs her that Matthew is planning to run for DA and all Maya is to him is political cover. She returns to Matthew's room as he is watching the news, but Effy turns it off reminding him its not worth the spike in his blood pressure. Matthew tells her the surgeon said he was lucky as it was only a deep laceration. She tells him there is a wave of public sympathy for her and he should take the moment to announce his candidacy. He wants them to take a moment to think about what they really want. She is scheduling a press conference and they can do it right from the hospital on Friday.

Maya grabs a bottle of whiskey, listening to Jules' message about Star not helping them. Maya sits down to review the file again but quickly closes it to open her laptop, watching Jessica's video of Sevvy abusing her. Maya suddenly notices something off with the video. Meanwhile, Sevvy can't comprehend that Jessica was planning on killing him to take all his money. He doesn't understand why she was training to be an assassin and Star is right as he didn't know who he was living with. Ezra stops when he suddenly realizes Sevvy might be innocent. Maya shows CJ the video again, both seeing there was a shadow and someone else was in the storage unit when she made the tapes. A computer is playing the video where Jessica made a mistake, as she forgot to say Sevvy's name specifically; the hidden person deletes the video.

asking to speak to Sevvy in private; Gabe takes Sunny to the beach so they can talk.

North informs Sevvy that Jessica Meyer was killed that morning, leaving Sevvy devastated as he was just making her breakfast. North continues to tell him that she was at the beach to meet a client; cause of death appears to be blunt force trauma and it appears she was murdered. Sevvy breaks down, but North wants him to come down to the station so they can ask him a few questions.

In the present day, Maya Travis wakes up on the couch to find Ezra Wolf at her front door. He comments on her rough night, as she comments about him walking with a cane. He says they need to speak off record and would appreciate if Riv Allgood wouldn't interfere; shocked to learn that Riv is gone. She demands that he get to the point and he informs her that he firmly believes that Sevvy didn't kill Jessica. He hates nothing more than having an innocent client ending up in prison; they torture him and that is why he is there with "hat in hand". She allows him to come in to speak to her.

Effy is at the hospital to escort Matthew Collier home, reminding him they talked about this being the perfect time for him to announce that he is running for DA. Matthew is furious that

he had told her he was not ready; she orders him to get ready and pushes him out the door. Matthew informs the press that he is not making an announcement but simply wants to thank CJ Emerson for saving his life.

At home, Sevvy is busy going through paperwork, when he finds an unopened envelope from Praw & Wilson Law Firm; a letter that shocks him. Meanwhile, Gabe is doing laps in the pool as Julianne "Jules" Johnson watches him from inside; smirking. Ezra makes breakfast for Maya, but she knows he is stalling. He reminds her that everything he is about to tell her is privileged as she questions about his legal ethics. Wolf reveals that the trip to Vegas proved that Jessica was practicing shooting and planning on killing Sevvy; Maya thinks she was scared of him and wanted to protect herself. Ezra shows her the video and Jessica definitely doesn't look scared but it looks like she had an agenda and he believes someone was helping her. Maya reveals that she watched the tapes made again and she thinks she saw a shadow feeling someone was in the storage locker with her. Ezra and Maya agree to find out what is going on but have no problem revealing what they find in court.

Alan Wiest meets with Brianna Dear whom he welcomes, confronting her on whether Matthew was hiring her. She says she only gave him some advice but refuses to share with Wiest unless he pays. She tells him all about the strategy she made for Matthew and it would work for him too.

Maya and Ezra go to see Star Johnson who is pissed to see them but more curious about why they are together. Maya tells her about the tapes and thinking someone might be with her. She reminds them if Jessica was cheating on her dad, she never would have told her. Maya thinks the person was part of the puzzle as Star denies her accomplice would be her mother because Jules only saw Jessica as an obstacle to Sevvy's money. She informs a shocked Ezra that if Sevvy goes to jail, Jules gets control of his entire estate.

Sevvy arrives at Jules' place, apologizing for the other night but feels that nothing was like he thought it was; Jules agrees with him. When asked, Jules tells him that she desperately loved him; which briefly makes him smile but as he is walking away he confirms that he knows everything. She apologizes that everything ended this way.

Maya and Ezra return to his office, where he shows her everything Buck Neal got on Julianne. Mayas remind him that Julianne has an alibi but he says that can be faked. His theory is that Julianne set up Sevvy for Jessica's murder so that she could get the money; he does admit that she is a master manipulator. He wants her to get a search warrant but Maya knows that it would destroy Jules' credibility as her star witness but Ezra reminds her, so would a Murder 1 charge! She doesn't think they will find anything but agrees they should look, asking for a couple of hours.

Maya sits with CJ explaining everything, but CJ is extremely hesitant to work with Ezra Wolf. Maya feels she needs to know who that shadow is and if Jessica was really planning on killing Sevvy, that makes her question everything; even whether he did it. CJ is surprised that her prime suspect could be Julianne. Maya needs something from CJ that isn't quite legal.

Sevvy is playing with Sunny on the beach, running into the waves when Star arrives on the beach. Sevvy tells her that Star is going to take care of her for a few days and is asked to gather her things. Sevvy thanks Star, telling her that he loves her. Star simply tells him that Sunny can stay with her for as long as he needs and walks away with her younger sister.

Ezra brings his team together, firmly believing that Sevvy Johnson's nightmare is going to end as he is working with someone and it is the time to begin preparing a motion to dismiss. Charlie runs into the conference room, turns on the TV saying the DA is making some announcement on Sevvy's case. Everyone turns to listen as DA Wiest informs the media and Ezra quickly messages Maya to find out what her boss is doing; something she had no idea about. Wiest informs the press that the Sevvy Johnson case was tragically mishandled, placing blame on Matthew Collier and Maya Travis; claiming they both have a blind vendetta against Mr. Johnson, something that is blinding them. He says he has no choice but to drop the charges on Sevvy Johnson and dismissing the case; Ezra feels he stole his thunder as Maya is left shocked.

Maya barges into Wiest's office where Matthew is already arguing with him; she joins in screaming that he cannot dismiss her case without consulting her. He reminds her he doesn't need anyone's permission. She says that wasn't a press conference but rather a character assassination; this is about him and his election but the people in the office know what he did and no one will respect him for doing this. Maya insists this is still her case and she will handle this.

Matthew follows her outside where she confronts him that this is exactly what he planned to do to her. When he acts surprised she reveals that Effy told her all about it. She orders him not to come to court with her as she doesn't want him there.

Jules walks into the kitchen, informing Gabe that the DA is dismissing the case; and there is nothing they can do as they lost. She tells Gabe it is time for him to find a place of his own. CJ watches as Gabe leaves the house, taking a photo of the entry code, she waits for CJ to leave as well before she enters the house.

Sevvy is at home when he sees the news revealing he is about to be in court, where it is expected that the prosecutor will dismiss the charges even though Wiest insists the case will continue. Sevvy stands with his son, Severen Johnson as they leave for court.

Maya walks in, Ezra saying he really didn't want it to go down this way as he wanted to beat her in a fair fight; together they walk into court. When Maya spots Wiest in the courtroom, she privately tells Ezra that he was never a target and it was Wiest who made the whole thing up and got Loni Kampoor to convince him. Ezra tells Sevvy this is a great day, something he always knew was coming. Judge Sandra Song arrives in court, saying they are there on the people's motion to dismiss; Sevvy stands up, saying he is firing his lawyer and wants to represent himself. He is also changing his plea to "guilty!" Ezra shouts at him, demanding answers as the courtroom erupts in confusion.

In his holding cell, Ezra tells him that he had this but Sevvy feels he had to do the right thing. Ezra knows he is protecting someone but Sevvy says he cannot stop him from doing this. Ezra promises to find out the truth but Sevvy tells him this is his choice even though Ezra has been the friend and support when he needed one but this is done.

Maya is sitting in the courtroom when Matthew walks in to sit beside her. He congratulates her on getting him as Sevvy Johnson will spend the rest of his life in jail; something they have wanted for 8 years. She disagrees on "doing this" and feels hollow. She thinks it doesn't always work out the way they feel. Matthew is sorry for everything; for a while, he lost sight of who he really is and decided he isn't going to run as DA or work as Chief Deputy because he wants to go back into the courtroom; something she was right about. He feels he belongs there. They are interrupted when Maya gets a text from CJ who has found something and wants her to meet in the parking lot. CJ shows Maya a journal, but after she reads it she has no idea what she is going to do.

Maya walks on the beach and sits beside Gabe; who wants to know what she is doing with his mom's diary. Maya admits they found it in his bag at Julianne's, only wishing they had found it 8 years ago. She wants him to help her understand why he killed Jessica?

4 Months Ago... — Gabe is given a letter from Cassandra Johnson. His mother had given some items to a law firm for safekeeping after she divorced Sevvy, and when she died they kept them until he is 21. Inside is a set of keys, they need to itemize the things as he removes them, one of the items being a green journal. Gabe spends nights reading it when Jessica comes out to see if he is okay. He hands Jessica the journal, revealing it was his mother's. Jessica is shocked but Gabe wants to know if that is the part where Sevvy choked her, or when he punched her for not coming home and not calling. Gabe demands to know from Jessica if Sevvy does that to her and she shows him the bruises on her arms.

Present day — Gabe tells Maya that the abuse had been going on for months; but every time Jessica thought about leaving him, it didn't work well for his mother. He admits that he doesn't know whose idea it was to kill Sevvy; determined to make it look like self-defense. They even had witnessed in Julianne and Ben Mitchell to back up their claims. He goes into details about the tapes, saying they were his idea but Jessica is the one who knew about the gun and could use that to kill him but right before she was set to do it; they took some trip and he did some kind of magic therapy and she decided their relationship was better than ever.

Gabe says his mom had great months with Sevvy too but then things would change. Gabe simply wanted to talk to her, trying to convince her that Sevvy isn't just going to stop. She told him on the beach that the plan is off as Sevvy has actually changed. Gabe throws it in Jessica's face that Sevvy murdered his mom but Jess doesn't want to go through with the stupid plan. She tells Gabe the plan is over and she is calling Sevvy; which enrages Gabe who hits her hard over the head. He never intended to kill her, he lost control but when he saw her lying there he knew to use Sevvy's towel that had sweat all over it. He cries that she didn't deserve to die.

Sevvy is escorted to a room where Maya is waiting. She tells him that she cannot let this stand and will file a motion to vacate the plea, as he didn't kill Jessica. He leans in, admitting he killed Cassandra and Nancy. Maya says that is over, but he insists it isn't because Gabe finding out about his mom is what started all of this. He kept waiting in the last trial for the words to damn him 8 years earlier but it was kept quiet. He figured out it was Gabe when he got the letter from the lawyer and everything made sense. He needs Maya to understand that this is Sevvy's fault but she reminds him that Gabe murdered the woman he loved but Sevvy says it is because he murdered Gabe's mother. Everything that has happened is all Sevvy's fault, so he begs Maya to let this stand. Maya wipes tears from her eyes.

Maya holds a press conference, revealing Sevvy Johnson killed his wife, Cassandra and Nacy 9 years prior and today he pleads guilty to the murder of Jessica Meyer. She pauses, saying Mr. Johnson will spend the rest of his life in prison where he belongs as today justice is finally served. She hopes this brings the family some peace. Ezra is at a bar when Loni sits beside him; he tells her that Maya will never be able to live with herself; she won but she didn't beat Ezra. He suggests they don't rehash the past and his firm needs fresh blood and he knows she is in need of a job. She realizes he wants to screw over Wiest but he reminds him that she is really good. She writes on a napkin, saying she is worth every penny. He offers his hand and welcomes her to wolf & Associates.

Star is putting Sunny in the car when Julianne arrives. Star says they are leaving, taking Sunny away from Jules and wanting to give her something normal. Jules insists everything she has done is for her and her brothers, only wanting them to be happy. Jules tells Sunny she is going to miss that face as Star gets her into the car; without another word to Julianne.

Sevvy is in the prison yard when Gabe comes to see him. Sevvy thanks him for coming as he simply says Maya told Gabe he should. Sevvy wants him to promise that he will make this all mean something and put it where it really belongs — on Sevvy. He needed Gabe to hear it, wanting him to know he is there for the rest of his life for what he took from him and the pain he caused him. Sevvy insists that Gabe live his life, but he has no idea how to do that. Sevvy suggests he wake up every day and start again.

Maya and Cj are clearing up the boards from the war room as Ezra sits at the local bar, playing the piano. Wiest sees what the women are doing and doesn't say a word but CJ confirms to Maya that she did the right thing. Matthew is at home, packing his stuff as he is leaving Effy. Jules walks into Sevvy's house, now that she owns everything, puts her hands on her hips and overlooks the city. Sevvy is brought to his cell, hearing the heavy doors slam behind him.

Maya walks down the stalls, finding Riv brushing one of the horses. She looks him in the eyes and says, "Yes!"
