Summary: As Grace navigates the aftermath of Sandy's suicide, his newfound son

Bruno, and a profound personal loss in his and Cleo's life, his team is called to a Sussex beach when an unidentified male body washes up dead in a barrel — the very same morning sees a Brighton football stadium receive a chilling anonymous demand and be faced with an impossible decision. Roy, who is at a match there bonding with Bruno, now finds himself locked in a frantic race to save hundreds of lives.



Something is shown floating in the water near some windmills. Later, a woman finds a barrel containing a body. DI Glenn Branson calls Ari from the crime scene and says DSU Roy Grace has finally taken a weekend off. As for Ari Branson, she's on lates again and they're down to two nurses on a ward of 20. DS Bella Moy tells Glenn about the victim after his call ends. Dr. Nadiuska De Sancha believes the victim suffered a broken neck. She also notices the smell of bleach. Glenn wants to know who supplied the barrel.

Driton orders people to get into a van. Laura tells a woman not to worry and just stay close to her. Driton stops the woman and tells her the boss has something special for her. Elsewhere, Kipp Kavinda tells Frank Kavinda it'll be good to spend some time together at the game. Frank gets upset and leaves in a hurry.

Dr. Zara Kavinda jokes that their morning went well. Margot Balkwill says she packed a bag for Bruno. She tells Roy that he likes the light on at night because it helps with the bad dreams. They talk about Cleo who is broken. Margot says no one should have to lose a child. Roy is going to take Bruno on a trip. Dren tells Kona she can get them out sooner than they thought. She just needs to do something for Baloz. Then, they can have their freedom and passports back. Kona reminds her that they cannot trust Baloz. He agrees to get out of there as soon as she has the passports. Kipp and Frank continue arguing at the stadium. Frank decides to sit elsewhere. Meanwhile, a powdery substance is placed inside a camera battery. Allegra tells Dren to take a seat when she arrives. Noel Ludlow catches up with Frank at the stadium. Noel says they should find someone to buy them a pint.

Patrick Morris receives a call while he's at the stadium. Allegra tells him that Brighton Royal Football Club will transfer two million pounds into an agreed account by the end of today's match. Otherwise, an explosive will detonate on the final whistle. She warns him not to try to evacuate the stadium before the end of the match. Dren makes it through the security gate. Roy and Bruno are at the game as well. Glenn receives a call about the bomb threat at the stadium. DC Nick Nicholl is told to let upstairs know about the bomb threat. After getting a drink, Frank and Noel head to their seats. Dren goes to the bathroom. Glenn and the others prepare to head to the stadium. Dren finishes assembling the explosive device in the bathroom. Then, she finds her seat and sits the bag down. Dren sends a photo to Allegra to let her know she's done it. The threat is sent to Patrick Morris. Glenn and the others meet Patrick moments later. Glenn tries to call Roy. Kipp is escorted out to see Morris.

Kipp is introduced to Glenn as one of the investors. Glenn explains it likely isn't a good idea to pay the ransom. He wants time to find the explosive device. Glenn calls Cleo to ask if she knows where Roy's season ticket seats are. After she helps, she learns about the bomb in the stadium. When Cleo can't get in touch with Roy, she rushes out of the house. Frank ignores his father's call. Dren notices dogs walking around with police officers. Roy notices Glenn nearby. He catches up with him and learns about the threat and the body found. Roy wonders if the victim had been working in a lab or a bomb factory. TATP could be confirmed as part of the device today. Nick is tasked with looking after Bruno for a while. Roy speaks to Patrick Morris. Dren becomes concerned as the dogs get closer. Cleo goes to the stadium to get Bruno. She tells Roy to let her do this. As time begins running out, Kipp believes they should pay the ransom. Allegra calls Morris and says she expects the money to be transferred in the next 25 minutes.

At home, Bruno tries to get answers from Cleo. He asks if there's going to be an explosion before running upstairs. Allegra tells Dren to plug in the connecting cable and get out of there. Roy happens to notice Dren fiddling around in her bag. He sends the units toward her. Dren tries to get out of the stadium. Roy finds the explosive device. He picks it up and carries it away from the audience. Roy takes the bomb outside to a technician who can deal with it. Dren hears an explosion behind her. The EOD technician confirms the ignition of the TATP was successful. Later, Roy tells Bella they were lucky today. A van seems to be following Frank and Noel. Seconds later, they are kidnapped by masked men. Roy calls Cleo to tell her everyone is fine. She tells Bruno who comes out of his room and sees the nursery. Roy and Glenn watch CCTV footage of Dren leaving the stadium. Roy wants to release a picture of her to the press. Dren catches up with Allegra and asks for their passports. Allegra tells her she's not done yet. Dren flees.

The masked men search Noel and Frank who no longer has his phone. Cleo plays a game with Bruno. Bruno asks if Cleo is a mother. Cleo says she was for a bit. He touches her hand to comfort her. Meanwhile, Nick and the others try to track down the bomber. Glenn points out that Semtex couldn't make it through security. They begin looking to see if anyone could've helped her. Roy says they should get some sleep. Glenn urges him to speak to Bella who wants to work a little longer. Roy talks to her about getting a new recruit in. Bella insists she's fine. She convinced Roy to leave. Roy makes it home where he finds Bruno already asleep. Cleo immediately checks on him. Roy says he could call Sandy's parents to come and get Bruno. Cleo says she wants to be there for him, but it is a reminder of what she doesn't have. Zara and Kipp talk about Frank who hasn't returned home. Zara wants to call the police. Kipp says the police's priority is the bomber and not a moody teenager. Dren calls Kona to say he was right. They were screwed and they still don't have passports.

Frank tells Noel he shouldn't even be there. He believes the kidnappers are after his dad's money. Nick and Bella look at CCTV of a van. They go to the scene and find Frank's cell phone. Meanwhile, Roy and Glenn talk about Kipp who is loaded. They speak to Kipp and Zara about the kidnapping. Roy mentions a text from a contact saved as Dalek around 11:30. Zara says Frank keeps to himself and doesn't bring mates home. Kipp explains that they had an argument so Frank changed seats. Kipp receives a message from the kidnappers who want one million pounds sent to a crypto account. Zara immediately wants to pay the ransom. In private, she tells Roy about a hit-and-run that killed their daughter Kayleigh and ripped their family apart. Zara believes losing Frank would finish her. Driton and Kona talk away from the captives. Kona insists it hasn't arrived. He's convinced they will pay though. Bella tells Roy that the female who made the call to the stadium was Albanian. The callers were analyzed and there is no evidence the caller was inside the stadium.

The caller and bomber are different individuals. They also believe the man on the beach was involved in making the bomb. Nick says the bomb's detonator contained TATP consistent with chemical traces found on the unknown male. Nick and Bella try to speak to members of the Albanian community. Laura sees them and notices the flyer. She tries to avoid them. Laura calls Dren to tell her the whole country is looking for her. She tells her that Kona didn't come back last night and Allegra is asking questions. Kona and Driton get tired of waiting for Kipp to pay. Noel is pulled out and bashed by Driton. Kona eventually stops the attacks and puts Noel back into the storage container with Frank. Dren meets Laura who tells her to run. Allegra has her kidnapped. Dren is thrown into a cage and told it wouldn't be a good idea to leave now. Allegra calls someone to let them know they have her. Glenn tells Roy that Frank's friend is Noel Ludlow.

He's a new student at Preston Grove College. His nickname is Dalek. Noel's parents, Joseph and Elena, are questioned. Elena says her son texted her to say he was going to stay with a friend over the weekend. Roy tells them the kids were taken before the text was made. Joseph claims not to recognize Frank. Roy suggests Noel was in the wrong place at the wrong time since they haven't received a ransom demand. At the station, Nick informs Roy that a black Vauxhall van was reported stolen three days ago. It has new plates now. Glenn says Kipp's business is on the verge of insolvency. He has continued to ignore his lawyer's advice to file. Bella says the report is in for the FLO at the Kavindas'. Kipp has gone missing. Kipp finds Noel badly beaten. When Glenn and Roy arrive, they're shown a threat saying Frank will be bloodier. Roy believes Kipp has jeopardized the entire operation by coming up there alone. Kipp has to tell them something if he wants them to find Frank. Glenn mentions his business being on the brink of insolvency.

Kipp admits that no one knows even Zara. He hasn't been at his best since Kayleigh died. Next, Roy wants to clone Kipp's phone and check his company's records. Frank is given a bottle of water. Kona and Driton talk about what they should do next. Kona is told to burn the van.

Noel explains what happened when he was blindfolded and abducted by people wearing masks. Roy asks if he recognizes their voices or accents. Noel says they were concerned about getting their money from Frank. He says one became stressed and hit him. Elena Ludlow comforts him. Joseph Ludlow stresses the need for Noel to rest. Elsewhere, Laura Kristo scans The Argues article about a male body found on the beach. She weeps while looking at a photo of her and what appears to be the man together. At the police station, Branson goes over the case with the team. Nick points out an area on a map where the tests sent to Kipp came from. Roy says they will make it the target of their search. A short time later, Laura tells Bella that Baloz "Sea Monster" delegates tasks to them if they refuse, their families in their home countries are threatened. She claims Zenith Evangjeli was delegated a task that he refused to do. At the police station, Nick informs Roy and Branson of a burnt Vauxhall van being discovered between two farms, one of which is abandoned, in a search area. At the morgue, Laura identifies the body found on the beach as her fiancé, Zenith. Bella informs Roy and suggests Zenith was ordered to plant the bomb but refused.

At the scene, Joseph tells Roy and Branson that he wants to take Noel home. Roy insists he stays. Elsewhere, Bella and an armed tactical team raid a worker's house. At the scene, Noel confirms the farm is where he and Frank were held hostage. Frank's shirt is discovered in the farmhouse. Elsewhere, Bella discovers fake British IDs and documents in a safe. She notifies Rov of undocumented Eastern European nationalities. A woman claims the bomber shares a flat with her brother. In the back of a moving van, a stressed Frank is restrained with a rope. Kona speeds down the road. Elsewhere, Driton watches people climb into a police van. He ignores a call from Baloz and an incoming text pops up on his phone. Baloz demands he meet him at Dials Way Car Park in an hour. At the police station, Branson tells Roy that Kipp has been working with Merida Blue which owns the worker's house and possibly employs Baloz. He questions if Kipp knowingly did it. Roy reminds him that Kipp was involved in organized crime. Nick and Bella barge in and show them photos of Laura working at the stadium several days before the bomb threat. A short time later, a weepy Laura claims to have believed it was drugs. Roy says Zenith developed the TATP explosive for the bomb. She believes he did it at a location in Brighton. He shows her two fake British IDs. Laura identifies them as siblings, Kona and Dren Dashvilli. She claims Kona disappeared on the day of the bombing and Baloz took Dren. Roy shows her a photo of Frank and Noel. She recognizes Frank as the son of Baloz.

Lena finds Joseph packing his laptop and files. He says they are leaving Brighton and goes outside to find Kipp in his car. Joseph scolds him for coming there and admits to destroying his

phone after the bomb. Kipp asks where is Frank. Joseph blames him for his two million-pound loss. Kipp accuses him of lying about the bomb being fake. Joseph assures him that was never his plan and recalls he promised the club would pay to protect their fans. Kipp apologizes for the club refusing to pay and pleads for Frank's return. Joseph threatens him if he doesn't leave. At the police station, Nick tells Roy that Kipp's phone is clean. Roy suggests he has another phone. A short time later, Branson serves a search warrant at the Ludlow residence while Joseph is out. Elsewhere, Kipp tells Bell and Roy his portfolio liquidation wasn't enough to clear his two million-pound debt. Roy asks if Joseph blackmailed his club to recover his two million pounds. Kipp admits to planning the scheme with Joseph. Zara criticizes him for putting Frank in danger. He claims Joseph said the bomb was fake and he is holding Frank hostage. Refusing to hear anymore, she walks away. Roy orders him to stay put before leaving.

At the police station, Roy fills Branson, Bella, and Nick in on the case. Branson believes the kidnappers received a tip of the impending raid at the farm. Roy orders a search of Joseph's real estate properties. At a parking garage, Joseph jerks Driton out of his car and demands to know why Noel was beaten. Driton claims Kona forced Noel into the car and beat him. Joseph demands to know where Frank is being held. Driton says he is at the farm. Joseph claims to have sold the farm that was raided by the police. Elsewhere, Kona receives a text from Dren warning the police are onto to them and they need to leave. Allegra sends Joseph a text confirming he took the bait. She and the others start cleaning up the old factory. Elsewhere, Kona demands Frank tell Dren that he has been treated well. Frank agrees. Kona promises it will be over soon when Driton approaches and hits him with a tire iron. Following Joseph's orders, Driton restrains Frank under Newhaven Pier. Joseph snaps his photo and shares it with Kipp. Frank struggles against the restraints. Joseph and Driton leave. At the police station, Roy tells his team about Frank's photo sent from the phone utilized in the blackmailing.

Driton drags an unconscious Kona into the old factory. Allegra pours a flammable liquid throughout a building. Dren pleads with her not to do it. A man ignites it. Dren manages to escape but finds Kona trapped in the building. She tries to force the door open when it explodes, sending her flying across the room. At Newhaven Pier, Frank struggles against his restraints as the tide comes in. At the police station, Branson shows Roy a photo of Kona. Roy suggests Noel tipped him off about the raid. Bella alerts them of the factory fire. Nick says the owner is Joseph. At Newhaven Pier, Driton warns Dren to stay away from there. Irate, she blames Joseph for Kona's death and ends the call. Joseph catches Driton using his phone and shoots him. On a stolen motorbike, Dren races to the pier. At the old factory, Bella notifies Roy that the body has been identified as Kona. She suggests it was utilized to build the bomb because explosive substances were found. She says Dren left the scene on a stolen motorbike. Elsewhere, Roy informs Noel of Kona's death. Upset, Noel admits his part in the extortion scheme. Roy orders him to call Dren.

Noel calls Dren and says she's sorry. He says he wants to help. Noel blames himself for what happened to Kona. Dren says it was his father. Glenn tells Roy that Dren is at Newhaven Port, East Pier. Dren grabs a weapon and confronts Joseph who has a handgun. She dodges a bullet and attack Joseph. Dren continues bashing him until she picks up the gun. Roy arrives and orders her to drop the gun. He worries that Frank is going to drown. Roy knows that Joseph killed her brother, Kona. Dren eventually throws the gun into the water. Roy jumps in to save Frank and Glenn rushes to help. During the chaos, Dren manages to escape. Nick and Roy drag Frank to safety. Allegra is taken into custody. Frank is reunited with Zara and Kipp. Now, Frank is okay with his daddy. Glenn finally decides to arrest Kipp who is given more time than necessary. Noel tells Elena that he had to do something. They leave with a police officer. Roy tells Bruno about the fish, Marlon, that his mom won at the fair.

He's returned to Margot a bit later. Dren is still walking free. Cleo tells Roy that she felt useful with Bruno around. She doesn't want to hide what has happened. The reminders are everywhere. Cleo feels stuck and misses having a purpose. Roy asks if she's ready to go back to work. Cleo says yes.

Summary: When a man is found dead in his hotel, the scene reads like a crime

of passion — the room was paid for in cash and booked in the name Travis Simmons. Travis has no ID and no bank cards — when Grace discovers a burner phone, he suspects that his victim was meeting someone in secret. When things don't quite add up and Grace realises that something in this case isn't what it seems, the team is thrown into a world where a tangled web of mistaken identity leads to a painful

secret.



As the episode begins, Emily Harton and Toby Seward are together at a motel. Emily tells him she needs to go. Charlotte Seward watches Emily when she leaves the motel. Toby looks at his phone. When Emily gets a call, she tells the caller that they've already said this. It appears Emily goes back inside. Jarvis Brookes gets a call from Toby who calls him gorgeous. Jarvis hopes he's booked his tickets because it's time they met face to face. Charlotte walks into Hotel Lenore. She bangs on the door and yells for someone

to open the door. A hotel assistant tells the duty manager that a woman is kicking off outside the Fairmont Suite. Charlotte leaves the motel crying. The workers check on Mr. Simmons in the Fairmont Suite and find him dead. DI Glenn Branson says the room was booked under the name Travis Simmons.

He's been a regular at the motel for the past six months. He always gets the same suit and always pays in cash. Glenn tells DSU Roy Grace about the woman who was banging on the door. They have a possible burner phone for Mr. Simmons. Roy wants to find out who he was.

Elsewhere, Georgina Driver reads messages from the same man and cries. Mr. Simmons has sent her a video message claiming they're soul mates. Roy drops off Cleo and informs her he has another murder victim. Cleo returns to work. At home, Glenn checks on Ari who seems to be distracted by something. Ari rushes out and says they're short staffed again. DS Bella Moy watches the new recruit, DC Vee Wilde, park in a CID only spot. Bella tells her she might want to consider a different parking stop. Vee tells her to mind her business. A bit later, Roy welcomes Vee to the board and says she'll be working with Bella.

They talk about the women who visited Travis Simmons last night. They discuss how Emily returned and likely took the stairs. Roy and Glenn agree it seems like she's not trying to be seen. Then, they talk about Charlotte who was reported by Mr. and Mrs. Tanner. Glenn believes Emily took the fire exit and exited onto a side street. Both women had a window of opportunity to kill Travis. DC Nick Nicholl is asked to get digital forensics to hurry on the burner phone. Vee and Bella keep butting heads. While working, Cleo gets a reminder about her upcoming maternity leave. Vee tells Roy and the others that she found a hotel room key in Simmons's trouser pocket. It's for The Brighton Central Hotel. Georgina Driver deletes all of the photos of Travis. Grace confirms that Simmons's real name is Toby Seward. He was a manager for Levinson Logistics. Glenn suggests Toby has been doing this long enough for a wife to find out and to do something about it. They find out that Toby's vehicle has been bashed.

Nick calls to tell Roy that Toby's home address is in London. He has two kids and his wife's name is Charlotte. The babysitter told Nick that his wife is visiting Brighton. Georgina contemplates calling 999. At the station, Nick tells Roy and Glenn that the only number in the burner phone was for Emily Harton who works at the same company as Toby. She's in Brighton as well. She has a hotel reservation in her name but she's not there. Charlotte pulls a piece of glass out of her hand. Vee is busy complaining on the phone when ACC Cassian Pewe enters to speak to everyone. Cassian tells everyone that the Chief is authorizing the creation of a new OCG task force. Roy speaks to Cassian in private about being stretched already, but Cassian explains that upstairs has said this is a priority. Cassian claims he's concerned for Roy's wellbeing and suggests stepping back if necessary. Roy tells Glenn about it moments later. Glenn says they picked up Toby's wife. Charlottes identifies the body. Cleo tells Roy that they found hair samples from two sources.

During an interview, Charlotte admits she followed Toby because she wanted him to know he was caught. She waited for Emily to leave before going up, banging on his door, and shouting. Charlotte admits she cut her hand. Roy suggests she did it on the broken glass from the coffee table. Charlotte denies that and blames a car. She confesses to bashing Toby's car. Charlotte insists she didn't want to kill him. Bella tells Roy and Glenn that Emily is being brought in. Vee asks if she can sit in. Roy tells her maybe next time. Ari is brought in to speak to the medical director and the head of surgery about her treatment of Beth Dankworth. Ari says she presented with sepsis so she prescribed an initial IV infusion of 500mg of amoxicillin. Beth had an adverse reaction. Ari insists it was just bad luck. She is asked if she knew the patient was allergic to amoxicillin. Although she says no, she's told it was clearly logged in the system. The report indicates the patient was allergic to penicillin.

Ari insists there was no allergy recorded. They try to convince her to admit to something so they can work together. Ari is told they'll do a full investigation. She's suspended pending the outcome. She's told not to try to get her story straight or anything like that. Emily tells Roy and Glenn about her relationship with Toby. She insists Toby was fine but irritated when she left. Emily says she was needed on a video conference. She denies returning to Toby's motel. Emily is adamant she didn't return to the motel. Roy notices something when watching the video with Bella and the others. They determine that it wasn't Emily. It must've been someone who disguised themselves to look like her. Roy says three women visited Toby that night. Cleo and a coworker have to deal with a woman who has hung herself. Jarvis has flowers and a sign welcoming Hans home. Glenn confirms the third woman was in the pub last night for a couple of hours.

Her name is Georgina Driver. Glenn tells Roy that she's a suspected suicide. Jarvis sees a picture of the dead man in the newspaper. He goes to the officers of The Argus and accuses them of writing false stories. Glenn tells Roy that Georgina was an investment banker. Her DNA matches the hair sample and skin samples from Toby Seward. Roy and Glenn check her car. They find the disguise she used. Roy hopes there's something on her laptop. They find a possible suicide note. Bella tells Roy that the brother is there. Tom Driver insists there's no way Georgina

would've done this. He says she doesn't even drink. Tom doesn't know Toby. Then, Roy and Glenn speak to Georgina's PA, Aisha. Aisha says Georgina made some mistakes and was let go. She believes Georgina was distracted by her boyfriend Arran. Aisha believes he's in the army overseas. It went wrong about a month back and Georgina said he wasn't what he seemed.

She confirms the picture of Toby is Arran. Jarvis returns home and gets his mail. He gets a final notice from his energy company. He tries to speak to Hans in the video game but doesn't get a response. Glenn tells Roy that Georgina started making a lot of bank transfers recently. She's having money troubles now. Bella tells Roy about Jarvis. Roy and Glenn go visit him at home. They find him dead after overdosing on pills. Dan speaks to Sam Fordwater on the phone. Sam is busy cooking near her father, Johnny. Dan tells her that he's been in Morocco working in rural clinics. Louise Fordwater enters seconds later. They talk about the blow-up because of his boyfriend Hans. Jarvis also had money problems. Glenn finds it odd that the gaming console is still on. Roy wants Vee to run a reverse image search on Toby's face. Vee goes to work with a folding bike. The gym staff member insists Jarvis wouldn't do something like that.

He says Hans and Jarvis met through an online video game. Hans was in Germany supposedly. They check Jarvis's locker. At the station, Vee tells everyone that Toby is all of the men. Roy says it looks like Toby wasn't involved at all. Bella says someone was using his face as bait. Someone was using Toby's identity and pictures to get money from the victims. Glenn explains that Toby was never Georgina's target. Vee says there's a charity with a phone line that you can call if you've become the victim of this type of fraud. Roy and Glenn speak to Angela who tells them how they help victims of such fraud. Rupert Thomas does most of the online work. He tells Roy, Glenn, and Nick how romance fraud works. Georgina and Jarvis did not contact the hotline. Rupert claims it's usually teams of scammers. Cleo tells Roy that Jarvis overdosed, but it was almost like the pills were ground down into a powder before they were swallowed.

Roy wants to visit Georgina's flat. Roy takes some measurements and determines that Georgina couldn't have killed herself. Roy wants to check the victims' devices to see if they can find spyware or tracking software. He's convinced there's a killer in Brighton. At the station, Nick says two sets of files were deleted from Georgina's laptop. Bobby says the photos of Toby were likely deleted by Georgina. The messages and emails are also missing, but someone else likely deleted those. It's believed they were deleted after Georgina's death. Meanwhile, Sam Fordwater talks to Dan and offers to give him money. Dan insists it should be over soon and they can be together. Someone keeps an eye on her using her webcam. Roy tells the team that the victims were murdered. He says Georgina had the exact same amount of opioids in her system as Jarvis. Glenn says there is no evidence of any surveillance software on any of the devices.

Glenn questions why the suspect would bother with Jarvis who didn't have a lot of money like the other victims. Roy remembers that Georgina's brother said she ran wild as a teenager. He wants to know if she ever went clubbing at the place Under the Arches. They speak to Jarvis's old boss, Colin, at the club where he was a bouncer. There was some kind of court case or something and Jarvis took himself out of the business. Cassian speaks to Margot Balkwill while Bruno is nearby. Cassian tells her that they're closing Sandy's case and he wants to offer his condolences in person. Margot says Sandy didn't want to speak to them in the end. Bruno says hello to Cassian. Roy tells the team that Georgina went to a club where Jarvis was a bouncer. There was a court case involving a guy named Ben Close who was a dealer in the club. One night, Ben spiked a girl's drink and she walked into traffic.

She got hit by a delivery van and ended up in a wheelchair. Ben got six years. There were four witnesses who testified against him. Jarvis testified that he saw Ben dealing multiple times. The other witnesses were friends of the girl, but their names were redacted. Georgina was one of those witnesses. Vee gets a photo of Ben. Roy and Glenn recognize him from the charity and rush down there. All of their computers have been wiped and Rupert has gone missing. Johnny Fordwater tells Louise she should think about online dating. Meanwhile, Ben keeps telling Sam lies. Sam just wants him to get over there soon. At the station, Roy tells everyone that Louise Fordwater was the victim in Ben's case. Her sister, Sam Fordwater, was a witness. Lena Cartwright also testified. The other teens testified to having seen Ben spike Louise's drink with some kind of powder. Ben was Louise's boyfriend at the time, but they had a falling out. Ben was ticked off and looking for a fight. Roy says Lena Cartwright, Sam, and Louise are likely still on Ben's list.

Roy and Glenn visit Ben's dad, Ronnie Close, who says he hasn't seen him since he got out. Ben's mother killed herself right after he got sent down. Outside, Glenn tells Roy that Georgina's suicide note was actually Ben labeling her. Bella calls to say Lena Cartwright may have moved abroad. Roy and Glenn visit Sam who is asked to turn her phone off completely. Roy tells her that she's being defrauded by Dan. Johnny questions why the guy would be after both of his kids. Roy tells them what they think about Ben Close. He says they need to take Sam's phone. They recommend not getting in touch with Dan. Sam doesn't want to give up her phone. She insists it's all rubbish and runs off. Roy tells Johnny not to let her hand over any money and to get in contact if Dan gets in touch. Nick calls to say Lena was abroad in Italy. She returned and died in a hospice. Sam tries to bum money from Louise for Dan. Louise suspects Sam has already given him a lot of money.

Sam says she gave him 10k and he gave it back with interest. Louise hopes they've met face to face. Sam claims he's going to be there any day when he gets leave. Louise can't believe she gave all of her money to a guy she never met. Roy wants to know more about Lena Cartwright. Nick says the Australians gave them a recent photo of Ben and it matches with a passport used to enter the UK 18 months ago in the name of Edward Stower. Roy suggests the software on their phones could link to a physical location. They also believe he would've been monitoring Toby. They might be able to get something from Toby's phone. Johnny questions Sam about the money she's given Dan. Before long, Dan gets in touch with Sam. He says he's in Britain and he can get her the money back with interest soon. Dan asks if she had any luck with the 20,000 since he needs to pay the lawyers to release the funds. Sam suggests using her dad's money since she had access to his account.

They talk about meeting up this evening at a little cottage. Sam agrees to bring the money. Roy asks Bella to visit the hospice where Lena stayed and find out whether she had contact with Ben Close. He tells Glenn that he doesn't understand why Ben just woke up one day and picked revenge. Nick says they're ready. Sam takes her dad's money. Bobby confirms that Toby Seward's phone is packed with spyware. She can get them a location, but Ben will know they're onto him. Roy tells her to do it. Ben doesn't notice Toby's phone turn on. Roy and Glenn rush to the scene to try to find Ben. He's already gone by the time they arrive, but they find all of his computer equipment. Bobby gets into his system and finds his messages to Sam. Conveniently, they find the location where they're going to meet. Glenn tells Roy that they can't get there in time. Roy tries to call her but doesn't get an answer. Johnny has set up Ben and attacks him.

Sam goes to Louise and tells her about Ben. Vee and Bella speak to a worker at the hospice who says Lena was upset. Lena said she didn't want to die with something on her conscience. Johnny bashes Ben who tells him he doesn't know the half of it. The police eventually go in and stop Johnny. Nick says something they found at Ben's place on the laptop doesn't add up. Some of the messages were time-stamped at the same time he was supposed to be at Georgina's place killing her. He also had remote access software on all of his machines. There is someone else involved. The nurse is asked about what Lena wanted to get off her chest. It got resolved. She had a visit and she spoke to them for about an hour. A woman in a wheelchair came. Roy learns that Lena made a deathbed confession to Louise Fordwater. Louise gives Sam a drink. He shows her a bottle of pills and says this is the easy way out. Otherwise, they can tell the truth about what Sam did to her and Ben. Louise threatens to make it all public.

Roy tells Glenn that he believes they set up Ben and Lena finally confessed. They cannot find Sam. Louise tells Sam that Lena told her the truth and filmed it. A video shows Sam drugging the drink. She insists she didn't mean it. Louise says they all lied and blamed the one person she really loved. She says Ben's mom killed herself because of this. Louise says it's their turn now. She says it's time to choose. Sam reaches for the bottle of pills. Before she can take them, the police arrive. Glenn and Roy watch the video of Sam poisoning the drink. Both of them are arrested. Bella talks to Vee about her impressive track record. She says they should sort the basics first. She gives Vee a parking permit. Glenn finds Ari upset. She tells him that she's being investigated for negligence. Glenn tells her that she needs to be certain. Ari gets upset and leaves. Bruno shows Cleo and Roy the piece of sea glass he found. Bruno asks about Cassian and tells Roy about him asking about Sandy.

Bruno doesn't think Cassian was really sorry about Sandy.

Summary: When a woman is discovered murdered in her flat, the evidence first

points to a burglary gone wrong in a case that conceals a chilling se-

cret.



As the episode begins, someone takes pictures of Hannah Belling in a parking garage. She rings the bell for Heal Remedy. Hannah receives a message from someone saying they're watching her. She goes inside where she speaks to Jasmine Alson and Sara Joshi. Hannah speaks to Sara about the possibility that smartphones could predict an upcoming health crisis. She insists the Heal Remedy app is a game changer. Hannah gets another message telling her that red doesn't suit her. The mystery sender continues both-

ering Hannah until she ends her conversation with Sara. When she makes it home later, Hannah tells Anya Chandanasiri that she's bothering everyone because of her loud music. Anya slams the door in her face. Hannah finds her door open. She calls someone and asks them to come right now.

It appears that Seymour Darling researches Hannah online. Anya wakes up in the morning to blood dripping on her face. Hannah is dead in her room. Cleo Morey and DSU Roy Grace get ready to leave. At the office, the Chief Constable talks to Glenn Branson and the others about the Benchdale OCG operating at an unprecedented scale. She wants to start with the top man, Kamran Elin, and bring down the organization. His crimes date back to the fatal shooting of London journalist Fiona Wilkinson eight years ago. She also wants to get his second in command, Roel Albazi. Amelia Pardoe was killed in a drive-by shooting and there's been no conviction. Cassian Pewe tries to change the subject only for the Chief Constable to yell at him. DC Nick

Nicholl says Elin and Albazi are elusive. They get lower level members of the organization to do their dirty work.

Glenn gets a call from the East Sussex Police. Roy and Cleo visit Dr. Rait Josif who insists there's nothing to worry about. Cleo says they haven't considered trying again. Roy gets a call before meeting Glenn who tells him about Hannah and her successful app. The downstairs neighbor, Anya, called in the discovery. She's a law student at East Sussex University. The next of kin is Hannah's ex-husband Corin Belling. They split about six months back. Bella Moy gives Roy a tour of the apartment. Nick tells someone no while on the phone. The victim's phone and computer are missing. Nadiuska De Sancha believes the victim died around 7:30 and 9:30 last night. Hannah has head wounds and she may have been strangled as well. Roy notices that her wedding ring is missing. Nadiuska says she likely wore it until recently. Hannah has been cleaned. They are working on extracting skin cells from the floorboards.

Nadiuska finds a hair that doesn't look like Hannah's. Glenn speaks to Sara Joshi outside. Sara tells Glenn about interviewing Hannah yesterday and the odd text message. Cassian tells Roy that the Chief Constable is breathing down his neck because of the Amelia Pardoe case. Cassian explains that he wants swift results on this one. Hannah's ex arrives moments later. Roy speaks to Corin who admits he still loved her. He's still wearing his wedding ring. Corin reveals that Hannah gave her ring back. Corin claims he was at home last night and didn't see Hannah. He says that Jessica, who is with Marcus, said that Hannah was very busy. Corin says she had a brother named Robbie but he's trouble. Roy mentions that they still haven't found Hannah's car. Corin says it's at his house because they still share a car. Roy asks for a DNA sample for elimination purposes. Corin says he'd prefer not to. Jessica O'Sullivan tells Chloe that she should get something to eat. Chloe's father, Marcus, was at the hospital last night.

Chloe notices Hannah's place on television and immediately tells her mother. Glenn asks Sara if anyone at The Argus might have intel on Sussex Central Hospital. He tells her about Ari's situation. Sara tells Glenn to leave it with her. Then, Glenn discusses Ari's case with Roy. Lauren Packham messages someone to say she did what they wanted. Now, she wants what she's owed. Ava Packham is nearby. Margaret Packham enters the room and speaks to Lauren. She tells Lauren that she doesn't have to sneak upstairs every time she wants to text someone. Lauren tells her mom that she doesn't. Someone watches Ava through the window until Lauren closes the curtain. At the station, Roy tells everyone that Hannah had a rape alarm and installed new locks. Roy thinks this was personal and that they should focus on Corin. He asks about CCTV at Lewiston Mansions. Bella says the side door entrance camera wasn't recording.

There's nothing suspicious on the front door cam. They talk about Hannah's brother Robbie Taylor. Hannah fired a MISPER report on him three months back. Roy wants him found. DC Vee Wilde says Hannah reported a former employee for threatening behavior. He was sacked for bullying a coworker so he started bullying Hannah instead. Furthermore, Seymour Darling's ex got a restraining order against him. Roy visits Nora Philips to see if she knows where Seymour is. She says she hasn't seen him in days. Seymour is watching them from a distance. Next, Jasmine tells Roy and Glenn that they had a break-in but nothing valuable was taken. They ask her about Seymour. Jasmine says she was bullied by him but she didn't report it. Esme Collins, who was a volunteer, was the brave one. There was a disciplinary hearing set up for tomorrow. Seymour lost it when he found out. He blamed Hannah for relapsing. Jasmine believes he would act on his threats. Glenn gets a message from Nora who just got in touch with Seymour.

When they speak to Seymour, he claims he just wanted to talk to her. He also alleges that Hannah always protects the wrong people. Seymour says Esme is a liar. Nora told him she did him a favor because it's not healthy for him to work with women like that. Seymour says the disciplinary hearing will give him the chance to tell the truth. Roy asks where he was last night. Seymour claims he was bird-watching on the Downs. Nadiuska tells Glenn and Roy more about the cause of death and Hannah's injuries. Semen was found. Cleo says it's believed Hannah had sex in the hours before her death. It appears it was consensual. The ring finger has an avulsion. There is recent ligament damage beneath the ring area. Nadiuska believes the ring was pulled off with force days or hours before her death. Corin is forced to give a DNA sample. He admits that he took the ring from her. He knew it would look bad so he didn't say anything about it. Glenn asks if Hannah had been seeing anyone. Corin says no and questions who said this. Vee and Bella speak to Jessica about her friendship with Hannah.

Jessica says Hannah didn't mention being with anyone else since Corin. She doesn't see eye

to eye with Robbie. Glenn says glass shards were found outside but not inside the office. The cleaner, Lauren Packham, was the last one to lock up. Roy realizes Glenn is distracted so he tells him to speak to Ari. Lauren tells Roy that she has worked at Heal Remedy since it opened. She says she left at the same time as usual before getting a message. When Roy leaves, he asks Bella to look into Lauren Packham. Glenn tells Ari about the journalist who is going to look into the hospital for them. Ari worries it was her mistake. Corin has been drinking. He goes to Marcus and asks if Hannah might've said anything to Jessica. Marcus believes Jessica would've told him. Corin says he needs something to help slow things down. Marcus doesn't want to give him drugs. He relents but insists this is the last time. Nick speaks to Roy. He tells him that he might see his vehicle on Lewiston Mansions. Nick explains he's been living in a B&B just opposite Lewiston Mansions for the last week. When asked why, Nick says there's some stuff to figure out.

Vee finds CCTV footage of a man leaving Lewiston Mansions last night. Nick says CCTV from outside Heal Remedy also flagged something. There was a man watching Hannah when she left work. Hannah was receiving many text messages from Seymour Darling. The last call she made was to an unregistered number. The last text she received was from a different unregistered number. Seymour is brought in and asked about being at Lewiston Mansions last night. He says Hannah was gathering evidence against him. He thought he should gather some evidence of his own to show people what kind of woman she was. Vee argues with him. Glenn mentions Seymour said he was Hannah having sex with a man in a car. Seymour didn't get a good look at the man, but he saw a man in her window. Seymour doesn't want to say who he saw. After the interview, Roy tells the team to go through Seymour's photos. The divorce lawyer said Hannah and Corin aren't technically divorced yet. Corin is contesting the house sale so that brought the whole thing to a halt.

Corin would get everything in Hannah's death. Bella says the skin cells found in the floorboards are from an unknown individual. The hair found in Hannah's blood belonged to Corin. Seconds later, Corin is arrested. Roy tries to get Corin to speak in an interview room. Corin gives them something and says they should ask for Kate Bullworth. She's his sponsor since Corin is an addict. That's why Hannah left him. Last night, Corin was supposed to be at his support group. He hit rock bottom and relapsed. He went to see Kate. Corin didn't tell because he'd lose his job if his boss found out. After the interview, Bella tells Roy and Glenn that Lauren Packham is Robbie's girlfriend. She speaks to Lauren. Bella suggests Ava missed her daddy, Robbie. She accuses Lauren of letting Robbie into Hannah's office. Lauren insists Robbie wouldn't hurt Hannah. She doesn't know where Robbie is. She claims she hasn't seen him in months. Lauren sees a man and immediately panics. Glenn confirms that Corin's alibi checks out. Bella tells Roy that Lauren is likely covering for Robbie.

She froze when she talked about him and someone was watching her. Robbie may be keeping an eye on her. Roy wants to call it a night. Roy goes home where he finds Cleo with Bruno. Bruno tells Cleo that he's mad at his grandmother because she won't talk to him about Sandy. He keeps thinking about what Sandy thought about before she died. Later, Roy talks to Cleo about it. Cleo thinks Roy should talk to Bruno about Sandy. Roy is interrupted by a call from Bella who says Nick has something. It happens to be Seymour's photos. The car in the photo belongs to Marcus O'Sullivan. Hannah's key fob was analyzed and compared with Corin's. It was last used at 9:40 last night. At that time, Corin was still with Kate and he walked so his car was still at home. Roy questions whether Marcus got into the car, retrieved Corin's DNA, and planted it at the scene. Marcus is brought in and told his DNA was found in Hannah. He denies killing Hannah and says they loved each other.

They started having sex a few months back, but their emotional relationship lasted much longer. Marcus admits to having sex with Hannah on Wednesday, but he insists he didn't kill her. Vee tells Roy that the skin cells from the floorboards belonged to crime scene personnel. The team returns to Hannah's flat.

At the crime scene, Branson notifies Roy of forensics finding another patch of blood. A short time later at the police station, Branson tells the team the familial blood isn't a match with Marcus. Roy suggests it belongs to Robbie Taylor. Branson says forensics believes the blood has been there for about 10 weeks. Bella tells them that Robbie was reported missing on May 18. Elsewhere, Lauren receives a video of a battered Robbie screaming through a mouthgag before he is shot. Lauren covers her mouth to muffle her scream and frantically packs up their things. At the police station, Nick tells Roy, Branson, and Bella that Sussex Central Hospital admitted a

man matching Robbie's description, with a gunshot wound on May 17. The attending physician notified the police but the man fled before they arrived. Roy recalls Amelia Pardoe was shot in a drive-by shooting on May 17. Nick says she was shot when Benchdale OCG opened fire on a rival gang. Branson points out that the driver and shooter were apprehended but an unidentified male escaped, who they believe was Robbie. Roy believes Benchdale OCG was after something Hannah had.

Bella discovers CCTV footage of an injured Robbie arriving at Lewiston Mansions and Marcus O'Sullivan arriving a short time later on May 17. At the police station, Roy confronts Marcus with the new evidence and threatens to charge him with Hannah's murder. Marcus claims to have gone there after receiving an urgent call from Hannah about a medical emergency. When he arrived, he found Robbie suffering from a severe gunshot wound but didn't know the specifics. He found out the next day about Amelia being killed in a drive-by shooting. Marcus expresses anger at Hannah for putting him and his family at risk. He claims Hannah promised the shooters would go down. Roy says the key witness was intimidated and they are still free. A short time later, Branson tells the team that DNA found in the backseat of the car confirmed the witness' story. He says forensics matched gun fragments from Amelia's shooting with a gun utilized in Fiona Wilkinson's murder and other crimes. Roy recalls Kamran Elin was connected to the murder. Later, Roy tells ACC Cassian Pewe that he believes the gun utilized in Fiona's murder is why Benchdale killed Hannah. Pewe argues that Hannah's murder was carried out haphazardly, not relevant to Benchdale crimes.

While walking down a sidewalk, Ava insists on playing and breaks away from Lauren. A vehicle pulls up, a man jumps out, grabs Lauren, and forces her into the vehicle. Lauren tells Ava to go home. Ava watches as the vehicle speeds away. At the police station, Branson and Roy receive a call about Lauren suffering severe injuries after jumping out of a moving vehicle. At the hospital, Roy says Albazi would have killed her if she hadn't managed to escape. Branson questions why Benchdale would target Hannah and Lauren three months after the shooting. Margaret gives them Lauren's phone and asks them to find her assailants. Lauren tells Roy and Branson that Robbie wanted to do right by Amelia, so he gave the gun to Hannah and tried to escape but they found and tortured him. She claims Hannah had already turned the gun over to the police when she was killed. Upon leaving the hospital, Roy receives a call from Bella saying there is no report of Hannah turning in the gun. Vee tells him Chris Haddock reported capturing a man utilizing the side entrance to access Lewiston mansions on the night Hannah was killed. A short time later, Chris shows Roy and Branson the dashcam footage. Nick tells Roy that he will drop the SD card off at Enhancement. A short time later, he inserts it into his laptop when his phone buzzes. Seeing if anyone is watching, he looks at it and slips it into his pocket. A forensic scientist notifies Roy that the drive is corrupted (wiped).

Roy tells Branson when Nick's car pinged at Lewiston Mansions, he claimed to have been staying at a nearby bed and breakfast. At the hospital, Nick shows his police ID to a staff member and requests a visit with Lauren. Roy and Branson race to the hospital. Bella informs them of Hannah's laptop being found at the harbor. Upon arrival at the hospital, they catch Nick before he sees Lauren. Outside, Roy confronts Nick about the corrupted dashcam and CCTV footage. Nick tells him that he and Jen were having money problems and she asked him to move out. Jen wants to move to Scotland to be with his family but his life is there. He complains about not seeing his son in three weeks. Roy confiscates his phone and places him on suspension. Nick gives him his warrant card. Uniformed officers take him away. Branson says if Sara met Hannah at last year's Police Commissioner's Dinner, so could have Nick. Roy suggests they keep it between them. Later at the police station, Roy shares his suspicions with Bella and Vee. Bella proclaims his innocence. Vee tells Roy that Chris saved the Dashcam footage and suggests letting Tim Weatherley have a look at it to see if he can help identify the man. Later, Roy asks Vee if she remembers the skin cell DNA samples that came back as crime scene personnel. She says the swaps were collected at 10:43am. He tells Pewe that Tim is there to identify Nick, captured on dashcam at Lewiston Mansions. He says Nick corrupted the footage but Chris had backed it up. Roy asks Tim to contact him with his findings. He receives a call from Branson saying there are photos of "him" at the commissioner's dinner. Tim informs Pewe that he couldn't identify the man in the dashcam footage.

Roy returns Nick's warrant card and welcomes him back. Branson shows them the commissioner's dinner photos. While driving, Tim calls Roy when a vehicle veers into his car, sending

it toppling over. Pewe approaches and looks inside the vehicle at an injured Tim. At the police station, photos of Hannah and Pewe are lying on a table. Roy says Pewe arrived at 11:07am and the skin cell samples were sent to the lab at 10:43am. Nick claims Pewe erased Hannah's hard drive but forgot her emails. A wellness app captures Pewe and Hannah at her flat. She says he has had the gun for three months and threatens to find out what is delaying the process. He kills her. Nick tells them that he was copying the dashcam footage when Jen called and Pewe erased it. Roy receives a call from Bella saying Tim's car was sideswiped by one of their pool cars which wasn't signed out. The driver took his phone and left him for dead.

Wearing a hoodie, Pewe sees uniformed cops surrounding the pool car. He sees in a car and flees on foot. Roy pursues him into a building and asks why he did it. Pewe says he knows nothing. Roy accuses him of Hannah's murder and being affiliated with Benchdale. Drawing a gun, Pewe claims to have the gun utilized to kill Amelia. He puts the gun to his head. Roy pleads with him not to do it. Sobbing, Pewe drops his hand. Roy takes the gun. Pewe steps into an opening and falls to a lower platform. Injured, he tries to flee when Branson, Bella, Vee, and Nick arrive. Roy hands the gun to Branson. Later, Branson tells Roy that he encountered a similar CCTV footage error code investigating Alvin Smallbone. He pulls up CCTV footage of Sandy Grace seeing Cassian and fleeing in the opposite direction.

Glenn tries to stop Roy who tells him to open the door. Roy goes inside and tells Cassian that he knew Sandy was alive all this time but said nothing. Cassian believes Roy knows why he didn't say anything. Roy does but he wants to hear Cassian say it. Cassian admits he was having an affair with Sandy because Roy wasn't there for her. Roy says he was doing his job and they needed him. Cassian argues that Sandy needed him. He asks Roy if he would've paid the 200,000 pounds she owed Roel Albazi and Kamran Elin. Cassian claims she was gambling and drowning in debt. Albazi and Elin were going to kill her and her unborn child. Cassian tells him he was too busy trying to chase a promotion. Summary:



As the episode begins, DSU Roy Grace is investigating someone called The Merchant. Four months earlier, Daniel "Danny" Starr is shown riding on a boat called the Red Funnel. Danny tries to get through the checkout. Officer Johnson asks him a few questions and asks him to step out of the vehicle. Roy and DI Glenn Branson watch from nearby. The officer checks the vehicle in the back. Meanwhile, Terrence Maxwell talks to Wesley about a school. Barbara Maxwell and Ellen Maxwell are with them. Wesley talks

about becoming an engineer. He thanks Terrence for defending him in court and everything else. Officer Johnson tells Roy there was nothing in the car. Roy cuts open the tire and finds drugs. Danny flees. He ends up hitting Glenn and uses a phone nearby. Danny is taken into custody on suspicion of drug importation.

In an interview room, Roy tries to get Danny to tell him who The Merchant is. Glenn tells Danny they got the number he dialed. Danny doesn't want to say anything. Ray knows his mother, Alma, is not in good health. Later, Roy and Glenn visit Terrence Maxwell to ask him to come to the station to discuss the call he received earlier today. Meg Magellan and Laura Magellan before Laura leaves. Laura promises Cassie will remind her to message every day. Laura tells her mother that she needs to do this and she believes her mom needs to do it too. At the station

four months later, Stephen Wolfe asks Roy about Maxwell's computer. The techs are still working on the encrypted files. Roy asks Stephen if he really thought Maxwell would change his plea to guilty. He can't understand why they're so confident. Stephen says Terrence's barrister, Primrose Morley, takes no prisoners. She'll take advantage of the fact that the investigation was carried out while Cassian Pewe was in charge.

Glenn agrees to cover for Roy who wants to be in court as much as possible. He says they're closing in on the Benchdale gang. Glenn is confident they'll get Albazi off the street. Roy admits he's shaken up because he missed Cassian. Maxwell will try to disrupt the trial in any way he can. Danny calls his mother and reminds her he's in a bit of trouble. Alma is told they're going to sort something out so she can come and visit. She doesn't seem to understand so Danny explains he's in prison. Alma says someone told her she's not going to see him again. Roy speaks to Cleo and asks if she's ready to do this. Cleo insists it's what she wants to do. It's just a reminder she doesn't need. Bruno is there to help. Meg heads to East Sussex Crown Court for Terrence's trial. Stephen tells the jurors that Terrence pretends to be a humble solicitor specializing in legal aid work. He claims Terrence is dangerous and a criminal mastermind. A man inside the courtroom is wearing a wire. Someone in the van outside watches Meg using the camera and says she's taking it all very seriously.

Roy testifies about their work to identify The Merchant. He tells the court how they got Danny Starr. A video is shown of Danny saying The Merchant is Terrence Maxwell. Meg speaks to the other jurors, including Janet. She messages Laura. Next, Primrose Morley KC questions Roy about working with Cassian Pewe. She claims their department is second-rate. Morley mentions that Roy's team picked up on a reference to the Merchant on a phone tap and ran with it. She suggests the Merchant could be code for anything or refer to multiple people. Roy claims otherwise. Ellen and Barbara talk about keeping things normal during the trial. Barbara says they cannot hide under the covers. Ellen asks if the things they're saying are true. Barbara says Terrence is great at getting justice for people who otherwise wouldn't stand a stance. As a result, he's made some enemies along the way. They join Brendan moments later. Meg believes she hears someone in her house so she grabs a knife.

She receives a call from someone talking about her daughter. They know a lot about Meg and suggest Laura and Cassie could disappear on their trip. Laura is offered a deal. She can't tell anyone. Laura just needs to make sure the foreman says not guilty at the end of the trial. Cleo tells Roy it might be a good idea to formalize things a bit with Bruno. She suggests speaking to his grandparents about giving him more visits and his own room. Meg has the locks changed. Stephen questions Terrence about money transactions during the trial. Terrence says he put seed money into Danny Starr's business about ten years ago. He got shares in exchange. Stephen says it's hard to believe Terrence lucked his way into a small fortune. Terrence admits to defending Danny when he was caught up in a car stealing operation. When Danny got out, Terrence agreed to cover the start-up fee because he liked Danny and his business plan. At the station, Vee Wilde asks Bella what the guys are doing. Bella says they're doing a deep dive review because of Cassian Pewe.

The Met is going through the same since Pewe spent time in London. Bella doubts Vee has anything to worry about since she has only been there for five minutes. The jury tries to pick a foreman. Meg gets a message telling her to get some fresh air at lunchtime. When she goes outside, she's told to exploit the divisions among the jurors and snatch the foreperson job for herself. Roy overhears her and follows her. He checks with her to see if anything is okay. Meg says she's just missing her daughter who is away traveling. When she leaves, Roy calls to run a PNC check on her. Mr. Colin MacKaye is questioned next. Colin says he oversees Maxwell's personal accounts and the business accounts of his law firm. He claims Terrence is not financially motivated. He tells Primrose that Terrence is not a man who cares about money. He also finds it funny that Terrence would import drugs. When Meg gets home, she finds out that someone has been in her home again.

They've left a note about her daughter and Cassie. Cleo calls Roy to say Margot is going to come over tomorrow night. Stephen arrives to strategize with Roy and Glenn. He admits they need more bullets in the gun. After a call, Grace tells Stephen he has a bullet. Meg tries to convince the other jurors to let her be the foreperson. Stephen wants to introduce new evidence. He says they managed to decrypt some encrypted files. The files were found on Terrence's home computer and prove the existence of an account in the Seychelles totaling 4.6 million pounds.

Primrose says the defense has a right to review the evidence before its divulged to the court. The judge doesn't think this was deliberate or malicious. Primrose speaks to Terrence who claims Grace is trying to set him up. He suggests the tech boys planted them after the fact. Terrence insists he's innocent. Terrence wants back on the stand. When he gets back on the stand, he begins blaming Colin MacKaye. Stephen claims he's getting desperate and finger-pointing.

Terrence mentions Colin's criminal record and explains that's why he couldn't open an account in the Seychelles. Stephen wants Colin to be testified against tomorrow. During a break, the jurors admit the Seychelles stuff was damning. Meg tries to sway their opinions. Meg watches a video of Laura and Cassie zip lining. It appears something goes wrong. Someone watches Janet when she gets on a bicycle. Laura tells Meg that Cassie seems okay. The mysterious caller gets in touch with Meg and mentions the zipwire. He mentions that they're going to help with the jury. A car forces Janet to wreck her bike. At the hospital, Glenn tells Roy there is no sign of tampering on the bike and no paint transfer. He reminds Roy that they're not supposed to be talking to her. Glenn thinks he should talk to her since he's not testifying in court. Roy idiotically storms into the room anyway. He speaks to Janet about the accident. Later, Stephen says the jury will likely want to proceed anyway.

Stephen points out that they still have their ace, Danny Starr. A Chaplain visits Danny in his cell. Danny asks what happened to Father Wilson. The chaplain says he's filling in. The chaplain begins talking about Alma. He says they'll more than touch her if Danny doesn't change his statement. Roy spies on Meg who notices him sitting outside. He is late to the meeting with Margot Balkwill. Margot says she and Derek have no objection to Bruno staying there. She's just worried that it might not be the right time for them. Sally and Richard sit on a bench. Someone comes out of the trees and shoots Richard. Both end up dead.

Forensics process the Ridgeton Park crime scene of a deceased male and female. Nick informs Bella and Vee the victims have been identified as Richard Bailey and Sally Jacobs, neither of which have a criminal record. Cleo points out a shoeprint on Richard's hoodie. Vee suggests it belongs to the killer. Cleo says the victims were shot from a distance. Nick tells her Sally's body was discovered 20 yards away, heading in the opposite direction. PC Dave Cripps recognizes Vee as the daughter of his former Met colleague, James Vernon. She denies Vernon is her father. He recalls seeing her at Vernon's barbecues. A piece of bloody rope is collected as evidence. Nick, Bella, and Vee discover blood splatters and tire tracks on the road. Vee turns and sees Cripps looking at her. Elsewhere, Meg encounters Roy and Stephen outside court. Roy claims Meg swept her home for bugs last night and insists on knowing who is calling the shots. Stephen warns him against making contact with a juror. Roy says the jury is being targeted and suggests bringing it to Judge Channing's attention. Stephen says Channing will demand evidence that they don't have.

In the jury room, Maisy Walter insists Janet Smythson thought Maxwell was guilty and now, she is in ICU. Deepak Singh says if she is right, there is a spy in the house. Meg suggests Maisy has been watching many movies. Sam Makerson tells them that such jury tampering is rare. Maisy criticizes Meg, the jury foreman, for having nothing constructive to say. In the courtroom, Channing announces the trial will move forward, although Colin MacKaye will no longer testify. He expresses his disapproval of case tampering and threatens to discharge the jury if he suspects it. At Harborside Way, Branson informs Roy that Colin left two months' rent and a note, requesting his possessions to be sold and a portion of the money given to his sister, Kirsty MacKaye. The landlady never saw him. Branson finds Colin's motorcycle and passport missing. Kirsty tells them that she spoke with Colin at 8pm last night. She claims he was upset about Maxwell blaming him for the police finding something on his computer and had plans to leave. She voices concern about him doing something stupid. Branson asks if she thinks Colin never left his past behind. Upon leaving, they receive a call from Vee saying Colin's motorcycle was captured on a seafront traffic camera at 10pm last night. Roy suggests the driver could be anyone.

At the East Sussex Police Station, Vee utilizes Bella's ID to search Cripps in the database. Vernon's, a former DCI at Chapelwood, profile pops up on the screen. He was dismissed for gross misconduct. At court, Branson confronts Roy about his obsession with Maxwell. Roy walks away without responding. In the courtroom, Roy looks around while Stephen questions Danny about his role in a drug ring. He asks if the Merchant is in the courtroom. Danny says no and denies the Merchant exists. Holding his sworn statement, Stephen reminds him that he identified

Terrance as the Merchant. Danny claims Roy pressured and threatened him. Stephen says that is not what happened, according to the interrogation recording. Danny tells the court that Roy is obsessed with Maxwell. Stephen says no further questions. Roy storms out of the courtroom. In the jury room, Maisy, Hugo Pink, and Harold Trout discuss Starr changing his statement. Maisy suggests they got to him as well. Meg argues that what they are suggesting is speculation and walks out. Outside the court, Roy receives a call from Vee saying Colin visited Barbara's salon yesterday. Upon arrival at the salon, Roy finds Brendan speaking with Barbara. He questions why she wasn't at court. She proclaims Maxwell's innocence. He tells her that Maxwell blames Colin for the police finding encrypted files on his computer. She says Colin is their bookkeeper and claims he said he would be gone for a bit.

At the police department, Bella explains her theory of how Sally and Richard's murders were carried out. Sally was shot while trying to flee the scene and forensics never recovered any bullets from the scene. Nick believes Colin is the third victim because his DNA was found at the scene. Pointing at the traffic photo, Roy says the driver isn't Colin. At the beach, Meg meets a friend. At the police station, Roy and Branson discuss Brendan's extensive criminal history. Branson says Brendan has laid low for 10 years. At the beach, Meg warns her friend that they are being watched. A man watches them from the rooftop of a building. At the police station, Branson tells Roy that Maxwell was Brendan's solicitor in 2004. He lost the case and Brendan got a seven-year sentence for intent to supply. There is no evidence of Brendan being associated with Colin or Starr. At the beach, Meg's friend urges her to go to the police. Meg says to protect Cassie and Laura, she must get a not-guilty verdict. At the police station, Vee shows Nick and Bella footage of Colin's motorcycle passing Shoreham Harbour at 10:30pm and a Brightfield Auto Repair van traveling in the opposite direction 10 minutes later. She says the van utilizes a ramp to load and offload motorbikes.

At Brightfield Auto repair, Branson and Roy order Derren Skinner to open his van. Skinner pulls the door open to reveal motorcycle gear, no bike. At the police station, Nick and Vee watch footage of a bloody-faced Skinner putting something into his van. Elsewhere, Roy asks Skinner if he is familiar with Colin. Skinner says no. Brendan arrives and introduces himself to Roy. Bella notifies Roy that Skinner is the Ridgeton Park shooter and is affiliated with Brendan. Skinner draws a gun. Branson kicks the van door, knocking Skinner off balance. Brendan retrieves a gun. Roy and Branson seek refuge behind a vehicle. Brendan and Skinner open fire on them. Roy and Branson run into the building. A pursuit ensues. Roy discovers Colin's body inside the building. Branson and Skinner wrestle over a gun and it misfires. Roy knocks Skinner out. Branson shoots Brendan. Roy asks him to identify the Merchant. Brendan claims it is Maxwell. At the police station, Branson informs Roy that a bullet recovered from the Ridgeton Park crime scene was a match to Skinner's gun which has Brendan's partial print on it. Roy questions why Brendan readily identified Maxwell as the Merchant and how Barbara knew Starr changed his testimony when she didn't go to court today.

At jail, Terry accuses Barbara of betraying him. At the police station, Barbara Devlin's file reveals two drug charges in 2002 and 2003. Her boyfriend, Brendan, was also charged. Barbara's solicitor, Maxwell, got her off and Brendan a seven-year sentence. Brendan is Ellen's father. Bella suggests the Merchant is Barbara. At jail, Barbara admits to being the Merchant. Maxwell accuses her of targeting him to be her scapegoat. She promises to have his back. He orders her to get out. In the courtroom, Channing dismisses the jury to allow Roy to explain Colin's absence yesterday. Roy says Colin was murdered to keep him quiet. Roy tells the court that Terrence is innocent. He's the victim of a framing plot orchestrated by Brendan and Barbara. They have evidence linking them to the murder of Colin MacKaye and two innocent bystanders in Ridgeton Park. Roy tells the jury that Janet is out of the ICU and has made a full recovery. He asks if anyone else has been threatened. Meg says they have Laura and Cassie. Barbara is marched to Roy and asks what he thinks he knows. Roy says it was a mistake for Danny to change his testimony when she wasn't in court. He also knows about her friends in Ecuador threatening Meg's daughter, Laura. Roy asks her to call them off. Bella finds Vee freaking out in her car. Bella says something tells her that PC in Ridgeton Park wasn't mistaken. He likely worked with Vee's dad in the Met. Vee says she found out he was suspected of killing an informant. He left when she was 16 because he was a drunk.

Bella tells her she doesn't need to run anymore because this is where she belongs. Meg gets a call from her daughter who is just fine. Laura is ready to come home. Terrence visits Barbara at

the jail as her client. He tells her he loves her. Barbara knows she doesn't deserve him. Terrence says he needs her signature to make it official that she'll be retaining his services. Later, Glenn talks to Roy about losing the baby. Glenn says he just wanted to give him space to grief. He believes Roy can be a great dad to Bruno. Roy doesn't think he's free of it yet. Cassian wants to see Roy. Vee receives a call from her dad. She doesn't want to talk to Bella about it. Roy goes to the jail to speak to Cassian Pewe who says they can be civil. Cassian mentions Benchdale. He says Benchdale has communicated something that impacts Roy. They killed Sandy and made it look like a suicide.

Cassian goes on to say Albazi was sighted in Munich two days before Sandy's death. He's not sure that was a car accident either. Sandy's debt still isn't paid. Benchdale knows she has a son. Albazi's failure to recover the debt led to his family getting seriously hurt. He's out for blood.
