Summary: In the wake of a disastrous mission overseas, Navy SEAL commander

James Reece returns home with conflicting memories of the op and

questions about his own culpability.



Navy SEAL Commander James Reece overlooks the coffins of his Navy SEAL battalion, who lost their lives following a military operation.

We suddenly switch to the past at a navy base at 'Incirlik,' as James prepares his team for the operation. They have been ordered to pursue Dr. Jahan Kahani, who has been overseeing a chemical weapons program in Syria.

One member of James' battalion, Donny Mitchell, is absent from the meeting. He is recovering from a headache.

Then, a short while after, Donny arrives. The camera shifts as the team are on a naval ship, preparing for the attack.

Accompanying them is a Syrian trooper, supplied by the Syrian Democratic Forces (SDF), who is keen to get his revenge on Kahani who gassed his family.

The SEALs arrive at the compound in darkness. They enter some tunnels following intel from James' contact (Moussa). As they navigate the sewers, the Navy SEALs overhear some people talking.

Underneath the water, however, is a tripwire that has explosives attached. Suddenly, James overhears gunfire. The team's cover has been blown. They enter into heavy gunfire as the Navy SEAL team attempts to retreat to the exit point.

The Syrian trooper looks unwell, which is why James reassures him that he will get him out. But the trooper makes a break for it, thus hitting the tripwire and setting off the explosives.

James is knocked unconscious, as we see him back at his house playing the guitar. He is with his wife, Lauren, and daughter Lucy. There is a sudden thud at the window, which turns out to be a dead sparrow.

As Lucy and James investigate, James has flashbacks of the operation. James was carried out from the tunnel after becoming unconscious. Thereafter, a helicopter arrived to shoot the enemy combatants.

As that happened, James boarded the chopper as it flew away. Back at the house, Lauren receives a phone call. It is James. He tells her the operation backfired, as many lost their lives.

The only survivors were James and Ernest "Boozer" Vickers. Lauren begs him to come home. James is now being interviewed by Special Agents Robert Bidger and Daniel Stubbs about the operation.

James informed them that his team supported the SDF to apprehend Dr. John Kahani. James suspects sabotage, given that there were armed loyalists to stop his team getting Kahani.

James is asked when he knew Donny was unwell. He is taken back by the question, as he is informed that Donny hit the tripwire and not the Syrian trooper.

The mission notes back this up too. There is a discrepancy between the accounts. Robert plays a tape recording as we hear Donny being very anxious. James can be heard telling Donny to remain calm.

James is adamant that it was the Syrian trooper. And as 12 lives were ultimately lost, this information is crucial. In the next scene, James is taken to the medical department. The doctor asks if he has memory issues, to which he answers 'no.'

Once discharged, we see James drinking at a bar with the only other survivor Ernest. They remember Donny, as James vows to get Dr. Kahoni.

They are suddenly interrupted by war correspondent Katie Buranek. James figures out she is a reporter looking for an inside scoop on what happened during the operation.

James refuses to divulge and states that Ernest will also not help. When Katie asks who Ernest is, the camera does not show him there. There is a hint that James could be imagining things.

In any event, Katie suspects something is being covered up. And yet, James walks away as he is not convinced by her motives. Soon after, James and 'Ernest' board a plane as they make their way home.

When James lands in town, he is picked up by his best friend Ben Edwards. Ben is a former Navy SEAL. He asks James what happened during the operation.

James states they were set up. James is convinced his voice was altered on the recording. Ben informs him he may have some contacts who could shed light on this.

James arrives home to embrace Lucy. Thereafter, he and Lauren have a hug before they put Lucy to sleep. Lucy shows him a drawing of the family. James is impressed by her art and states he has never seen this before.

However, Lucy differs as she showed it to him before he left. It is clear James has memory issues, as Lauren looks worried from the nearside.

Lauren begs James to get himself checked out, as she suspects he could have more health issues. James reassures her he is fine. As they sleep, James has another flashback. The next morning, James, Lauren, and Lucy are having breakfast.

Lauren suggests James joins them for Lucy's new hobby: paddle boarding. James agrees before he is interrupted by a phone call from Captain Howard. Something has happened.

James gets in his car and drives off. It turns out Ernest is dead. The man on the scene, Special Agent Holder, questions James on Ernest's state of mind.

James discloses that he flew home with Ernest 'yesterday,' but agent Holder states this is not possible. Ernest flew home two days ago with the bodies of the dead military personnel and took his own life. James is once again questioning his sanity.

James is now back with the Navy SEAL team. He informs his superior Admiral Gerald Pillar that the operation was an ambush.

James also states the audio was doctored. James refuses to change his statement and is adamant that the SDF trooper set off the wire.

As for Ernest's death, when James receives confirmation from Captain Howard that Ernest shot himself with his personal pistol, a 9-millimeter platoon gift, that gets his interest piqued.

The next shot shows Ben and James on a sailboat. James has a gun and asks Ben what is wrong with the bullet? Ben has no clue. James says Ernest was never a fan of 9-millimeter bullets.

Therefore, he does not believe the coroner's account that this was a self-inflicted wound. Ben advises him to take some time off and take the boat.

James asks him, 'Do you think I'm losing my mind?' Ben reassures James that he is not but states that he is there for him if he has any concerns.

Back at home, James googles Katie to get more information on her. He drops her an email saying, 'When we met... was I alone?' He wants to see if he is losing his mind.

In and amongst that, we see James attending the funeral of the military personnel, including Ernest. As James and Lauren leave the funeral, they are stopped by the Madam Secretary of Defence Lorraine Hartley.

She reassures James she will help in any way to get his life back to normal. He will also be honored with the 'Navy Cross.' She then discloses that new Navy SEALS will continue with the operation, as his informant (Moussa), who gave him intel on Kahani, was found dead.

Thus, the security breach has gone if Moussa had betrayed the team. James tells the Secretary that he wants to be there when they find Kahani. She replies stating that when he is dead, he will be notified before walking off.

We are back with James and Lauren in the car. He is looking at the rear mirror, as he notices a car behind. He suspects they are being followed, but this could be paranoia.

Lauren asks if he has booked his MRI scan, but he reassures her that he feels better. They arrive home, but as they do so, a car pulls up near them.

James informs Lauren to get Lucy, as it is the same car that he noticed at the funeral. Lauren goes inside as James gets his gun. As James approaches the car, he points the weapon at the driver.

To his surprise, it is Katie. He invites her inside, as Lauren meets her, and then goes off to put Lucy to bed. James wants to know the answer to his email: Katie tells him Ernest was already dead on the day she met James.

She produces a death certificate and the date as proof. James is not happy, as he tells her to go. She leaves but gives him her card anyway. James has a flashback of him drinking with Ernest at the bar.

Once he finishes his drink, we see a full cup next to him with nobody there. He then puts his gun in a safe. Thereafter, James tells Lauren that something is wrong and that he will ring the clinic.

At the clinic, James undergoes a scan. As he does so, he has a flashback of Donny. This time Donny hits the tripwire. With the scan over, James wakes up to find someone pointing a gun at him.

The gunman has a mask on. James sees the doctor dead in the background. Then a gun approaches the side of James' head. There are two attackers. James pushes one away as a gunshot is fired.

In the scuffle, Nick shoots one to injure him. He beats the other on the floor. The latter then slits James' chest with a knife as they engage in a brawl. James manages to stab the knife in his arm and then break free from a headlock from the other person.

James shoots one dead as the other escapes. He goes after the other one, but his gun has no ammunition. He then notices that the attacker's gun was the same one he had put in his safe.

Thus, he suspects something has happened to Lauren and Lucy. He drives home in a panic. Lauren is not answering, so he leaves her a voicemail stating he had nearly been killed. He tells her to leave the house with Lucy.

He also rings the police to get them to his house. James arrives home to find them both dead and cries in anguish. Police sirens can be heard as the episode ends.

Summary: Reece locks onto his first potential target, enlisting Ben's help. With

his mental health in question, Katie and Reece strike up an uneasy

but mutually beneficial partnership to find answers.



James Reece has flashbacks of the murder scene where his wife Lauren and daughter Lucy were killed.

In and amongst that, Ben arrives to assist James as they carry the coffins for the funeral. With the funeral over, a friend of the family, Marco Del Toro, sits with James and consoles him, stating he should not be alone.

James joins Marco around a fire with Ben and Lucy's godmother Liz Riley as they reminisce about Lauren and Lucy over drinks. James demands to go home.

Back at the house, James is all alone in the dark as he looks at Lucy's drawing of the family she had shown him before. Then we have a flashback of Lucy drawing it.

James plays the guitar, as he jokes about his worries over the picture not being finished before he has to leave. He sings as Lauren joins him for a drink in amusement.

Once again, there is a thud at the window, which shows the same sparrow lying dead. Lucy asks if it will be fine, to which James reluctantly states she is just 'stunned.' Lauren corrects James by saying, 'you don't have to lie to her,' as the flashback is broken up.

James finds himself standing alone in the apartment, as he notices someone walking inside. He grabs his gun and finds a man sitting on his bed looking at Lucy's picture. However, to the audience's shock, the man sitting on the bed is James.

The following day, Special Agent Joshua Holder visits James' house. He has been assigned to look into Lauren and Lucy's homicide. He wants to clear up a discrepancy surrounding where the murder weapon was taken from.

James tells him his gun was stolen from his safe. Holder demands to know how the attackers would have accessed it, as the safe required James' fingerprints.

James is frustrated that Holder is not doing enough to find the assailants. Holder responds by stating he must look at all possibilities before leaving.

As Holder leaves, James arrives to meet with his own superior, Admiral Gerald Pillar and another in command Commander Bill Cox.

James lets the Admiral know that Special Agent Holder From NCIS is not qualified to investigate his family's homicide. He demands that a counter-intelligence team is set up and suspects that Kahani has sent people to go after him.

After all, James has been tracking him for years, so things may have become personal. The Admiral is not convinced. The former admonishes James on two counts.

First, he managed to keep James in his job despite the latter giving an inaccurate account of who set off the tripwire, as James admits to having changed his statement from the Syrian trooper towards Donny.

Second, James has put the Admiral in a difficult situation already. As the Admiral continues highlighting James' mistakes, Reece loses it and grabs the Admiral's throat before walking out.

In the next scene, Katie gets a call from someone named 'Jordan.' She ignores it, as she approaches Special Agent Holder. She wants to know about the homicide, but he refuses to talk to her.

However, Katie tells him she was with Reece the day before the murders as he 'waved' a gun in her face. She is willing to give a witness statement if he talks to her off the record.

Holder brings her in to see the crime scene of the clinic where Reece was attacked. Katie tells Holder that Reece did seem a 'little off' but not like a man ready to kill his family.

However, there is the potential for the authorities to blame the death of Lauren and Lucy on him. Reece's account of the attackers being there is disputed, as Holder confirms there were no bodies or blood.

Not only that, but Holder states he was first on the scene and found nothing. And yet, Holder recognises that Reece believes his own version of events. In addition, there is the knife wound that Reece had. Clearly, these loose ends have not been tied up.

Back at home, James gets a knock at the door. He picks his weapon up and makes an approach. As he notices the person is unarmed, he puts the gun down. It is Katie. She tells him there were no bodies at the scene and asks how is that possible.

James tells her to meet him at the side of the garage. Katie wants James to sign a document that would allow her to access his MRI scan results.

Thus, if the scan is clear, it will prove he is not insane. James will only agree if she lets him see the police report on Ernest's death. She complies as James looks at the document.

James notices that Holder was the first person at Ernest's crime scene, as well as at the clinic where he was attacked. After that, he signs the document from Katie.

Before she is about to leave, James gives her another phone with instructions on how to contact him without being tracked. As he goes to get it, she notices some damage on the window, which the audience knows was caused by the sparrow in the flashback.

But with the phone in her possession, she leaves. Once she leaves, James tries desperately to get more information on Holder. He suspects Holder could be lying about his credentials.

As he ponders over it, Reece has a flashback from the attack and puts Holder's face to the attacker through the eyes that were visible from the mask.

Clearly shocked, he recognises that Holder was one of the assailants trying to kill him. The following day, Reece goes for a run and grabs his car to arrive at the NCIS headquarters with a camera in hand.

He is intent on tracking Holder's every move. With the pictures taken, James arrives at Ben's house in the dead of night to tell him he knows the killer, i.e. Holder. Ben looks at James' file on Holder and wants to know the plan of action.

The next scene shows James meeting an estate agent, as he looks to rent an apartment under another name in the same area where Holder lives.

He looks around the building and takes pictures of the door locks while the estate agent is not looking. This, taken with James' question about the building's security, which shows no alarm system, suggests he intends to break in.

The camera then shifts to James having the lock in his house, as he attempts to break into it. As he tries to do so, Liz leaves a voicemail stating she is in town and suggests that she pick him up to meet.

As the voicemail ends, the camera shows Reece successfully picking the lock. We then shift to Katie playing poker. She is interrupted by Jordan, the man whose call she ignored earlier.

She has been ignoring him for a week. As she is about to win, Jordan tells the other player not to go all in. The player agrees, preventing Katie from bluffing to victory, which peeves her off.

Katie and Jordan then proceed to talk at the bar. It turns out Jordan is in the journalist field too. She tells him she has medical authorisation from Reece to access his records.

He tells her she has 24 hours to give him something to 'release' to the media, the implication being that he is her 'boss.' The next morning, as Holder leaves the house to go to work, Ben is on hand as James' lookout.

Ben follows Holder while Reece breaks into Holder's apartment. Once inside, Reece copies the files on Holder's laptop. Back at home, James and Ben download the files.

So far, the files do not show anything untoward. However, James is interrupted by a call from someone based in Washington. The next scene shows James arriving at a bar to meet Madam Secretary of Defence Lorraine Hartley.

James is shocked to see her. She mentions him assaulting the Admiral before sitting down to have a drink. James tells her that Kahani is a threat, and he has reason to believe Kahani has an asset in NCIS.

The Secretary dismisses the idea, as a news report confirms the US has killed Kahani in a military operation. The Secretary tells James this mission 'is over' and walks off.

With James looking dejected, Ben arrives back at home to tell him what he found on Holder's files. It turns out Holder got James' fingerprints two days before the murders.

Therefore, he could have used the prints to access James' safe to get the gun to kill his family. James states the only way to know is if Holder has a knife wound on his left arm.

Thereafter, Ben gives James a gun in honour of Ernest and James' family to use on Holder if it was him. Meanwhile, Katie arrives at the clinic to get James' scan.

The receptionist tells her a new doctor has to be assigned to the case before any information can be released. Katie convinces her otherwise by bribing her with some cash.

With the files in her possession, Katie rings Jordan to tell him she needs another neurologist to look at the case, as she has discovered something. The audience, however, is not told what that is.

As for James, he breaks into Holder's apartment at night, fully armed. He enters the bedroom, pointing the gun at Holder. The latter has no knife wound on his arm and denies killing anyone.

James continues to ask him who he works for? Suddenly, James has flashbacks. He is in a war zone with Ernest, as he fades in and out of the past and present.

Holder continues to deny any involvement and tells James he will forget all about it and not press charges. With Reece pointing the gun at Holder, there is a danger he could fire it.

Holder informs Reece that he is unwell. Reece refuses to believe that he would kill his own family. With that being said, he gets ready to blow Holder's brains out.

With Holder now begging for his life, he spills the beans. Holder tells him that a man by the name of Saul Agnon pays him to get information on Reece.

Suddenly, out of nowhere, Holder attacks Reece. In the scuffle, Reece shoots him dead. He quickly clears up the scene and leaves as the episode ends.

James Reece begins burning his file on Special Agent Holder after having killed him in the last episode.

He googles Holder's handler, Saul Agnon, who wanted information on Reece. Saul works for 'Capstone Industries,' as the VP of Asset Management.

After printing his details, he messages Katie to arrange a meet-up, the implication being that Reece wants her to find out about Saul. He loads up his car with a bag of weapons, money and passports to meet her.

The scene shifts to Madam Secretary of Defence Lorraine Hartley leading a meeting at the Pentagon. She informs her staff that there will be a significant change in the budget to deal with the mental health crisis in the special ops teams.

Thus, fewer special operation personnel will be employed on a lifetime basis with mandatory retirements. After the meeting, her colleague Richard Fontana suspects this change is because of Reece's behaviour.

We join Katie, who has gone to Jordan's office. She shows him Reece's medical records. It turns out the doctors requested more tests on Reece, but he checked himself out, so he could attend the funerals.

Reece finally arrives to meet Katie at a restaurant. He asks her about 'Capstone Industries,' but she knows nothing. Reece tells her they have funds up to \$60 billion. Katie wants to know how he got a lead on Capstone. Reece lies and tells her he is the source.

Katie then confronts him about his medical records. The scans show Reece has a tumour on the brain. The symptoms include memory problems, headaches, and paranoia. James refuses to believe the scan, but the only way to know is if Reece has a biopsy.

Suddenly, Reece sees someone in a brown cap and shades. With no time to lose, he tells Katie they have to go. They were being tracked by an operative, but she thinks he is imagining it. Reece tells her to get in his car.

As they do so, the car behind pulls out to follow them, so Reece reverses into it. He accosts the driver, who starts firing gunshots. Reece shoots him dead and takes a file from the man.

He gets in the car, as they drive off. Katie is in shock, as the file shows Reece was the target of a hit. Thus, he is not insane. Reece switches cars as the police arrive on the scene.

Katie watches the crime scene from afar, as she tries to convince Reece to tell the cops. He refuses and suggests she lay low. He gives her a gun, but as Reece is about to leave, she tells him to provide her with more information on Capstone Industries.

Reece gives her a file and drives off. Katie later arrives home to get some things, as she plans to leave. As she does so, she rings Jordan to tell him she was wrong about Reece and cannot help with a story before hanging up.

The next scene shows a shooting exercise led by Steve Horn, the head of Capstone Industries. He is unhappy with how his team conducted the exercise; the results show it was not his finest performance.

Following the training, he goes with his team to Capstone Industries. He has a meeting with Saul. Saul tells him the hitman Adrian Gordonis hired to take out Reece is dead, while Reece got away.

Not only that, but Reece was meant to be killed in Syria. Steve promises Saul he will handle it. Saul has been ordered to meet Mike Tedesco and Elias Ryberg at a golf tournament in Santa Barbara.

The former (Mike) is the founder of 'Nubellum Pharmaceuticals,' which was financed by Capstone Industries. The latter (Elias) is interested in buying 'Nubellum Pharmaceuticals.'

The aim is for Saul to convince Elias to make offer to buy it, with the help of Mike as Steve has shares in it. Meanwhile, Reece is now at a motel.

He has a flashback of Lauren. She is pregnant. Once again, his flashback is disrupted by sparrows hitting the window. This time around, there are many, as Reece panics.

He wakes up and hears a knock on the door. It is Ben who advises Reece not to go home. Not only that, but the shooter who tried to kill him was hired by a private company called 'Tallos Tactical.'

Reece then shows Ben his information on Saul. Ben offers to look into 'Capstone Industries' for him. Reece lets Ben know he has a 'journalist' (Katie) working on it. This worries Ben, as he is CIA now, so that could get him compromised.

James reassures Ben they have each other's backs. Ben tells him to keep a low profile, and he will be in touch if he finds anything as he makes his way to the golf tournament to keep an eye on Saul.

Saul arrives in Santa Barbara to meet Mike and Elias. The latter two are talking privately about working together. Elias tells Mike he is impressed by his work. Mike had different plans for his company before Capstone got on board.

Mike suggests they could work together if the sale goes through. Saul interrupts their conversation. Clearly, Mike and Elias are not fond of Saul. Saul offers to host the two at a house, so they can discuss business. They agree as Ben watches from afar.

Back at the Pentagon, Richard arrives in Madam Secretary's office to have a frank discussion. He tells her the budget reforms may not even be authorised.

In addition, she may ruffle the feathers of major contractors. Madam Secretary stands her ground as Richard leaves. He then rings someone (presumably Steve) to tell them what is happening. After all, Nubellum does have contracts with the Pentagon.

Back with Reece, he arrives at a strip club as a stripper named Raven sits on his lap. They talk as Reece agrees to buy some methadone from her to deal with his headaches.

It turns out the methadone was actually for Saul. Reece arrives back at the motel to meet Ben, who comes with some rope and other essentials as they prepare to go after Saul.

Saul arrives at the party as he talks to Elias. Saul is frustrated that Elias fails to confirm if he wants to close a sale for Nubellum or not. Elias tells him he will speak with his board and draw up a proposal the following day to present to Steve.

But as Elias leaves the party, Mike informs Saul he was out of order for speaking out of turn with Elias. Thereafter, Saul throws everyone out of the party.

With Saul alone in the house with his dog, he goes to the bathroom as Reece breaks in. Suddenly, out of nowhere, some music starts playing.

As Saul checks it out, he sees his dog eating a bone. Then from behind, Reece suffocates him with a plastic bag and ties him up. Saul goes unconscious.

Saul wakes up naked as he is tied to a chair. He screams for help, but Reece only plays the music louder. Realising nothing can help him, Reece asks Saul why Capstone Industries wants him dead.

Reece hints he will torture him, so Saul gives him the name of Steve Horn. However, Saul does not know why Steve acts in specific ways.

He is only a go-between and does what he is told. But Steve's focus is on something called 'Project RD 4895.' This is worth lots of money, but that's all he knows.

Reece then asks Saul who was sent to kill his family: Saul drops the name of a lawyer Marcus Boykin, who hired a gunman by the name of 'Navajas' from Mexico.

He was the gunman who got away from Reece at the clinic. Reece kills Saul by injecting him with the methadone. Back with Katie at the house, she is looking into Capstone Industries.

She receives a message from Reece stating, 'Project RD 4895.' She now has a lead. The following day, Ben and Reece burn any evidence linking them to Saul.

James shows Ben the names of Steve and Marcus. Ben asks James to choose if he wants answers or blood when deciding who he wants to go after next. Reece chooses blood as the episode ends.

James Reece and Lucy are walking in the woods. Reece's flashback is then broken up, as we see him hiking alone. The scene shifts to lawyer Marcus Boykin waking out of bed.

Marcus gets in his car to get to work. Reece gets his rifle ready to shoot at him. Once Marcus is on the highway, Reece shoots him. The vehicle veers out of control and crashes to a standstill. Reece approaches the car.

He takes his phone and copies the files before leaving him to die. Thereafter,

Reece meets Liz Riley. She will take him to Mexico to pursue the man that killed his family.

Reece advises her to leave, once she drops him off. However, she refuses and vows to stay there until the end as Lucy was her goddaughter. Once on the plane, Reece calls Ben to say he killed Marcus.

Meanwhile, the audience is introduced to Tony Layun, the head of the Fugitive Task Force. He is reviewing the CCTV footage showing Reece killing the hitman, Adrian Gordonis.

Tony wants to know who was in the car with him. Therefore, Katie is now a prime suspect. As for Katie, she is on the phone discussing 'Project RD 4895' with one of her contacts.

It turns out 'Project RD 4895' consists of a network of 100-plus-different investments that have connections to Pentagon assets. Suddenly, Katie hangs up as someone tries to break into her apartment. Katie grabs her gun.

Two people named Brian Buranek and Deborah Buranek arrive. They are shocked to see her, but they know each other. Katie lies and says she is back from Syria, which she told them via email.

They assumed she was meant to return next weekend. With that misunderstanding over, Katie manages to bluff her way out. However, she knows things are not ideal.

Moving on, Steve is in a boardroom meeting with his staff. The budget cuts proposed by Madam Secretary of Defence Lorraine Hartley will impact Capstone, as their contract would terminate.

And given that Elias has still not made an offer for 'Nubellum,' things are not looking good. Steve advises Nubellum's board to stay patient.

But as Saul was found naked and dead, it has left Steve in an embarrassing situation. Back on the plane, Reece's hand is trembling as he and Liz arrive in Mexico.

They meet Marco Del Toro and his wife Paula and daughter Antonia Del Toro. They all have dinner.

As that happens, Madam Secretary is informed by Richard that Reece was involved in the killing of Holder and the hitman, Adrian Gordonis.

The duo are interrupted by Senator Joe Pryor, who doubts Madam Secretary's budget changes. She demands that the vote be televised to the public, so people can see which politicians favour the protection of 'special interests' over the mental welfare of special operatives.

Back with Katie, she is drinking alone when Reece asks for an update on 'Project RD 4985.' She informs him that other members in his platoon had brain tumours too.

She asks where he is, but Reece ignores the text. She is then interrupted by Brian, who recognises she is in trouble. Katie tells him she just needs a few days to stay as she is working on a story.

As for Reece, Marco interrupts him to state Ben has traced a payment made by Marcus' phone to a man. This would allow James to find out where the money was sent, thus identifying the shooter that killed his family.

The following day, James wakes up with a massive headache. He finds Ben, Liz and Marco having breakfast. Marco tells Reece that the leader of his security team has found his family's killer: Navajas.

That positive discovery contrasts with Katie. She wakes up and offers to go out to get some coffee for Deborah and Brian. She borrows their car. As she is about to leave, Tony from the Fugitive Task Force pulls up with his team to question her.

Tony demands to know where Reece is, but Katie tells him she doesn't know. Tony tries to convince her to tell whatever she knows; otherwise, she could be an accessory to murder.

Katie tells him to look into how Capstone Industries gave an entire platoon of Navy SEALs brain tumours. However, Tony informs her that Saul died of an overdose a day after she and Reece were together.

Not only that, but Holder was found dead on the night Reece went on the run. Katie promises to cooperate if she knows James' whereabouts. Tony gives her his card and leaves.

Back at the Pentagon, Richard is leaving work when Steve stops him. The latter wants to talk, so they go for a walk. Steve wants the budget reforms stopped. Richard informs him that their deal was only for an exchange of information.

Steve has now changed the deal and tells Richard to do something about Senator Joe Pryor. Steve wants Pryor to be brought to him, as he has an influence on the budget reforms.

Back with Reece and the team, they meet Marco's head of security. He informs them that he is sure the man they have found is the person who killed Reece's family. After all, he has a knife wound on his left forearm.

However, they disagree on whether to do a raid or a distant shot. Marco's security advises a shot, while Reece wants a raid. Ben recognises that Reece wants revenge but advises him to look at the bigger picture of going after Steve.

Reece, though, feels obligated to look at the killer in his eye. They reach a compromise to use Marco's men to join Ben and him on a raid. Suddenly, Reece starts getting disoriented.

He collapses and wakes up to find a doctor telling him that a biopsy is recommended to see the severity of the tumour. The doctor advises him if he does the biopsy, he could get his life back in 6-9 months. Otherwise, he could die.

Reece requests some drugs to help with the symptoms. Liz is not happy that Reece didn't mention his tumour to them. Ben understands Reece's reasons for keeping it quiet, but he asks if he still feels up to going after his family's killer.

Reece states he has nothing left to lose. As they leave, Marco's wife tells Reece not to come back after the raid as she is not happy that he is willing to use his friends in his quest for vengeance.

Reece and the team carry out the operation. They kill numerous men and free some captives. Reece manages to shoot Navajas. He is wounded but still capable of running. However, Ben has been shot and is also injured.

Reece then corners the killer and shoots him. He drags his body out alive. Reece ties his hands, gets an axe and pulls out his organs while the killer cries in anguish before dying.

We then arrive at the beach, and Katie apologises to Brian for getting him and Deborah mixed up in her troubles. Brian tells her that she can stay before walking off to state: "I love you," even though he is married to Deborah.

Katie's phone then rings. Her contact tells her that Steve brought a controlling share in 'Nebullum six years ago. He then put his entire share into military neotropics, a major contractor.

And as Nebullum will be sold outright for over \$70 plus billion, she has dirt on Steve. Katie then asks Brian and Deborah if they want margaritas. As she goes to get some, she decides to pack her files and leave without saying goodbye.

As Katie drives off, Tony is in the background following her. As for Reece, Ben gives him a file on Steve Horn as he says goodbye. He cannot accompany him, as his bosses are already asking questions about his 'irregular working hours.'

Reece says goodbye to Marco and gives him his father's gun. He then gets on the plane with Liz. They fly off as the episode ends.

The episode begins with James Reece in 2007 during his time in Najaf, Iraq. He leads his platoon with Ben driving. James defies his superior's commands to go ahead with a rescue mission.

The team arrives amid gunfire. Reece rescues Liz, who has been shot in the body. Then Reece's flashback is broken, as he finds himself awake on the plane with Liz, which is parked in their remote headquarters.

The next scene shows Steve meeting with Senator Joe Pryor as Mike waits out-

side. The meeting seems to have gone well.

Mike enters Steve's office, who reassures him that Nubellum is the biggest military contract, regardless of Madam Secretary of Defence Lorraine Hartley's budget reforms. Thus, Elias will reconsider.

Mike, however, wants to sell 'Project RD 4895' to Steve. That way, Steve can flip it, and Mike gets to keep his company. Everyone is a winner as they all part ways. Steve refuses, as he states they will sell the whole company.

Back with Reece, Liz wakes up to find him planning the next move. Reece suggests they nab Steve by going to Capstone Industries' headquarters.

That is what they do, as Reece and Liz arrive outside the headquarters. They watch from a van as Tony Layun from the Fugitive Task Force turns up to go inside with his colleague Mackenzie Wilson.

Once inside, they question Steve about the death of his man Adrian Gordonis, who had tried to kill Reece. Steve tells them he doesn't know what Adrian's assignment was as it was 'off the clock.'

Tony informs him that Reece killed Adrian, but Steve denies knowing who Steve is. However, as Mackenzie has a military background, she notices that the tattoos on Steve's body show he was in the same unit as Reece.

Steve replies and states his tattoos only signify remembrance and nothing else as they leave. Meanwhile, Katie is in a meeting with Mike, the CEO of Capstone.

She is grabbing an interview with him and his publicist before the sale goes through. Mike founded Nubellum to make drugs to help tackle Alzheimers disease.

Katie grills Mike on why his company moved towards military nootropics when Capstone came on board. Mike walks out, as it is clear is not happy.

Katie follows him to the bathroom, as she wants the interview. She asks Mike what is 'Project RD 4895' and states it could be producing tumours? Mike looks worried, but he tells her it hasn't reached human trials.

Katie suggests it could have been used on the Navy SEALs who died recently in Syria and caused them tumours, including Reece. Steve tells her he has no idea what she is talking about.

Katie asks him if he is willing to talk before leaving her number and asks him to reach out. As Katie leaves Capstone in a cab, she is being followed by Tony's men.

Reece notices her leaving from his van and texts her to leave town as she is being followed. Katie is on the phone telling her contact about her meeting with Mike, but she notices a car outside watching her.

Back with Mike, he is in a meeting with Elias and Steve as they discuss the offer. Elias wants to reconsider his first offer. After all, the Pentagon is reconsidering Nubellum's contract in light of the budget cuts.

Steve interjects and states the contract is still good to go. Mike gives Elias an ultimatum by stating he can pull out of the deal altogether, if he is concerned.

Steve asks Elias what is his number? Everybody leaves with just Steve and Elias in the room. Once outside, Steve copies all files on Nubellam onto a memory stick and calls Katie.

He tells her he might have something useful and arranges a meeting in person tonight. Katie tells him to leave his phone, so he cannot be tracked. Mike walks back into the office and asks Steve if they agreed on a price.

Steve doesn't answer but thanks Mike for all his work. As Mikes leaves, one of Steve's men tells him that Mike copied some files and could be talking to the press. Steve orders his man to follow Mike.

Katie leaves at night to get ready to meet Mike. Meanwhile, Steve leaves Capstone with his men in two cars. Reece is outside Capstone, as well as Tony and Mckenzie.

The latter duo follow Horn. Reece notices that Steve has never had his men split up, so he follows one of the cars going the other way. Katie meets Mike at the train station.

He tells her if Nubellum was doing anything illegal, then it was outside of his knowledge. As for 'Project RD 4895,' it allows the brain to encode memory data without the associated trauma. Thus, it could stop PTSD.

Mike began developing the project to prevent PTSD. Steve, though, froze the project after animal testing, but Mike doesn't know why. However, Mike noticed accounting irregularities two months ago, which is somehow connected to the dead NAVY SEALS.

Reece follows Steve's men to the train station, who are presumably there to kill Mike and Katie. James gets his gun ready while Steve gives Katie the files he copied.

Mike tells her if she believes his drug caused tumours in the NAVY SEALs, then she should publish the story. However, that is going to take time. Katie notices Steve's men approaching them, as Mike only left his phone in the car. Thus, he was tracked.

They make a run for it. Steve is shot dead, while Katie continues to run. As she runs, Katie waits and shoots the man dead. As she leaves, another man is about to shoot her dead until Reece kills him. Reece and Katie leave in a car.

She tells Reece if 'Project 4985' works, then Nubellam is one of the most valuable companies in the world. If it fails, then all of Horn's investment is not worth anything.

That is why Steve is rushing the sale and moving his shares from Nubellum to other companies. Thus, any Navy SEALs with tumours have to be silenced. James demands the names of the companies from Katie.

She tells him she needs time and then will leak it via a story. However, James has none of it. He takes Katie's files and tells her to get out of town.

James is intent on killing whoever is responsible, but Katie tells him he will destroy the story and let Horn get away with it all unless he lets her work on the story. James points a gun at her and drives off.

Reece rings Ben and tells him to find out the names associated with the companies. Ben agrees but warns that this will lead to questions from his superiors.

Back at the Pentagon, Madam Secretary has found Richard's encrypted phone that he was using to get in touch with Steve. She tells him they know Steve was sending him money to an account in his mother's name.

Richard is now under Madam Secretary's control and will need a good lawyer. Ben has now gotten the news of some names. He tells Reece that Marcus Boykin and Saul Agnon had a piece in Nubellum.

To his shock, though, the Admiral, Captain Howard and Commander Cox's names were on the list too. He tells Liz, who is also shocked that they would kill Reece's family.

James demands they build a bomb to kill Steve, but Liz tries to tell him to think things through. She agrees to help on the condition there are no civilian casualties.

With the bomb made, the media gathers on the day of Nubellum's sale. Reece arrives outside Capstone in his van with Liz close by in another vehicle. The aim is to set off the bomb.

Katie happens to be there, as Tony and Mackenzie are on hand from the authorities. Steve walks out to the media as they question him about Mike's death.

He tells the media he is grieving, as well as Reece being involved in Saul's death. He continues to blame Reece for having had a psychotic breakdown. He then walks away from the media.

As that happens, Tony and Mackenzie notice a van holding up traffic. They check it out. When they do so, another tinted-out vehicle behind them containing Reece makes a move.

James drives closer until he gets parallel with Steve's car, which is waiting for him. As Tony and Mackenzie approach the vehicle with their guns, they startle Liz, who is just pretending to unload her van full of flowers.

As Steve walks away to get in his car, Reece presses a button for the activation of the bomb. However, Katie approaches Steve and tells him that he killed Mike, not Reece. If Katie doesn't get out of the way, she could get blown up too.

She tells him she knows everything about 'Project RD 4895' and will expose it and destroy the deal. Steve gets in his car and says he closed the deal yesterday. However, he didn't announce it due to Mike's death, out of 'respect.'

Reece gets out of his car after having signalled to Katie through the window to move. As she moves, Steve orders his men to drive quickly. As they begin to go, Reece activates the bomb.

In the ensuing chaos, Horn is alive but is badly burnt. Katie is alive but hurt a little. Reece gets his gun and shoots Horn's men dead. Tony and Mackenzie try to stop things.

Reece then approaches Horn, as the latter is at his mercy. He shoots Horn dead. Reece then steals a car and rings Liz to meet him so they can escape. The episode ends with the police on Reece's tail in some cars from behind.

He looks for the first-aid kit and applies a massive plaster to the wound. He then looks for his medication, realising that it is not there, Reece starts worrying. He grabs whatever supplies he can, including a map, and runs out.

Liz is next to her plane, waiting for James. She rings Ben as she worries about him. With a heavy storm on the horizon, Ben reassures her James has a better chance of not being caught.

Ben tells Liz to sit tight, while the police hunting dogs look for Reece. The latter takes cover in a cleft, as he looks at Lucy's drawing that includes the names of his targets on the back.

As he does so, Reece has a flashback of his NAVY SEAL training where he was tied to a log in the sea. The cold tide was designed to see if he would quit. Reece vowed never to stop, which is something he intends to do even in his current predicament.

The following day, some NAVY SEAL reinforcements arrive to meet Tony and Mackenzie. Tony tells them they are after Reece. One of the men, Cody 'Smitty' Smith, cannot believe Reece would be a fugitive.

Cody will stay behind, as he cannot be trusted to bring Reece in, while Tony demands to join the others to help them. Reece continues to run. However, someone has identified that he may be in the area. The NAVY SEAL helicopter arrives near Reece.

He hides under a tree, looks at his phone and then makes a run as the SEALS get off the plane. Reece's phone signal gets picked up as the SEALS find his phone near a tree. However, Reece has buried/camouflaged himself under some straw.

As they approach the phone, one member warns not to touch it as it could be an IED. Reece pulls a trigger, which blows up some smoke and sets off a piercing sound. With the vision clouded, Reece tackles one SEAL and takes his backpack before running off.

Reece then throws multiple batteries to throw off their scent, as the heat sensors detect various activities. With Reece almost cornered, Tony tries to make him surrender. The SEALS shoot but miss.

Reece makes his way to the top of a cliff, but there is nowhere to go but jump. As the SEALS make their way to the top, Reece is not there.

He could have jumped, but in any event, Reece left an empty bullet which symbolises he could have shot the SEALs but didn't, making Tony question if Reece is the bad guy.

Meanwhile, Reece made his way down the terrain by climbing down. As he is about to reach the bottom, he falls as his hand gives way. Reece is not hurt by the fall, as he takes shelter for the night during another storm.

He searches the NAVY SEAL bag he stole but finds no medical supplies. But he does find an emergency flare. He sets off the flare and uses a knife to heat the blade before pressing that knife on his wound in anguish.

Suddenly, he has a flashback of him with Lauren. He is speaking through a baby monitor as she tends to Lucy. As the flashback ends, it turns out Reece was talking through a NAVY SEAL walkie-talkie that Tony picked up.

After realising, Reece goes silent as Tony tries to make him talk. Tony wants Reece to surrender, but Reece will not unless the people who killed his family are taken out.

The following day, the SEALs send a mini drone to track Reece. He can now see San Rafael airport from a distance. As he makes his way down, Reece has another flashback.

This time he looks at the dead sparrow from the outside. The flashback is broken as the drone approaches Reece. He shoots it down. But with the signal picked up, the SEALs know where Reece is located, so he makes a run for it.

With some IEDs from the SEAL bag, Reece lines up some bombs. As Mckenzie ambushes Reece, he has the detonator in his hand. He tells them to move back, or he will press it.

Mckenzie refuses, and with Reece now ambushed by Tony's men from the other side, he has nowhere to go. Reece blows it up as an avalanche of rocks tumble down. In the ensuing chaos, Reece emerges from the rubble.

He finds Mckenzie, drags her out and gives her CPR to save her life before running. But the SEALs have now lost track of Reece. Meanwhile, Liz overhears a news broadcast stating Reece

could be dead.

She begins crying, but suddenly, Reece breaks through the door alive. Liz hugs him, and they get on the plane, as she tends to his wound. With his medication in hand, Liz confirms Katie is alive.

Reece tells Liz he needs to get his flashbacks out of his head. She tells Reece no amount of killing will bring his family back. Reece understands but parachutes out of the plane as Liz flies off.

Reece emerges from the sea to meet Ben, relaxing on a beach, as the episode ends.

The episode begins with James Reece sitting in his car at night outside his home.

He goes inside and has a flashback of him moving in with Lauren. His watch alarm goes off as the flashback ends. Then we switch to a scene 15 hours earlier.

Captain Howard arrives to speak to the Admiral, alongside Commander Bill Cox.

Captain Howard gives the Admiral a file stating they should have immunity from prosecution over the operation that

killed Reece's battalion in Syria. However, there is no guarantee.

Captain Howard suggests they consider moving to other countries as he has a family to look after. Commander Cox refuses, while the Admiral reassures the other two that Reece can do what he wants.

After all, Reece will have to contend with 5,000 SEALs under the Admiral's control. Meanwhile, Reece is watching all three from afar on a boat with Ben.

All three have had daily meetings since Steve Horn was killed. Commander Howard and Commander Cox do leave the base, but the Admiral is always there. Ben and Reece discuss how they can take them out.

Meanwhile, Madam Secretary of Defence Lorraine Hartley is on a plane looking at a headline about how Steve died.

She has footage of Katie confronting Steve about his role in 'Project RD 4895,' and how he killed the NAVY SEALs. Having watched that footage, Madam Secretary gives a speech confirming Reece is a domestic terrorist.

Meanwhile, Tony tells his Fugitive Division to stop Reece by getting to his targets before he does. Katie then arrives to speak to Tony. She agrees to help him find Reece.

However, she wants some information in exchange that allows her to finish her story. She wants Tony to access Steve Horn's computers and look for the 'cap table,' this is a list of people who made money off the Nubellam sale.

Tony agrees, but Katie must remain in his office. Shortly after, the Admiral is joined by Madam Secretary, who has made an impromptu visit to his office. She has come with DCIS Agent Bijan Azad.

She grills him about the failed operation on Dr. John Kahani and is curious as to why the intelligence was flawed. The Admiral claims the Pentagon ordered him to move on Kahani as soon as possible, but she is not convinced.

She leaves, but Agent Azad confirms he will be in touch. After that, the Admiral demands to see Captain Howard as he looks worried. The latter has just arrived home. He receives a call from work but ignores it.

Instead, he walks in to see his wife helping their son with his studies. Captain Howard tells them they are going on holiday tonight to Key West. Naturally, they are shocked. But Commander Howard tells them to pack.

He tells his family they have to go because he covered for the Admiral, who had gotten involved in some 'wrongdoing.' However, he reassures his wife that everything will be fine.

As he does so, Ben overhears the conversation from his car after having bugged the laptop that is in use in Captain Howard's house.

Ben arrives back to tell Reece about Captain Howard's plans. They plan to deal with Captain Howard, and as they discuss it, Reece finishes making a bomb which he straps on himself.

Meanwhile, Tony's search on Horn's computer shows the list. He tells his superior that the Admiral, Captain Howard, and Commander Cox were all paid by Horn for allowing the experiment with 'Project RD 4895'.

However, there is one company, (Oberon Analytics) whose owner is unaccounted for. With Tony's supervisor giving him the go-ahead to act, Tony puts each of his team on the Admiral, Captain Howard, and Commander Cox in anticipation of Reece attacking them.

And that is what happens. Captain Howard's doorbell rings and his son tells him it is the FBI. Howard goes to the door, it is Ben impersonating an FBI agent.

Meanwhile, Tony arrives with his men at the Admiral's headquarters. He has a search warrant. His team enters as Tony and the Admiral talk. The latter tells Tony he knows why he is here and gives him a file that will clear things up.

The Admiral then tells Tony to tell the person who sent him to never step foot here again. Tony is then interrupted by a phone call from Mackenzie Wilson.

She tells Tony that Captain Howard missed his flight, while she is tracking Commander Cox. The latter is at a bar drinking. The bartender asks if he is fine, as he is drinking a lot.

Commander Cox ignores her, finishes his drink, and leaves. As he is about to go in his car, Reece accosts him. They get into a fight. Reece comes out on top and injects him with a sedative.

As Commander Cox wakes up, he is tied to a log at sea as Reece overlooks him. Reece wants to know all the names of those involved in the experiments.

Commander Cox tells him that only he, the Admiral, and Captain Howard knew about the experiments. Reece lets go of the log as Commander Cox drowns.

Reece then goes back to the car. He has Captain Howard and his family tied up. Reece tells Captain Howard he will kill his family unless he cooperates.

Captain Howard begs Reece to stop and agrees to do whatever he asks. Reece tells Ben to get Howard prepared while he goes home to relive some flashbacks.

As for Katie, she is still in Tony's office. She then gets a phone call from Reece. He tells her he never meant to put her in harm's way. Katie tells him he doesn't have to do any of this, as he is at home and not at war.

Reece states his home doesn't exist anymore. He hangs up and then gets out of his car and returns to the house in the same scene at the start of the episode.

Meanwhile, Tony is looking at the file the Admiral gave him. He is wondering why the Admiral gave him evidence that showed he was doing secret drug trials on NAVY SEALs.

Tony's San Diego police force is then visited by DCIS Agent Bijan Azad and his team. Tony's superior requests a word with him, and he joins Agent Bijan in the office.

Tony and his team have been pulled off the case. Bijan tells him he had no issue with his work, but Tony's superior felt he overstepped the mark. The experiments were legal, as the Admiral had emergency authorisation.

And yet, Bijan confirms they still have reason to believe there was some cover-up. Tony is told to give agent Bijan everything he has on the Admiral and take some leave.

Clearly unhappy, Tony approaches Katie. He tells her 'Project RD 4985' had emergency authorisation, while the last person who profited from Nubellam's sale was unknown. He gives Katie the entire file he got from the Admiral and lets her go.

But she must get the story out as soon as possible. Tony also tells his team to leave, as he watches Reece's house from his car. Katie begins working on the story in the library. She calls Jordan and tells her she has Reece's story.

He asks Katie if she is ready to publish it. However, she still has some issues to work out. Madam Secretary had signed a paper for the emergency authorisation of experiments that ended up giving Reece and his team brain tumours.

And with the last shareholder still unknown, Katie suspects Madam Secretary could be it. Jordan tells her he can publish everything in the next hour.

Katie sends Jordan the story with the headline: 'Secret Tests and Stock Payouts: 'Lorraine Hartley's War Crime Against James Reece.'

Meanwhile, Reece is in his house. He has another flashback of Lauren. She tells him she is pregnant. They discuss baby names, and Lauren chooses the name Lucy.

He then walks through a door, which takes him back to the flashback of the operation. He relives numerous moments of his life with Lauren and Lucy before his watch alarm breaks up the flashback, just as at the start of the episode.

After turning the alarm off, Reece gets a message from Katie. She tells him Madam Secretary approved the whole thing. Meanwhile, Captain Howard arrives at the Admiral's office under Reece's prior authorisation.

He looks nervous. The Admiral claims Madam Secretary attempted to pin the blame on them, which is why he gave Tony the file Captain Howard gave him earlier in the episode.

Captain Howard's phone rings, but instead of answering it, he gives it to the Admiral. The Admiral answers to find Reece on the phone.

As they talk, Captain Howard unzips his vest with the bomb that Reece had made earlier on his chest. The Admiral begs Reece not to do this. He promises to tell him everyone involved in the operation.

But as Reece suspects Madam Secretary is the final person, he presses a button on his phone which detonates the bomb. With Tony having heard of the news flash about the bomb that had just gone off, he asks his team if Reece was at the scene.

They tell him it could have been detonated remotely. With only one way to know, Tony gets out of his car to enter Reece's house. He approaches with his gun, and they engage in a tussle.

Reece knocks him down and has a gun pointing at him. Tony tells Reece he has evidence about Horn and the Admiral. As such, he urges Reece to let justice run its course, to which Reece replies: "I am Justice."

Tony states he cannot let Reece continue. With Tony at the barrel of a gun, Reece chooses not to kill him but knocks him out instead. He then informs Tony to stay out of his way before leaving.

In contrast, Katie rings Jordan to ask why the story has not been published. After all, it has been over an hour. He tells her he has not received an email.

When Katie checks her sent items, her email is not there. Katie tells Jordan she has to go and hangs up. Katie gets ready to leave the library, but as she does so, she is stopped by Madam Secretary.

Madam Secretary tells Katie she read the story. However, the story was wrong. She informs Katie she is free to walk away if she wants.

Madam Secretary recognises Katie as a good journalist, but that story is not befitting her. Therefore, if Katie wants the whole truth, Madam Secretary is willing to give her an interview as the episode ends.

We see Tony for the first time as he runs on a treadmill. Afterward, he walks outside to talk to Mackenzie Wilson.

She gives him a file on Ben, as they know he is CIA after Captain Howard's family identified him. Tony tells Mackenzie that Reece was the victim, while the people he was after were not, which shocks her.

And yet, Tony vows to bring them all in at the expense of their careers, even if they have been told to get off the case. Ben and Reece are now on the highway in their van, preparing to go after Madam Secretary.

Reece receives Katie's text but ignores it. As they drive, they suddenly see a checkpoint. With traffic on both sides, they have nowhere to run. Reece gets himself armed and hides somewhere in the van. Ben shows the officer his license.

The officer has a list of Reece and Ben as wanted men. He demands to see the back of the van, as his other colleague checks it out. Ben's license comes back clear, while Reece is almost discovered in the van. However, Ben is given the all-clear as they drive off.

Katie picks up the interview with Madam Secretary. It turns out that the latter's father was an alcoholic and took his own life, after some psychotic episodes having served in Korea/Vietnam.

Katie does not believe this justified Madam Secretary's decision to push through 'Project RD 4895.' Katie then rewrites the story and changes the headline.

Back with Ben and Reece, they arrive at a boat which was left by Reece's contact dubbed 'R.' R left a message on the boat stating they are now even and if Reece wants to 'make it out,' he knows 'where to go.' They get on the boat and ride off toward the island.

Meanwhile, Tony and Mackenzie join the NAVY SEAL team that was after Reece initially. They get on the boat and proceed to go after him.

Reece gets ready to swim to the island as the night has arrived. He tells Ben to stay on the boat, but the latter wants to go with Reece, but he refuses.

Ben then tries to convince Reece to turn around, and they can walk away to Peru as Katie has the story. Reece refuses and states he must see things through as he goes off.

Katie has finished the story with a new headline: "Lorraine Hartley's Legacy and Her Private War For Special Operators." She gives a copy of it to Madam Secretary and tells her she is leaving.

But before Katie leaves, she wants to double-check her facts. Katie questions Madam Secretary over the mission log involving Reece's operation with his platoon.

Madam Secretary did not see anything suspicious about the Admiral's behaviour from the control room. She had walked into the control room to see the operation at 21 minutes and 12 seconds.

And then, there were 9 minutes and 21 seconds until communication with the platoon was cut off. Katie calls out Madam Secretary's account.

Madam Secretary admits the Admiral told her that the platoon had 'complications' and there were 'unfavourable developments.' However, she took the Admiral's words that the medical issues were 'resolved.'

Katie lambasts her by stating she had 9 minutes and 21 seconds to tell the men to abort the mission. Thus, Katie implies Madam Secretary feared the consequences of 'Project RD 4895' being discovered, which is why she didn't pull the men out and save them.

However, Madam Secretary states those men saved lives, as once 'Project RD 4895' comes out, it will save more lives. Thus, the men were expendable for a more significant cause.

And yet, it is murder irrespective of whether this was used to save lives. With Katie having recorded the conversation, she has everything she needs to finish her story.

Madam Secretary refuses to allow Katie to publish that story as an armed man walks in to keep Katie in check. Meanwhile, Reece has arrived on the island. He is armed, and Ben keeps watch from a lighthouse as he gets into the position as a sniper.

Reece gives him the go-ahead, through his earpiece to fire at a boat. It blows up, Tony and his men are near the island as they hear the boat blow up and proceed towards it.

Katie is then taken away, along with Madam Secretary, into a safe room. As Madam Secretary's men approach the blown-up boat, Reece makes a run towards her house.

Ben covers him by shooting any men that get in his way. Ben also shoots out the lights, so Tony's men are in darkness. Tony's team is now intent on going after Ben, as they want the shooter dead.

As Tony's men arrive at the island, Ben tells Reece to abort as they may be outnumbered. Reece refuses, as some of Tony's men approach Ben's direction, while the others cooperate with Madam Secretary's team to get Reece.

Reece blows up one van as he finally enters her house and takes out several men. He then throws some tear gas to cloud the security's vision. He proceeds to take out further men but has been shot in his waist.

Madam Secretary orders the two men watching her and Katie, in the safe room, to go after Reece. She is now alone with Katie as she opens her drawer, which has a gun. Reece kills her final two men and walks in to confront Madam Secretary.

Katie begs him not to kill her as she has everything on tape and shows him Lucy's drawing to convince him. Reece, though, is injured from the gunshot.

Meanwhile, Madam Secretary continues to look at the gun in her drawer. But before Reece can kill her, Madam Secretary commits suicide by shooting herself.

Tony's men arrive at the house and find Madam Secretary dead. Katie is in the room, but Reece is nowhere to be seen. Tony finds Reece limping outside and tells him to surrender. Reece puts his gun down but continues to go ahead and dive back into the sea.

Tony now has the choice to kill Reece or let him go. Then he gets a radio message from Mackenzie stating that Katie is alive, but Madam Secretary took her own life.

With that being said, Tony lies and states he does not know the whereabouts of Reece as he lets him go. Three weeks later, a news headline states Congress will investigate all significant military contracts, as there will be mass reform at the Pentagon.

Katie has published her story as she receives a text from Reece. He thanks Katie for her story, while she tells him Oberon Analytics operates through a bank in Peru. The implication is that Ben is the final person involved, as he wanted to live in Peru.

And that is the case, as Ben is in Mancora, Peru, living off his boat. Once he gets out of the water, Reece confronts him. Ben admits everything. The Admiral told Ben that Reece and his men would die anyway due to the 'tumours.'

Therefore, it was better for them to die on their feet than in a hospital bed. And yet, Ben still could have stopped everything. Ben tells Reece he had nothing to do with Lauren and Lucy's death.

With Reece emotional, Ben gives him the go-ahead to finish the list and shoot him dead. The camera shows a clear shot of the sea, as a gunshot goes off, signifying Ben's death.

Reece then relives the flashback of the dead sparrow on his window, as he sits alone on the boat. This time, he tells Lucy the truth by stating he doesn't think the sparrow will be fine. Lucy then asks him what if he never returns home from his NAVY missions.

Reece says, 'he will always come home,' before taking her to the side. He tells Lucy if he doesn't come home, then know he died doing something important. He reassures Lucy that her mother will watch out for her.

As Lucy cries, Lauren and Reece hug her as a family. Reece then kisses Lucy's picture after killing all his targets and throws it into the sea. He then points his finger at Malawi on a map for his next destination, as he sails off into the sunset, and the episode ends.
